Law strengthens liability enforcement

In September, the simple matter of registering a motor vehicle in Texas will become a little more complicated.

The change is a result of insurance reform enacted by the 72nd Legislature.

Beginning September 1, the owner of a motor vehicle must submit current proof of financial responsibility with an application for initial registration, renewal of registration, or transfer of registration. This new requirement is a must, regardless of whether registration is accomplished in person or by mail.

The most common evidence of financial responsibility is a liability insurance card issued to the policyholder by the insurance company. Examples of other types of acceptable proof include insurance policies and binders, pool coverage documents, and certificates of self-insurance, bond, etc.

The original or a photocopy of the evidence will satisfy the requirement of proof of financial responsibility. All original documentation will be returned.

Questions about proper evidence of financial responsibility may be directed to your automobile insurance company, your local County Tax Assessor-Collector, or to the local Division of Motor Vehicles Regional Office.

For more information, contact Kristeen Roe, Coke County Tax A/C, at 453-2614. Beginning September 1, \$350 to \$1,000 and face the possibility of having their vehicle impounded for 180 days.

"Starting September 1, anyone wishing to renew his driver license, get a license for the first time or needing to get a motor vehicle inspected will be required to show proof of financial responsibility at our Driver License offices or Motor Vehicle Inspection Sta-



Texans will be required to show proof of financial responsibility before they can get a driver license, renew a license or have their motor vehicle inspected, according to DPS Director Col. Joe E. Milner.

"This may seem like an inconvenience to law-abiding Texans, but in the long run, this new law should help protect all motorists by increasing the number of persons who have the legally-required auto liability insurance," Milner said.

Texas motorists have been required since 1981 to have auto liability insurance, but only about 75% of the state's drivers have valid policies in force.

Also effective September 1, the fine for not having liability insurance will be increased from \$75 to \$175 - \$350. Repeat offenders will have to pay
