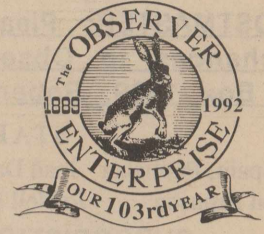

Stock show big success despite weather

It wasn't a sandstorm this year, but veteran stock show participants knew to expect the worst. And, sure enough, Mother Nature didn't disappoint. The sandstorm was replaced with rain, snow, and generally cold weather.

But the rain and snow didn't dampen any spirits at the 52nd Annual Coke County Stock Show. This year's show was highlighted by an increase in exhibitors over previous years.

Despite the national news media's predictions of eco-

nomic doom and gloom, this year's premium sale was also up over last year's sale, thanks to the efforts of the directors of the annual event.

J. J. Tennison started the weekend off right on Friday night, as his champion mediumwool lamb was selected as grand champion lamb of the show. Tennison also exhibited the reserve champion finewool lamb, the champion OPB swine, and took home the sheep showmanship trophy as well as the coveted Ralph Walker Top Hand

Award. Shelley Burrows exhibited the reserve grand champion lamb of the 1992 show.

On Saturday morning, Michael Blair took the top spot in the swine show with his Hampshire market hog taking grand champion honors. Reserve grand champion in the market hog show was exhibited by Kim Blair.

Grand champion steer honors went to Teresa Vaughn, with Shea Kelton taking the reserve champion trophy in this division.

Cathy Smith was a double winner in the meat goat division, taking grand and reserve honors with her two meat goat entries.

Detection unit set for RL

According to the American Cancer Society, one out of every nine women in the United States will develop breast cancer sometime during her lifetime. Every year over 37,000 women die as a result of breast cancer.

According to a spokesman from TransAmerican Diagnostic Services, Inc. in Midland, Texas "The death rate from breast cancer could be drastically reduced if women would have mammograms done before a problem exists." By using modern state of the art X-ray equipment breast cancers can be found when they are about the size of a grain of rice and well before the cancer can be felt. A woman who is diagnosed with breast can-

cer at this early stage has a 90%-97% survival rate. However, a woman who is not diagnosed until a lump can be felt has approximately a 50% survival rate in five years.

In an effort to find cancers at the earliest possible stage and prevent unnecessary deaths, a Mobile Breast Cancer Detection Unit will be made available to local women on Wednesday, January 29th.

The Mobile Unit will be set up inside West Coke County District Nursing Home, 307 West 8th, Robert Lee, Texas. Appointments can be made by calling 453-2511. For more information you may call Transamerican Diagnostic Services, Inc. at (915) 561-8888.

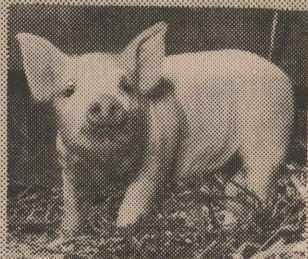
Vincent honored for ASCS efforts

Included on the Dean's List is Robert Runnion of Robert Lee. His parents, Mr. and Mrs. Art Runnion, also reside in Robert Lee.

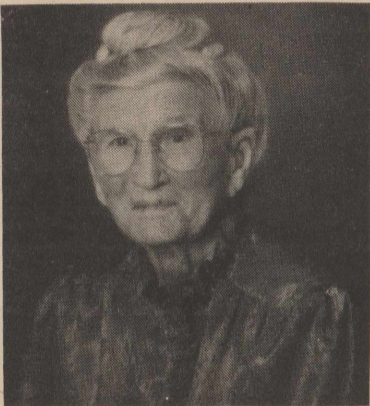
Sorosis Club meeting in Bronte

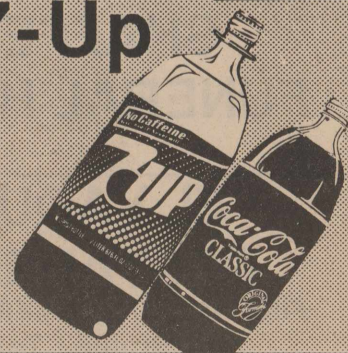

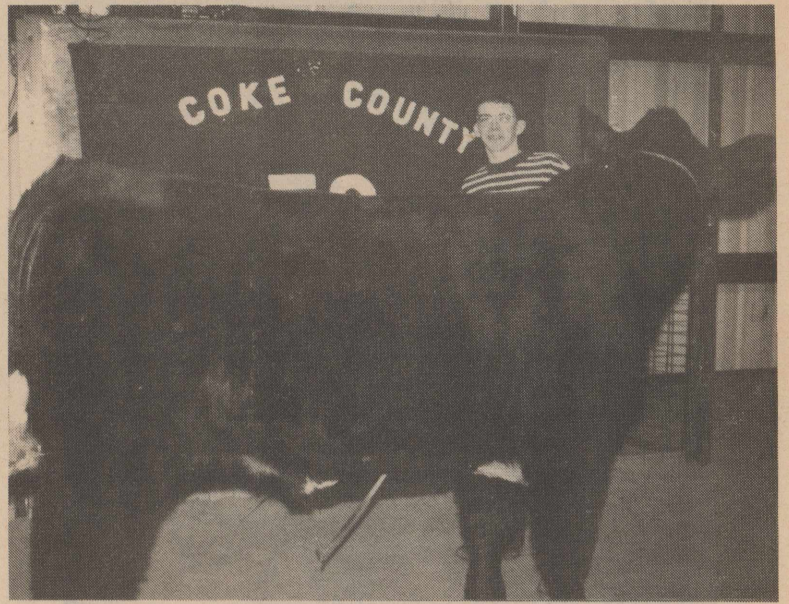

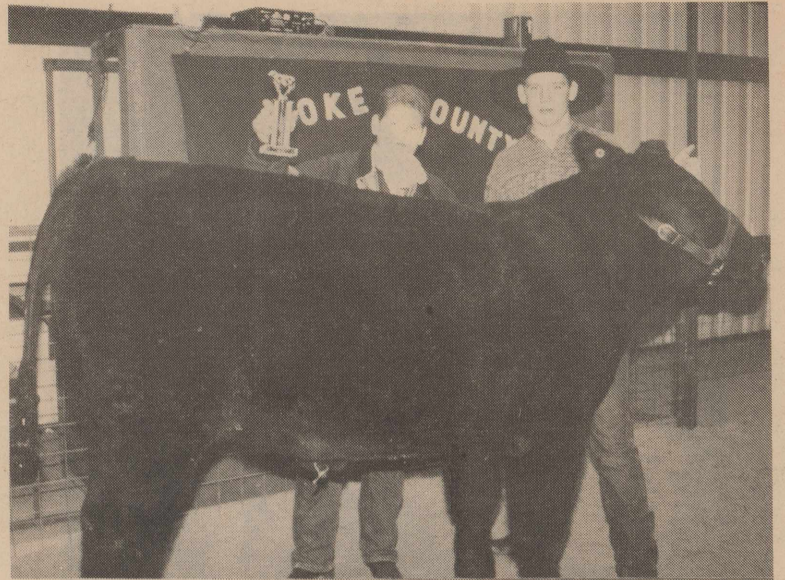

According to the American Cancer Society, one out of nine women in the United States will develop breast cancer sometime in her lifetime. It is currently estimated that over 37,000 women die each year as the result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has a 97% five year survival rate and a 90% 10 year survival rate.

A mammogram can detect a cancer this small, ● even before it can be felt.

Guidelines For Screening Mammography Established by the American Cancer Society.

I. 35-40 years of age - One baseline mammogram.

II. 40-50 years of age - A mammogram every 1-2 years depending on breast type and risk factor.

III. 50 years of age and over - An annual physical examination and annual mammogram.

IV. Asymptomatic women under 50 years of age with significant high risk factors should be examined at appropriate intervals. These risk factors include previous breast cancer and family history of cancer.

V. A symptomatic woman should have a mammogram at any age when she experiences a mass, nipple discharge, skin changes or unexplained breast pain.

A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers.

A female technologist who is highly trained in mammography will perform the examination.

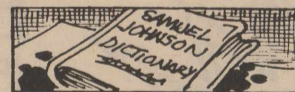

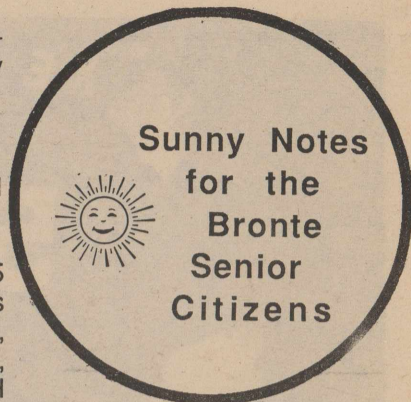

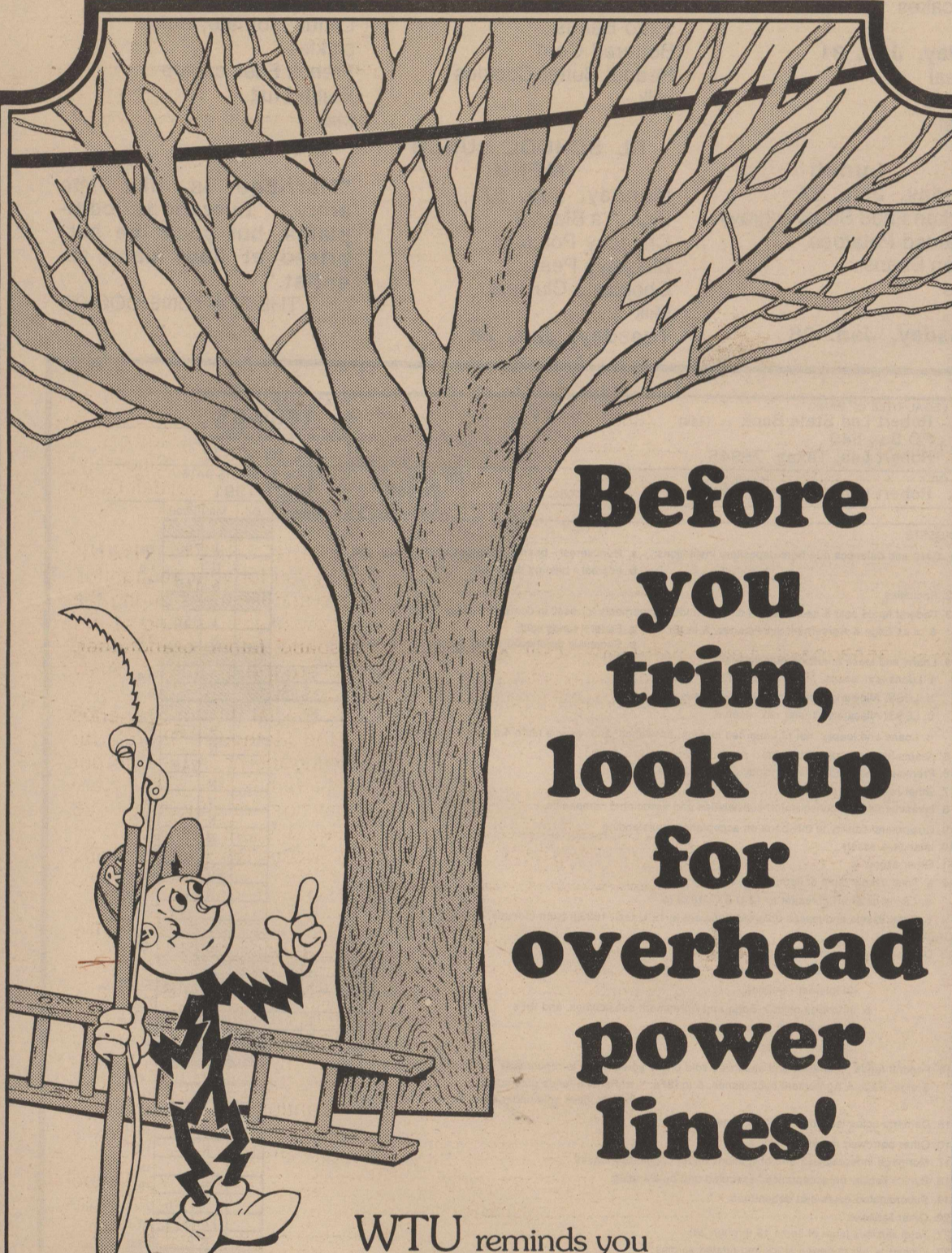
Media Fair

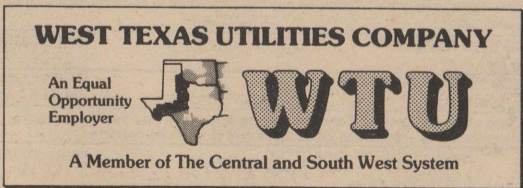

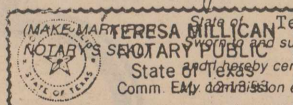
