## Sims discusses issues during county visit

Senator Bill Sims of San Angelo made a campaign swing to Robert Lee Monday morning before going on to Bronte, Abilene, and Sweetwater. He was accompanied by Darryl Schriver, his travel aide.

Senator Sims visited several businesses in town, including the Coke-Sterling Farm Bureau, and made an appearance at the County Commissioners Court meeting, as well as other offices in the courthouse. He spoke briefly in answer to questions and concerns of constituents.

Rural water control has been a concern of most Texas communities. Mr. Sims predicted the new laws will have little serious effect on windmill wells and that underground water rights will remain in the hands of landowners. He said an announcement was forthcoming Tuesday.

At the time of his visit Monday, a committee meeting was

scheduled to take place on Tuesday, February 11, to study the proposal, already enacted in some states, to prohibit elected individuals from serving in an office for longer than 8 to 10 years. Oklahoma, Colorado, and Oregon have passed legislation to that effect, as well as Texas cities, Houston and San Antonio.

Senator Sims opposed this proposal by saying he asked a man in favor of the issue if he was a better husband now than he was in the beginning. The man answered that of course he was. Sims said that everyone improves with experience, whether in the family, business, or elective environment. He said it will never happen in Austin.

His aide, Schriver, said he felt poor representation should be controlled by voters at the polls, by removing those who aren't doing a good job.

Sims, a native of Paint Rock, makes his home in San Angelo which is more or less the center of ranching country in West Texas. His interest has always been in the area and is currently serving as executive secretary of the Texas Sheep and Goat Raisers Association. His first job following graduation from Texas Tech in 1955 was in the county agent's office in Howard County until 1960 and was a county agent in Irion County for six years.

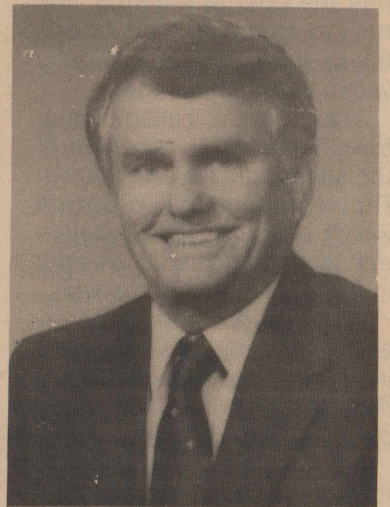
In addition to his ranching background, Sims proclaims support for small businessmen including his 6-year fight

on the workers' comp issue.

He began his public service in politics as a state senator in 1983 and has garnered a number of honors and awards for his leadership.

A federal court panel redrew the boundary lines for Sims' 25th Texas Senate District and Temple Dickson's 24th Texas Senate District, pairing the two senators in the March 10 Democratic primary.

Republican primary contenders are State Representative Troy Fraser, R-Big Spring, and Jim Deats of Boerne.

## Council slates election

A declaration for write-in must be filed no later than 5 pm on the 30th day before election day. This filing deadline is extended if a candidate whose name is printed on the ballot dies or is declared ineligible on or after the 33rd day before election day. The deadline for a write-in candidate is then 5 pm of the 27th day preceding election day.

She is a graduate of Bronte High School and lives in Bronte with her mother, Marcella Zuniga, and her two children, Stephanie and Michael Martinez, who are students of Bronte schools.

### RLISD Board calls election

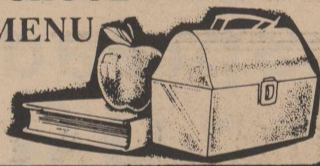
The Robert Lee ISD Board of Trustees have called an election to be held on May 2, 1992, for the purpose of electing two school board members.

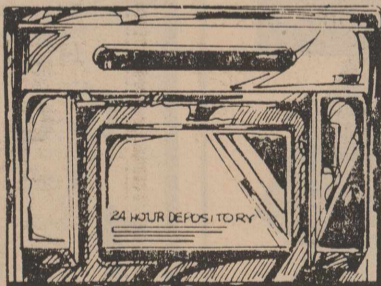

The Longhorns' overall record stands at 14-10 with a 6-3 District record.

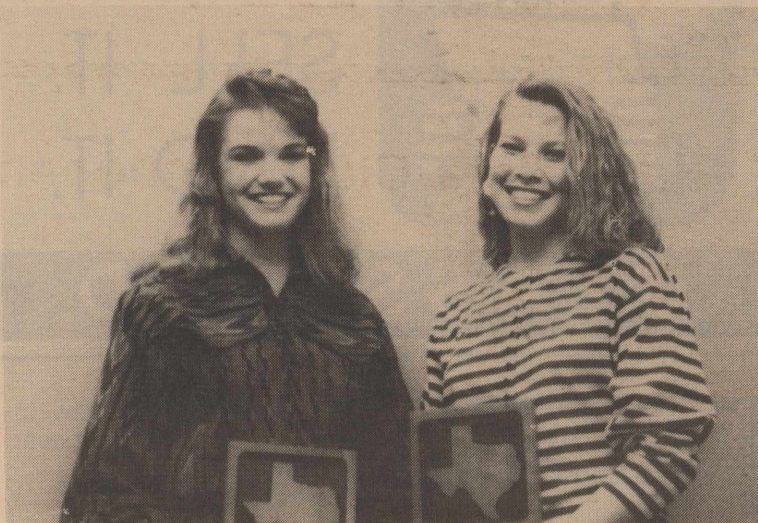
The JV boys didn't fare as well as the Varsity as they lost to both Sterling City and Robert Lee.
