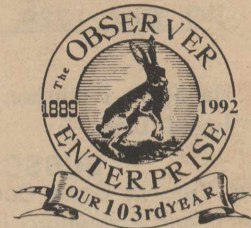

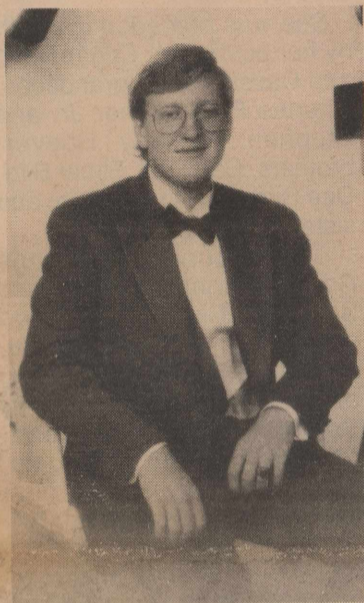

Music will be under the direction of Rev. Jimmy Rogers, Pastor of Pecan Baptist Church. His wife will serve as pianist.

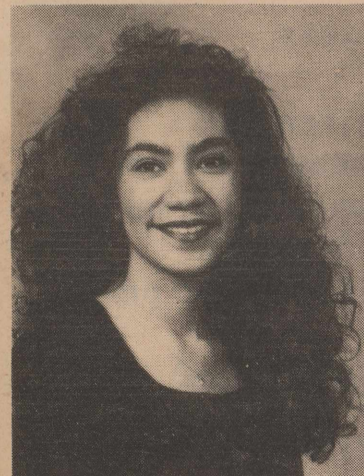
The Rev. and Mrs. Rogers are well known in Coke County and other areas for their rendition of church and special music.

Budget amendment fails

Recently Congressman Charles Stenholm (D-TX) along with Representative Bob Smith (R-OR), Tom Carper (D-DE), Olympia Snowe (R-ME) and Jim Moody (D-WI) expressed regret that the constitutional amendment requiring a balanced budget failed.

The House voted 280 to 153 on H.J. Res 290. The legislation required 290 votes or 2/3 of the House to pass.

"We currently have a \$400 billion deficit and a \$4 trillion debt. Statues have proven useless to stop this excessive spending but I remain committed to working toward deficit reduction and will continue to look for ways to cut spending so that we do not continue to pass on excessive debt to future generations," said Stenholm.

"The American people have repeatedly expressed their desire for a balanced budget and I plan to continue working toward that goal."

The amendment would

have required the President to propose a balanced budget and the Congress to adopt a balanced budget, unless 3/5 of both the House and the Senate agree to unbalance the budget for a particular year.

Stenholm pointed out that this will be the 23rd consecutive year and the 31st out of the last 32 years that the government will spend more than it takes in.

"I am encouraged that the balanced budget amendment has generated so much discussion in the past few months. The budget and our country's debt has become a campaign issue and I am encouraged that with continued discussion, we will find workable solutions to this ever increasing problem."

The Senate has an identical amendment being sponsored by Senators Paul Simon (D-IL) and Larry Craig (R-ID). It will be discussed and voted on this summer. It will require 67 votes or 2/3 of the Senate to pass.

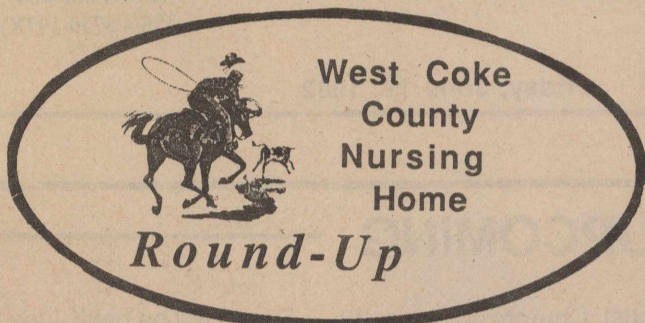

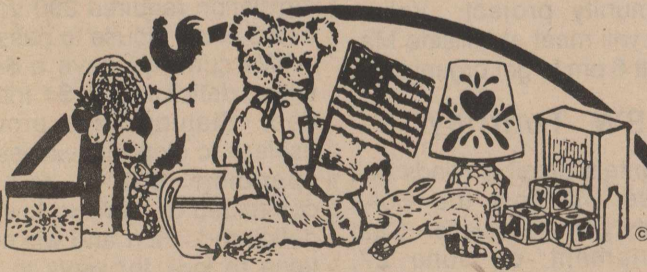

Detection clinic slated

The American Cancer Society predicts that about 44,000 women will die of breast cancer this year. Experts estimate that if every woman had regular mammograms according to guidelines established by the American Cancer Society, nearly a third of the women who die of breast cancer would survive. The guidelines are:

- Begin mammography by age 40.
- Age 40-49 mammogram every 1-2 years.
- Over age 50 annual mammogram.
- Monthly breast self-examination.
- Regular breast exams by a physician.

Mammography is the best means for early detection of breast cancer.

Transamerican Diagnostic Services has been accredited by the American College of Radiology since 1989. The American College of Radiology program is voluntary and designed to insure women receive optimum quality mammographic examinations. 

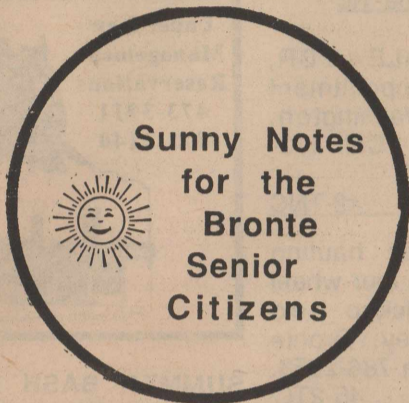

This ordinance was adopted June 8, 1992, with certain changes for the original animal ordinance adopted by the City of Robert Lee in February, 1991. The changes are as follows:

No. 7. Maximum Square Footage Requirements for pens or enclosures and Maximum Allowable Units for Individual:

No person shall have a pen or enclosure that shall have less than 150 square feet per animal unit. All pens or enclosures shall be built so that each animal unit shall have at least 150 square feet for utilization. There shall, however, be a limit of 7,000 square feet. (This being the equal of two 25' x 140' city lots or one 50' by 140' city lot). For the purpose of this provision the following types of livestock shall be deemed to constitute the following animal units, to-wit:

One Animal Unit Equals: 1 cow and calf; 1 horse; 1 mule; 5 sheep; 6 goats.

No.12. There shall be a 48 hour exclusion wherein residents of the City shall be allowed to maintain animal units in excess of footage requirement, this for temporary purposes.

13. Notice of Violation of Ordinance: In the event any person shall be in violation of the provisions of this ordinance, they shall be first sent, by certified mail, return receipt requested, notice of the alleged violation with request for corrective action to be completed within five (5) days from the date of said letter.

15. This ordinance supercedes any and all ordinances passed in conflict to it, including, but not exclusively, ordinance number 1016, dated the 12th day of February, 1991.

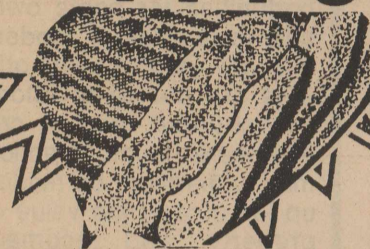

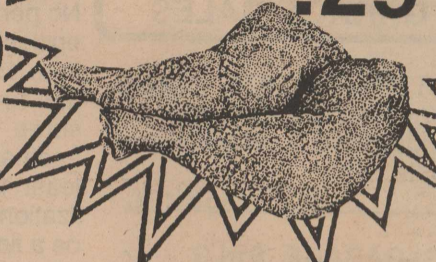

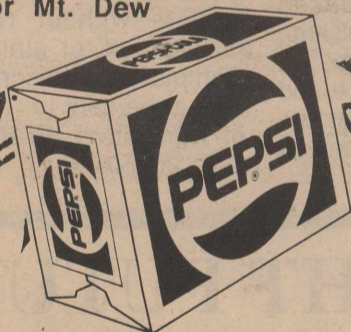
