Gruimaraes to speak at Baptist Church

Spending 2 1/2 weeks in Robert Lee is Moema Gruimaraes of Baura, Sao Paulo, Brazil. She will speak at the Robert Lee Baptist Church at the Sunday worship service January 8 at 11 a.m. During her visit to Texas, she has spoken several times to surrounding groups.

Ms. Gruimaraes is the director (superintendent) of a Baptist school in Brazil which teaches a full curriculum to about 700 students, ages 3 through 15, including both boys and girls. Within two years she hopes to include older teenagers. Residents of the city of 300,000 people speak Portuguese, but English is taught at the school. Although Brazil has public schools, the quality of education is quite poor.

The Baura Baptist School was founded by Ms. Gruimaraes' father, a pastor of a local church, five years ago at the church with 7 students.

RL City Council to implement ordinance

Although the ordinance has passed approval within the council, it has yet to be enforced as the dog pound has not been completed. City employees are working to complete that facility. Once the pound has been completed, enforcement will begin and all animals will be required to be licensed and registered. 1995 Social Security changes

Social Security and Supplemental Security Income (SSI) benefits will increase 2.8 percent, beginning with the payments that Social Security beneficiaries receive January 3rd and SSI recipients receive on December 30th, Franklin H. Upp, Social Security Manager for San Angelo, said recently. The automatic cost-ofliving adjustment is made annually.

For Social Security beneficiaries, the average monthly benefit amount for all retired workers will rise from \$679 to \$698. The maximum federal SSI monthly payment to an individual will rise from \$446 to \$458. For a couple, the maximum federal SSI payment will rise from \$669 to \$687. Some states add a supplement to the federal payment.

Social Security and SSI benefits increase automatically each year based on the rise in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) from the third quarter of one year through the corresponding period of the next. This year's increase in the CPI-W was 2.8 percent.

Windbreak seedlings available

One aspect of West Texas weather that can always be counted on is the wind. Although it provides such benefits as cooling breezes and power for windmills, it can also cause a variety of problems for Coke County residents. Wind erosion strips bare fields of valuable topsoil and deposits it where it is neither needed or wanted, such as fence lines, roads, and dining room tables. Cold winter winds raise utility bills and are dangerous to unprotected livestock.

Windbreaks help reduce many of the problems associated with the wind. Field windbreaks significantly reduce soil erosion. Windbreaks around a homesite help reduce dust and protect the home from cold winds.

in confinement or in open pastures.

In an effort to assist landowners in this area, the Coke County Soil and Water Conservation District, in cooperation with the Texas Forest Service, is providing tree and shrub species for conservation planting. Firstyear seedlings of evergreens (6-12 inches) and bareroot hardwoods (10-18 inches) are available at reasonable rates.

Wildlife packets for quail, deer, turkey, and squirrel are also available. Each packet contains 4 species and 25 seedlings of each species, totaling 100 seedlings.

Statewide interest in the program is very high and the quantity of available species is down this year. Most of the more popular species sell out very quickly. Interested parties should place their orders as soon as possible.

Orders can be placed at the

Service office at 214 East 7th Street. The seedlings will be delivered to the office by the Forest Service on February 15, 1995. To help ensure successful establishment, they should be collected and planted as soon as possible after delivery.

The district can also provide drip irrigation supplies at a reasonable price. Drip irrigation greatly increases the seedlings chances of survival, particularly in the first two years. Drip is a highly effective way to water and has many applications in areas with low availability or high cost of water. More information and prices are available at the SWCD/NRCS office.

Hinnard traveled twice from the Mediterranean Sea through the Suez Canal and Red Sea, then across the Indian Ocean into.

the Persian Gulf.

Hinnard began the deployment by participating in the 50th anniversary of D-Day with visits to England and France. During the D-Day commemoration, Hinnard's ship helped support the visit of President Bill Clinton and numerous other government and military officials as part of the program honoring thousands of World War II veterans.

Hinnard's ship spent the last weeks of its deployment helping deter Iraqi aggression on the Arabian peninsula. Based in Norfolk, Virginia, the 529-foot-long USS Kalamazoo worked supporting the aircraft carrier USS George Washington and several guided missile cruisers equipped with Tomahawk cruise missiles as they operated in the Gulf. The group presented a formidable presence capable of moving 700 miles a day. Hinnard's ship served as a floating gas station and supply center, capable of supporting a 15,000person aircraft carrier battle group for 30 days with fod, spare parts, equipment and

fuel.

Hinnard also visited Spain, Sicily, Greece, Turkey and the United Arab Emirates during the trip.

Hinnard's involvement in the deployment is an example of how the Navy-Marine Corps team is designed to operate overseas and respond quickly when needed. Whether delivering humanitarian assistance, cargo, or troops from the sea, these highly-trained naval forces provide a unique crisis-response option, which can be withdrawn quickly when no longer needed.

The 1985 graduate of Robert Lee High School joined the Navy in April 1990.

After Cesarean

Efforts are being made to reduce the number of Cesarean deliveries, especially those for which there is no medical need. Previous research showed that more than one-third of cesarean deliveries are performed simply because previous births were cesarean.

Dr. Bruce Flamm and his colleagues at Kaiser Permanente Medical Centers in Southern California followed more than seven thousand pregnant women with previous cesarean births. Seventy-percent of these women had trial labor and vaginal births while the rest chose repeat cesarean deliveries.

The report, in the journal Obstetrics and Gynecology, showed seventy-five percent of the women who chose trial labor went on to deliver normally. Dr. Flamm says giving birth either way is not risk free, but with careful supervision trying labor eliminates the need for a large proportion of repeat cesarean operations.
