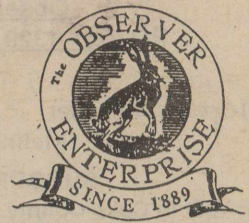

County teams gear up for season opener

Friday night football is back (finally). Coke County teams have been hard at work preparing for the opening night of the season. Both the Robert Lee Steers and Bronte Longhorns have suffered through two-a-days and scrimmages in preparation for opening night. After several years of consistently having a team in the playoffs, Coke County folks are fired up and ready for some great football.

According to Athletic Director Ed Poehls, Robert Lee will be suiting up 45 players this season. Of the 45 only 7, 3

offensive and 4 defensive, are returning starters.

When asked about the strengths of such a young team Poehls stated, "We have above average size and the will to succeed. Our players have a lot of heart and they have proven in practice that they are willing to work hard enough to win. Our seniors and juniors, though lacking in numbers, are showing great leadership." During discussion concerning the flip side of the coin, weakness, he said, "We are depending on more young players than

usual and our speed is lacking. We will have to be real smart and play with great technique in order to be successful."

Poehls indicated the team's attitude is great and they are getting in very good physical condition for the season. He concluded with this statement, "With a lot of new people in different positions, we are coming along kinda slow. But, maybe, we will be ready at just the right time to make a run at our very tough district."

Robert Lee will host Cross Plains here tonight at 7:30 pm.

Thirty-nine players will hit the field for Bronte this year. Four offensive and 4 defensive players are returning starters for the Longhorns. Coach Keith McCutchen feels the returning starters and good attitudes are the strengths of this team.

He stated that overall, he feels that inexperience will be the weakness of the squad.

When questioned about the readiness of the team for the beginning of the season he said, "The kids have worked hard, their attitude has been good, and other than the players with injuries, they should be ready physically."

The Horns will be on the road for their season opener. They will face off against the Eden Bulldogs at 8:00 pm in Eden.

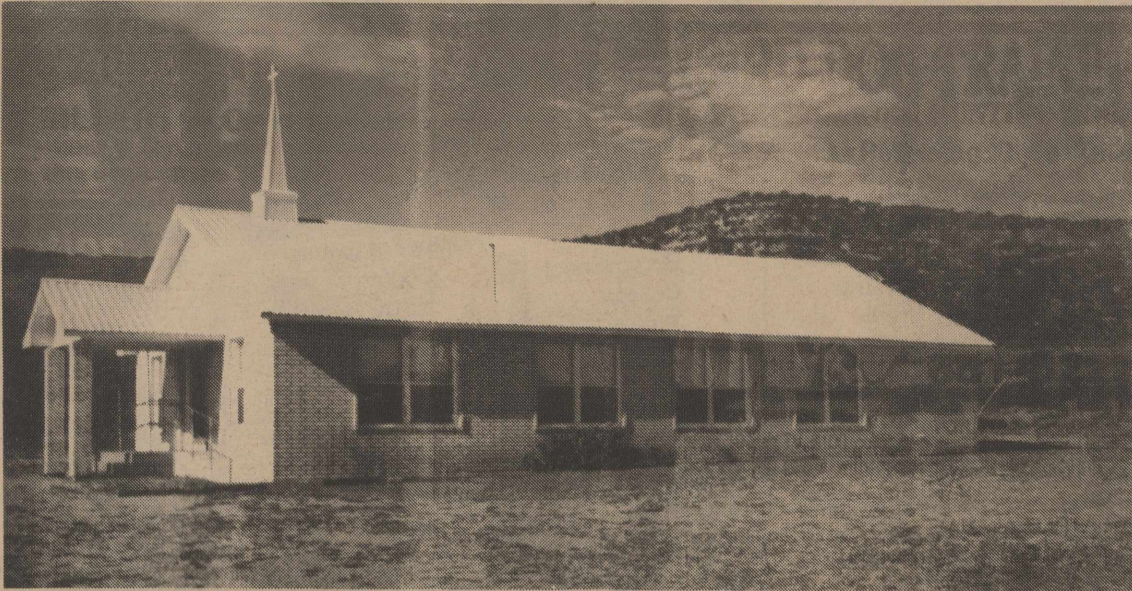

Pecan Baptist Church will celebrate its 100th anniversary later this month. The church has undergone many structural improvements over the years.

Pecan to celebrate 100th year

Pecan Baptist Church, located 12 miles west of Robert Lee, will celebrate 100 years of existence on September 13-14 and invites everyone to attend.

The centennial celebration is set to begin at 10:00 am both Saturday and Sunday and each day will include services, a catered meal and various entertainment related to Pecan's history.

Pecan is the only rural church organized in Coke County before the 1900s that has remained in its original location. A small number of Baptists met under an arbor on Pecan Creek in 1897 and organized Pecan Baptist Church. Elders J.L. Simpson, G.C. Copeland and Isaac Reed (son of the Isaac Reed who helped organize the first Baptist Church in Texas in 1835) acted as presbytery.

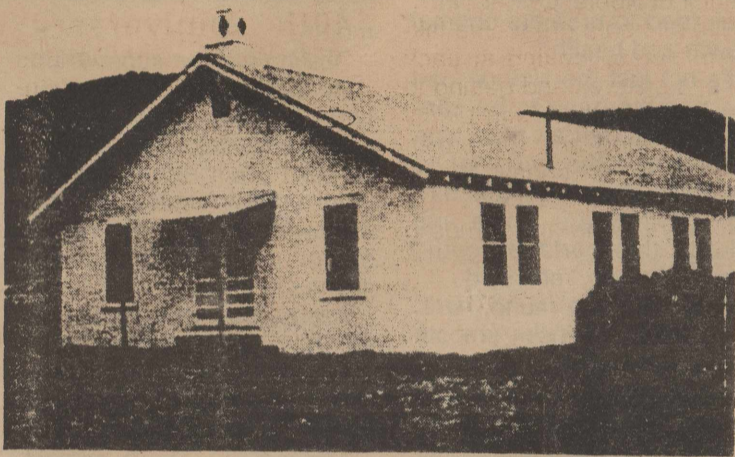
John Reed, a Pecan minister ordained in 1895, gave personal land for Pecan's first church home. It was the Pecan School House, located in Reed's pasture. The nearby creek served as a baptistry, making the location ideal. Members worshiped there until 1904, then built on the present site. They built again in 1926 and later added on an annex.

Pecan held singing schools, Christmas programs, summer revivals, and "dinners on the ground". Couples also enjoyed climbing Green Mountain, located directly behind the church.

Other communities have shared the gospel from Pecan's early missionary efforts. Holding services monthly, Pecan "extended an arm" to Wild Cat and Divide Union churches.

Pecan's ministers were: J.L. Simpson, Isaac Reed, G.C. Copeland, J.B. Denton, John Reed, Bro. Murdock, Bro. Branham, Bro. Volles, D.K. Smith, M.E. Watkins, J.H. Hallford, M.E. Patterson, Joe Yates, Charles Carroll, H. Scheanrock, John Hix, Billy McDorman, and current pastor, Jimmy Rogers.

Rogers is a graduate of Texas Tech University at Lubbock. He served Pecan for two different periods, accumulating thirty-two years. His wife, Lola Beth, a talented musician, has assisted greatly in his ministry. They live in San Angelo, where he is a retired park superintendent and

she, a retired English teacher. Coke County people refer to him as "The Visiting Pastor" at the bedside of the sick, regardless of church affiliation.

From the time Pecan opened its doors, numerous capable and willing members have been recruited to serve in capacities such as deacon, pianist, song leader and teacher.

The public is encouraged to share in the memories and good times the centennial will bring.

Protect children from choking

Food is essential for life, in everyone, but it can be one of children's deadliest enemies if it leads to choking, according to a nutrition specialist with the Texas Agricultural Extension Service.

"We, as children or adults, depend on food to provide nutrients," said Dr. Dymple Cooksey. "The goal in feeding children - whether they be infants, toddler or pre-schoolers - is to provide safe, nutritious food to promote optimal growth and health."

It's not just the size of food that parents need to be concerned with, but also the type of food and the behavior of the child when they are eating. "If they are active and talking, this certainly could lead to choking," she said.

Foods that are round, hard, small, thick and sticky, smooth or slippery should not be offered to children under four years of age. Some of these foods are hot dogs (sliced into rounds), hard, round, or chewy candy, nuts and seeds, whole grapes, spoonfuls of peanut butter, marshmallows, dried fruit, raw peas, peanuts, potato chips, corn chips, pretzels, popcorn, chunks of meat larger than can be swallowed whole, and "loop" type cereals.

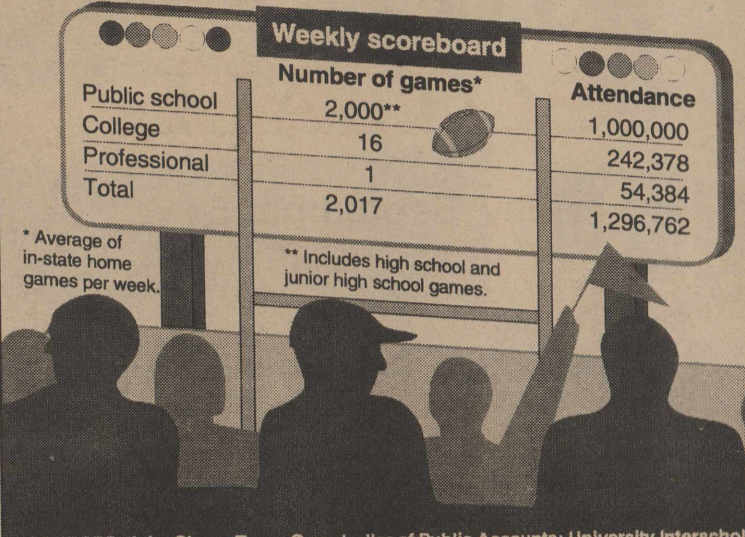
Behaviors or situations that may lead to choking are:

- *An infant drinking from a bottle with a nipple that has too large a hole.
- *Propping a bottle in the infant's mouth.
- *Feeding an infant or child too fast.
- *Stuffing food in the mouth.
- *Eating while walking, talking, laughing, crying, lying down, playing.
- *Running with food in the

By taking proper precautions, Cooksey said, the risk of choking can be lowered. "When preparing food for young children, make sure it is in a form that does not require much chewing," she explained.

Foods that are very hard or tough, such as meat, certain raw vegetables or fruits, should be cooked until soft enough to pierce with a fork.

Additionally, foods should be cut into small pieces or thin slices that may be easily chewed. Round foods, like hot dogs or carrots, should be cut into short strips rather than round pieces, Cooksey recommended.

Grapes should be cut into quarters, and pits and seeds should be removed from fruit such as oranges, grapes, watermelon and plums.

Food for infants should be ground or mashed. Also, parents can substitute food that may cause choking with a safe substitute, such as thinly sliced meat or hamburger instead of hot dogs, she said.

Nuts or seeds should be avoided, unless they are in prepared foods and ground finely or chopped. "If peanut butter is served, use only smooth varieties and spread it thin," Cooksey said.

Cheese should be served in thin strips, not in chunks, she added.

Crackers may be served if they are saltines and easy to chew. "Swallow without causing serious problems. "I would be a bit careful, though, about the really tiny crackers," she said.

School bus safety tips offered

As we start a new school year, it is important for parents and children to review safety tips together, according to Steve Anderson, director of TDH Traffic Safety Program.

"Parents should put a review of important safety guidelines at the top of the family's back-to-school checklist," Anderson said. "Some of the most basic safety rules, such as those concerning school buses, save young lives and prevent thousands of injuries yearly." He warned, however, that although school buses are one of the safest ways to travel to and from school, injuries do occur. In 1995, 36 Texas children age 14 and younger were killed and about 5,000 others were injured in school bus-related incidents. Twenty-one of the children killed were pedestrians.

Many of the injuries happen while children are boarding or exiting their buses. One reason is that the front of a school bus obscures the driver's view of children near the bus. "Young children are not aware of the driver's blind spot, or might imagine if they can see the bus, the bus can see them," Anderson said.

TDH urges parents and teachers to discuss these safety tips with children:

1. Waiting for the bus -- A child's behavior at the bus stop is an important aspect of pedestrian and school bus safety. Children should remember to:

- *Arrive at least five minutes before the bus arrives;
- *Stay out of the street and avoid horseplay;
- *Always wait for parents on the same side of the street as the bus stop; and
- *Cross the street at least 10 feet in front of the bus.

2. Riding the bus -- While on the bus, children should:

- *Remain seated at all times and keep the aisles clear;
- *Never throw objects;
- *Never shout or unnecessarily distract the driver; and
- *Always keep heads and arms inside the bus.

3. Boarding and leaving the bus -- While getting on and off the bus, children always should:

- *Walk in a single-file line;
- *Use handrails to avoid falls;
- *Wait until the bus comes to a complete stop before exiting;
- *Exit from the front of the bus; and
- *Be aware of the bus driver's blind spot (10 feet ahead of the bus) when walking away.

Anderson added that parents should remove loose drawstrings, straps, or ties on children's clothing and replace with Velcro, snaps, or buttons. Loose drawstrings or book bags can also snag on bus handrails. Since April 1991, seven children in the US died when their buses dragged them alongside the vehicle when their clothing or other items caught on the bus handrail or door.

Texas law is strict about other traffic passing a stopped school bus. The law requires drivers to stop when approaching a stopped school bus that is operating a visual signal light or sign as required by law. Drivers may not proceed until the school bus resumes motion, or when the bus driver signals the other drivers to proceed, or if the bus driver turns off his stop signals.

Drivers on highways separated by a median are not required to stop for a school bus on the opposite side of the median. Also, drivers are not required to stop for a school bus that is stopped in a specified loading zone that is a part of or next to the highway and where pedestrians are not permitted to cross the roadway.

Any driver who violates these statutes for passing school buses faces a fine of up to \$1,000.

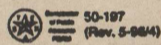

These tax rate figures are not adjusted for changes in the taxable value of property.

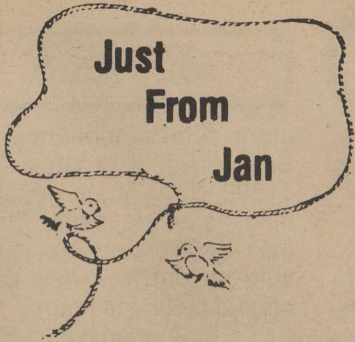
Criminal Justice Mandate (for counties):

Laundry challenges everywhere!

Stain removal can be one of the most challenging problems faced when doing laundry -- here are some of the most common stains and their treatments.

Common kids' stains:

*Blood - Rinse in cool water and pretreat with soil and stain remover. Rinse and repeat until stain is gone. Launder in cold water, using appropriate bleach.

*Grass - Pretreat stains with soil and stain remover, allow to sit for 5 minutes. Launder in hottest water safe for fabric, using appropriate bleach.

*Mud - Allow to dry, then brush off excess mud. Pretreat stain, allow to sit for 5 minutes. Launder in hottest water safe for fabric, using appropriate bleach.

*Crayon - To remove crayola stains, the Crayola company recommends: Place the stained surface down on a pad of paper towels, spray with WD-40, and let stand for a few minutes. Turn the fabric over and spray the other side. Apply liquid dishwashing detergent and work it into the stained area. Replace towels as they absorb the stain. Wash in hot water with laundry detergent and bleach for about 12 minutes (use "heavy soiled" setting if there is no minute timer on your ma-

chine), and rinse in warm water. [To clean melted crayon in the dryer drum, spray a soft cloth with WD-40 and wipe the drum. Run a load of dry rags through a drying cycle to ensure that your drum is clean].

*Finger paints, ballpoint ink & felt tip markers - Pretreat stains and launder in hottest water safe for the fabric, using appropriate bleach. Permanent markers may be impossible to remove.

*Baby formula - Soak in cool water using a presoak product. Launder in hottest water safe for fabric, using appropriate bleach.

Diaper stains, vomit - Rinse of soils, follow presoak instructions. Launder in hottest water safe for fabric with appropriate bleach. To kill bacteria that contribute to diaper rash, add liquid bleach to the wash cycle.

*Vitamins, liquid pain relievers - Pretreat and let sit for 5 minutes. Launder in hottest water possible, using appropriate bleach.

Food stains:

*Beverages - Sponge promptly with cold water or soak in cold water. Pretreat and launder in hottest water safe for fabric, using appropriate bleach.

*Eggs, milk & milk products - Rinse in cool water and pretreat. Rinse and repeat, if necessary. Launder in cold water, using appropriate bleach.

*Chocolate, fruit flavored drinks, gravy, juices, tomato products - Soak in cool water. Pretreat, wait a few minutes, then wash in hottest water possible safe for fabric, using appropriate bleach.

*Mayonnaise, mustard, salad dressing - Pretreat, launder in hottest water safe for fabric, using appropriate bleach.

Common stains:

*Oil & grease, perspiration & deodorant - Pretreat and launder in hottest water safe for fabric, using appropriate bleach.

Unknown stains:

Soak the item in cold water for 20 minutes, pretreat and launder with a generous amount of detergent and the hottest water possible for the fabric. If item is bleach-safe and you know the stain is not rust, use liquid bleach. Air dry item until stain is removed. Machine drying can set the stain and make further removal almost impossible.

Presoak procedures

*Use 1/4 cup household liquid bleach per gallon of water.

*Submerge entire garment and soak for 5 minutes.

*Rinse and wash according to care label.

Powdered Color-Safe Bleach presoak

*Use 1 cup dry bleach per gallon of water.

*Soak 30 minutes or overnight.

Note: When using any bleach as a presoak, be sure to soak the entire garment as well as other sections worn together for best results.



Forfeiture of reserved water supply for failure to pay applicable fees;

Payment of costs of any improvements to Coke County Water Supply Corporation's system that are necessary to provide the water;

Construction according to design approved by Coke County Water Supply Corporation and dedication by the developer of water facilities within the subdivision following inspection.

New boating safety laws are in effect

Many may be unaware that a new law which for the first time requires a mandatory boater education course for some operators and dictates who may operate a boat went into effect on September 1, 1997.

Among the highlights of the law are 1). requirements that directly impact those under the age of sixteen; 2). mandated boater education course for those who violate specific portions of the Texas Water Safety Act; and 3). new personal watercraft restrictions.

Texas will now require a boater education course and a fine for those who violate specific sections of the Texas Water Safety Act including, but not limited to, violations related to: reckless or negligent operation, excessive speed, hazardous operation, operation of boats in restricted areas, operational rules for personal watercraft, and time and manner of operation. The new law also provides for a Class A Parks and Wildlife Code misdemeanor for failing to successfully complete a required boater education course.

The new law also requires a mandatory education course for persons born after Sept. 1, 1984 who operate, on public water, a vessel of 10 horsepower or more, or a wind-blown vessel more than 14 feet in length. Exceptions include: those who hold master's, mate's, or certain operator's licenses issued by the US Coast Guard; those who are supervised by a person who is exempt from the boater education course or has completed the course and is at least 18 years of age; those who are at least 18 years of age; and persons who are not a resident of this state and have proof of successfully completing a boater education course in another state.

"This new law should encourage parents to enroll their children in a boater education course and attend the class with their children," said Jim Robertson, TPWD law enforcement director.

New personal watercraft (PWC) requirements include the provision that no person may operate a PWC within 50 feet of another personal watercraft, except at headway speed.

Although the new law went into effect on Labor Day, TPWD law enforcement officials say that for the most part, they will not begin issuing citations right away.

"Similar to any new regulation, our primary goal will be to educate the public to ensure that folks are aware of the new legislation," said Robertson. "We realize that it will take time for everyone to become familiar with the many new aspects of the law."



Service academy apps sought

Congressman Charles Stenholm has announced that he is currently seeking applicants for nomination to the United State Service Academies. Applicants for nomination to the US Military Academy in West Point, NY, the US Air Force Academy in Colorado Springs, CO, the US Naval Academy in Annapolis, MD, and the US Merchant Marine Academy in Kings Point, NY, may be obtained by writing to Congressman Stenholm's San Angelo office.

Nominations are available to young men and women who will be at least 17 years of age, and not past their 22nd birthday, upon entry into the academy in July. Protect yourself from mailbox vandalism

Rural area mailboxes are vulnerable to vandalism because they are usually isolated, located on public thoroughfares, and frequently not visible to the box owners from their homes. City residential mailboxes are vandalized to a lesser degree.

Mailboxes are considered federal property, and federal law makes it a crime to vandalize them. Violators can be fined up to \$250,000 or imprisoned for up to three years for each act of vandalism.

You can take the following actions to help prevent the vandalizing or destruction of your mailbox (or any mail that may be inside it):

1. Immediately report theft, tampering, or destruction of mail and mailboxes to your local postmaster.

2. Remove your mail from your mailbox as soon as possible after its delivery. Allowing mail to pile up for several days only tempts would-be vandals and thieves.

3. Obtain Label 33 from the Postal Inspection Service. This sticker, which warns that willful damage to mail boxes and theft of mail is a crime, can be affixed to your mailbox.

4. If you discover someone tampering with your mailbox or your neighbor's, obtain that person's description and that of his vehicle, including the license plate number. Immediately report the infor-

mation to your local police and postmaster.

5. Keep your mailbox in good repair by using proper installation methods. This may help prevent theft of the mailbox itself.

If you have information on mailbox vandalism or mail theft in your area, contact the Postal Inspection Service with your information. Your cooperation helps apprehend violators. You may provide your information and complaints to your local postmaster or to Postal Inspectors in the Fort Worth Division. The 24-hour number is 817-317-3400.

Milk may lower cancer risk

Milk may lower your chances for getting certain types of cancers according to the Texas Agricultural Extension Service.

The milk from cows that graze East Texas pastures may contain more anti-carcinogens - compounds that prevent cancer - than the milk produced in other regions of the country, says Max Sudweeks, who is based at the Texas A&M University Agricultural Research and Extension Center at Overton.

Data from both mouse and human studies show that milk and milk fat may lower the chances of breast, prostate and other cancers, Sudweeks said.

A review in the American Journal for Nutritional Sciences noted that several studies have shown clearly less tumor development of mice fed butter than those fed margarine made of polyunsaturated (vegetable) oils.

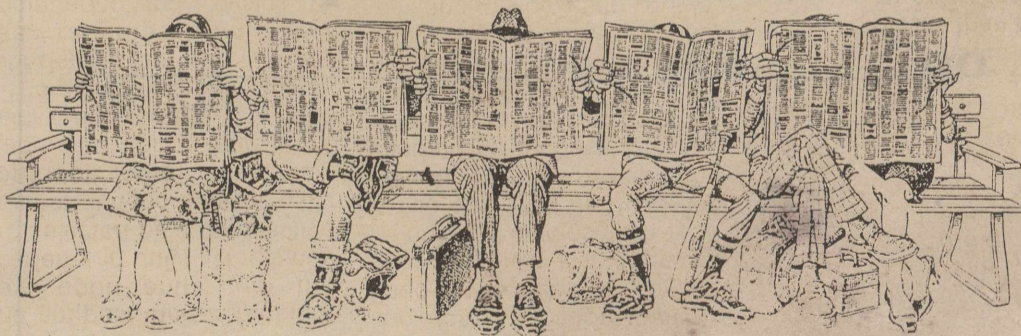

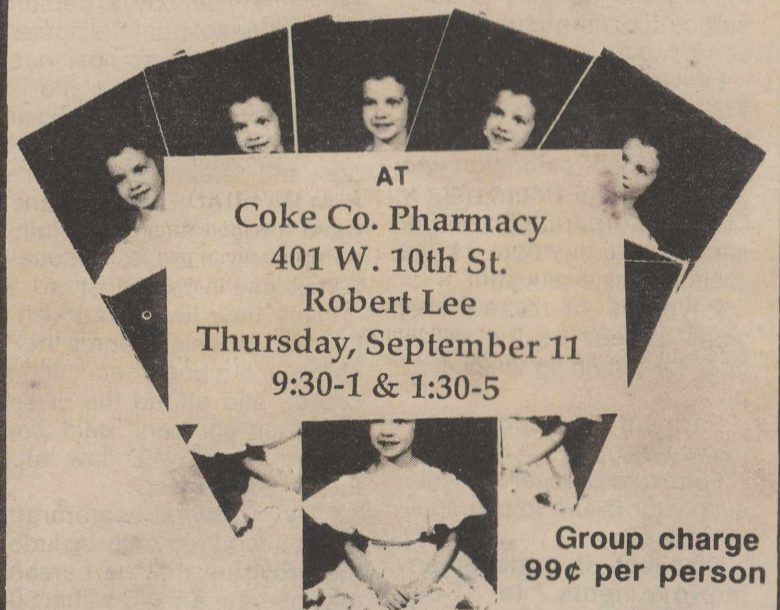
