# Court considers hard choices of raising taxes, cutting jobs

The summary included below
will bring the reader up-todate on county business.

June 28
The meeting was called to order with the pledge to the flag and prayer led by Commissioner Percifull. Minutes were approved as presented.

Treasurer Phelan Wrinkle gave a presentation on investment proposals from Investors Cash Trust and Logic concerning a money market fund.

Tax assessor/collector Kristy Roe presented a sample of what a 1% tax increase might bring in revenues.

Sheriff Styles requested information on the fence in/fence out laws.

Trapper's report was received.

Sheriff Styles was appointed Accident Investigating Officer for Coke County for worker's compensation claims.

The Appraisal District's budget was reviewed.

The court agreed that the judge and county auditor would choose the long distance telephone carrier for the county.

Bills were paid and the court proceeded with a budget workshop.

July 6

The meeting was called to order with the pledge to the flag and a prayer led by Judge Walker.

Chief Appraiser reported on the concerns regarding the Appraisal District budget.

Court approved setting the speed limit on Lake Dam Road at 25 mph.

Employee health insurance was reviewed, and the court agreed to remain with West Texas Rural Counties until July of 2,000.

Court entered into budget workshop session.

July 12

The meeting was called to order with the pledge to the flag and a prayer led by Commissioner Rawlings.

The minutes were approved for the prior two meetings as presented.

A large crowd of concerned citizens was present for the meeting, and most of the attendees took advantage of the open forum to express their opinions on increases of taxes, increased valuations of property, and possible elimination of courthouse employees. The consensus of opinion was that the voters hoped that the commissioners would take a serious look at not raising taxes before making all possible cuts in the courthouse staff.

Commissioner Rawlings requested that a letter of thanks be drafted and sent to Nolan County commissioners, especially Tommy White, for the help given on the Lake Dam Road project.

The treasurer's affidavit was approved as presented:

Cash - \$537,359.00; Other Assets - \$1,022,887.47;

Previous Month Cash - \$606,108.59; Previous Month Other Assets - \$1,022,887.47;

Previous Year - \$654,580.52; Previous Year Other Assets - \$787,177.40.

Extension report reviewed, bills paid, and the budget workshop continued.

Child, Elderly Abuse/Neglect phone number change announced

As of July 1, 1999, in Coke County, all allegations of abuse or neglect to children or the elderly or disabled will be taken by the Statewide Intake (SWI) of the Texas Department of Protective and Regulatory Services for 24 hours a day and 7 days a

Beginning July 1, SWI has been taking all night and weekend reports. Previously all reports were taken at local Children's Protective Services (CPS), Adult Protective Services (APS), or Child Care Licensing (CCL) offices.

The public will now report all suspected abuse/neglect to 1-800-252-5400 and get a recording that will list your options in order to handle your call as expeditiously as possible. When the report is made using this number, the caller will speak with a trained and experienced intake worker. This will allow the specialist in the local offices to concentrate their efforts on investigations and service delivery.

It is important to remember

that the statewide 800 phone number is not an emergency rescue service. Persons reporting abuse should use the 9-1-1 number if you have a life threatening situation.

### Crossroads Trade Days set for Big Spring

The first annual Crossroads Trade Days will be held July 24 and 25 in the Dorothy Garrett Coliseum in Big Spring. The show will feature everything from arts and crafts to collectibles and be open on Saturday from 10 am to 6 pm and Sunday from noon to 5 pm. There is no admission charge.

Mel Prather, organizer for the event, said the trade days was not a new idea to Big Spring. "It started out as the 'Crossroads Stampede' in Comanche Trail Park several years ago. It was then moved to downtown Big Spring as part of the Main Street program and renamed the 'Heart of the City Festival'," Prather said. "Since it was held during the summer, the heat took its tole and it fell by the wayside."

### Hinnard

Lace Eugene Hinnard, 68, or Fairbanks, Alaska, and formerly of Robert Lee, died July 1999 in Providence Hospital in Anchorage. He had been in critical condition since early June with complications following initial heart valve surgery.

A resident of Fairbanks for 10 years, he recently retired from Sears, Roebuck, and Company as a repair technician. He was a member of American Legion Post 57 and a mentor for the Alaska Youth Challenge Corps Program.

Memorial services were held July 10 at 2:00 pm at the American Legion Post 57 Hall in Fairbanks.

Gene was born November 28, 1930, in New Mexico and attended high school in Hobbs, where he was named all-state guard on the local football team.

His parents, Pee Wee and Pauline Thompson, preceded him in death.

Gene served in the U.S. Army from March 1953 through March 1955 before going to work for West Texas Utilities in Robert Lee, where he was employed for 29

He was an active and tireless volunteer in all community and public service projects. A member of the Robert Lee city council, he was named Man of the Year and later recognized as Citizen of the Year. Gene was also an active member of the Havrick Masonic Lodge, Robert Lee Baptist Church, and the Robert Lee - Silver Lions Club.

A charter member of the West Coke County EMS, he was a driving force in establishing an efficient and caring volunteer group that still serves today.

Perhaps his greatest achievement, with the most lasting results, was more than 30 years of service to hundreds of Boy Scouts. Gene was Scoutmaster of Troop 461 with total commitment to summer camp at Camp Sol Mayer; took local and area youth to national jamborees and Canadian canoe trips as well as weekly meetings and campouts.

Gene was active in the Order of the Arrow and served as the lodge advisor. He had a high percentage of scouts who attained the rank of Eagle (the highest rank that can be achieved in scouting). Gene. himself, was honored by receiving the Silver Beaver award, the ultimate a scout leader can achieve. He successfully completed and later became instructor for Wood Badge courses for scout leader training. He was recognized for many other awards over his long years of service on district, council, and national levels of scouting. Fairness and dedication were part of his makeup.

Gene's survivors include his son, John Hinnard, and his wife Lynn of Connecticut; his daughter, Cookie Burns and her husband Sid; and two grandchildren, Jeremy and Molly Burns, all of Robert Lee.





### Fighting fraud on the Internet

by John Cornyn Attorney General of Texas Question: What recourse do I have against unsolicited e-mail from pornographic Web sites? Answer: The Internet remains almost entirely unregulated, creating unique and challenging difficulties for all who utilize this technology. It is unfortunate that the ease this technology affords has engage in disgusting enterprises.

You should attempt to work directly with your Internet service provider to determine what steps are being taken to confront this activity. The provider may have existing guidelines that regulate this practice.

My office is working with other committed parties to identify and confront problems on the Internet, particularly in regard to child pornography. To that end, the Internet Child Pornography Prosecution Unit was created in the Prosecutors Assistance Division of my office.

To report concerns of child pornography on the Internet, you can complete the electronic complaint form on the Criminal Justice page of the Office of the Attorney General, Prosecutors Assistance Division, Child Pornography Prosecution Unit, PO Box 12548, Austin, TX 78711-2548.

Question: I receive tons of junk e-mails each day in my email account. All say that I can be taken off the mailing list by replying and putting remove in the subject line, but it never seems to work. I know that these are scams and just delete them, but isn't there some way to stop these messages? Others might be taken in.

Answer: It is an unfortunate fact that just about everyone with an e-mail account receives dozens of unwanted junk e-mails, or spam. They clutter our mailboxes and increase our download times. Some of the messages are

about get-rich-quick schemes, work-at-home scams or advertisements for pornographic sites on the Internet.

Many of the messages do come with a disclaimer that instructs you to reply with "Remove" in the subject line to be taken off the mailing list. Unfortunately, sometimes this does not work. Instead of taking you off a list, it registers your address as an active account and opens you up to more spam.

Offers and business opportunities that are illegal in the real world are also illegal on the Internet. If you have a concern about possible illegal activity being advertised through the Internet, contact your local prosecutor's office for assistance.

If you have a specific complaint against a particular Internet business, you can file a consumer complaint with my office. You can download a complaint form from our Web site at www.oag.state.tx.us or call the Consumer Protection Division at (800) 621-0508 or local Consumer Protection Field Office.

In addition, you should work with your Internet service provider (ISP) to eliminate such messages. Contact your ISP to get information on its spam policy.

The best course of action that you can take to avoid being scammed over the Internet is to simply delete the spam.

You probably know how draining working or playing in too much heat can be. But if the heat and humidity are very high, there is a danger of heat cramps, heat exhaustion, or heat stroke. This is most likely to occur when the temperature is 90 degrees F. or more. First aid for heat cramps and exhaustion can make the person much more comfortable,

and able to return to normal

activities more quickly.

Causes of heat stress: You know that as you move, you get warmer. Perspiring is one of the ways your body has of cooling off. Your body also directs more of your blood to the surface of the skin, which is why your skin may look flushed when you are hot. Sometimes your body gets too hot. This is called heat stress. You may be working too hard, or not drinking enough water when it is very hot or humid. You may not be used to working in the heat. Or, the air may be very still, with no breeze or fan to help cool you. When your body over heats, it begins to pay most of its attention to cooling off. But other jobs your body must do may not get done, and you can have symptoms of heat stress.

First Aid for heat cramps: If you are working or playing hard in the heat, you can get cramps, pains, or spasms. Often they are in your arms, legs, or abdomen. You will probably be perspiring heavily. You can also get heat cramps from drinking too many cold liquids, or by drinking them too quickly. Massage or use firm pressure on the muscle that is cramp-

ing. Drink small sips of water with a little salt added (if you have a heart or blood pressure problem drink plain water) to help cool your body. Move into the shade or a cooler place.

First Aid for heat exhaustion: People with heat exhaustion have some or all of the following symptoms: sweating, clammy, flushed, or pale skin, dizziness, weakness, nausea, rapid and shallow breathing, headache, vomiting, fainting. Those with heat exhaustion should lie down in a cooler place, with feet raised and tight clothing loosened. Give them sips of cool water, adding 1 teaspoon of salt per quart of water. Call a doctor, especially if there is vomiting or fainting.

Avoid heat stress: It takes about 4-7 days to get used to unusual heat, if you know you will be exposed to hot temperatures, spend more time each day in heat for about a week before beginning your task. Always drink plenty of cool water when you are in the heat. You may not be thirsty, but your body can still be losing as much as three gallons of water a day in hot weather. Wear hats, sunglasses, and loose cotton fabrics to help you stay cool. Take frequent breaks in a cool place.

Know about heat stress: Too much heat can make people lose their concentration, get tired, or grouchy. Understanding how to deal with heat stress can help you avoid accidents and misunderstandings. Extreme heat can be bad for your health; so learning first aid for heat stress can be important to your health and well being.

### **Employers** notified concerning wrong SS numbers

To help employers keep accurate employee records, Social Security notifies the employers when reported employee names and Social Security numbers (SSN) don't agree with Social Security's records, states Fredi Franki. "A mismatch does not necesarily mean the worker is using someone else's Social Security number or that the worker is an undocumented immigrant."

"It could be something as simple as an inverted number or a failure to report a name change. If a notice is received from Social Security, the employer should check their records for a mistake in the reported number of worker's name."

"Remember, removing an employee from a job because of a mismatch of Social Security information may be a violation of federal law and might result in adverse legal consequences for you."

Franki states that when filing the annual wage report, the employer should verify employee records and W-2s for accuracy by:

\*asking employees to check the name and number on their W-2s with their Social Security

\*reminding employees to report name changes to

### Workshop planned to aid in developing foundations



### Vaccinate babies for health, life

by Laura Bush First Lady of Texas When I approach a child, his presence inspires two feelings in me; affection for what he is now, and respect for what he may one day become

Louis Pasteur
Louis Pasteur is one of the most important men in medical history and the first to develop an effective rabies vaccine. After five years of painstaking research, Pasteur decided to test the vaccine on himself. The process entailed securing the bite of a rabid animal followed by 14 days of innoculations -- one per day, each stronger than the next.

The day he was to carry out the test, though, a man came to the door with his child who had been bitten 14 times by a rabid dog. Rather than see the child consumed by the dreaded hydrophobia, his parents agreed to the risk of trying the untested inoculation.

Pasteur treated the boy over 14 days, and each day, much to Pasteur's delight, his young patient's condition improved. One month after the final injection, Pasteur announced his treatment a success, and in the years that followed, thousands of patients flocked to his office for the life-saving inoculation.

Pasteur's medical triumph saves lives even today, and many other once-deadly diseases are now preventable with vaccines.

Yet even in this modern world of medicine, thousands of children have not been immunized. Sadly, many are at risk of contracting life-threatening diseases such as chickenpox, measles, mumps, polio, and tetanus.

Last year in Texas, more than 20,000 people were diagnosed with diseases that could have been prevented by safe, effective, and low-cost vaccines. In Houston, El Paso, the Rio Grande Valley and border region, roughly 26 percent of children have not been immunized. The rest of the state has low rates as well.

There are several reasons for low immunization rates. Families may not realize that many clinics throughout the state offer low-cost or free immunizations to any child who needs them, regardless

of where he or she is born.

Many new parents don't have all the information they need about their baby's health. They might not know their babies should have as many as 12 immunizations within their first year of life. Often parents don't have immunization records for their children, and without records, doctors who are seeing new patients have no way of knowing how many shots or which vaccine a baby may have already received.

Fortunately immunization rates are showing modest gains, thanks to local efforts and partnerships. In one region of the state, rates have improved from 67 percent to 74 percent.

Businesses, local officials and health care professionals are creating public/private partnerships to raise awareness. Health officials in Texas and in Mexico are collaborating to ensure that more vaccines are available to children on both sides of the border. And many hospitals throughout Texas are giving new parents a congratulatory card donated by Hallmark Cards with a message from Governor Bush and me that urges parents to immunize their children. The cards have a pull-away panel that lists all the shots a child needs and helps parents keep a record of the vaccines a child receives through age

These small victories are important, but more needs to be done. We are working toward the goal of having 90 percent of all Texas preschool

# Construction plans for FEMA's tornado safe room now available on the internet

Residents of tornado-prone areas who are considering building a tornado 'safe room' in their homes can now download construction plans directly from the Internet by logging on to the Federal Emergency Management Agency's (FEMA) website (www.fema.gov).

FEMA director James Lee Witt is urging everyone in tornado prone areas to build a 'safe room' that can provide protection against deadly tornadoes. Once on the FEMA website, click on 'Mitigation', then 'Tornado Safe Rooms'.

The construction plans are provided online with a 25

page illustrated FEMA publication, Taking Shelter from the Storm: Building a Safe Room Inside Your House, which outlines the basics of in-house safe room shelters, including designs of several different kinds of safe rooms, materials and construction cost estimates. Taking Shelter from the Storm has been available online for some time, but until now the construction plans had to be ordered through FEMA publications

People without Internet-access can still order Taking Shelter from the Storm: Building a Safe Room Inside Your House along with the construction plans at no cost from FEMA Publications by calling 1-888-565-3896.

"Regardless of where you build your safe room in your house, the walls and ceiling must be built so that they will protect you from missiles and falling debris and remain standing if your house is severely damaged," Witt said. The safe room designs in Taking Shelter from the Storm specify building materials and combinations of building materials that will resist penetration of flying objects in extreme winds.
