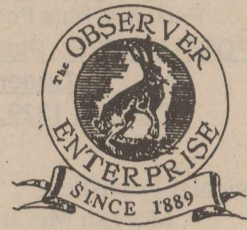

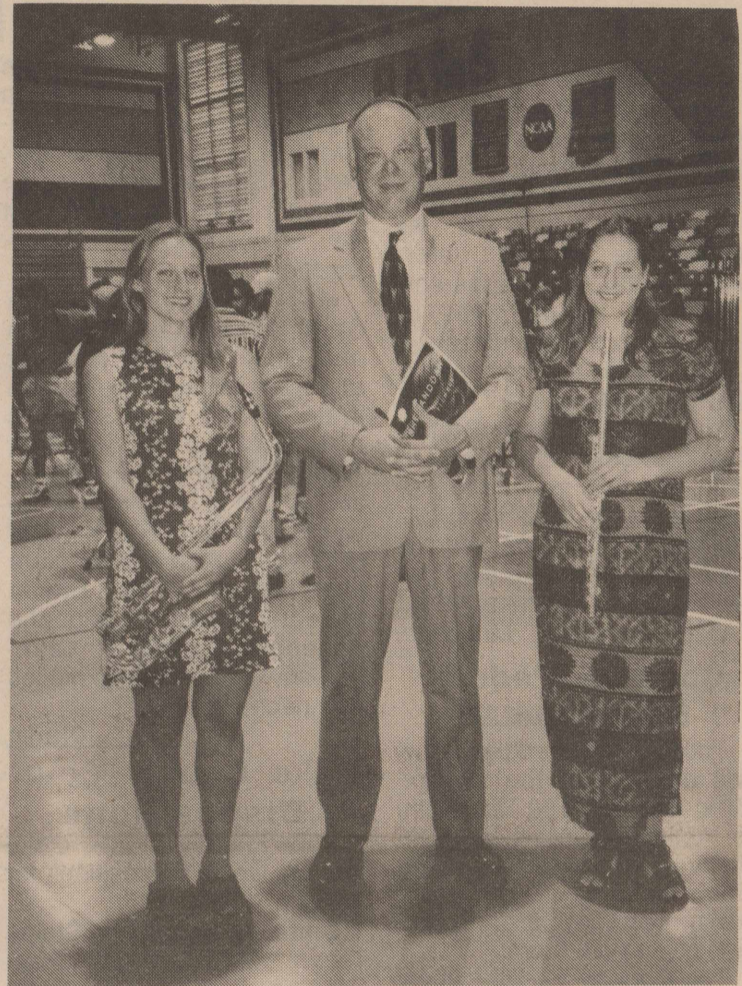

Burial was in Fairview Cemetery in Bronte. Mrs. Carwile was born Wilma Stewart September 27, 1917. She graduated from Bronte High School. On July 16, 1941, she was married to J.L. Carwile, who died in 1979. For most of their married life the Carwiles lived on the Foster S. Price Panther Gap Ranch near Silver. Mrs. Car-

 Life in general is pretty unpredictable - a jog in the road can change one's life and those around them. In the mid-40's and early 50's, Coke

Austin, Sr., his wife, Buna, and five sons lived near Sanco, and later, closer to Robert Lee. Austin was a farmer and a rock mason. His boys, Coke, Jr., Jack, Garland, Alfred (Bud), and small Tommy helped out but times were hard. Coke County, along with all of West Texas, was entering into a longterm drought. The family moved on to San Angelo, hoping for better days.

form and a "swearing in" ceremony. He also was granted a ride in a DPS helicopter, a tour of their facility, and met the DPS director. Chris was buried shortly after in his uniform at 7 years old.

This painful experience led Tom to think that the country could benefit other children with a dying wish. Nineteen years ago, Make-A-Wish Foundation was born and now has evolved into a huge organization with 82 chapters, 59 divisions and 16 international groups. The only qualification for the foundation's wish list is to be a child 2 1/2 to 18 years old and be diagnosed with a life-threatening illness. It has changed the lives of thousands of children and their families and gave them purpose to fight their diseases.

The years passed and with a number of ups and downs, small Tommy became Tom, and he graduated in 1959 from Central High School in San Angelo. He served with the Army in Korea. Eventually he became a US Customs agent in Arizona and had a family of his own. That's where the jog in the road comes in.

Graveside service was Tuesday in Lawnhaven Memorial Gardens in San Angelo. Arrangements were by Shaffer Funeral Home.

Due to a gut wrenching personal experience, Tom made a commitment to children with life-threatening diseases and became the founder of the Make-A-Wish Foundation.

Survivors include three sons, Jimmy McClelland of Odessa, Bobby McClelland of San Angelo and Jay McClelland of Robert Lee; two brothers, Jack Averett of San Antonio and John Averett of Statesboro, GA; two sisters, Louise Stewart of Odessa and Ann Motl of San Angelo; seven grandchildren; and four great-grandchildren.

Tom's wife became acquainted with a woman whose 4-year-old son, Chris, was suffering from Leukemia. After work one day, Tom came in to find the mother and child visiting. After meeting Chris, the two developed an immediate bond when he found Tom was in a branch of law enforcement. He told Tom he would be a policeman someday and was totally obsessed and fascinated by uniforms, guns, badges, and police work. His proudest possession was a US Customs patch Tom gave him. The boy and his mother became extended family to the Austins.

Tom took a special role in Chris's life, as a hero and partner in law enforcement. 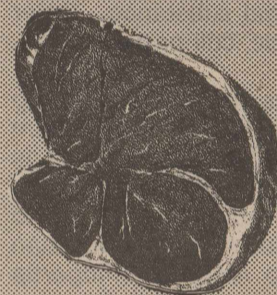

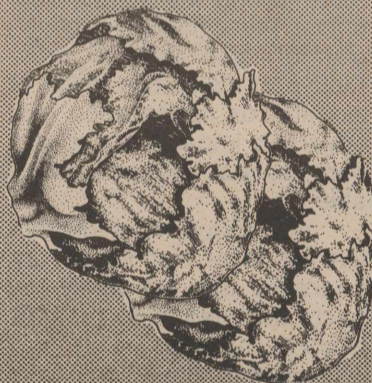

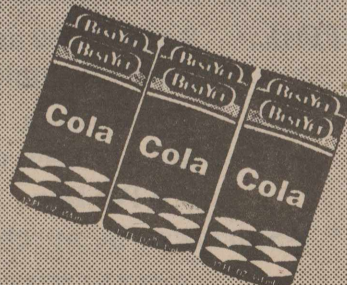

RLISD dress code published (Dress Code for all students K-12)

The district's dress code is established to teach hygiene, instill discipline, prevent disruption, avoid safety hazards, and assert authority.

In order to develop, promote and maintain an atmosphere in our school which will at all times be conducive to the promotion of the educational process and encouragement of learning efforts on the part of students consistent with the desired high standards and the character of our student body, the following dress regulations are prescribed for students in the Robert Lee School.

- The District prohibits pictures, symbols, or writing on clothing and accessories (i.e. jewelry, rings or belt buckles) that: are lewd, offensive, vulgar, or obscene. Advertise or depict tobacco products, alcoholic beverages, drugs or any illegal substance. Refer to satanic, cult or gang activities.

- Girls may wear walking shorts, full-legged denim shorts, front pleated shorts as well as rompers and skorts. Length requirement is set to be mid-thigh, no shorter than fingertip length. (Fingertip length is defined by outstretching arms, straight down by your side. Hem length should not be shorter than your fingertips.)

- Boys may wear walking shorts, full-legged denim shorts and front pleated shorts. Length requirement is no shorter than fingertip length.

- All boys and girls garments are required to be hemmed and not have any frayed edges. No bicycle or slider shorts may be worn as an outer garment.

- Pants, shorts and slacks must be worn at the natural waist.

- Basic underwear must be suitable for the outer clothing that is worn. Underwear may not be worn as outerwear.

- Blouses, dress tops or sweaters should be worn on the shoulder and should not be cut so low as to attract attention. Sleeveless shirts are acceptable as long as they have a full cut shoulder. Students will not be permitted to wear see-through clothing or have midriffs exposed. Shoulder straps must be at least 2 inches wide.

- Dresses or skirts should be worn no shorter than mid-thigh or fingertip length. No part of hem should be above fingertip length. Pants or trousers of suitable design are acceptable, including legions and stirrup pants if long tailed shirts are included as part of the ensemble. Excessively tight fitting shirts, blouses, shorts, pants or other clothing should not be worn.

- Shirts with tailored tails may be worn outside pants and unbuttoned provided the student wears a full sized, full cut T-shirt tucked in pants under the shirt. Otherwise tailored shirt tails will be worn inside pants or trousers; sports shirts, designed to be worn on the outside may be so worn. Shirts are to be buttoned at all times, except that

the collar button may be left unbuttoned. No tank tops, midriff, or see-through shirts will be allowed. Students should at all times present a suitable, well-groomed appearance.

- All students are to be clean-shaven. A beard and/or mustache will not be permitted. Side-burns which extend below the ear lobe are prohibited.

- Hair for all students shall be neat and shall not be done as to draw undue attention to the student. Any excessive coloring, shaving, or designs that may be construed as gang related are not allowed. The principals shall have discretion on student haircuts and learning environment of RLISD. Hair should be clean and well groomed in appearance.

- Students may not wear hats, caps, visors, head coverings, or bandannas in the building during the school day. (Neither male or females.)

- Extremes in types of dress or clothing or hair arrangement must be avoided.

- Sponsors of extracurricular activities may set individual dress and appearance standards with the approval of the principal. Otherwise they must be within the District Dress Code.

- No disruptive apparel or ornamentation will be worn, i.e. boys' earrings (ear, nose, tongue, brow or other visible body parts); girls' earrings (nose, tongue, brow or other visible body parts). No jewelry may be worn in any pierced area of the body except the ear (for female students) during the school day. Other visible markings or tattoos are forbidden. No jewelry may be worn in any pierced area of the body except the ear during the school day.

- Sunshades may not be worn in the building or classroom during the school day, unless prescribed by a physician for indoor use. Any disruptive or distracting mode of clothing or appearance that adversely impacts the education process is not acceptable.

- Any disruptive or distracting mode of clothing or appearance that adversely impacts the education process is not acceptable.

Continued deviations from the provisions of the dress code by a student after warning by the principal will be considered a willful violation and grounds for disciplinary action.

Students should at all times present a suitable, well-groomed appearance.

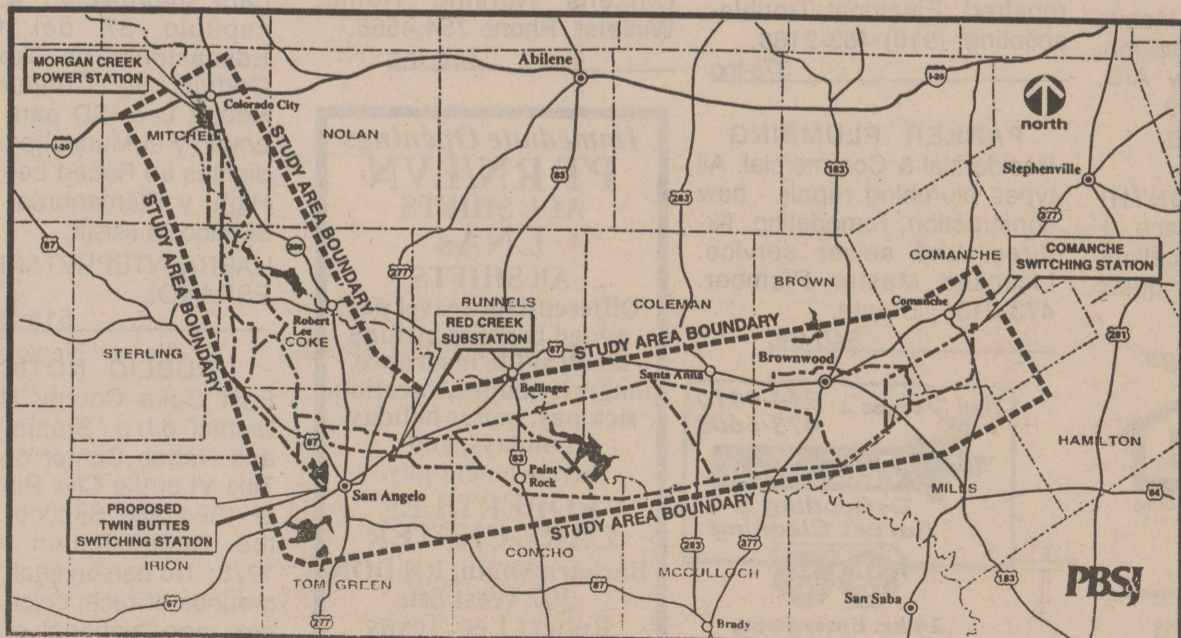

WEST TEXAS UTILITIES/TXU ELECTRIC PUBLIC PARTICIPATION SESSIONS FOR PROPOSED MORGAN CREEK-TWIN BUTTES-RED CREEK-COMANCHE TRANSMISSION LINE

West Texas Utilities Company (WTU) and TXU Electric are proposing to construct new 345-kilovolt(kV) electric transmission facilities in west-central Texas. The proposed line will be 200-225 miles long and constructed within an approximately 160-foot wide right-of-way. The study area and existing project facilities are shown on the map below.

WTU and TXU Electric are committed to routing the proposed transmission line in a manner consistent with the values of the local communities and the need to provide reliable electric service to their customers. In order to accomplish this, WTU and TXU Electric want to solicit input for use in determining the preferred route for the proposed transmission line and share information about line routing alternatives. Individuals attending the "come and go" open house meetings will have an opportunity to ask questions and make comments to representatives and technical experts from WTU and TXU Electric regarding the routing of the proposed transmission line. PBS&J, a consulting firm retained for the project, has identified preliminary alternative transmission line routes for consideration which are shown as dashed lines on the map below. These preliminary alternative routes are subject to modification based on further study and the results of these public meetings

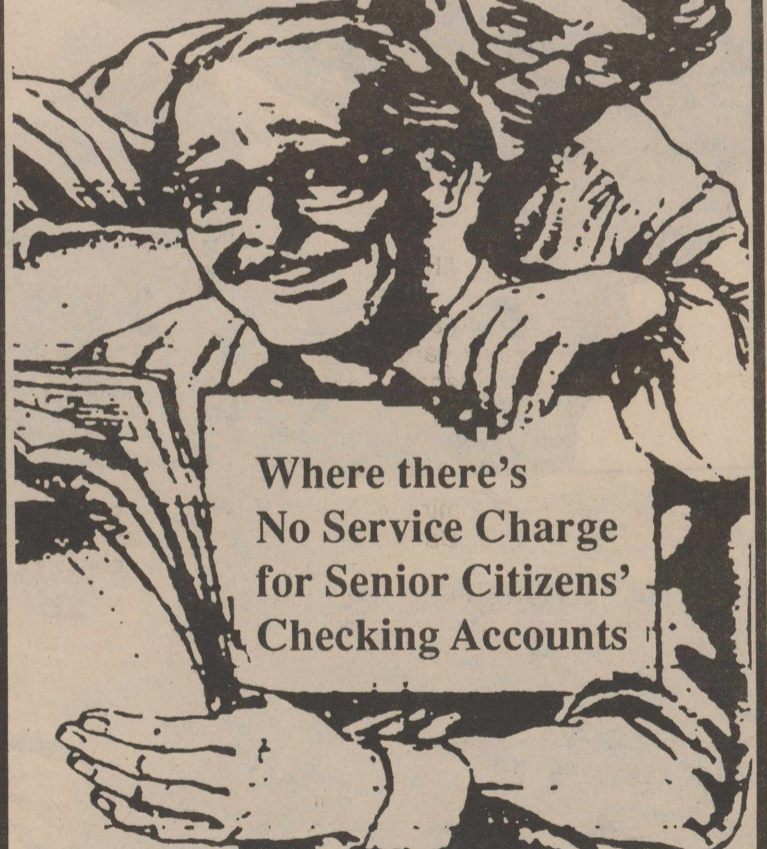
Flanagan family moves to Robert Lee
