Back to school means immunization requirements

When preparing your child for school, make sure required immunizations have been administered. Keep a copy of your child's shot record for your files.

"If a child does not receive a vaccine at the recommended age, a catch-up immunization should be given," said Dr. Celine Hanson, a pediatric immunologist at Texas Children's Hospital in Houston.

Four- to 6-year-olds need to be vaccinated for DTaP (diptheria, tetanus, and pertussis), Polio, MMR (measles, mumps, and rubella), Haemophilus Influenza b and Hepatitis B, if the shots were not given earlier.

Children 7 to 11 should receive an additional MMR and any previously recommended immunizations that were missed.

The Td (tetanus and diphtheria) vaccine should be given to children 11 through

Sanco navigator witnesses America's S. Pacific comeback

[Taken from a story originally printed in the <u>weekly</u> San Angelo "Standard Times", published in 1943.]

The story of America's comeback in the southwest Pacific is, in effect, the story of Captain Ira M. Bird of Sanco.

In his 43 combat missions in the New Guinea theater, he has seen American troops advance up the coast from Buna Mission to Finschhafen and has been a navigator on constantly-strengthened bombing forays against the Japs.

When he arrived in New Guinea little more than a month after graduating from navigation school at Mather Field, Sacramento, Calif., hitand-run night attacks by lone American bombers were more often the rule. Before returning to the states he participated in the massive Oct. 12 raid on Rabaul, when the biggest air armada ever amassed in that area, according to Lt. Gen George C. Kenney, "marked the turning point in the war in the south

Wearing the Silver Star and Distinguished Flying Cross, Capt. Bird arrived home Nov. 5.

When he first went over, Capt. Bird flew in a B-17 for many things for which they were never intended, simply because there were no other planes. Maj. William Benn flew a B-17 to originate skip-bombing -- ordinarily a job for mediums -- and Maj. Kenneth McCullar, flying a B-17, developed this new tactic into a deadly, precise science of destruction. Both men are now dead.

Capt. Bird flew many times with Maj. McCullar and "Ken" was at the controls that night in Rabaul Harbor when Capt. Bird earned his Silver Star.

Reports of shipping concentrations in the outer harbor at Rabaul sent three Fortresses up there on a night "call". Maj. McCullar led the flight, and Capt. Bird was lead navigator.

Nearing Rabaul, the Fortresses went into a dive from around 5,000 feet, leveling off just over the masts of the ships. Capt. Bird saw bombs from his plane break a 5,000-ton ship in two.

"We were right down on the

water," Capt. Bird said. "By that time the Japs figured out that something was happening. They had their searchlights on and were looking for us but couldn't find us." But flack was not the only difficulty. Rabaul Harbor is an old volcanic crater, and on the other side a sheer rock wall loomed hundreds of feet high.

high.
"We just brushed over it,"
Capt. Bird said.

But the Fortress turned and made another run from the other direction. This time they spotted a 7,000-ton ship and got three direct hits and a near miss. When they left the ship was burning and exploding.

In all, the three Fortresses accounted for five Jap ships that night. All three bombers returned safely and without damage.

The next night a few American bombers were over Rabaul again -- but this time on a horizontal bombing mission

"The Japs all had their lights down on the water and never spotted us," he said. "They seemed to think we would be foolish enough to repeat the same tactics."

When the P-38 (Lightning) fighters arrived, the Americans really were able to gain the upper hand in the air. Capt. Bird said, "The P-38's had happy hunting. The morale of the P-38 pilots was so high it scared you. They were always wishing they could find some more Jap planes to shoot down."

A bomber man, he nevertheless gave much of the praise to the fighter pilots. "We always felt pretty safe if we went out on a raid any place and had P-38 cover," he said

"When Allied troops started to push up to Salamaua and Lae, we began cooperating with the ground forces in a big way," Capt. Bird said. "Prior to that, most of our work was just hit-and-run, just trying to worry the Japs.

"When Lae was invaded, the Navy and Air Forces were working closely together. We put everything in the air that would fly. Transports took off nose to tail, five or six going down the runway at once. They were followed by heavies, mediums, lights, and fighters.

"Parachute troops were dropped in the Markham Valley by the transports while the lights (light bombers) kept the Japs busy. I saw the smoke screen and saw parachutes on the ground, but didn't actually see the paratroopers make their jump.

"Our squadron was assigned to knock out a pretty-well-emplaced system of machine guns in a little clearing between the paratroopers and Lae. When we got finished, there was just a bare place on the ground where the guns had been. The Bombardiers got it -- and got it right."

Capt. Bird was aboard the first four-engine plane which landed at Lae. "There wasn't anything left there above ground," he said, "except some of the ack-ack guns that had shot at us before. It looked like the Japs had pulled up and run and left everything as it was. That's the first time they ever did that."

Particularly in the beginning, "some of the most anxious moments were getting into our own base coming back," Capt. Bird said. Often the planes would return from a night raid to find an alert at their own base and they would have to land in the dark.

Most of that is a thing of the past now. "There are very few night raids any more," he said. "Now they go out in daylight with large formations of fighters."

His own squadron twice broke the southwest Pacific area record for the number of missions by a heavy bombardment squadron -- the second time breaking its own record

As might be expected, casualties were heavy. Of the five men from his class (42-16) assigned to his squadron, he is the only one to return.

He has nothing but praise for Gen. Kenney, commander of the Fifth Air Force in New Guinea. "Gen. Kenney not only has the highest respect of the Fifth Air Force, but is personally liked by every man he comes into contact with," Capt. Bird said. "We knew he was our friend and would do anything he could for us, and no man could do anything more."

"When he had to improvise, he could improvise as well as anybody. Yet he understands straight out tactics, and can use large groups of aircraft."

Of the New Guinea climate, he says, with feeling: "It's terrible. We had three seasons -hot and wet, hotter and wetter, and hottest and wettest."

"The mildew gets half an inch thick on the inside of the tents. Anything left on the ground rots in three days. Slit trenches turn into wells."

He related that the fliers dug drainage ditches around their tents, and the water ran out of the ditches in a steady stream.




The 2nd half belonged to the Longhorns as they scored 2 touchdowns while holding Rankin scoreless.




Help your child cross the street safely



Strategic culling due to drought

With the continued hot and dry conditions we are having, the long-range outlook for available forage in our area is bleak. With these type of conditions, our available forage or grass production is greatly reduced or in some cases almost nil. Even if we get some much needed rains in the next few weeks, the prospects of us growing a lot of tonnage is not great. Most of these drought stressed grasses will green up and shoot a tall single stem with the seed head on it that from a distance looking across your pasture you get the idea that there is lots of grass out there, but in reality, if you go out in the pasture and look straight down, we have not grown a lot of forage. Even if we get significant rains in the next few weeks, we are basically looking at the amount of forage that will be available for livestock from now until next Reduced body condition in cattle is of great importance simply because what condition a cow is in now and going into winter not only determines what kind of calf she will have this spring and how big it will get but can also determine the reproductive efficiency and productivity of

that cow for the next year or more.

With this greatly reduced amount of forage we have or expect to have, there may become a time that we will have to cull our livestock to maximize the production of our herds. A strategic plan for culling cows of at least immediate economic benefit and maximum production of remaining animals is as follows. Cull in the following order: 1) open fallcalving cows; 2) dry spring and summer calving cows; 3) open replacement heifers; 4) short bred fall/winter calving cows; 5) bred replacement heifers; 6) wet cows with poor teeth or other unsoundness; 7) wet, historically poor producers; 8) wet, open cows and heifers; 9) wet, bred individuals in poor body condition, cows below body condition score 4 and heifers below body condition score 5; 10) wet, bred cows over 7 years of age; 11) wet, bred first and second calf heifers; 12) remaining wet, bred cows, 4-7 year old, as conditions require.

Culling of your herds that have taken years of selection and pride to build is no easy but sometimes conditions force us to do it. There are always some animals that can be culled for some reason or another. Another good rule of thumb is that if conditions get bad enough to feed your cows, don't hold onto low production animals or too many animals and wind up owing the bank for cows and the feed store for feed. As conditions worsen, take a load of cows to town and buy that much feed to save the rest.

Check out guaranteed loans

A new breed of loan shark is

preying upon unwary consumers. Most credit scams and specifically, advance-fee loan scams, "guarantee" or represent a "high likelihood of success" that the advertiser will be able to get or arrange a loan or other form of credit for a consumer, regardless of the consumer's credit history. These scams differ from legitimate, guaranteed offers of credit in one critical way: they require payments up-front, before the lender is identified and the application is completed. Legitimate lenders may require consumers to pay application, appraisal, or credit report fees, but these fees never are required before the lender is identified and the application completed. In addition, the fees generally are made payable to the lender, not the broker or arranger of the supposed "guaranteed" loan or extension of credit.

Legitimate lenders rarely guarantee a loan or extension of credit before evaluating a consumer's creditworthiness. However, there are legitimate guaranteed offers of credit. For example, guaranteed offers of credit cards or other extensions of credit do not require any payments up-front for a consumer to accept the offers. These are firm offers of credit that require a consumer to accept the offer; they are advance-fee loans only if they offer the consumer the "opportunity to apply" for credit.

Advertisements that promise loans generally appear in the classified section of newspapers and magazines and on the Internet. Often, the ads feature "900" numbers, which result in charges on your phone bill. Advance-fee loan scams also are promoted through direct mail and radio and cable TV spots. The appearance of an ad in recognized media outlets - such as your local paper or radio station - does not guarantee the legitimacy of the company behind the ad.

The Federal Trade Commission says you can avoid advance-fee loan sharks. Here's how: •Don't pay for a promise. It's illegal for companies doing business by phone to promise you a loan and ask you to pay for it before they deliver. •Ignore any ad - or hang up on any caller - that guarantees a loan in exchange for an advance fee. Legitimate lenders never "guarantee" or say that you will receive a loan before you apply, especially if you have bad credit or no credit record.

•Never give your credit card or bank account numbers, or Social Security Number, over the telephone unless you are familiar with the company and know why the information is necessary.

If you have been victimized by an advance-fee loan scam, contact your local consumer protection agency, Better Business Bureau (BBB), or your state Attorney General. You also may file a complaint with the FTC online at www.ftc.gov - click on Complaint Form; call, toll free, 1-877-FTC-Help (382-4357),

Protection from Stalking

by John Cornyn **Texas Attorney General** Stalkers try to control their victims through behavior or threats intended to intimidate and terrify. A stalker can be a stranger, an acquaintance or a former spouse or partner.

The most important thing one can do is notify local law enforcement and prosecutor's offices of the stalking incidents. Each time an incident occurs you should make sure it is documented, and request a copy of the report.

Another tool to aid in the prosecution of a stalker is an accurate and complete diary of all incidents of stalking. This includes recording each

incident that occurred.

The Texas Penal Code makes stalking a Class A misdemeanor. Punishment can be fines of up to \$4,000 and/or up to one year in jail. If the offender has a previous conviction for stalking, the penalty is up graded to a thirddegree felony with a fine of up to \$10,000 and two to six years in prison.

In addition, if the stalker is convicted and sentenced to prison, the releasing officer is required to make a "reasonable" effort to notify the victim when the stalker is being released.

Protective orders are civil court orders issued to prevent continuing acts of family violence. Such orders are avail-

able to blood relatives, relatives by marriage, former spouses, parents of the same child, foster parents or children or any member or former member of a household.

.A protective order may prevent an offender from committing further acts of violence and harassing or threatening the victim. The order can also contain a clause that prohibits the offender from coming within a prescribed distance of the victim or initiating any other form of contact.

PROPOSITION NO. 15 ON THE BALLOT

HJR 36 - HJR 36 proposes a constitutional amendment that would allow spouses, by an agreement in writing, to convert all or part of their separate property into community property. Separate property is primarily the property owned or claimed by the spouse before marriage and the property acquired by the spouse during the marriage by gift or inheritance. Community property consists of the property, other than separate property, acquired by either spouse during marriage.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting spouses to agree to convert separate property to community property.'

PROPOSITION NO. 16 ON THE BALLOT

HJR 71 - HJR 71 proposes a constitutional amendment that would allow a county with a population of 50,000 or more, rather than 30,000 or more, to be divided into four to eight justice of the peace and constable precincts. The amendment also would allow a county with a population between 18,000 and 50,000 to have two to eight justice of the peace and constable precincts, rather than the current maximum of five precincts. Furthermore, the amendment would limit Randall County to not less than two and not more than six precincts. Finally, the amendment would set a minimum of four precincts for any county that as of November 2, 1999, is divided into four or more precincts.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that certain counties shall be divided into a specific number of pre-

PROPOSITION NO. 17 ON THE BALLOT

HJR 58 - HJR 58 proposes a constitutional amendment which would require the board of regents of the University of Texas System to manage investments of the permanent university fund (PUF) according to the standards of a prudent investor. Generally, earnings from the PUF are distributed to the available university fund (AUF) and then ultimately distributed to the public university systems of Texas. Under the amendment, the amount distributed to the AUF would consist of distributions, as determined by the University of Texas System board of regents, from the total return on all investment assets of the PUF, instead of consisting only of the dividends, interest, and other income of the PUF minus administrative expenses. The amendment also would provide guidelines for minimum and maximum amounts to be distributed to the AUF, and require that the board of regents manage distributions to the AUF in a manner that will provide the AUF with a stable and predictable stream of annual distributions and maintain the purchasing power of the PUF investments and annual distributions to the AUF.

CONSTITUTIONAL AMENDMENTS

Special Election NOVEMBER 2, 1999

PROPOSITION NO. 1 ON THE BALLOT

HJR 44 - HJR 44 proposes a constitutional amendment that would ensure a clear succession in event of vacancies in the offices of Governor and Lieutenant Governor. Specifically, the amendment would provide that if after qualifying for the office, the Governor is temporarily unable to serve, the Lieutenant Governor shall act as Governor until the Governor is able to serve; but if the Governor is permanently unable to serve, the Lieutenant Governor shall become the Governor for the remainder of the unexpired term. The amendment would require a Lieutenant Governor who becomes Governor to forfeit the office of Lieutenant Governor. The amendment would also provide similar succession procedures when a vacancy occurs in the office of Governor before the newly elected Governor qualifies for office, and when the newly elected Governor is temporarily unable to take office. The amendment also would provide that if there is a temporary vacancy in the office of Lieutenant Governor, the President pro tempore of the Senate will fill the position; but if there is a permanent vacancy in the office of Lieutenant Governor, the President pro tempore of the Senate shall serve as Lieutenant Governor only until such time as the whole senate can convene to elect one of its members to perform the duties of Lieutenant Governor. Finally, the amendment would provide that if the Lieutenant Governor, while temporarily exercising the powers of the Governor, becomes temporarily disabled or unable to serve, the President pro tempore of the senate shall exercise the powers and authority of the office of the Governor until such time as the Governor or Lieutenant Governor re-

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to revise the provisions for the filling of a vacancy in the office of governor or lieutenant governor.

assumes those powers and duties.

PROPOSITION NO. 2 ON THE BALLOT

SJR 12 - SJR 12 proposes a constitutional amendment that would resolve conflicts between the Texas Constitution and federal law relating to the definition, rules, and procedures of reverse mortgages. The amendment would define "reverse mortgage" in part as an extension of credit made against the homestead of a person who is 62 years or older, or whose spouse is 62 years or older. It would expand the list of circumstances under which payment of principal and interest become due and the procedures involved in foreclosure, and would require certain advances to be made according to specific terms in loan documents, including advances by the lender, on behalf of the borrower for payments necessary to protect the lender's interest. Finally, the amendment would require the Texas Supreme Court to promulgate rules of civil procedure expediting court-ordered foreclosures of reverse mortgage liens.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment relating to the making of advances under a reverse mortgage and payment of a reverse mortgage.

PROPOSITION NO. 3 ON THE BALLOT

HJR 62 - HJR 62 proposes a constitutional

amendment that would simplify and clarify the language of the Texas Constitution. The amendment would make no substantive changes, but would eliminate duplicative, expired, out-of-date, and ineffective terms.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to eliminate duplicative, executed, obsolete, archaic, and ineffective provisions of the Texas Constitution.

PROPOSITION NO. 4 ON THE BALLOT

HJR 4 - HJR 4 proposes a constitutional amendment that would broaden the definition of charitable organizations. The amendment would exempt from ad valorem taxation the property of any organization engaged primarily in public charitable functions, and it would allow such an organization to conduct additional activities to support its chari-

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt property owned by institutions engaged primarily in public charitable functions from ad valorem taxation.

PROPOSITION NO. 5 ON THE BALLOT

SJR 26 - SJR 26 proposes an amendment that would remove the restriction prohibiting state employees who receive all or part of their compensation from the state from serving as members of a governing body of a school district, city, town, or other local governmental district unless the state employee receives no salary for such service. The amendment would allow state employees to receive compensation from the governing bodies of which they are members.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment allowing state employees to receive compensation for serving as a member of a governing body of a school district, city, town, or other local governmental district.

PROPOSITION NO. 6 ON THE BALLOT

SJR 22 - SJR 22 proposes a constitutional amendment that would increase the maximum size of an urban homestead, which is a homestead in a city, town, or village, from one acre to ten acres and require the urban homestead to be composed of either a single lot or several lots that are adjacent to one another. The amendment also would provide that the urban homestead must be used as a home or as both a home and place of business, whereas current law does not require that an urban homestead that is used as a place of business be used also as a home.

Current law further allows a person to secure a home equity loan on their homestead, provided that the loan does not overburden the homestead. That is, the principal amount of the home equity loan, when added to the total of the outstanding principal balances of all other indebtedness secured against the homestead, does not exceed 80 percent of the fair market value of the homestead on the date the extension of credit is made. The

proposed amendment would clarify current law by specifically allowing home equity loans on all or part of urban homesteads of up to ten acres and subject such loans to the same requirement that the refinanced or new loan not overburden the homestead.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment increasing the maximum size of an urban homestead to 10 acres, prescribing permissible uses of urban homesteads, and preventing the overburdening of a homestead."

PROPOSITION NO. 7 ON THE BALLOT

HJR 16 - HJR 16 proposes a constitutional amendment that would provide that if an employee is delinquent in paying court-ordered spousal maintenance, a portion of that employee's wages may be withheld to pay the spousal maintenance. Current law allows such withholding, or garnishment, only for payment of delinquent court-ordered child

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing garnishment of wages for the enforcement of court-ordered spousal

PROPOSITION NO. 8 ON THE BALLOT

HJR 95 - HJR 95 proposes a constitutional amendment that would provide that the adjutant general, who is appointed by the Governor and who serves as the governing officer of the state military forces, serves as long as the Governor wishes the appointed person to serve in that capacity rather than serving a specific two-year term set by the

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that the adjutant general serves at the pleasure of the governor.

PROPOSITION NO. 9 ON THE BALLOT

SJR 10 - SJR 10 proposes a constitutional amendment that would authorize the legislature to create a judicial compensation committee to make recommendations for salaries for the justices and judges of the Supreme Court, the Court of Criminal Appeals, the Courts of Appeals, and the District Courts. The amendment would mandate that the recommendations become law if neither the Senate nor the House of Representatives rejects them by majority vote.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to create a judicial compensation commission.

PROPOSITION NO. 10 ON THE BALLOT

HJR 74 - HJR 74 proposes a constitutional amendment that would provide that the commissioner of health and human services, who is appointed by the Governor, serves as long as the Governor wishes the appointed person to serve in that capacity rather than serving a specific two-year term set by the legis-

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that the commissioner of health and human services serves at the pleasure of the governor."

PROPOSITION NO. 11 ON THE BALLOT

HJR 69 - HJR 69 proposes a constitutional amendment that would authorize a county, city, town, or other political subdivision to spend public funds or extend credit to purchase nonassessable property or casualty insurance from a mutual insurance company authorized to do business in Texas. Under current law, a political subdivision is generally prohibited from spending public funds or extending credit to become a stockholder in a corporation but is permitted to purchase nonassessable life, health or accident insurance policies from a mutual insurance company authorized to do business in Texas. This amendment would authorize a political subdivision to also obtain non-assessable property and casualty insurance from such a com-

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting a political subdivision to purchase nonassessable property and casualty insurance from an authorized mutual insurance company in the same manner that the political subdivision purchases life, health, and accident insurance."

PROPOSITION NO. 12 ON THE BALLOT

SJR 21 - SJR 21 proposes a constitutional amendment that would exempt from ad valorem taxation a leased motor vehicle that is not used by the lessee primarily to produce income. The amendment would provide that the legislature also may limit the ability of a political subdivision to subject such a vehicle

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation leased motor vehicles not held by the lessee primarily to pro-

PROPOSITION NO. 13 ON THE BALLOT

SJR 16 - SJR 16 proposes a constitutional amendment that would authorize the legislature to allow the Texas Higher Education Coordinating Board to issue and sell general obligation bonds in an amount not to exceed \$400 million in order to finance educational loans to students. The amendment also would authorize the Legislature to limit the amount of interest the bonds can bear and establish procedures for the investment of the bond proceeds. The proposed amendment would specify the method of repaying the bonds.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of \$400 mileducational loans to students.

PROPOSITION NO. 14 ON THE BALLOT

HJR 29 - HJR 29 proposes a constitutional amendment which would authorize the Legislature to require the board of regents of the state university and boards of trustees or managers of the educational, charitable, and penal institutions of the state, whose members serve six year terms, to be composed of an odd number of three or more board members (for example, 5, 7, or 9 members). The proposed amendment would allow approximately one-third of members of boards whose membership is not evenly divisible by three to be elected or appointed every two years. The amendment also would allow the Legislature to set the composition of constitutionally required boards, whose members serve for a term of six years, to a number divisible by three so that exactly one-third of the board members may be elected or appointed every two years.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide that a state board, commission, or other agency shall be governed by a board composed of an odd number of three or more ment relating to the investment of the permanent university fund and the distribution from the permanent university fund to the available university fund.'

FOR NON-COMPLIANCE: Any person, firm, or corporation violating this Ordinance or any part of this Ordinance, and found guilty by the Judge of the Municipal Court, will be guilty of a Class "C" Misdemeanor, and be fined not more than \$500.00 (Five Hundred Dollars) except for health violations which may be fined not more than \$2,000.00 (Two Thousand Dollars). Each day such violation continues, or be permitted to continue, shall be a separate offense.

Protecting Your Credit

Q: I recently applied for a
credit card and was turned
down because of an item on
my credit report. It turns out
that someone else used my
name to get a credit card.
How can I fix my credit and file
charges against the person
who did this?

A: Identity theft occurs when a criminal uses another person's information - name, address, social security number, driver's license number, etc. - without permission, to obtain credit or open checking accounts.

Many victims do not realize that their identity has been stolen until they are denied credit, turned down for a job or sent a bill for a purchase they did not make. By that time, a person's good name and credit history may be in ruins.

Evidence of unauthorized accounts or credit activity should be reported to the appropriate credit issuer or reporting entity as quickly as possible. Your prompt reporting of information regarding unauthorized charges will assist the companies in rectifying this situation and protecting your credit history. These companies may request your assistance is pursuing criminal charges against the perpetrators of such fraud.

A new state law also makes use of another person's identifying information with the intent to harm or defraud that person a felony. You should report any activity of this type to your local law enforcement authority.

The federal Identity Theft and Assumption Deterrence Act of 1998 was passed to crack down on identity fraud. This law allows victims the right to file police reports and recoup their damages. Q: I recently received a phone call from someone who claimed to be with my bank. He told me that the strip on my ATM card would not work on January 1, 2000, because of the Y2K bug, and asked for

could send me a new card. I know this was an attempted scam, but others might not. Can you warn people?

A: As the beginning of the new year approaches, many consumers are concerned about the effect that the Year 2000 (Y2K) computer bug will have one their finances.

The Y2K problem is a result of programming that causes many computers to recognize only the last two digits of a For example, vear. September 1, 1999 would read as 09/01/99. Because of this programming glitch, some computers may not work properly on January 1, 2000. (Editor's Note:) Recent results of testing for Y2K problems in the banking industry has indicated that over 99% of the nation's banks are already prepared for the year 2000; so be very wary of scams such as these perpetrated from someone who claims to represent your local bank).

Unfortunately, consumer concern over the Y2K problem has created new opportunities for scam artists. My office has received complaints about many scams similar to the one you describe. All of these scams have one thing in common: the consumer's fear of losing his or her money. Instead of protecting your money, these criminals take it and run.

There are ways you can protect yourself from these scams. The most important way is to never give out personal information such as bank or credit card account numbers over the phone to someone who has called you. You have no idea who is really on the other end of the call. If you receive a suspicious call from someone claiming to be from your bank or credit company, request his or her name and number and verify that he or she really is with the company in question.


Other scams that we have heard about involve fraudulent investment schemes in products claiming to fix the Y2K bug and offers of services to protect investments and savings from the problem.



Teach Your Kids to Eat Right

take the morning meal too seriously. Breakfast is the most important meal of the day for you and your kids; so make an effort to have a nourishing breakfast each day. Your kids will learn from example. Your children will also pick up other eating habits, frequent snacking, eating when bored; so be careful about the message you are sending to your young ones.

*Do not buy Junk Food: Fortunately, unless your child is independently wealthy and/ or does the family shopping, you have total control over the types of food you allow in your house. If you do want to allow your kids an occasional hot fudge sundae, make a trip to the ice cream store and buy individual servings, do not buy all the fixings and keep them in the freezer. If you do

not keep junk food in the house, your kid will not be able to eat it, at least not at home. As simple as this sounds, this is the most effective weapon you have in the war against junk food.

*Be Flexible: Even though you may not buy junk food, your kids are apt to eat it elsewhere. In fact, chances are if you forbid your kids to eat junk food altogether, they will crave it even more. What can you do? Be flexible. An occasional bag of chips or a fast food meal will not kill anyone. You might even consider setting aside one day week when your children can satisfy their junk food cravings. In short, accept the fact that your kids will indulge in nutritionally empty foods now and again, but make sure it's the exception, not the


