2002 Coke County Livestock Show results announced

The key word for this year's county stock show was "more", as the exhibitor numbers were up as well as the total number of livestock projects exhibited. 87 exhibitors (up from 80 last year) showed 269 livestock projects at this year's show (up from 250 last year).

The weather cooperated as well, to make the 62nd edition of the Coke County Stock Show one to remember. Sale results were pending at presstime, but officials are confident these figures will be positive as well. The buyer's appreciation barbecue, held at noon on Saturday, was excellent as usual, thanks to the good cooks and dedicated servers.

Highlights of this year's show included Ashlee Millican's seventh win in the market lamb show, with her entry being named Grand Champion on Friday night. Younger brother Lance exhibited the Reserve Grand Champion Lamb.

Lance also showed the Grand Champion Meat Goat, with Stacey Denton's first place heavyweight meat goat being named Reserve Grand Champion.

Kailey Howell's entry was named Grand Champion Market Hog on Saturday morning, with Katie Bessent exhibiting the Reserve Grand Champion.

Grand Champion Steer was shown by Chelsea Cook, with Clay Antiley exhibiting the Reserve Grand Champion Steer.

Wayne Douglas McCabe, 82, of Robert Lee passed away Friday, Jan. 18, 2002.

Wayne was born April 11 1919, on the divide, already the third generation of a Coke County ranching family, the second son of John Franklin McCabe and Fern Chumley McCabe.

His brothers are Victor McCabe and J.F. McCabe Jr. He married Delia Frank (Sitter) Jameson on July 6, 1940, in Pecos. Wayne and Sitter made their ranch home near Silver where they raised their two daughters, Charlotte and Fredda.

He actively ranched in Mitchell and Coke counties. Throughout his life he loved ranching, throughout the good and bad times, and weathered the change that accompanied the industry. He was an avid horseman and was involved with rodeo, roping, polo and horse racing.

Wayne was committed to keeping his community strong and independent through active participation on various boards and organizations. He served as a director on the Robert Lee State Bank Board since 1983, West Coke County Hospital District from 1981 to 1984, and Coke County Underground Water District from 1990, including a stint as president from 1992 to 2001. He was a member of the Pro Rodeo Cowboy Association, Texas Sheep and Goat Raisers Association and Texas and American Quarter Horse Association and Southwestern Cattle Raisers Association.

Wayne is survived by his brothers; his daughters; one grandson, David Northcutt; and two great-grandchildren, Celia and Randy Northcutt. Pallbearers were Jeffrey McCabe, Mike McCabe, Jerry McCabe, Terry McCabe, Todd McCabe, Wade Love, Tye Love, Sam Chumley, Joe Ash and Melvin McCabe.

Javelina season remains open in Coke County until Sunday, Feb. 24. Annual bag limit is two javelinas or collared peccary.

There is an unlimited bag limit for squirrels. Coke County's general season will be open through Saturday, August 31, 2002.

Hunters may take quail statewide through Feb. 24, 2002 with a 15-a-day bag limit.

The favorite hunting season for most shotgunners is still some time away. Spring Rio Grande Turkey Season is set for Saturday, April 6, through Sunday, May 12. No hunter may take more than 4 turkeys per year statewide, all coun-

ties, species, and seasons combined. Some planning is required before you reach the spring gobbler-only hunting season. The \$5 turkey stamp fee is also required and proof of sex is also a must.

Fire Safety

Bud Thompson, Robert Lee Fire Marshall, would like to remind Robert Lee residents of the constant fire danger.

January has been a very dry month, with low humidity, high winds, and warm temperatures. It doesn't look like there is anything out there to burn, but there is. The grass is dry, and the cedar is all around us.

It only takes a spark to start a range fire. One careless cigarette thrown from a car, a flat tire running on the rim, or an unattended camp fire or barbeque are all potential fires. Always keep a hose or bucket of water nearby when cooking outside.

Take care in the home also. Overloaded or frayed extention cords can become a fire hazard. Don't place anything too close to the heater or fireplace. Don't block exits. Have a fire plan worked out. Know how to exit the house, where to meet outside and remember, never re-enter a burning building. A meeting place will ensure that everyone is out safely. Every home should have a smoke detector. Fire safety is everyone's responsibility.

Burning trash in the city limits is prohibited. The ranchers have been good about letting the Sheriff or the Fire Department know when they plan to burn and the Fire Department appreciates their consideration.


Lady Steers win at Roby and at home against Bronte

They adjourned the meeting and worked on the trucks.









DEC. 12, 2001
ORDINANCE

The Board of Directors of the District shall have the power to adopt and promulgate all reasonable regulations to secure, maintain and preserve the sanitary condition of all water in and to flow into any reservoir owned by the District, to prevent waste of water or the unauthorized use thereof, to regulate residence, hunting, fishing, boating, and camping, and all recreational and business privileges, along or around any such reservoir and the Colorado River and its tributaries, or, any body of land, or easement owned or controlled by the District.

An Ordinance enacted by the Board of Directors of the Colorado River Municipal Water District adopting Rules and Regulations under the powers and provisions of Chapter 12, Title 128 (Article 8280-137) of the Laws of the State of Texas and Chapter 51, Title 4 (Texas Water Code, Section 51.127 et seq.) providing for and to:

Regulating toilets and sewage disposal; regulating industries upstream from the lakes and reservoirs; regulating garbage and trash disposal; requiring permit for any construction on lands bordering on the lakes and reservoirs owned by the District and covered by flowage easements held by the District.

Requiring certain standards of safety, size, construction, equipment, and occupancy of boats; providing for the removal of boats in violation of applicable provisions; providing certain sanitary standards for boats having overnight accommodations; defining certain types of boats and docks; providing that the Texas Boat Safety Laws apply to the lakes or reservoirs.

Requiring permit for operation of commercial activities on waters of District owned lakes and reservoirs or lands owned by District and providing for concession areas.

Providing for the inspection of boats and other floating devices on the District owned lakes and reservoirs for sanitation and safety; providing for certain recreation permits and fees to be charged by the District for access to boating, fishing, skiing, surfboarding, camping and picnicking on the lakes and reservoirs or in designated recreation areas adjoining the lakes and reservoirs; providing for certain exemptions.

Regulating the use of firearms, fireworks, and pellet and BB guns on District owned land, lakes, and reservoirs.

Providing that State Laws regulating fishing in Borden,

Coke, Coleman, Concho, Howard, Mitchell, Runnels, and Scurry Counties shall apply to District owned lakes or reservoirs located therein.

Providing for the establishment of code enforcement officers and defining the powers of such officers.

Regulating the construction of piers and wharves, floats, and boathouses.

Regulating the anchoring of rafts and floats.

Prohibiting the anchoring of boats, trot lines, and other apparatus to buoys, floats, and boathouses owned by the District.

Prohibiting the discarding of cans, bottles, and rubbish into or on the waters of District owned land, lakes, and reservoirs

Providing a time limit for camping in public areas.

Providing certain penalties for violation of the terms of this Ordinance said penalties shall not exceed fines of Two Hundred (\$200) Dollars or imprisonment of more than thirty (30) days.

Providing for structures to be built on areas covered by a flood easement granted to the District: (a) Lake J.B. Thomas between Elevations 2258.00 and 2265.00 mean sea level; (b) E.V. Spence Reservoir between Elevations 1900.00 and 1912.00 mean sea level; and (c) O.H. Ivie Reservoir between Elevations 1555.00 and 1567.00 mean sea level.

Providing for pumping of water for personal and private use.

Providing for pumping of water for commercial use.

Providing for the changing the water line of District owned land and water.

Windbreak seedlings offered by Coke County SWCD

Seedlings for conservation windbreaks are available through the Coke County Soil and Water Conservation District (SWCD). Landowners in Coke County are encouraged to purchase the one-year-old seedlings before preferred stock is sold out.

Each year, thousands of regionally adapted seedlings are grown from seed by the Texas Forest Service West Texas Nursery in Lubbock. The agency's primary objective is to produce and sell quality seedlings at a price landowners can afford, allowing them to plant large quantities of trees for windbreaks.

Windbreaks are trees and shrubs systematically planted adjacent to fields, homesteads, or feedlots as a barrier to reduce or redirect the wind. They create permanent, natural protection and habitat for wildlife, reduce erosion, and increase land value and aesthetics. Evergreens available for Coke County include Afghanistan Pine, Arizona Cypress, Austrian Pine, Italian Stone Pine, Pinyon Pine, and Red Cedar. Deciduous trees and shrubs include Amur Honeysuckle, Aromatic Sumac, Bur Oak, Catalpa, Desert Willow, Flameleaf Sumac, Fourwing Saltbush, Green Ash, Hackberry, Honeylocust, Lacebark Elm, Nanking Cherry, Russian Olive, Sandcherry, Sand Plum and Shumard Oak.

Wildlife packets for habitat establishment also are available. Each of the four wildlife packets contain 100 bare-root trees and shrubs which cater specifically to the habitat needs of quail and pheasant, deer, turkey or squirrel.

Time to re-register your brand

Brand re-registration is under way in Texas and will continue through February 28, 2002. A visible brand is the best way to protect cattle and horses against theft; however, many persons who don't own either register brands for historical or nostalgic purposes.

It is illegal to use a brand without first recording it, and re-recording is required every 10 years by Texas law. Brands that are not rerecorded by February 28, 2002, will become available for other persons to use.

Brands must be registered with the county clerk in every county where you intend to use them; therefore, if you run cattle in four counties, you must register your brands with each of those county clerks.

Brands used on horses must be registered separately, even if they are the same ones used on your cattle. Each county charges a small registration fee, ranging from \$8 to \$17.

A brand may be registered by more than one person in each county, if it will be used in a different place on the animal. Some ranchers prefer to register their brands in all locations to prevent others from using them.

Most county agents send a copy of each brand registration record to Texas and Southwestern Cattle Raisers Association. TSCRA headquarters is the only location where brand records are kept for all 254 Texas counties.

Washing hands can prevent colds

A simple 15-second procedure just might prevent you from coming down with a cold this season -- washing your

'Many people come down with colds in the winter, not because of cold temperatures, but because people live and work in close quarters," said Dr. W. Paul Glezen, a professor in the department of molecular virology and microbiology at Baylor College of Medicine in Houston. "The more crowded a room is, the greater the chances are for spreading germs."

When washing your hands, use soap and warm water and wash all areas thoroughly including wrists, palms, back of hands, fingers and underneath fingernails. Rub hands together vigorously for 10 to 15 seconds and dry with a clean disposable towel.

According to Glezen, remembering to wash your hands correctly not only promotes good health and good personal hygiene, but also reduces the number of circulating colds.

"On average, young children contract five to seven colds per year," said Glezen, who is also head of the preventative medicine section in the department of peiatrics at Baylor. "Children learn by example, therefore it is important for parents to model behavior that promotes good health."

Glezen offers the following tips for avoiding colds:

* Avoid hand contact with your mouth, nose, and eyes.

* Avoid sharing cups, glasses, silverware, and towels with others.

Use a hand sanitizer as an alternative when soap and water are not available. This kills

99% of germs and other bacteria.

Instead of handkerchiefs, use disposable tissues. Handkerchiefs are breeding grounds for germs.

Don't forget to wipe down faucets, doorknobs, and light switches. Germs can easily be transmitted through any household due to daily con-

Make sure that there is good ventilation throughout your home or workplace. If necessary, go outside for some fresh air.

"If we wash our hands well, we can help reduce the number of disease-causing germs on our hands," Glezen said. "It's simple, takes very little time, and will help us all stay




