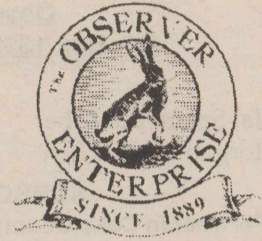

## Kirk wins primary runoff victory over Morales

As expected, voter turnout was light in Coke County as it was throughout the state for Tuesday's primary runoff election. With no local or area candidates on the ballot, the county recorded a total of 55 Democratic and 8 Republican ballots counted in the runoff.

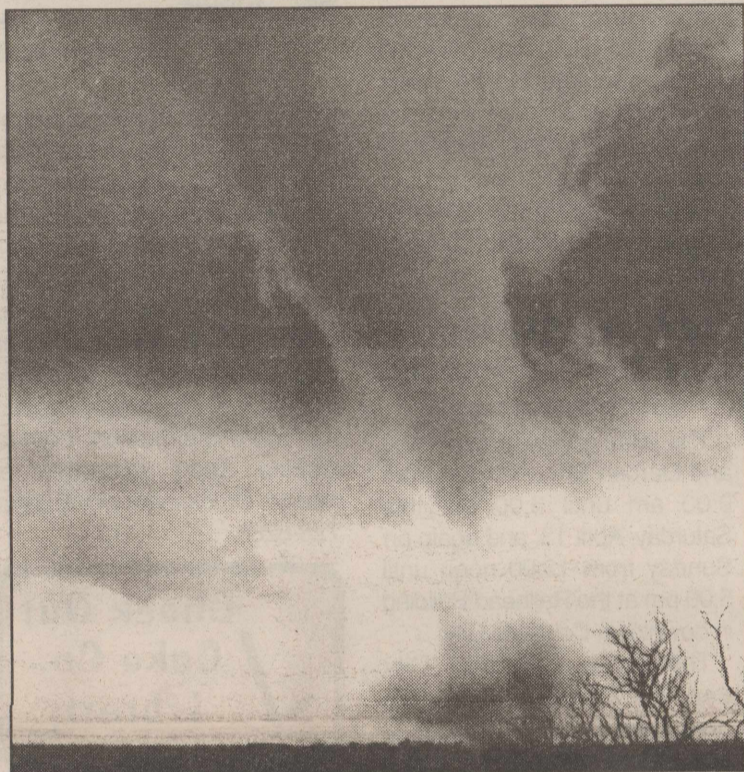
The most visible of the races was the Democratic nominee for United States Senator (Phil Gramm's previous position). In this runoff election, former Dallas mayor Ron Kirk defeated school teacher Victor Morales in Coke County and throughout the state. County voters cast 34 ballots for Kirk and 21 for Morales. Kirk is now the Democratic Party nominee who will take on Republican state attorney general John Cornyn in the November election.

With just 8 local votes in the Republican runoff, no clear trend was indicated. However, local Republicans did mirror state totals in voting for Dale Wainwright over Elizabeth Ray in the Supreme Court Justice, Place 2 race. Also, county Republicans voted for Cathy Cochran over Guy Williams in the Court of Criminal Appeals, Place 3 race.

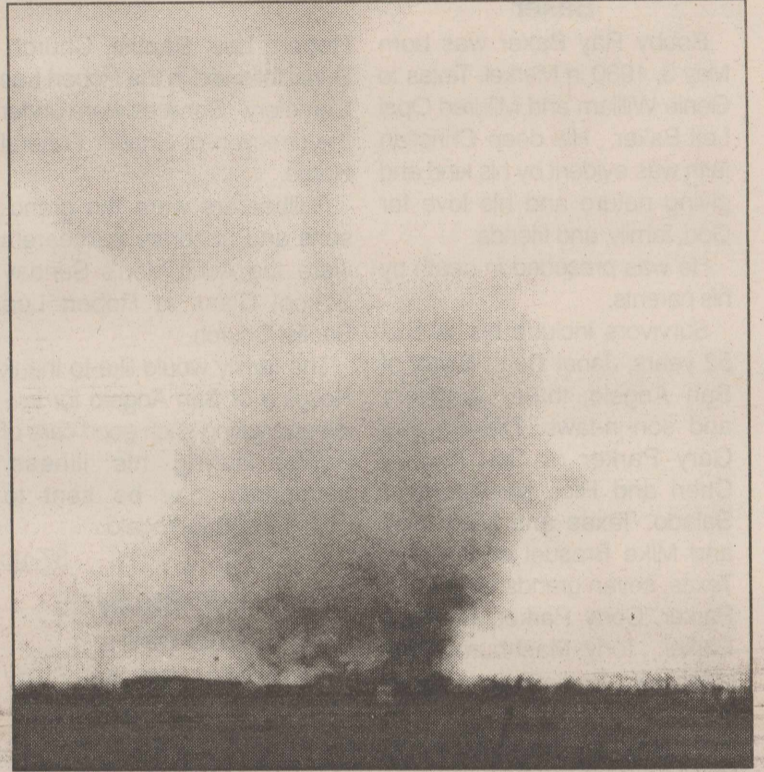
### CC Retired

The Federal Register has been posted for 2001 and 2002 NAP. Producers have until April 18, 2002 to make an application

for 2002 NAP crops. If you wish a 2002 NAP policy on any hay crop or grass crop this is the last day for purchase of a policy.

Also, producers who had production for any 2001 NAP crop must report that production by April 18, 2002.

It is very important that we don't let this date pass as there can be no late-filed applications.

The 27-week school is the longest continuous training academy offered by any law enforcement agency in Texas, and one of the longest in the nation.

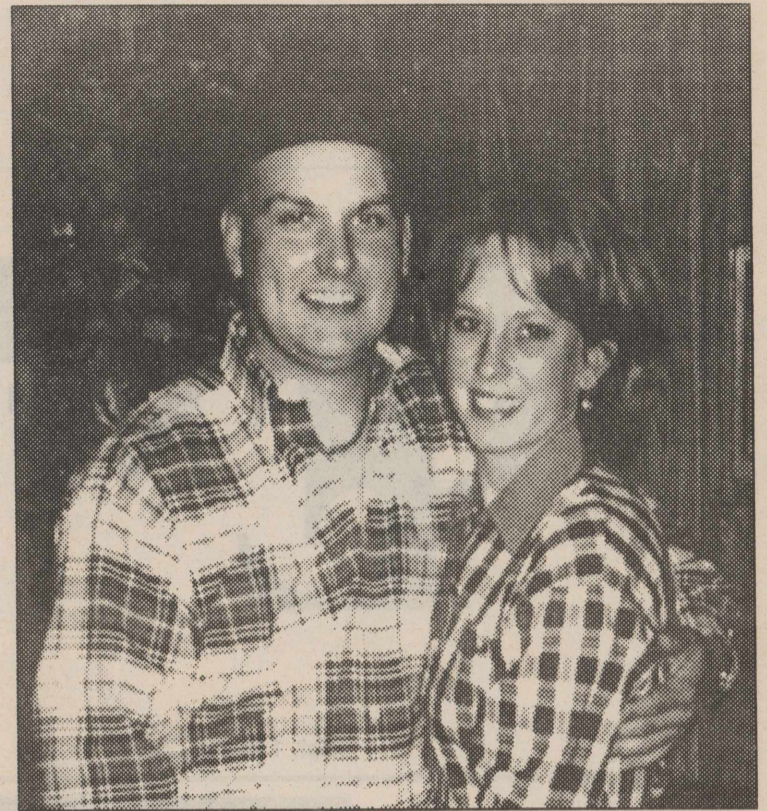

**Don't miss annual Historic Preservation Conference**

The Texas Historical Commission (THC), in association with Preservation Texas and the Texas Historical Foundation, invites all preservationists, historians, students, community leaders and Texas history buffs to the 2002 Annual Historic Preservation Conference April 18-20 in Abilene.

"Frontier Folklore: Preserving the Lone Star Legacy" is the theme for this year's conference at the Embassy Suites Hotel in Abilene. This year's theme honors what is truly unique about Texas and its citizens - its folklore.

New this year is a training workshop for county historical commissions, tours of preservation projects designed to give participants ideas to take home and more sessions for small museums. Experts in archeology, downtown revitalization, heritage tourism, and community assistance will be on hand to answer questions. **Delay the game when storms approach**

Countless lightning tragedies have occurred on sport fields in Texas through the years. People on open sport fields are at higher risk for lightning strikes.

Sports fields are dangerous because they are large open areas where people are often the tallest objects. Sports fields also have metal bleachers, fences, light poles, and goal posts that attract lightning. When lightning hits these objects, its charge travels along the object shocking anyone who is touching it. Lightning can also bounce off any of these objects and strike people nearby.

"Schools, athletic programs, day care centers, and summer camps, as well as coaches, referees and parents participating in field events need to understand the danger of lightning and be prepared to take immediate action. Activity policies should clearly state that if thunder is heard, games and activities should be suspended until the threat passes and thunder is

no longer heard," says Division of Emergency Management Coordinator, Tom Millwee.

"No sporting event is worth risking the lives of the people and children on or around fields," says Millwee. "When a game or practice is delayed due to a thunderstorm, move everyone indoors or into cars or buses until the storm passes."

The Division of Emergency Management offers the following lightning safety tips:

- \* Stay tuned to local weather forecasts.
- \* If you can hear thunder, you are close enough to the storm to be struck by lightning.
- \* Find a low spot away from trees, bleachers, goal posts, and other structures.
- \* Make sure the area is not prone to flooding.

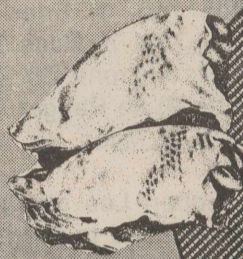

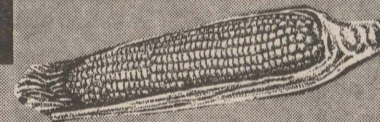

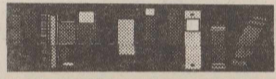

## ATTENTION PROPERTY OWNERS

Property owners have certain rights that may reduce their property tax burden

### HOME OWNERS

Persons who owned and lived in their home as their principal residence on January 1, 2002, may claim a residential homestead exemption. The filing of this document is necessary if the homeowner has changed homesteads since January 1, 2001, or has become eligible for additional exemptions since last year, or if the appraisal district has requested a new application. Homeowners may defer the portion of the tax on their residence homestead if the value of the home was raised more than 5% above the previous year. Although the tax collection is deferred, interest continues to run on the unpaid portion of tax at a rate of 8% per annum and the deferred tax remains a lien on the property. To apply for the deferral, the owner should contact Coke County Appraisal District.

### DISABLED PERSONS

Persons who are disabled under Social Security law are entitled to additional exemptions on their residential homestead. Disabled applicants must apply with the appraisal district and furnish a determination letter from Social Security.

### PERSONS WHO ARE OVER 65 YEARS OF AGE

Persons who are over 65 years of age may file for additional exemptions and a ceiling on school taxes for their residential homestead. They are also eligible to defer paying the tax, but the taxes continue to accrue during the deferral along with interest of 8% annually. No attempt will be made to force payment during the deferral period. Details and an application may be obtained from the appraisal district or the State Comptroller's Property Tax Division.

### DISABLED VETERANS

Persons who have a service-connected disability and have been declared disabled by the Veterans- Administration are eligible for additional exemptions on property they own. The declaration letter from VA is mailed annually, but the appraisal district needs a copy only in the first year of eligibility or if the percentage of disability changes.

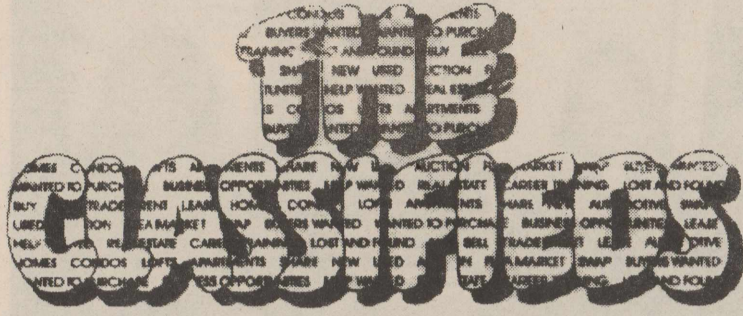
### FARM AND RANCH OWNERS

Farmers and ranchers may be entitled to receive an alternate method of appraisal determined by the productive income on the property. This method is available to farms and ranches raising crops or livestock or which are used as a wildlife habitat under State guidelines. An application for agricultural-use value and additional information is available from the appraisal district. Re-filing is necessary in the event of a change of use, or if requested to do so by the Chief Appraiser.

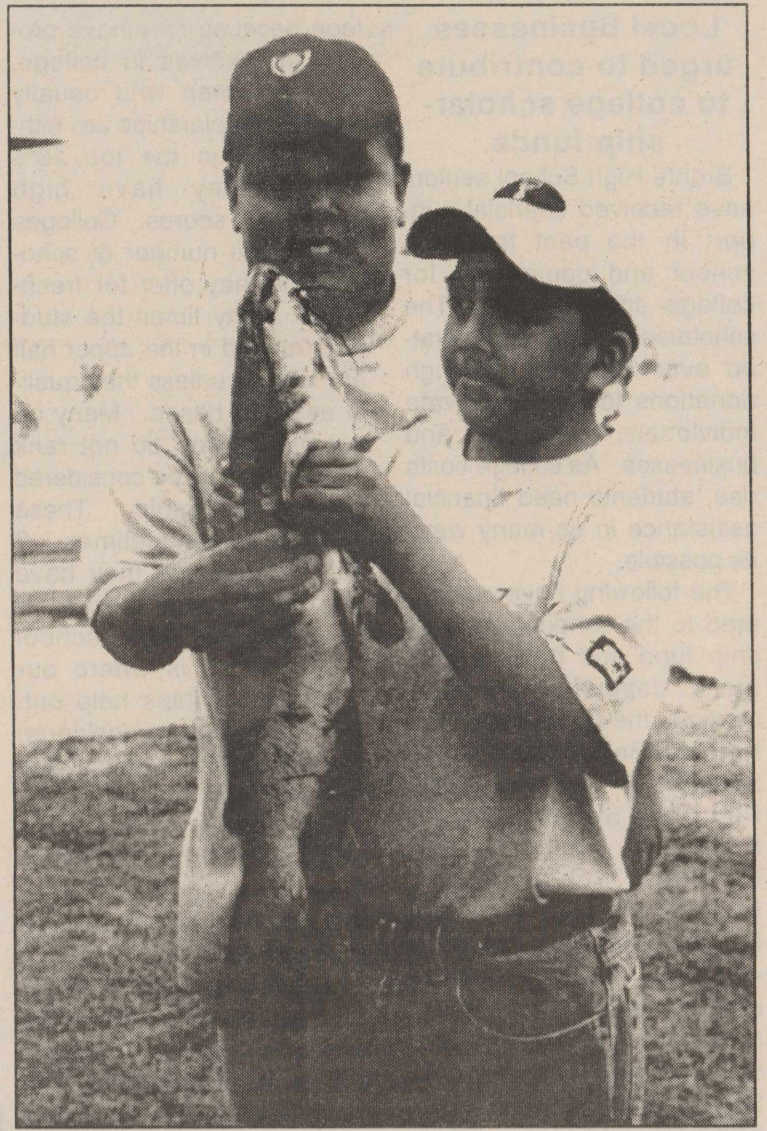

**Local businesses urged to contribute to college scholarship funds**

Bronte High School seniors have received financial support in the past from the school and community for college scholarships. The scholarship fund has generated over \$7,000.00 through donations locally by private individuals, the school and businesses. As college costs rise, students need financial assistance in as many ways as possible.

The following have contributed to the school's scholarship fund and have helped many deserving students continue their education: First National Bank Scholarship - \$2,000.00; Bronte ISD Faculty Scholarship - \$1,500.00; BHS Sports Boosters Scholarship - \$600.00; Pat and Martin Lee Christian Athletic Scholarship - \$500.00; Bronte Chamber of Commerce Scholarship - \$150.00; Eastern Star Scholarship - \$265.00; Sorosis Club Scholarship - \$200.00; Lion's Club Scholarship - \$500.00 and Wackenhut (CCJJC) - \$1,000.00. Students in the past have received scholarships from Taylor Telephone Cooperative, Inc., and Angelo State University's Carr Scholarship program.

Students may apply to the college of their choice and could possibly receive scholarships from this source. The valedictorian will receive tuition only for the first year. Students are supplied scholarship lists that are received from the guidance counselor's office which are duplicated for them to apply. Many resources to search for scholarships are included in their career notebook. The real truth of scholarships for entering freshmen is an eye opener. Most scholarships go to upperclassmen in col-

lege because they have proven themselves in college. The freshmen who usually receive scholarships are either ranked in the top 10% and/or they have high ACT/SAT I scores. Colleges vary in the number of scholarships they offer for freshmen. Many times the students ranked in the upper half are left out unless they qualify as need based. Many do not qualify and do not rank high enough to be considered for a scholarship. These students are sometimes left out even though they have maintained a high average all through their high school years. This is where our local scholarships help out. All students are considered for the local scholarships and are encouraged to apply.

Out of the 25 seniors in the class of 2001, 16 are attending college, 5 are in the military and the remaining students have jobs.

**TxDOT reminds motorists about work zone safety**

This week traffic safety officials and transportation industry members will observe National Work Zone Safety Awareness Week April 8 - 12. The observance is part of a national campaign to help increase public awareness of work zone safety.

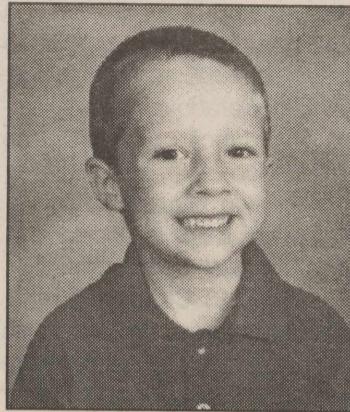
The warning sign "Give Us a Brake" is a way to remind motorists about the safety of both the construction worker and the motorist, according to Public Information Officer Patsy Rainwater-Maddux from the Texas Department of Transportation (TxDOT). Annually, approximately 120 construction/maintenance

workers suffer work zone related accidents or are killed in Texas. Since 1991, approximately 14,700 work-zone related injuries are sustained each year in Texas.

One way TxDOT is addressing work zone injuries and fatalities is through research. State transportation officials are partnering with researchers to develop new devices and methods that will improve safety and reduce work zone-related fatalities in Texas. TxDOT is currently funding nearly \$1 million for work zone research projects.

Locally, public service announcements for Work Zone Safety Awareness Week have been produced locally, featuring Kacee and James Roberts, children of Robert Lee Maintenance Supervisor Douglas Roberts. The television and radio PSAs remind motorists to "drive like its your daddy" when seeing workers in a construction or maintenance zone.
