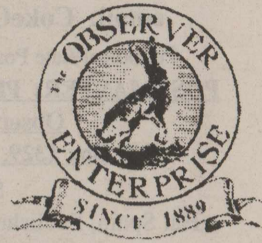

## County precincts consolidated for Saturday's local elections

As a convenience to county voters, the County Clerk's office has announced that the precincts will be consolidated for Saturday's local elections. Precinct 1 will vote at the courthouse with Precinct 3. Those voters will be casting ballots in the Amendment Election, City of Robert Lee, Robert Lee ISD, and West Coke County Hospital District. Precinct 2 will vote at City Hall in Bronte along with Precinct 4. Those voters will be casting ballots in the Amendment Election and the Bronte ISD election.

West Coke County Hospital District has two 2 year terms on the ballot. The terms of Mary Bessent and Dessie Kendall are expiring. The incumbents will be joined on the ballot by Don Fields.

The City of Robert Lee has to fill three 2 year council seats. City officials whose terms are expiring are John Carver, Jackie Walker, and Gary Payne. Incumbents Jackie Walker and Gary Payne will be joined on the ballot by Barbara Jenkins, Manuel Abalos, and Troy Wimberley.

The Robert Lee Independent School District Board of Trustees will have to decide on two 3 year terms. The terms of Kevin Roe and Tod Reed are expiring. Roe and Reed have both filed for re-election and will be joined on the ballot by Brandi Ramon and

Charles Blount.

The Bronte Independent School District has two vacancies to fill for full three-year terms. Positions open are currently held by Terry Charles and Quinda Feil-Duncan. The incumbents will be joined on the ballot by Paul Williams.

The East Coke County Hospital District and the City of Bronte have unopposed candidates for their elections, and each entity has cancelled their election, and declared their candidates elected to office. Doris Sims and Alonzo Robbins will each be serving a 2 year term for the East Coke County Hospital District, and Elton Moore, Misti Bedford, and Paula McWright have been declared elected to office on the Bronte City Council.

Polls will be open this Saturday, May 12, from 7 am to 7 pm, at the courthouse in Robert Lee or City Hall in Bronte. The clerk's office would like to remind voters to bring your voter registration cards or proper identification. If you have any questions, please contact the clerk's office at 453-2631.

and 65 and never had a diagnosis of cancer, you may qualify. It will only take 20-30 minutes. You will complete a brief survey, give a small amount of blood (similar to a doctor's visit) collected by a professional, trained phlebotomist, and have a waist measurement. Within four months after the Relay, you will be mailed a more extensive survey to complete with questions related to medical history, lifestyle and behaviors. Every two years, you will receive a survey to update that information. Confidentiality is of the utmost importance and every effort will be made to protect the privacy of the participants.

Past long-term American Cancer Society follow-up studies have played a major role in cancer prevention at the American Cancer Society, as well as in other national and international efforts. The current study population (CPS-II) is becoming elderly. A new study population must be recruited for the next generation of research.

President Bessent announced a quorum was present, and the minutes of the previous

meeting were approved. Capital equipment was discussed, and Cy Jenkins informed the Board members the term referred to equipment costing \$500 or more, and lasts for more than one year. Mr. Jenkins also provided the Board with a copy of the policy sheet for information concerning an update on drug testing. President Bessent suggested a special called meeting at a future date to review and finalize the employee policy handbook.

The time clock used at the facility was discussed and the possibility of obtaining an updated version which would be a time saving device in the process of figuring payroll, and also be cost effective.



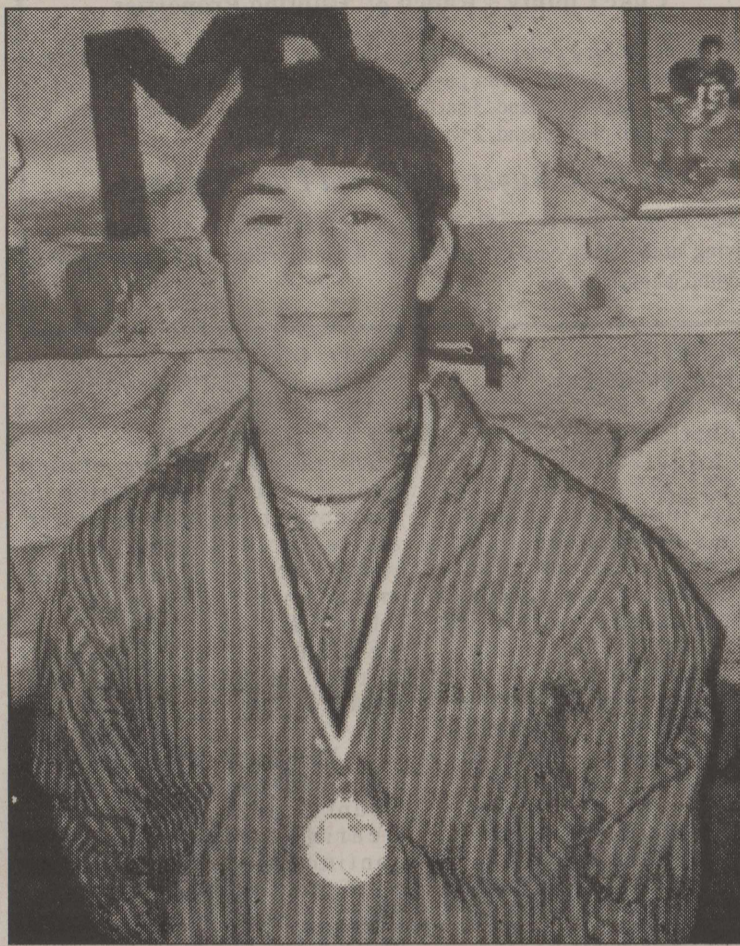

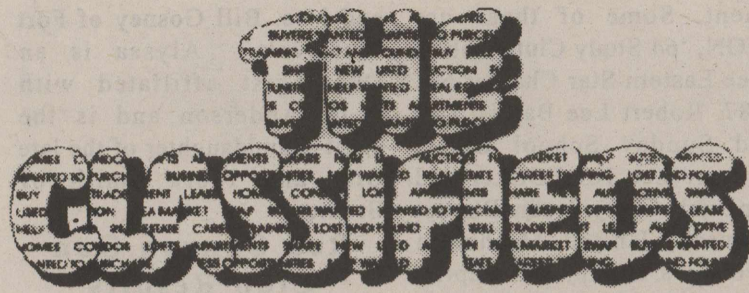

### Many Mosquito Controls Only Hammer Buyers' Pocketbook

When it comes to mosquito control devices, about the only thing that works is common sense.

Many Texas citizens are using devices or controls costing hundreds or even thousands of dollars that may offer only marginal control or may actually draw more mosquitoes onto their property.

This warning comes at a time when mosquito populations are on the rise due to warm, wet weather. It is also a time when Texans need to heed the threat of mosquito-borne diseases, such as West Nile Virus and Eastern Equine Encephalitis. Fueled by fears of mosquito-borne diseases, the market is ripe for a host of dubious mosquito control devices.

First, there are the sonic repellants. Whether wrist-band or table-top model, these devices emit a high frequency sound, inaudible to humans, that mimics the sound that male mosquitoes make. Only female mosquitoes that have already mated with males bite humans and animals. By nature of their mated status, female mosquitoes tend to ignore male mosquitoes during this period.

Good theory, but unfortunately these devices just don't work. The female's lust for blood is more on her mind than avoiding males. Also female mosquitoes are only repelled by the sound of the male mosquito when they are already gorged with a blood meal. Consequently, the sonic repellent devices tend to only chase away females that aren't prone to bite anyway.

The best thing about sonic repellants is they are generally inexpensive to buyers so you wouldn't be throwing that much money away.

Another type of sonic device supposedly attracts insects by imitating the sound of a human heartbeat. Unfortunately for the buyer, perhaps fortunately for the mosquito, the pest is not attracted by the sound of heartbeats but by the carbon dioxide and heat large mammals, such as humans, emit.

Some sonic devices also add heat to the attractive properties and draw mosquitoes into traps. If left on, they may actually trap hundreds of mosquitoes and that is fine, but the problem is that in wet areas the mosquito

headcount may be as much as several million individuals per acre.

Another type of mosquito trap goes a step further. It uses propane to produce carbon dioxide and heat to draw the mosquitoes close enough to be sucked into a fan-driven trap. Though these propane-fueled devices may trap thousands of mosquitoes in a few days, there are again generally hundreds of thousands or even millions of mosquitoes an acre to deal with, thereby overwhelming the trap and its ability to effectively limit bites. A warning flag on these devices is that they come with the caveat that they must be left on 24 hours a day, seven days a week, and then the owner will only realize a lowering of mosquito numbers in four to six weeks.

With most mosquito species weather conditions and the insect's breeding patterns will result in a decline in four to six weeks without any intervention.

As with the buy zappers, the propane-fueled devices may actually draw more mosquitoes from long distances onto your property than can be controlled to prevent bites.

What is particularly disturbing are the pesticide misting devices now on the market. There are several models, but they generally work by emitting small puffs of the insecticides at timed intervals around a house's perimeter. The devices are expensive, costing as much as \$5,000 and their effectiveness is suspect. Worse is the amount of pesticide they release into the environment over time and the possibility of inhalation by residents and the drift

of the pesticide to other properties. It is a very indiscriminate and irresponsible use of a chemical control.

The best ways to avoid mosquito bites are the tried and true methods. As mosquitoes are most active at night, limit evening activities when possible. When you do go outside, cover up and use proven repellants.

The DEET-containing repellants are still the most effective, but other products and the organic repellants will work for awhile.

Citronella candles repel mosquitoes but are most effective in enclosed patios and other confined spaces. The candles will not work if conditions are windy.

Dispose of prime breeding locations by getting rid of anything that will hold water. For areas that have standing water and can't be drained, mosquito dunks are a good buy. The dunks, shaped like small donuts, use a bacterially derived pesticide called Bacillus thuringiensis israelensis (Bti). Bti disrupts the life cycle of insects that lay their eggs in standing or running water. It is non-toxic to humans, amphibians, fish, crustaceans, adult insects, flatworms and mollusks. Neither is it toxic to insect predators of the black fly, such as dragonflies. The dunks are inexpensive, can be simply dropped into the breeding pools and generally last for months.

### Adding Value to a Calf-Crop Pays Regardless of the Market

Adding value to a calf crop involves a bit of basic "cowboyology", but is well worth the expense and effort. Husbandry practices common to large operators are often skipped by small operators. The result is dollars the producer should be getting, but isn't.

Most of these practices pay dividends every time, regardless of the market. Castrating bull calves is the

No. 1 way to increase a male calf's market value. Most Texas producers sell their calves at 450 pounds or less to avoid having to do anything with the animals. But they usually forfeit considerable income by doing so. True, younger, lighter animals usually bring more per pound than older, heavier animals, but there is just not enough pounds there to maximize the animals' full market potential.

These younger calves are also the most susceptible to getting sick. Castrate and de-horn those calves, even if you have to haul them to someone to have it done.

How much do buyers care whether or not they are castrated? Up to 450 pounds, they don't care. At 500 pounds they start caring and at 600 pounds they care quite a bit, due to the added stress castration puts on an older animal. Dollar-wise, 500 pound un-castrated calves are usually docked 3-5 dollars per 100 pounds. At 600 pounds, the penalty is closer to \$10-\$12 per 100 pounds. Horns on an older calf usually cost the seller about \$15 per head. It is the cow/calf producer's responsibility to castrate and de-horn his calves. Do it and pocket the money.

Bull calves gain faster than steers of the same class and size, but growth implants can change that ratio. Implants currently on the market cost \$1-\$1.25 per head. The added gain usually averages 20-30 pounds per head. Never implant bulls or the adverse affect on an intact male may cost the producer money.

Should you implant heifers you intend to keep? There is no incentive to implant replacement heifers. Does implanting affect a heifer's fertility? Researchers say 90 percent of the time, there is no problem. If you are undecided whether or not you are going to keep or sell the heifer, go ahead and implant her for the 20 pounds or so gain you will get.

De-worming nursing calves is nothing new, but few producers do it in this area. Timing is critical. The month of May is the best time to de-worm Texas calves because that is when moist, warm conditions make the parasites active and calves have the most potential for growth.

De-worming is as economical as implanting. Like implanting, it cost about a buck a head, and stacks up as much as 20-25 pounds per head advantage over non-de-wormed calves.

Older cattle, cows and bulls benefit from an occasional worming, but across much of Texas it is best to allocate the de-wormer to the calves and yearlings. They need it the most and will benefit from it the most.

Fly control is important, but frustrating. Mis-use of pesticides has led to insects resistant to most products on the market. Producers using ear-tags should put one tag in both ears of every animal and remove them when they are no longer working. Tags should be rotated between an organophosphate tag and a type containing a pyrethroid to minimize resistance.

Cattle grub problems have increased in recent years. Treat with a pour-one or an injectable product in mid-summer.

Producers doctoring cattle for parasites should buy products which don't harm dung beetles. Research has found that the dung beetle contributes to pasture health and the reduction of parasites of cattle.

Vaccinations are more of an insurance policy than anything else. Check with a local veterinarian to find what is needed in a given area.

When a producer says "Yeah, they've had all their shots," 90 percent of the time that means they've only been vaccinated against blackleg. Leptospirosis is the most prevalent disease in Texas cow herds today. It, and a seven-way blackleg vaccine, need to be in any good vaccination program of young cattle. Saving one calf will pay for an awful lot of vaccine at today's cattle prices.

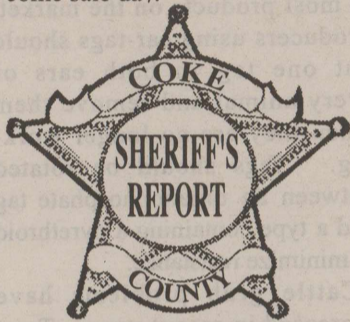

Branding is another important practice most small operators skip. It is recommended to fire brand, since other methods are too easily botched.

Use a small, well-vented iron on the corners of the cow. Brand on the lower shoulder or upper hip away from the prime leather areas. There aren't many luxury car owners who would be happy sitting on a rafter-C brand or something similar, every time they crawled into their car.

Do the numbers. Most of these practices will make you money every time. None are new, but many producers continually neglect them. If you can't do the husbandry yourself, or don't have the facilities, haul the calves to someone who can process them for you. Chances are, you'll be happy you did, come sale day.

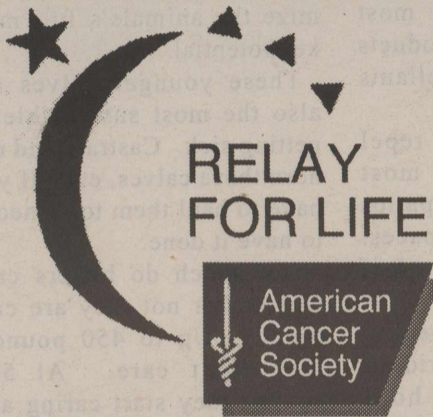

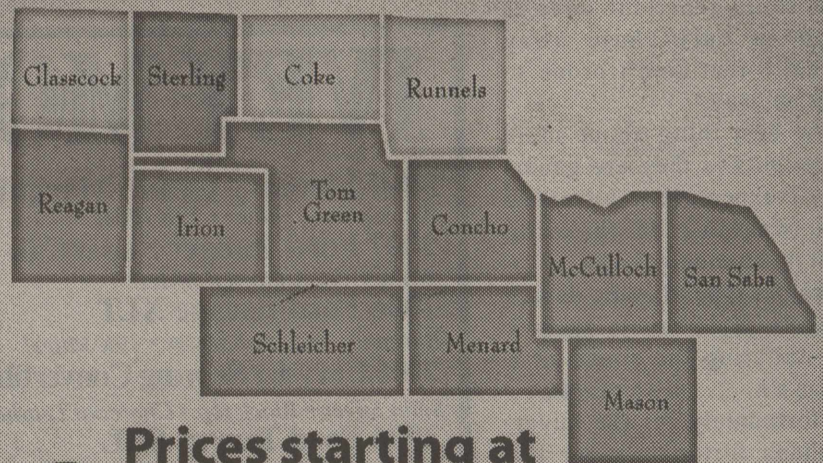
