

#### Alex Saldana suspect in Stephen Adams' death

(Editor's note: The following article was originally printed in the November 19, 2008 edition of the Midland Reporter.)

More charges were filed against the Midland man who allegedly shot and killed another man in a Whataburger parking lot Sunday morning.

Alex Ricardo Saldana, 22, was charged with aggravated assault with a deadly weapon, a second degree felony late Tuesday. The charge is in connection with his allegedly firing his weapon in the direction of another victim.

The second victim was not struck by the shots fired.

The Midland District Attorney's office is looking at the possibility of adding additional charges to Saldana as well. There were other individuals who were threatened and shot at during Sunday morning's incident, according to District Attorney Teresa Clingman.

On Sunday morning, Midland police responded to the Whataburger restaurant near the intersection of Wadley Avenue and Midkiff Road. There, they found that 44-year old Stephen Adams had been shot and killed when Saldana allegedly fired his weapon randomly into the crowded parking lot.

Less than 15 minutes later, MPD arrived at Saldana's home, in the 3600 block of Louisiana Avenue, and arrested him.

He remained at the Midland County Jail late Wednesday on the first-degree felony charge of murder and the new charge of assault.

His total bond amount is now raised to \$350,000.





I buy a frozen turkey or a fresh one? How do I store my turkey?

A few simple steps will not only ease your holiday fears, and a safe meal for you, your following information may help you prepare your special Thanksgiving meal and help holiday.

Plan Ahead beth

Plan your menu several weeks before the holiday. Shopping early will ease the countdown tension for your Thanksgiving meal. Ask these questions to help plan your meal. Do you want a fresh or frozen turkey? Do you have enough space to store a frozen bird if purchased in advance; if not, when should you purchase a turkey? What size bird do you need to buy?

turkey should I buy? Should fresh turkey, be sure you purchase it only 1-2 days before cooking. Do not buy a prestuffed fresh turkey.

What Size Turkey to Purchase Here is a good rule of thumb but will ensure a delicious to follow, whole bird one pound per person; boneless breast of family, and your friends. The turkey one half pound per person; breast of turkey three fourths pound per person. Thawing in refrigerator, place you countdown to the frozen bird in original wrapper in the refrigerator. Allow approximately 24 hours per 4 to 5 pounds of turkey. A thawed turkey can remain in the refrigerator for 1-2 days. Thawing time in the Refrigerator depends on the size of turkey:

- 4 to 12 pounds 1 to 3 days
- 12 to 16 pounds 3 to 4 days
- 16 to 20 pounds 4 to 5 days
- 20 to 24 pounds 5 to 6 days.

Preparation takes time for a Thanksgiving meal, the day before Thanksgiving, make sure you have all the ingredients you need to prepare your holiday meal. 



**STATE OF TEXAS COUNTY OF COKE ORDER RESTRICTING OUTDOOR BURNING** 

WHEREAS, the Commissioners Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning.

IT IS HEREBY ORDERED by the Commissioners Court of Coke County that outdoor burning is restricted in the unincorporated area of the county for 90 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code §352.081, and other applicable statutes. This Order does not prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training: (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting of agricultural crops; or, (4) burns that are conducted by a prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

BE IT ALSO ORDERED THAT the purpose of this order is the mitigation of the hazard posed by wildfires by curtailing the practice of outdoor burning, with the exception of barbecuing in an enclosed fire box with water hose or fire retardant accessible at all times and someone attending the fire at all times, and materials used outdoors in activities such as welding and any other activity that could result in a fire. The purpose is to be taken into account in any enforcement action based upon this order. A. Burns that are conducted after submission of a Natural **Resources Conservation** Service approved burn plan to the Coke County Judge. Burns conducted under this section must meet the following conditions: 1. Prior to beginning a burn

2. The person giving notification to the Sheriff's office must identify the area to be burned by describing the pasture or range by address, by location of County Road or State Highway, and also must give the name of the person requesting the burn;

3. A water sprayer apparatus or water containers and other fire fighting tools must be available on site;

4. Fire guards are to be used whenever possible;

5. Wind speeds must not exceed 15 MPH;

6. The Humidity index must be 20% or higher as determined by the Texas Forest Service for Coke County; and,

7. A cellular telephone or other reliable radio communication must be available on site for emergency notification and response.

B. Outdoor welding or cutting and grinding associated with welding activities are permitted under the following circumstances:

1. Welding and cutting and grinding associated with welding activities shall not take place when the wind is over 15 miles per hour;

2. The welder must notify the Coke County Sheriff's Department before any welding, cutting or grinding begins;

3. All grass, leaves, brush

hand before any welding, cutting or grinding begins and remain on hand until the activity is completed.

C. Burning of household trash is permitted under the following conditions:

1. Shall take place only when the wind speed is 15 miles per hour or less:

2. All grass, leaves, brush and other easily combustible materials must be cleared within a fifty (50) foot radius surrounding the area where the activity is to take place and before any burning of trash begins;

3. The burning takes place in a container with a mesh cover; and

4. A spotter with water and a ready pressurized delivery system must be on hand before any burning begins and remain on hand until the burning is completed.

D. Outdoor cooking is permitted under the following conditions:

1. Shall take place only when the wind speed is 15 miles per hour or less;

2. All grass, leaves, brush and other easily combustible materials must be cleared within a fifty (50) foot radius surrounding the area where the activity is to take place and before any outdoor cooking begins; and,

3. A spotter with water and a ready pressurized delivery system must be on hand before any outdoor cooking begins and remain on hand until the outdoor cooking is completed.

In accordance with Local Government §352.081 (h), a violation of this Order is a class C misdemeanor, punishable by a fine not to exceed \$500.00. ADOPTED this 24th day of November, 2008 Roy Blair, County Judge Attest: Mary Grim,

On Thanksgiving day be sure and judge your cooking time for your turkey. The times will help you have a easier time in the kitchen and done turkey on time. These times are approximate. Turkey that weighs:

• 8 to 12 pounds - 2 3/4 to 3 hours

• 12 to 14 pounds - 3 to 3 3/4 hours

4 1/4 hours

4 1/2 hours

• 20 to 24 pounds - 4 1/2 to 5 hours

Cooking temperature for all turkey is 325 degrees.

Use a food thermometer to check the internal temperature of the turkey. A whole turkey is safe cooked to a minimum internal temperature of 165 °F throughout the bird. Check the internal temperature in the innermost part of the thigh and wing and the thickest part of the breast. All turkey meat, including any that remains pink, is safe to eat as soon as all parts reach at least 165 °F. The stuffing should reach 165 °F.

When turkey is removed from the oven, let it stand 20 minutes then carve the turkey.



#### Letter to the Editor "We The People"

By Jim Clendennen Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

The First Amendment has largely been ignored and misconstrued for years. Remember when small towns used to display a montage with Santa Claus, Reindeer, a Christmas tree, and a Manger scene in the town square. The public school opened each day with the pledge of allegiance to the flag. The high school football games were preceded by a prayer spoken over the stadium's public address speakers. This took place for years before the American Civil Liberties Union stepped in to assault our Constitution, the pledge, and the prayer. The action ACLU took has been through countless lawsuits against cities and schools.

Unfortunately most towns and schools have caved in and Manger scenes are disappearing. The pledge of allegiance has been omitted, and the prayer replaced by a moment of optional silence. The Christmas trees have been renamed "Holiday Trees".

Watch for another attack on the First Amendment. The progressive-liberals in Congress will probably pass the "Fairness Doctrine" and President Obama will sign it. The "Fairness Doctrine" will classify radio programs such as Rush Limbaugh, Mark Levin, NRA News, Sean Hannity and others promoting conservative ideas as being "unfair". 
