(1) Round up, (2) cutting the calves out and bringing little ones int to the area where work is to be done, (3) vaccinating, marking ears, branding, oiling ears for ticks, and then that delicate operation, depending on the sex. These cowboys know what they are doing. Note the hold of the man in picture #1, left knee on the neck, foreleg bent. Note the man with the vaccinating needle in his hand, he steps on the other foreleg as he applies the needle. There's also a man partially seen in the background that's holding his hand and with his right foot against the other leg to keep it from kicking. In picture #2 it shows three men holding as the brand is applied. Note the cowboy on the right with both feet firmly planted against the animal and the top leg stretched out. No, the calf's not choking to death, he's bellowing.



Have you ever gone to a park just to observe the birds, watch the pigeons and the sea gulls? How about a 16 year old boy swinging the hand of a 15 year old girl? Have you ever ridden on a bus and enjoyed a pleasant conversation from across the aisle, or observed a young mother and how attentive she is to her first born?

Why, it was just yesterday when I was sitting in the school cafeteria and the 4th grade boys were discussing the pros and cons of the post office. I looked a little more the other way, ate slower and slower as they kept discussing the post office.

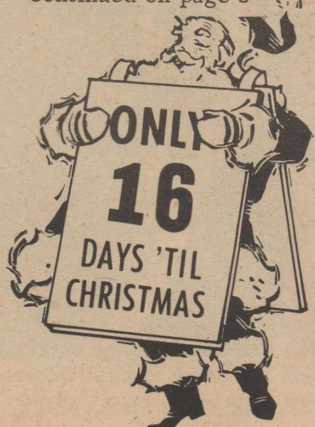

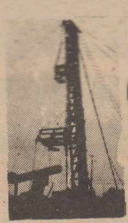

# Farm hand

In 1924, forty-six years ago, Jim Golden and family moved to Seminole from Coppers Cove in Coryell County. "We moved to Seagraves in a box car and on out to Fairview by wagons." The livestock, he went on to say, included one milk cow and six horses and mules. "Yes, I remember how much cotton I made that first year - three bales, but we had some good gooseneck maize and raised some good corn. I had 320 acres in all, with 150 in cultivation. We traded in Seminole, Dr. Richards was our doctor. Cothes Drug was where we bought our drugs. There were not too many people in town then and everybody had to learn to help each other."

Concerning old times, he went ahead and related about buying his first car in 1918 for \$350. "We drove it for one year. Times got hard and we left it setting in the shed the next two, we didn't have any money to buy gas. The tires on the front were 30x2.5, the ones on the rear 30x3.5. I'll tell you, that Model T would pull mud axle deep, but would pull very little sand."

"In 1936 I bought my first tractor, a four-row Moline MTA. It listed three rows and planted four. Yes, I tried to run a row binder way back then but they'd throw you out of the church for just trying to run a row binder. I recall throwing back a gap (gate) and the four of them (horses and mules) ran away with my row binder and they got to hitting the posts and I'll tell you, there was little of it left. There were few antelope left in those days, especially at Five Wells and there was lots of prairie chickens."

The occasion was Mr. Jim's 80th birthday, who still rounds up cattle, doctors cattle, drives a tractor and discusses about his kin-folks living to be near 100. He explained longevity something like this. "When the belts jump off, we die, and my arthritis bothers me when I work." The Jim Golden farm is 14 miles east and one mile south.

**THE SEMINOLE AREA CHAMBER OF COMMERCE HAS ENDORSED PROPOSITION NUMBER ONE IN THE SCHEDULED BOND ELECTION ON DECEMBER 19TH**

These are some of the reasons why we endorse Proposition Number One.

1. The Gaines County Hospital Survey recommended that one 50 bed hospital be built in Gaines County and located in Seminole.
2. A 50 bed hospital would be large enough to attract and provide adequate facilities for doctors and nurses.
3. A 50 bed hospital would provide better patient care for our county.
4. Federal and State requirements for hospitals are increasing steadily.
5. An adequate 50 bed hospital would provide better patient care for the increasing number of Medicare patients.
6. We need to be able to provide continuing and better patient care for our citizens who are 65 and older.
7. There is a high mortality rate for small hospitals.
8. There is a growing trend toward area wide consolidation of hospitals.
9. No hospital in our area that has under 50 beds is approved by the Joint Commission on accreditation of hospitals.
10. To be able to bring State and Federal funds back to Seminole.
11. Reduce unnecessary loss of time and money spent in other counties because of the lack of doctors and services here.
12. If we have large enough facilities we can accommodate three or more doctors.
13. Industry and people will not locate in a town that does not have adequate medical facilities.

The following is a reproduction of the recommendation made to the Commissioners Court by the consulting firm of O'Connell and Probst who made an impartial and unbiased survey of the medical needs of Gaines County.

**GAINES COUNTY HOSPITAL SURVEY**

21 May 1970

Revised

27 July 1970

**Recommendations**

**1. One Facility**

We recommend to the Court that a single adequate hospital facility for serving the medical requirements of citizens of Gaines County be established. It is a well known fact that the supply of health career personnel is very limited. Combining the two small units into a single unit would allow the same number of personnel to care for a greater number of patients. Conversely, a smaller number of staff could care for the same number of patients presently being hospitalized. A single facility would eliminate a duplication of building, equipment, and supplies. It would provide a more efficient use of space. And finally, it should provide better patient care to the public by attracting the young and new health career professionals.

**2. Location**

We recommend that a new facility be constructed in Seminole and located on the highway leading to Seagraves. Seminole is near the geographic center of the county. The majority of the population is in Seminole and thence to the north and east. This we believe would be the most convenient location for the majority of the people of Gaines County. We have considered the suggestion of a location near the county park approximately half-way between Seagraves and Seminole and cannot find justification for locating the facility in an isolated area. If the remodeling and expansion program is considered by the Court to be the best solution to the problem, then the site should be Memorial Hospital in Seminole with the acquisition of additional land.

**HIGH SCHOOL LIBRARY**  
by MRS. P. A. MORGAN

Seminole High School Library is one of the finest, most modern libraries to be found anywhere in West Texas. Under the capable supervision of Mrs. Janelle Sullivan, the library serves 599 students. Mrs. Sullivan has been librarian since 1962. She was joined by Mrs. Juanita Morgan, library clerk, in 1964. "Service is our primary aim," said Mrs. Sullivan. A wide variety of materials are provided to give a balanced collection from which students may read and evaluate with discrimination all facets of a subject.

The library has been in its present location since 1965. The 4,000 square feet of floor space, with a comfortable seating capacity of 120 in the library proper, houses more than 10,260 books. There are also three conference rooms, librarian's office, workroom, and magazine room. In addition two classrooms and a faculty room join the library. The library subscribes to 75 periodicals. Back issues are kept for five years for research work. A number of magazines are bound volumes dating as far back as January 1964. Also housed in the library are 785 filmstrips, 278 records, and 67 sets of transparencies. Films, such as 16 mm, are rented to assist in teaching.

The library subscribes to ten newspapers, namely, the Austin American Statesman, Odessa American, Lubbock Avalanche Journal, Ft. Worth Star Telegram, Hobbs News Sun, National Observer, Christian Science Monitor, Texas Observer, Seminole News and Seminole Sentinel. All English books under the phasing program are checked out through the library. A careful record must be kept on the 4,240 books, plus hundreds of pamphlets and books that are used to assist in the teaching of research techniques and mass communications.

The library is open each day from 8:00 a.m. until 4:00 p.m. Since classes are over at 3:10 on most of the school days, ample time is provided for students who want to use the library when they are not in classes.

Student library assistants work each hour during the day and receive a half credit in library for working two semesters. This year the assistants are Tanya Driver, Jerry Woodard, Ora Mitchell, Marsha Wakefield, Luann Locke, Helen Morris, Frances Riojas, Gary Matthews, Cecil Holbrooks, Linda Hancock, who types in Junior High Library, and Russ Mabry, who works in the Primary School Library.

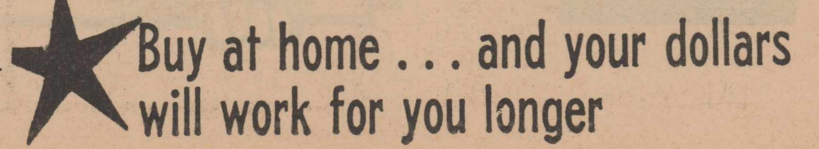
5. That the Commissioners Court hereby orders and covenants that if either of the aforesaid Propositions should carry, the Commissioners Court shall issue bonds in not to exceed the amount and for the purpose set forth in the Proposition which carries; provided that if both of the aforesaid Propositions should carry, the Proposition receiving the greater aggregate number of "FOR" votes shall be declared adopted, and bonds shall be issued by the Commissioners Court in not to exceed the amount and for the purpose set forth in the Proposition receiving the greater aggregate number of "FOR" votes, and the bonds authorized by the other Proposition shall be void and shall never be issued.

We will begin a fund raising campaign very soon and hope to be able to raise at least \$7,500.00 which will enable us to complete our obligation, to Dr. Howell and have some funds to use in the event other interested medical personnel have need of our service.

### CARRIE RICHARDS FUNERAL HELD

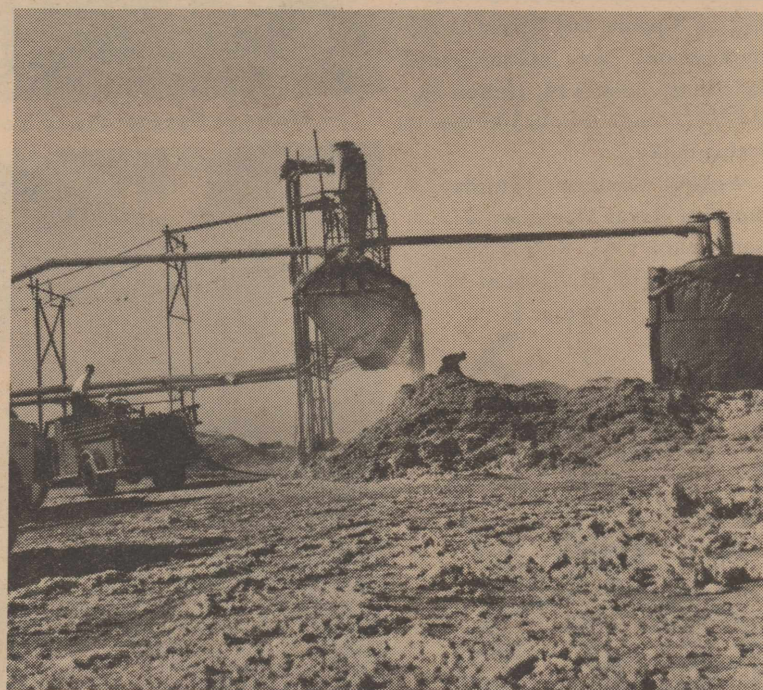

Survivors include a niece, Miss Nuel Mitchell of Seminole.

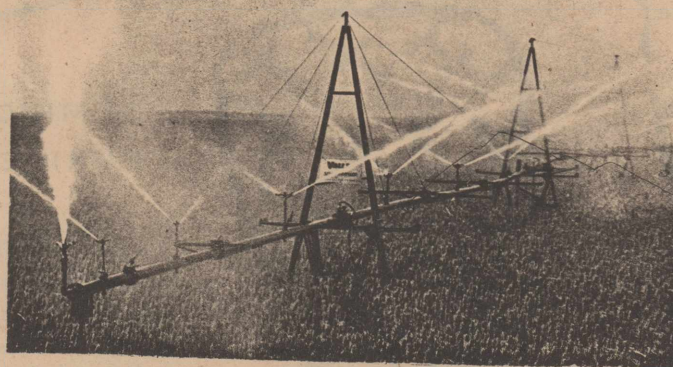

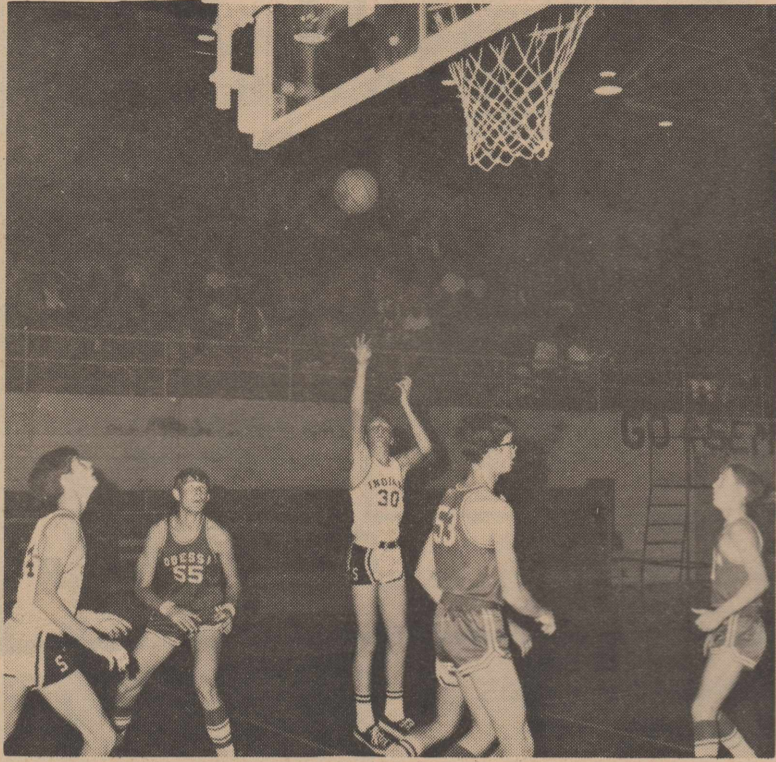

# SEMINOLE B-TEAM

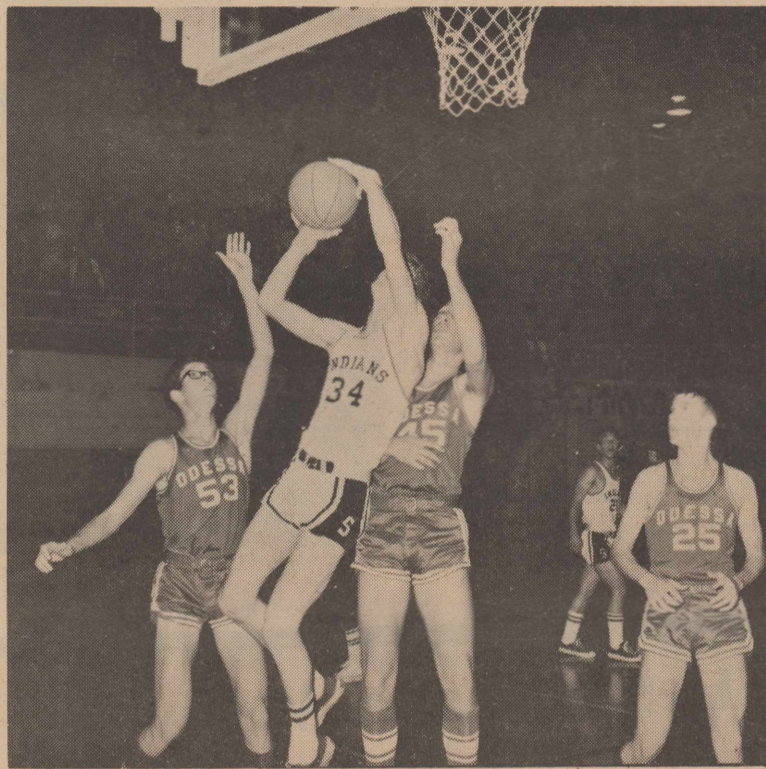

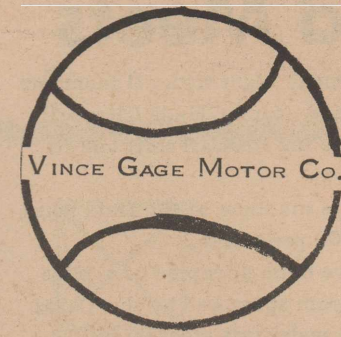

Danny Farris fires for the B-team.



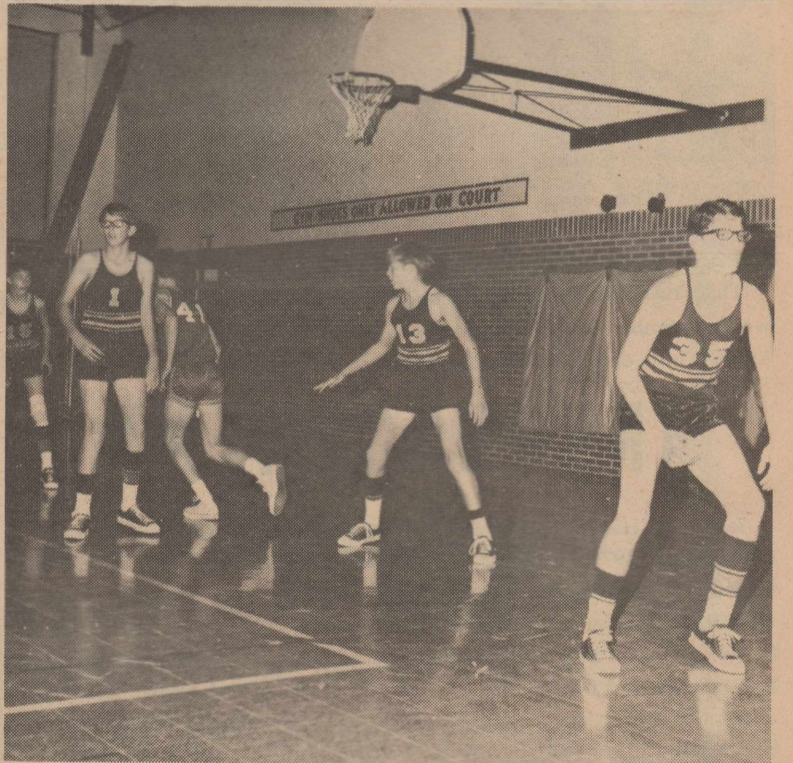

er and were behind by 5. But, oh, that 4th quarter. They managed only 1 free throw, by Stan Hughes, and Brownfield ran wild.

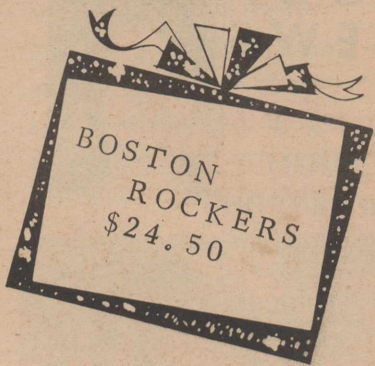

Dear Editor:

Isn't it wonderful to live in a progressive county where industry has confidence in the community. But, isn't it a shame when a few panic stricken, pessimistic people can spread a cloud of gloom over such a wonderful area as our? Of course, I am referring to the incorrect information that the neighboring chamber of commerce placed in your paper last week.

They stated that our taxes would increase 25%. This could not happen because the cost of the bonds will not exceed \$2.2 million at the most. For a county our size the raise in taxes will be small. The real crisis that Gaines County faces is not a tax crisis but whether we will have adequate medical facilities to treat the sick, the industrial accidents, to care for the elderly, and last, but not by any means the least important, the assurance that if your child or mine gets sick or hurt that we will have facilities to meet the needs that arise.

Yes, the present Seminole hospital ran in the red this year, but did you know that they have collected well over 80% of the bills? The red ink was caused because our facilities were inadequate. Of course, if someone leased Seminole a hospital for one dollar (\$1.00) a year it could run in the black, also. (If clinic and hospital were together there would be a better chance for a profit.)

Gaines County has in the past assisted the residents in the northeastern part of the county. They lease them an entire hospital for one dollar (\$1.00). We even pay through an equalization tax of \$.40 per hundred dollars to the Seagraves and Loop Independent School Districts. This will amount to \$125,000 or more this year to Seagraves. If Seminole didn't want to do this they could stop it by voting an independent school district.

What a shame when a few in number try to control the destiny of the majority. But, we find a loud vocal minority across our nation today that is against progress.

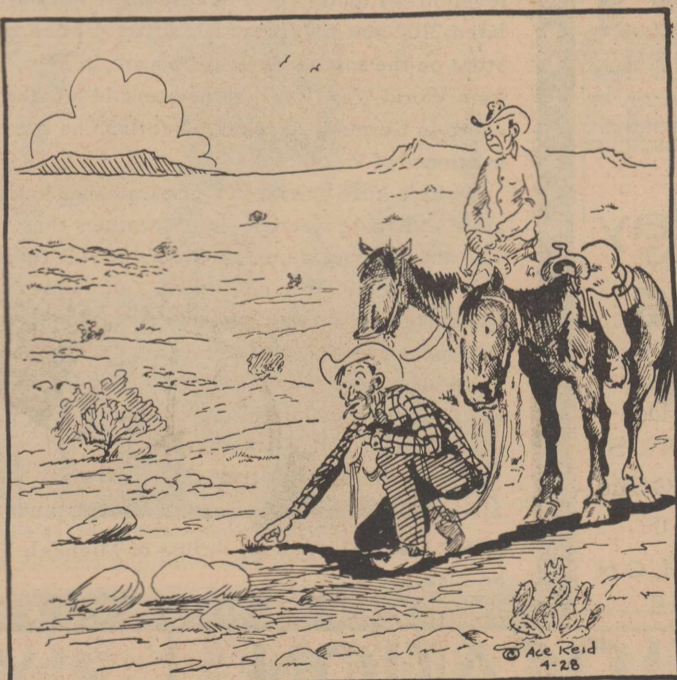
