Sun Shines Through the Smoke! The sun peeps through the heavy smoke as the White Hat fire prepares to jump Highway 70 north of Blackwell Monday evening. The fire began Sunday afternoon of undetermined causes somewhere on or around the Arledge, Austin, Adams Ranch area in north central Coke County. No Forest Service assistance was available to the Coke County firefighters the first day. Several volunteer fire departments joined with the Robert Lee, Bronte and Blackwell Volunteer units to battle the blaze, located in extremely rough terrain. Firefighters came at it from every side, saving several residences in the process. It jumped FM 1170 between Maryneal and Blackwell just after lunch on Monday and raged northeast. The fire continued to rage through Tuesday evening until heavy rain fell and quenched the flames.

Many of our county officials, employees, private contractors and volunteers put in over 24 hours at a time fighting this latest fire. Emergency vehicles and equipment are deteriorating rapidly as these fires roll through the roughest terrain of Coke County. At press time, no exact acreage estimates or complete damage estimates were available. In next week's issue of the Observer/Enterprise, we hope to include a map showing all the burned area in Coke County beginning with the Wildcat Fire.

City of Robert Lee to further restrict outdoor watering

In order to comply with City Ordinance #1140 Drought Contingency Plan, passed and approved July 10, 2006, the City must achieve a 35% reduction in daily demand. Therefore, the Robert Lee City Council has initiated the next step of Stage 3 Water Shortage Restrictions. As of July 1, there will be no outside watering (household use only). Violators will be fined up to \$500.00 for each offense. If a 35% reduction is not achieved, the next phase will be a pro-rata allocation of water per customer with a surcharge of five times the normal water charge for water deliveries in excess of the monthly allocation.

These steps may seem severe, but the extended drought, three major fires, and extreme heat and wind conditions have taken a toll on area lakes. The water well field that the Upper Colorado River Authority is developing is moving forward but not at a rate that is keeping up with conditions. The City of Robert Lee is also working with the Texas Division of Emergency Management to seek help with an interconnection with

Junior Golf Play Day Set

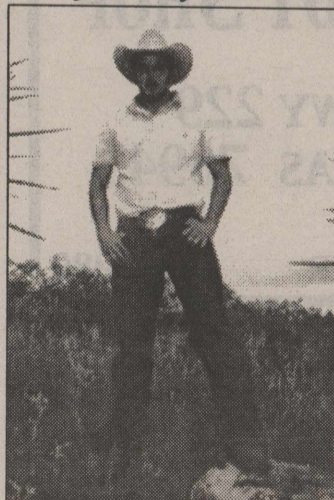
A play day for junior golfers has been set for 9 am Wednesday, June 29, at the Longhorn Golf Course in Bronte.

Members present included Wes Washam, Jeffie Roberts, Beverly Sinclair, Tom Sawyer, Irma Torres, Brandi Brosh and Tracy Allen.

The invocation and pledge were led by Beverly Sinclair.

Rusty Hodges with W.B. Kibler attended the meeting and gave an update on the construction project. The Board recessed for a tour at 6:12 pm and reconvened into open session at 6:41 pm.

Jeffie Roberts made a motion to approve the

minutes of June 13, 2011, with corrections, seconded by Tom Sawyer. All voted for.

Tom Sawyer made a motion to accept the financial report presented by Robin Allen and to pay the bills, seconded by Irma Torres. All voted for.

Supt. Hood considered any matters related to 2008 Construction Project.

A motion was made by Jeffie Roberts and seconded by Brandi Brosh to adjourn meeting at 7:37 pm. All voted for.

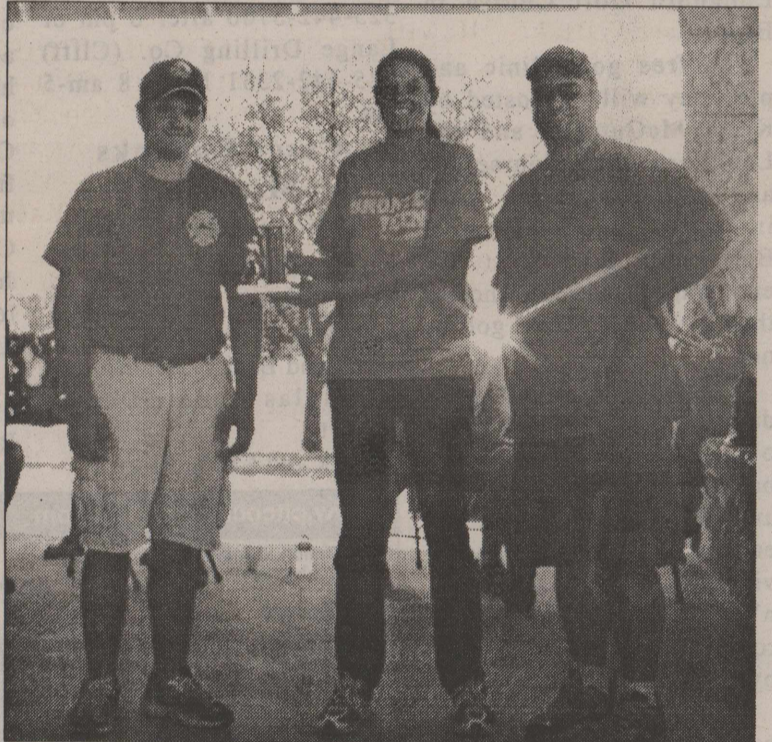
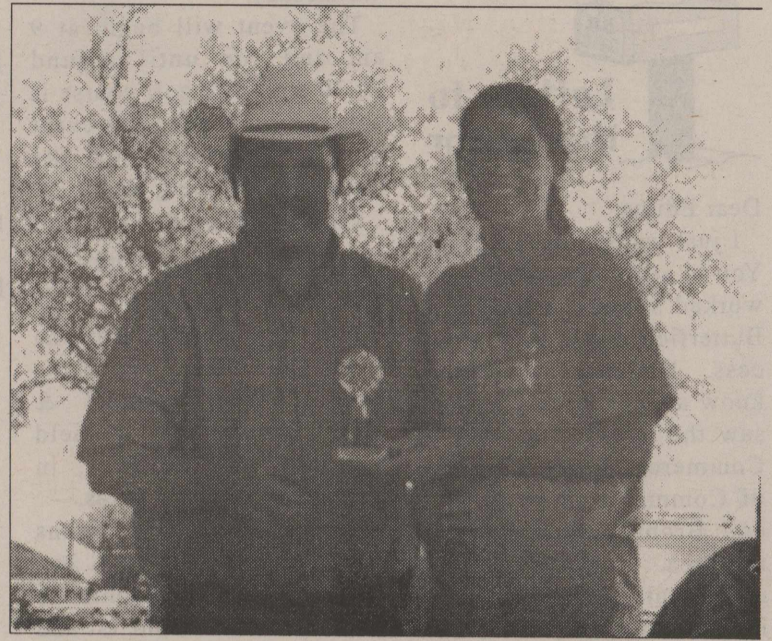
USDA/FSA

Program signup for ECP & LEP deadline is July 1

The deadline to sign up for the ECP program is July 1, 2011. This program is for cost share assistance for fence loss due to the wildfires.

Coke County became eligible for the Livestock Forage Program (LFP) April 19, 2011. This program provides payments to producers for losses suffered in 2011 due to dry conditions. To be eligible, grass acreage must be covered by a NAP policy or Rainfall Insurance. At the time of signup, you will need to provide proof of insurance, copies of leases and livestock numbers. Qualifying livestock must have been owned 60 days prior to April 19. Producers have until January 30, 2012 to make an application.

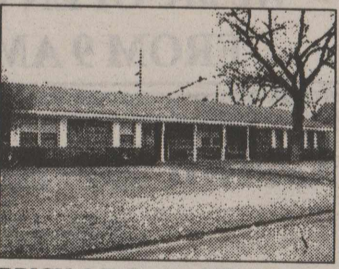

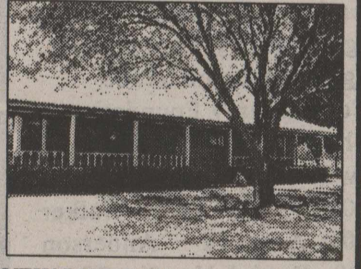

DECLARATION OF DISASTER AND ORDER PROHIBITING OUTDOOR BURNING FOR COKE COUNTY, TEXAS

WHEREAS, Coke County, has been affected by recent wildland fires and continues to be threatened by high or extreme wildland fire hazard. This threat is caused by abundant fuel and extreme dry and windy conditions across the State of Texas and in Coke County, and ;

WHEREAS, extraordinary measures must be taken to alleviate the suffering of people and to protect and/or rehabilitate property;

NOW THEREFORE, IN ACCORDANCE WITH THE AUTHORITY VESTED IN THE COKE COUNTY JUDGE BY SECTION 418.108 OF THE TEXAS GOVERNMENT CODE, I DO HEREBY PROCLAIM THE EXISTENCE OF SUCH DISASTER AND DIRECT THAT ALL NECESSARY MEASURES BOTH PUBLIC AND PRIVATE AS AUTHORIZED BY THE LAWS OF THE STATE OF TEXAS BE IMPLEMENTED TO MEET THAT DISASTER:

1. That a local state of disaster is hereby proclaimed for Coke County pursuant to Section 418.108 (a) of the Texas Government Code.

2. Pursuant to Section 418.108 (b) of the Government Code, this Declaration of a local state of disaster shall continue for seven (7) days unless extended by the Coke County Commissioners' Court and then for so long as such conditions.

3. Pursuant to Section 418.108 (c) of the Government Code, this Declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk of Coke County.

4. Pursuant to Section 418.108 (d) of the Government Code, this Declaration of a local state of disaster activates the Coke County Emergency Management Plan.

5. The purpose of this order is the mitigation of the hazard posed by wildfires by curtailing the practice of outdoor burning, which purpose is to be taken into account in any enforcement action based upon this order.

BE IT THEREFORE ORDERED that the following emergency regulations are hereby established for all unincorporated areas of Coke County, Texas for the duration of the declaration;

(1) Actions Prohibited:
(a) All outdoor burning of any combustible material is prohibited. A person violates this order if he burns any combustible material or

orders such burning by others.

(b) The sale and use of all fireworks.

(2) Actions Allowed
(a) Any propane cooking, and outdoor cooking fires as long as they are under the supervision and control of an authorized Volunteer Fire Department.

(3) Enforcement:
(a) Upon notification of suspected outdoor burning, the fire department assigned to the location of the fire shall respond to the scene and take immediate measures to contain and/or extinguish the fire.

(b) As soon as possible, a duly-commissioned peace officer shall be sent to the scene to investigate the nature of the fire.

(c) If in the opinion of the officer at the scene and/or the Fire Chief, the goal of the order can be attained by informing the responsible party about the prohibitions established by this order, the officer may, at

his discretion, notify the party about the provisions of this order and request compliance with it. In such instances, an entry of the notification shall be made into the dispatchers log containing the time, date, and place of the warning, and the name of the person receiving the warning.

(4) At the discretion of the peace officer and/or Fire Chief, subsequent or flagrant violations of this order may be prosecuted in accordance with the statutes and procedures governing misdemeanors.

BE IT ALSO ORDERED that this order may be enforced by any duly-commissioned peace officer and that the venue for prosecution of this order will be the Justice of the Peace Court, Coke County, Texas.

This Declaration and Order shall take effect immediately from and after its issuance and continue for a period of seven (7) days unless extended by the Coke County

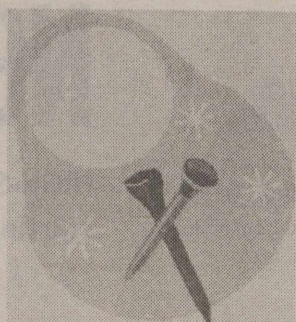

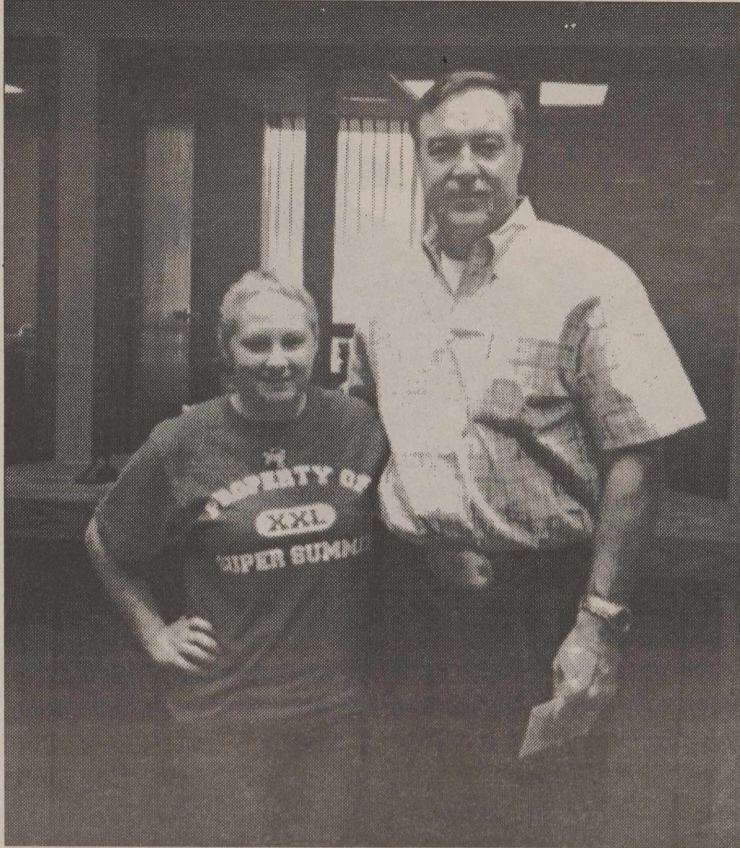

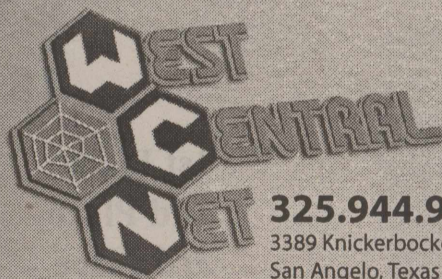
