#### **Primary Election is** Tuesday, March 4

Early voting, which began Tuesday, February 18, 2014, for the March 4th Primary Election ends today, Friday, February 28, 2014.

Voters who wish to vote early today must do so at the courthouse between 8 am and 1

On election day, Precincts 1 and 3 will be voting at the courthouse. Precincts 2 and 4 will vote at the Bronte Senior Citizens Building. Voting hours are from 7 am to 7 pm.

Only two local offices will have contested races. Coke County Commissioners in both Precincts 2 and 4 will face challengers. Currently, these offices are held by Wendell Lee in Precinct 2 and Bobby Blaylock in Precinct 4. Facing Lee for Commissioner Precinct 2 is Paul Williams. Blaylock is being challenged by Joe Sefcik for Commissioner Precinct 4. Political profiles begin on page 3 of this issue of The Observer/ Enterprise.

Incumbents without opponents filing to retain their positions include: Roy Blair, County Judge; Mary Grim, County/District Clerk; Hal Spain, County Treasurer; Jackie Walker, Justice of the Peace, Precinct 1; and Grady Coulter, Justice of the Peace, Precinct 2. All of the above offices except for Justice of the Peace, Precinct 2, are in the Republican Primary.

Potential candidates in the upcoming May 10, 2013, local entity election may file for their place on the ballot until today, Friday, February 28, 2014.

There are three two-year city council member terms and the mayoral office on the ballot for the City of Bronte. Mayor Gerald Sandusky has filed for re-election. Incumbents Paul "Buzz" Gohmann and Jimmie Guthrie have filed to retain their council seats. Stautzenberger has filed for the re-election. remaining council position.

There are two council member terms and the mayoral office on the ballot for the City of Robert Lee. Currently, these council seats are held Mayor John Jacobs and council members Sid Burns and Richard Johnson. As of presstime, there have been no filings for these offices. Applications can be picked up at the Robert Lee City Hall from 8 am to 12 noon and 1 pm to 5 pm Monday through Friday. To be eligible for the office of Mayor a person must be a registered voter and must have lived within the city for at least 12 months preceding the date of election day. To be eligible for the office of city council a person must be a registered voter and must live within the city on the date of the election.

> Judge Blair recessed the meeting at 9:10 am for no longer than 72 hours.






