Open Carry has been passed by the Texas Legislature and signed into law by Governor Greg Abbott. The law takes effect January 1, 2016, for all those who already hold a Texas Concealed Carry

Open Carry becomes the law in Texas

Governor Greg recently signed the law legalizing openly wearing handguns by residents of Texas who hold Concealed Carry licenses. The law will take effect on January 1,

One group may have had a great deal to do with this moving through the Texas government and becoming law. Many may remember seeing a story on social media about a man and his child walking down a country road with a hunting rifle and being reported to local law enforcement. The interaction with this officer and the fear expressed by the caller planted the seed for the involved man. C. J. Grisham, to found Open Carry Texas (OCT). OCT is a registered non-profit organization dedicated to the safe and legal carry of firearms openly An the state of Texas in accordance with the United States and Texas Constitutions and any applicable laws.

· The organization includes four purposes in their mission statement.

1. Educate all Texans about their right to openly carry rifles, shotguns, and black powder revolvers in a safe manner.

2. Condition Texans to feel safe around law-abiding citizens that choose to open carry.

to pass less restrictive open carry legislation.

Unfortunately Texas is not as gun-friendly as most people think. Prior to this year, Texas was one of only a handful of states not allowing any form of public open carry. Forty-four states allow some form of legalopen carry, and of those states, thirty-one of those states do not even require a license. The only states refusing to allow any form open carry are now


California, Illinois, Florida, South Carolina, New York and Washington, DC.

Constitutional Carry basically means that if you can legally own a gun, you are able to carry it openly or concealed.



Texas ranchers rebuilding herds, lower beef prices to come

Despite recent flooding rains wreaking havoc on Texas farmers, there is a bright spot for agriculture and consumers.

Ranchers across the state, including County, are now working to rebuild their cattle herds. The heavy rains will help Texas pastures recover from the many years of drought and fill soil profiles with water.

The greener pastures on the horizon are good news for consumers, too.

"Years of drought devastated pastures, leaving virtually nothing for cows to eat," said Coke County Farm Bureau President John Ross Copeland. "Ranchers were forced to sell cattle, which resulted in low

numbers and higher beef prices for consumers."

With help from recordbreaking rainfall in May, pasture conditions statewide are the best since 2007 and above the national average.

"This was just what was needed to recover from the drought," said. "It's the key ingredient to rebuilding the largest beef herd in the nation."

The overall beef supply should increase as Texas ranchers restock their herds, and consumers will eventually see a drop in beef prices. Although, noted, the lower prices won't happen overnight.

Final water rule adds risk, uncertainty for Texas

A final rule by the Environmental Protection Agency (EPA) will expand its authority under the Clean Water Act and could leave Texas agriculture mired in regulation.

After months of debate, thousands of comments from farmers and ranchers including 1,200 from Texas and direction from Congress, EPA moved forward on their interpretation of the rule.

"The agency will have more power to regulate farmers, ranchers, landowners and other businesses under this final Waters of the U.S. (WOTUS) rule,"County President John Ross Copeland said. "It's troubling for County agriculture and local businesses."

An initial review of the 88page rule shows that EPA, under broad interpretations, can regulate most anything—farm ponds, ditches and fields—as waters of the U.S. This could allow the agency to dictate landuse decisions and farming

Farmers and ranchers could be required to obtain a permit for many farming practices. Fertilizer and pesticide applications might also be affected.

"We do have hope that Congress will send EPA back to the drawing board and tell them

to ditch the rule,"said. "The U.S. House and the Senate Environmental and Public Works Committee recently passed legislation telling the agency to start over. We have high hopes the full Senate will pass that legislation, too."



The Department of State Health Services (DSHS) is granted authority to set immunization requirements by the Texas Education Code, Chapter 38, Health & Safety, Subchapter A, General Provisions.

IMMUNIZATION REQUIREMENTS

A student shall show acceptable evidence of vaccination prior to entry, attendance, or transfer to a child-care facility or public or private elementary or secondary school in Texas.

Receipt of the dose up to (and including) 4 days before the birthday will satisfy the school entry immunization requirement.

Serologic evidence of infection or serologic confirmation of immunity to measles, mumps, tubella, hepatitis B, hepatitis A, or varicella is acceptable in place of vaccine.

Previous illness may be documented with a written statement from a physician, school nurse, or the child's parent or guardian containing wording such as: "This is to verify that (name of student) had varicella disease (chickenpox) on or about (date) and does not need varicella vaccine." This written statement will be acceptable in place of any and all varicella vaccine doses required.

Texas law allows (a) physicians to write medical exemption statements that the vaccine(s) required would be medically harmful or injurious to the health and wellbeing of the child or household member, and (b) parents/guardians to choose an exemption from immunization requirements for reasons of conscience, including a religious belief. The law does not allow parents/guardians to elect an exemption simply because of inconvenience (for example, a record is lost or incomplete and it is too much trouble to go to a physician or clinic to correct the problem). Schools and child-care facilities should maintain an up-to-date list of students with exemptions, so they may be excluded in times of emergency or epidemic declared by the commissioner of public health.

Instructions for requesting the official exemption affidavit that must be signed by parents/guardians choosing the exemption for reasons of conscience, including a religious belief, can be found at www.ImmunizeTexas.com under "School & Child-Care." Original Exemption Affidavit must be completed and submitted to the school or child-care facility.

For children claiming medical exemptions, a written statement by the physician must be submitted to the school or child-care facility. Unless it is written in the statement that a lifelong condition exists, the exemption statement is valid for only one year from the date signed by the physician.

Provisional Enrollment

All immunizations should be completed by the first date of attendance. The law requires that students be fully vaccinated against the specified diseases. A student may be enrolled provisionally if the student has an immunization record that indicates the student has received at least one dose of each specified age-appropriate vaccine required by this rule. To remain enrolled, the student must complete the required subsequent doses in each vaccine series on schedule and as rapidly as is medically feasible and provide acceptable evidence of vaccination to the school. A school nurse or school administrator shall review the immunization status of a provisionally enrolled student every 30 days to ensure continued compliance in completing the required doses of vaccination. If, at the end of the 30-day period, a student has not received a subsequent dose of vaccine, the student is not in compliance and the school shall exclude the student from school attendance until the required dose is administered.

Additional guidelines for provisional enrollment of students transferring from one Texas public or private school to another, students who are dependents of active duty military, and students who are homeless can be found in the TAC, Title 25 Health Services, Sections 97.66 and 97.69.

Since many types of personal immunization records are in use, any document will be acceptable provided a physician or public health personnel has validated it. The month, day, and year that the vaccination was received must be recorded on all school immunization records created or updated after September 1, 1991.



It has long been known that criminals carry weapons

regardless of licensing laws or even bans. OTC and others who are strong 2nd Amendment supporters believe law abiding citizens should be able to defend their lives, their family and their property. Numerous studies have shown that open carry is a deterrent to crime. In one study, 81% of violent criminals interviewed reported that it was important to determine if a potential victim was armed.

The Many Faces of Medicine

By Robin Roller Have you ever heard the term "born with a silver spoon in your mouth"? You might be surprised at its origin.

Before refrigeration in Europe, it was customary for the wealthy families to use silver for food storage. Silver has strong antibiotic, antibacterial and antiviral properties. A silver coin often would be dropped in a bottle of milk to keep it from spoiling. After refrigeration, this practice became obsolete.

The term "blue blood" was used to refer to these same families because the silverthat stored their food, after many years and constant use, left traces. This caused a condition called argyria — characterized by the blue grey coloring of the skin, very noticeable, but harmless.

Now to answer the opening question: These noble familieswould often give their babies silver spoons much like a pacifier to suck on in order to build their immune systems. This was done to keep them healthy. Remember, they had the plague and other epidemics that created a fear for infant mortality.

The practice is little known today. However, silver is now becoming popular in the form of colloidal silver. Colloidal, meaning suspended in water, silver has been said to have more health benefits than most anything you can get your hands on today.

The substance has been said to be able to defeat viruses which, according to modern medicine, is impossible.

I have used colloidal silver safely. I make my own and it's easy to do. My only personal experience with this is using it when I feel run down or think I might be coming down with a cold. I very seldom get sick.
