W.J. Mangold Memorial Hospital approves Health Career Scholarship Program

At its meeting on September 29, 2021, the board of directors for the Lockney General Hospital District approved the funding of a scholarship program for employees and local residents in pursuit of a healthcare career. The board and administration of W.J. Mangold Memorial Hospital feel strongly about a "grow our own" program to encourage local residents to enter into a healthcare career such as nursing, laboratory tech physical therapy or others.

There is already a shortage of certain hospital staff, and the need for clinical healthcare workers will definitely grow in the future. Jobs in healthcare pay well and oftentimes offer excellent benefit packages. This is an opportunity for residents in the area to have a professional career in their own community and not have to relocate or commute

long distances for a good job. This fund is available for existing W.J. Mangold Memorial Hospital employees who want to advance their education or career in healthcare or high school or current college students interested in a healthcare career.

The process begins with a scholarship application that is available from administration and human resources at the hospital or on the website, www.mangoldmemorial.org.

A committee will decide on awarding the scholarship and the specific dollar amount to be provided to the applicant. A contract will need to be signed by both parties. Once the student graduates from the healthcare program, then they will be obligated to work for W.J. Mangold for a period of time, more likely to be two to three years, to satisfy the

scholarship requirement. If the scholarship winner does not successfully complete the program and graduate or does not become employed by W.J. Mangold Memorial Hospital, then they will have to pay back the scholarship amount plus interest. At the present time, our most pressing need is for nursing staff, but other clinical healthcare positions will be considered for scholarship.

Candidates have begun to file for 2022 elections in Floyd County.

In this area, seats that are up for election are county clerk/ district clerk, county judge, county treasurer, Precinct 2 commissioner, Precinct 4 commissioner and justice of the peace.

Interested candidates file with county party chairs and pay a filing file to get their names on the ballot.

The Hesperian-Beacon connected with Kerry Pratt, chair of the Floyd County Republican party, via email to get this week's primary filings for the Floyd GOP primary.

Four candidates, all incumbents, have filed to be on the GOP primary ballot.

Filing so far have been: Marty Lucke, county judge; Clint Bigham, commissioner precinct 2; David Martinez, commissioner precinct 4; and Lori Morales, county treasurer.

The newspaper reached

out to the Democratic party to identify a party chair for Floyd County, but had no response.

Filing for the March 1, 2022 Republican and Democratic party primary elections continues through Dec. 13. Individuals interested in running for office should contact the county party chairs. The last day to register to vote for the March 1 primaries is Jan. 31, 2022. Early voting will run Feb. 14-25, 2022 and the last day to apply for a ballot by mail is Feb. 18, 2022.

Samsung taps Taylor for new plant

AUSTIN-Electronics giant Samsung an- ES DROP, AS DO nounced last week that it will build a new semiconductor manufacturing facility in the Central Texas town of Taylor, about 40 miles northeast of Austin. The \$17 billion investment will be the largest foreign direct investment in Texas to date and brings the company's total investment in the state to \$35 billion.

Samsung already operates a facility in Austin, its lone U.S. manufacturing plant. The deal was helped along with a \$27 million Texas Enterprise Fund grant, according to Gov. Greg Abbott's office. In addition, city, county and school district officials put together incentive packages worth of hundreds of millions of dollars, according to the Austin American-Statesman.

The project will create more than 2,000 hightech jobs, thousands of indirect jobs and at least 6,500 construction jobs. Construction is slated to begin early next year with a target completion date in the second half of 2024.

"Samsung Austin Semiconductor has been proud to call Texas home for more than 25 years," said Dr. Sang Sup Jeong, president of Samsung Austin Semiconductor. "We are excited about our growth and future opportunities in Central Texas and appreciate the support from all Central Texas leaders."

STUDIED. The damage caused by Winter Storm Uri to the state's trees is still being assessed. While many hardwoods whose crowns turned brown after several days of bitter cold have recovered, pine trees in East Texas are now suffering from an invasion of beetles. The beetles attack both stressed and healthy pine trees, but can only successfully invade severely stressed pine trees, such as those recovering from Uri.

"Looking back at the past nine months, the fact that these beetles are now taking center stage in the decline and death of our pine trees is inevitable," said Allen Smith of the forest service. "Uri was a major stressor of trees, and the following extended droughty conditions throughout the pine regions of East Texas added additional stress."

Standing beetle-killed trees should be removed and burned or otherwise disposed of to stop the emergence of beetles. Smith said the best-case scenario for pine trees is for a wet winter in East Texas so that trees have ample soil moisture when they start growing again in the spring.

STATE TO GET \$400 MILLION FOR CHARGING STA-TIONS. Texas is slated to receive \$408 billion for electric car charging stations under the recently passed federal infrastructure plan and could apply for additional grants, according to The Dallas Morning News. The money comes under a Biden administration plan to shift half of passenger vehicle sales in the U.S. to electric vehicles by 2030.

The state needs more than 14,000 charging stations to support the number of electric vehicles projected to be traveling on Texas roadways by 2030, according to a 2018 report from Environment Texas. The state had just over 52,000 registered electric vehicles as of last June, according to the Morning News story.

COVID-19 CAS-DEATHS. While new cases of Covid-19 are spiking again in the Upper Midwest and Northeast, the number in Texas dropped during the past week to 14,745 - down 36% from the previous week. The number of new deaths reported in



However, the number of hospitalizations of lab-confirmed Covid-19 patients in the state was virtually unchanged at 2,681, according to the Texas Department of State Health Services.

The number of Texas who are fully vaccinated continues to inch upward, with 15.838 million reported by DSHS as of Sunday. That is 54.3% of the state's total population.

Still, while noting hospitalizations are at their lowest levels in many months, officials are still cautious. "We're certainly in a better place right now than we have been in quite a while," Chris Van Deusen, spokesperson for the Texas Department of State Health Services, told the Texas Tribune. "But we are sort of starting to see things change again. And you know, if there's one thing we know about this pandemic, it's that it's going to keep changing."

Meanwhile, another variant of Covid-19 named "Omicron" has been discovered in South Africa and several other countries. Experts are concerned that the new variant may spread more aggressively than previous versions and could prove to be resistant to current vaccines.

EXPERTS URGE TEXANS TO GET FLU SHOTS. A resurgence of influenza this winter is overdue, and Texans are urged to get vaccinated.

"Flu is overdue right now," Dr. Donald Murphey, an Austin pediatric infectious disease specialist and chair of the Texas Medical Association Council on Science and Public Health, told the Texas Newsroom.

"We should be concerned about flu returning. Flu is here every year consistently and last year, with mitigation for Covid, we didn't have a flu season at all," he said.

Murphey added that this year's flu season could be even worse as the decline in Covid-19 cases leads to an increase in public gatherings with fewer people wearing masks. The Texas Medical Association encourages flu shots for everyone 6 months of age and older. TMA says Texans can safely get vaccinated for the flu and Covid-19 at the same time.

Well, Thanksgiving 2021 has come and gone. It is not the only time to give thanks.



Sausage and gravy breakfast casserole makes a hearty holiday meal

Breakfast casseroles are in the spotlight during the holidays. Even if we are not expecting a large group of family or friends, it is still a nice idea to have one planned for Christmas morning. Or to have anytime during the holidays.

The combination of biscuits and gravy, or better yet, biscuits and sausage-gravy, is very popular in this area. It's a good, filling, country meal that people I know really appreciate.

This one starts with a layer of hash browns or grated potatoes. I'm inclined to add a layer of green chiles as well, or you may find you and yours would like a sprinkling of cheese tucked in somewhere between layers.

Customize this hearty casserole to your liking. I also have a few tips to make life easier for you:

Remember, if you are out of buttermilk for this recipe, or don't use it frequently enough to warrant buying it, add a couple of spoonsful of vinegar to about a cup of whole milk. Let set for 3 or 4 minutes and stir to combine. This will create a sour milk that tastes like buttermilk when baked into recipes.

I also have times when I'm out of self-rising flour, but we can quickly create our own by mixing 11/2 teaspoon baking powder and 1/4 teaspoon salt per 1 cup all-purpose flour.

Enjoy food made fresh!

Sausage and Gravy Breakfast Casserole

- 2 cups grated potatoes or prepared hash brown potatoes
- 1 teaspoon ground black pepper, divided
- 3/4 teaspoon salt, divided
- 21/2 cups self-rising flour
- ½ cup cold butter (1 stick) cut into tiny pieces, plus 2 tablespoons,
 - 1 cup buttermilk
 - 1 pound ground breakfast sausage
 - 2 tablespoons water
 - 4 tablespoons cooking oil
 - 6 tablespoons all-purpose flour
 - 3 cups whole milk

Preheat oven to 400° F. Grease a 9-by-13 inch baking with 1 table-

spoon butter. Evenly press the grated potatoes over the bottom of the baking pan. Season with about 1/4 teaspoon each salt and pepper. Bake in preheated oven for 20 to 30 minutes while preparing the remainder of the casserole, until they begin to crisp and brown.

Place self-rising flour in a medium-size mixing bowl. Add 1/2 cup of butter pieces and mix with a fork until you form "pea-size" crumbles. Add buttermilk and mix with fork until shaggy.

Turn dough out onto a floured surface and press together with your hands. Let dough rest.

Brown the sausage in a medium skillet over medium heat. Make sure to crumble it evenly, (a potato masher works well for the task). Set aside on a plate lined with a paper towel.

Add 2 tablespoons water to the skillet to deglaze, scrapping up the brown bits. Add oil and stir to combine. Add all-purpose flour and whisk. Continue cooking over medium heat for 2 or 3 minutes until flour is light golden brown. Add whole milk and whisk until combined. Season with remaining salt and pepper. Mixture will begin to thicken after 3 or 4 minutes. Add the browned sausage and stir to combine. Pour over the precooked hash browns.

Increase oven temperature to 450° F.

Roll dough out to approximately 9-by-13 inches to fit the baking dish. Place the biscuit dough over the gravy. If you desire, you can cut circles in the top of the dough to indicate the serving size. Bake for approximately 20 minutes until top turns light golden brown. Brush the top with 1 tablespoon butter. Serve warm. Makes 8 good

Googaly-eyes pine cones

The eves have it.

Eves bring inanimate objects to life. I refer to the little blackand-white glue-on kind with pupils that rattle around under clear plastic lenses. Granddaughter Emily calls them googaly eyes.

Sticking them on pinecones is a good holiday activity for all ages. To wit, my husband and I experimented with eyes and pinecones in the brief calm before our Thanksgiving storm. It's the perfect way to wind down from intense housecleaning.

When our kin arrived, we provided 5-year-old Emily an assortment of eyes, pine cones, pipe cleaners, autumn leaves, pyracantha berries and one desiccated buffalo gourd. (I just learned that official name; I grew up calling them "gourd balls.")

Emily put eyes on the lackluster gourd, stuck some reddish leaves on it plus a pipe cleaner or two and, with a felt-tip marker, added some tiny blue hearts. Use your imagination. She did.

Incidentally, pipe cleaners are now called "chenille stems." If you hear me say "chenille" I'll be talking about a robe or a bedspread. Pipe cleaners will always be pipe cleaners to me. "Chenille stem" sounds uppity. I'm anti-uppity.

As for Emily and the pinecones, she didn't glue any eyes on the one she chose to decorate. She turned it into a Christmas tree with pyracantha berries for ornaments and then added a pipe cleaner for extra pizzazz.

She also made pipe cleaner bracelets for some of us (although not for me) and managed to wrap one pipe cleaner very tightly around her 2-year-old sister Haley's finger. Dad managed to remove it before Haley lost the finger.

If we'd plugged in the hot glue gun, we might have made the holiday even more memorable.

Advice: If you don't use a hot glue gun, it's hard to make those eyes stick on anything. We plan to fire up our gun at Christmastime and just hope no one gets any permanent scars.

More advice: When you gather pine cones, don't worry about uniformity. The bedraggled ones are sometimes the best. Presented horizontally and given eyes, they lend themselves to all sorts of interpretations, warthog to armadillo. Some of the rattiest cones I've gathered this year are survivors of the great February freeze and who knows what other indignities.

Yep, if you're so inclined, you can turn a pinecone decorating activity into a lesson on appreciating diversity in general and making the most of things imperfect. Or not. Moralizing is a luxury when you're in charge of a working glue gun.

By the way, I'm something of an expert on children and art, meaning I've read the weighty tome "Creative and Mental Growth" by Victor Lowenfeld (1903-1960).

Final advice: Give the child freedom. Don't guess at what they've created. Let them tell you what it is. That's what Lowenfeld would

Read his book, and you'll think twice before you give a child a creativity-stifling coloring book. Come to think of it, Lowenfeld would no doubt be opposed to

Forget I mentioned him. The eyes have it.





I get the opportunity to develop techniques and most of these skills are from participating in CDE's and SAE's. Nevertheless, many young responsible adults get this opportunity to do what needs to be done.

Pacheco commented, "The event I am looking forward to this year is the Career Development Events. The reason for this is because all four years my team and I get the opportunity to judge poultry and we learn something new each year."

Nominations for prestigious Marine Corps Heritage Foundation award program now open



THE FLOYD COUNTY HISTORICAL MUSEUM MEMORIES 1979 • JUDGE ARTHUR DUNCAN

Floyd County Hesperian, 1940

Judge Arthur B. Duncan, whose death in 1931, wrote finals to a half-century of service to Floyd County, was not only the first citizen of the county during his many years here but was also the first settler. He and his family built the first home in the county and were pioneer settlers two years before any others came upon the scene.

From the beginning, Arthur B. Duncan had a prominent part in the affairs of the county. After Floyd County was attached to Crosby County for land and judicial purposes, he was appointed by the commissioners' court of Crosby County, Justice of the Peace for Floyd County. This position he filled until his election as County Judge of Floyd County in 1890.

Because of numerous legal disputes that came up with reference to land matters, he provided himself with the Revised Statutes of Teas and a copy of the Acts pf the Texas Legislature. His own experience as a land litigant, coupled with his duties as Justice of the Peace, entailed upon him the duty of consulting the Statutory Laws of Texas and in this way he soon formed a fondness for the study of law, which knowledge served him well in the different offices which he later filled. On account of these land litigations which arose between the settlers and the large ranch interests, all the early settlers, except Mr. Duncan wearied of the strife and compromised by relinquishing their claims for a small consideration.

1886, the year which marked the exodus of these same settlers from the canyon settlement, also was marked by an influx of newcomers. The year also was marked by the birth of Maud Eudora, first daughter of Judge and Mrs. Duncan, being also the first white girl born in the county. She was so small and frail that she seemed unfitted to this new rough country. Her proud father called he his "Lily of the Valley and the Queen of the Plains."

That winter of 1887 and 1888 was extremely cold, thousands of cattle and a few antelope froze to death. Mustang horses were troublesome and would often get with the gentle horses and lure them away, but perhaps the greatest menace of the early settlers was the fear of prairie fires. Only a very few of the earliest settlers can remember one of these when one ranch firm lost its entire herd of three thousand sheep on Crawfish Draw near the Crosby County Line.

Those first years in Blanco Canyon were the hardest for the newcomers, but as each problem of life was solved, thew settlers learned better to adapt themselves, and their experiences lessened the labor and suffering for later homeseekers who could now profit by the experience of those preceding them.

Floyd County was organized in 1890 and in the first election held for Floyd County officers, Duncan was honored with the election of County Judge which office he held for nine successive terms. After retiring for a number of years he was again elected in 1912. The County Judge's office even at that early day carried numerous duties, though the remuneration seemed rather small. The first month the office paid only twenty-eight dollars, being raised the second month to thirty-five dollars and finally settling on the salary of forty dollars per month.

After being elected to the office of county judge, Judge Duncan and his family began preparation to move to the new settlement where they began at once to build a new home. The Plains country was quite a change to the home in Blanco Canyon, and many hardships were here to face. As Claude Hall says in his "History of Floyd County" speaking of those first days "No Mollycoddly could thrive there."

Only a few people made up the new settlement. These were obliged at first to carry water from the public well. Accommodations were few and living high, as all supplies must be shipped from Amarillo or Childress and it took six or seven days to make the trip to either place, even when the weather was favorable. Western windstorms were a sore trial to many newcomers and in 1892 came an awful visitation of grasshoppers. These afflictions together with repeated dry years,

caused many settlers to move elsewhere.

Floyd County's first effort to build a court-house resulted in two of the commissioners voting for, and two against the proposition. The County Judge cast the deciding vote. This resulted in Judge Duncan's vote being responsible for the building of the first courthouse. It was a wooden structure costing ten thousand dollars. Later a small jail was added to the equipment and Floydada became the executive center.

Judge Duncan's home at that time was a two room frame building. Later more rooms were added until the large frame house which served as home which served as home to his ten children evolved.

By 1897, practically all school lands in Floyd County had been filed on by settlers and a new epoch in the history of the county was begun. The construction of the Fort Worth and Denver Railway to Amarillo swelled the tide of immigration; improvements were bought in and living became more pleasant.

Each county election provided its quota of new witnesses, and as Judge Duncan was honored with election so repeatedly, it was conceded by some that "Old Buck" was responsible for his good luck. Old Buck was the family's gray horse and a very familiar figure in the early politics of Floyd County. To assist early settlers of Floyd County, Judge Duncan experimented with the growing of fruits, grains, and vegetables, thoughtfully searching for the products most suitable to the soil and climatic conditions of the locality. Everyone who lived here that early day can remember the judge's office with its display of farm products.

Outside of the usual routine court work imposed on the judge's office, Judge Duncan served as superintendent of the public schools, presiding at institutes held over the county, visiting rural schools, and supplying the early needs of education in Floyd County. He also served as a "marrying parson" and it was nothing unusual for him to drive or ride many miles through the snow to administer the rites of matrimony to some couple desirous of such service, and every marriage ceremony performed by him carried its spirit of binding sublimity.

For many years, Judge Duncan was engaged in the real estate and abstract business, having complied what is considered to be one of the most complete sets of abstract records in the Panhandle. He also served in the capacity of attorney in examining and perfecting titles. He served also as vice-president of the First National Bank of Floydada, selling his interest later on account of the growing responsibility of his office. He served as president of the board of Floydada Schools from 1908 to 1912, at which time he resigned that position on account of again being elected judge.

The progressive spirit of this dauntless pioneer is indicated by the fact that he was the first man to purchase a typewriter and bring it to Floyd County, was the first to buy and bring into the county registered Jersey cattle. He also brought and had shipped from the State of Missouri the first registered Poland China Hogs for foundation stock. He also brought the first fine chickens from New York State and the first thoroughbred turkeys from the state of Pennsylvania. He is credited with having set out the first fruit trees in the county and the first to put out shade trees on the public square of Floydada. With his untiring efforts to render aid to every enterprise which meant wealth and comfort to the county, it is evident that the Judge Duncan was a real benefactor of Floyd County.

From those early days of the dugout and covered wagons, he was able to watch the steady growth of the country, and from the bareness of the Plains he has seen towns rise up with fine homes, schools, and churches with their accompanying advantages. At the time of his death, he owned extensive farm lands and city property in Floyd County. At all times he kept in close touch with state and local affairs and to the end he never lost that quality that keeps men eternally young-an eager curiosity to learn and an earnest desire to improve himself and his opportunity for serving those about him.



Lockney holds Thanksgiving Community Fellowship




Churches from the Lockney community came together on the evening of Sunday, Nov. 21 to celebrate Thanksgiving and to count their blessings.
