



Lockney residents close to Water Restrictions

LOCKNEY - City Manager Buster Poling announced a notice to the city's residents on Monday, May 11 regarding possible water restrictions due to recent usage of water reserves.

"The City of Lockney is approaching water usage numbers that would trigger the City's Stage 1-Voluntary Water Restrictions of the Drought Contingency Plan," stated Poling. "The City is required to implement the Drought Contingency Plan when 80% of the ground storage capacity for seven (7) straight days is used."

To ensure the City's reserves, residents are asked to voluntarily limit:

1. Washing of automobiles, motorcycles, boats, airplanes, etc.

2. Washing of exterior walls of houses and/or businesses.

3. Lawn watering.

Manager Poling made the point, "If we all do our part, we hope not to trigger Stage 1: Voluntary Water Restrictions."

If residents of Lockney do not limit their

current water usage resulting in a critical drop in water reserves, the following mandatory restrictions will be put into place.

Stage 1: Voluntary Water Restrictions: 1. Alternate week-day watering schedule for even-numbered and odd-numbered addresses

> 2. No washing of automobiles, motorcycles, boats, air-

3. No washing down exterior walls of houses.

4. Other water usage restrictions.

Under the Drought Contingency Plan, the City must give immediate notice to the

Texas Commission on Environmental Quality upon entering Stage 1: Voluntary Water Restrictions.

"The City of Lockney is diligently trying to bring the Aiken well back online, however, having that well up and running does not impact the Drought Contingency Plan because that well's capacity does not change the volume of the ground storage capacity, nor would that water alleviate the need for future water resources for the City of Lockney," said Poling. "Engineering plans are in hand, and we are moving forward as quickly as possible to reactivate Aiken.".

Item eight on the agenda was discussion and action on the Floyd County Appraisal District 2020-2021 budget. Commissioner Smith made the motion to accept the Appraisal District's budget and Commissioner Bigham seconded the motion. It passed by unanimous vote.

Discussion and action were taken on the extended warranties for the Hart InterCivic voting machines. The new machines are currently still under warranty. The extended warranty is for the original machines. Commissioner Johnson made the motion that the extended warranty is something that should be investigated. Commissioner Bigham seconded the motion and it passed by unanimous vote.

Item 10 on the agenda was discussion and action on Bounty Agreement in Precinct 3. Commissioner Johnson made the motion to accept the motion. It was seconded by

Commissioner Martinez and passed by unanimous vote.

The next item on the agenda was discussion and action on the regulations for Forest Lawn Cemetery. Someone drove out there and ruts were made. A motion was made to set some regulations for the cemetery. A motion was made by Commissioner Johnson to accept the motion to set regulations for Forest Lawn Cemetery. Commissioner Martinez seconded the motion and was passed by unanimous vote.

The next item on the agenda was discussion and action on Floyd County Disaster Declaration. Commissioner Smith made the motion to accept the motion to extend the declaration till June 8. Commissioner Johnson seconded the motion. It passed by unanimous vote.

mountain cabin I and a few friends visit each year

of West Texas this morning.

GREEN balcony minutes before, I smelled the earthy scent of desert soil after a rainfall. It must have been a very light sprinkle - just enough to produce petrichor, the earthy scent

emanating from a light dampness on arid soil. The word "petrichor" is an interesting term. It comes from combining two Greek words: "petra," meaning "stone" or "rock", and "ichór," which is the fluid that flows in the veins of the gods in Greek mythology. It creates a nice word picture for the fragrance one smells after a rainfall in

West Texas or the Panhandle of Texas. Perhaps the only smell I like better in the world is that following rainfall in a desert that includes numerous creosote bushes. The creosote leaves emit a light, semi-oily coating that mixes with rainwater to produce an intoxicating scent that hangs in the air like the smoke from

Speaking of fine cigars, they accompany us on each annual West Texas trip. As soon as we arrive after a long day's drive, we unpack, break out the cigars and deposit ourselves in the rocking chairs on the back

We sit on the edge of a stunning valley, surrounded by desert

mountains, have a glass of wine, smoke a fine cigar and we systematically solve all the world's many problems. For a few days each year all the world's politicians, philosophers and

pundits are vision impaired and only my friends and I can see clearly. We do not shop, sightsee (in the tourist sense) or eat at fancy restaurants. We cook for ourselves, scan the valley below us with

binoculars and view constellations, asterisms (star patterns that make

shapes) and shooting stars with a telescope set up in front of the cabin. It is difficult to put into words what a trip like this means to men. It is what men do to clear their minds and shake the dust from their souls, built up over time from the commotion of life in the modern world.

For a brief few days out of each year, we get as far away from work as we reasonably can and let the nature of common sense take its course. And we smoke a few cigars.

I've never been what you'd call a smoker, except for the occasional cigar, but that doesn't count. Philosophically, a cigar is not about tobacco; it's about metaphysics - that branch of philosophy that deals with things that transcend what is physical and natural. So, smoking a good cigar is a window to the soul, and a motivation to deep conversations about things that matter.

I am reminded that a former president of Texas A&M University Robert Gates took a long cigar-assisted walk around the A&M campus to ponder President George W. Bush's offer for Gates to become the

In his book "Duty", Gates tells of how difficult the decision was and that it was the walk around campus "smoking a cigar" and looking at familiar landmarks that finally gave him clarity. I personally think he should have stayed at A&M, but he didn't ask me.

It's a little-known fact that the 2007 troop surge in Iraq began with Gates walking around the Texas A&M campus, smoking a cigar.

While I am not presently available to become secretary of defense, just thinking about the peaceful vistas of West Texas and the Panhandle, makes me want to pick up a fine cigar and take a long, slow walk.

Raul Julia comes close to capturing the experience when he said, "Maybe it's like becoming one with the cigar. You lose yourself in it; everything fades away: your worries, your problems, your thoughts. They fade into the smoke, and the cigar and you are at peace". Gates is the Chancellor of the College of William & Mary these

days. He's also been elected to the Starbucks Corporation board of directors, which surprises me a bit. Maybe he didn't disclose his love

As far as I know, Gates still does his important thinking with a cigar in hand. He said, by the way, that "[a] wild and crazy weekend involves sitting on the front porch, smoking a cigar, reading a book". That's an opinion I share.

We don't have any room for politicians on our West Texas trip; otherwise, I am sure we'd enjoy having Gates join us on the balcony of our mountaintop cabin. But I wouldn't be interested in his political opinions; I would like to know what was up with Condoleezza Rice telling Jay Leno that her favorite band is Led Zeppelin.

I know Gates and Rice are close, and I'd like someone to explain how a classical pianist educated at Notre Dame, and a former professor at Stanford, would like Led Zeppelin. Obviously, Rice doesn't smoke cigars. bgreen@lknewsgroup.com.

Starks who contracted homes and school buildings. Some of the school houses they built were Lockney, Quitaque, Hart. Lura

to kindergarten at the Lockney Christian College. She finished high school in Lockney in 1926, attended West Texas State College in Canyon two years and Draughon's Business College in Abilene. Norton graduated from Lockney High School in 1953 and Southern Methodist University Law School in 1959. He was in active duty in the US Army in

Dorsey Lynn received his LLB degree from Southern Methodist Law School in 1966 and worked a patent examiner at the U.S. Patent Office, Washington, D. C. while attending George Washington Law School for the requirements of a Master's of Patent Law Degree. He married Charlyne Brown of Lockney in June, 1965. They have two daughters, Stacey and Kari and live in Chicago, Illinois where Dorsey Lynn practices law.

> Edwin Stinebaugh finished high school in Lockney in 1928 and married Bill Stewart in Lakeview, Hall County in 1934. They moved to a farm east of Lockney and eventually farmed near Petersburg. They were killed in an automobile accident near Carlsbad, New Mexico in March 1950. They had two children, Frances and Eddie who were reared in the Masonic Home in Ft. Worth after the death of their parents.

> Frances graduated from high school in Ft. Worth and received her BBA and MA degree from the University of El Paso. She married Aubrey Cherry in Hedley, Texas in 1957. They live in El Paso and are connected with the

El Paso School System. They have five children; Richard, Clay, Craig, Melanie, Mary Etta.

Severe weather can happen in the blink of an eye

FLOYD COUNTY - Hail, lighting, thunder, high winds and rain are just a few things that can happen in the blink of an eye during severe weather.

Accuweather defines a severe weather as a destructive storm or weather. It is usually applied to local, intense, often damaging storms such as a thunderstorm, hailstorm and tornadoes. Unfortunately, this time of year we are highly likely to experience severe weather is some shape or form and probably more that once or

Lightning is one of the oldest observed natural phenomena on Earth, and it is a leading cause of injury and death from weather related hazards, according to FEMA. Although most lightning victims survive, people struck by lightning often report a variety of long-term debilitating problems.

Thunderstorms are dangerous storms that includes lightning. It can also include powerful winds over 50 mph, create hail and can cause flash flooding and torna-

For those who find themselves under a thunderstorm warning, find a safe place. Remember when "thunder roars go indoors". A sturdy building is the safest place to be during a thunderstorm.

Tune into the local weather and pay attention to the reports and warnings. During a thunderstorm, things can change at any time. Be ready to change plans if necessary. You may need to take shelter in a basement or cellar. If a storm comes up while

boating or swimming, get to land and find a sturdy grounded shelter, warns the American Red Cross. If necessary, take shelter in a car. Listen to authorities and weather forecasts for information on whether it is safe to go outside.

A thunderstorm can turn into a tornado fast. A tornado can destroy buildings, flip cars and pickups over and create deadly flying

Tornadoes are violently rotating columns of air that extend from thunderstorms. Remember a tornado can happen anytime and anywhere. For those who

find themselves under a tornado warning, find a safe shelter right away. For those in a building with no basement, get to a small interior room on the lowest level. Stay away from windows, doors and outside walls. For those in a car, do not get

under an overpass or bridge. It's safer in a low, flat location. Do not try to outrun a tornado and watch out for flying debris that can cause injury or even death. If necessary, the American Red Cross suggest using arms to protect the head and neck.

The storm season is here and having a severe weather kit is always a good idea. Once the kit is assembled, it should be stored in the same space when seeking shelter. The contents will not help if they are in another area of the

Just a few things to grab for the kit is bottled water, weather radio and extra batteries, first aid kit, flashlight, a blanket, a change of clothes and an extra pair of shoes couldn't hurt. For those with a pet, include some pet food. It'd be a good idea to include a whistle in the kit along with some cash.

- 4 cups cooked shredded chicken 19 oz. can El Paso Red Enchilada sauce
- 16 oz. can cream of mushroom 4 cups of sharp cheddar cheese
- 2 large bags of Fritos
- ½ cups of diced onions (optional)
- 1 to 2 cups of chicken stock or broth

Preheat oven to 350 degrees. In a large bowl combine enchilada sauce and cream of mushroom soup. Mix in chicken, onion and three cups of cheese and



mix until fully coated.

Fold in the two bags of Fritos. If mixture is too dry add one to two cups of chicken stock or broth and mix well.

Pour mixture into a 15x11 casserole dish or foil pan. Top with the remaining cup of cheese and bake uncovered for 20 minutes or until cheese is melted. Serve hot.

FSA Reminds Producers of Ongoing Disaster Assistance Program Signup

WASHINGTON, DC - The U.S. Department of Agriculture (USDA) has started making payments through the Wildfire and Hurricane Indemnity Program - Plus (WHIP+) to agricultural producers who suffered eligible losses because of drought or excess moisture in 2018 and 2019.

Signup for these causes of loss opened March 23, and producers who suffered losses from drought (in counties designated D3 or above), excess moisture, hurricanes, floods, tornadoes, typhoons, volcanic activity, snowstorms or wildfires can still apply for assistance through WHIP+.

"To date, FSA has received more that 33,000 WHIP+ applications," said Richard Fordyce, Administrator of USDA's Farm Service Agency (FSA). "We want to remind producers that we are still accepting applications for WHIP+, and we encourage producers to call our offices for next steps on how to apply."

To be eligible for WHIP+, producers must have suffered losses of certain crops, trees, bushes or vines in counties with a Presidential Emergency Disaster Declaration or a Secretarial Disaster Designation (primary counties only) for qualifying natural disaster events that occurred in calendar years 2018 or 2019. Also, losses located

in a county not designated by the Secretary as a primary county may be eligible if a producer provides documentation showing that the loss was due to a qualifying natural disaster event.

For losses due to drought, a producer is eligible if any area of the county in which the loss occurred was rated D3, or extreme drought, or higher on the U.S. Drought Monitor during calendar years 2018 or 2019. Producers who suffered losses should contact their FSA county office.

In addition to the recently added eligible losses of drought and excess moisture, FSA will implement a WHIP+ provision for crop quality loss that resulted in price deductions or penalties when marketing crops damaged by eligible disaster events. To ensure an effective program for all mnacted farmers the Agency is currently gather ing information on the extent of quality loss from producers and stakeholder organizations.

USDA Service Centers, including FSA county offices, are open for business by phone only, and field work will continue with appropriate social distancing. While program delivery staff will continue to come into the office, they will be working with producers by phone and using online tools whenever possible.
