## Floyd County to be included in historical travel guide

The newest travel guide by the Texas Historical Commission will be launched next week in Lubbock with big fanfare—and Floyd County will be included. The public is invited to be a part of the celebration.

The Texas Plains Trail Region is a heritage region brochure that highlights the heritage of the Texas Panhandle by exploring the frontier life, diverse cultures and the pioneer spirit in dynamic museums, unique historic buildings and vibrant festivals.

The official kickoff of the brochure will be held at the American Wind Power Center, 1701 Canyon Lake Dr., in Lubbock on March 31. A press conference

will be held at 11:00 a.m. followed by an 11:30 a.m. lunch and entertainment.

"We have worked very hard to be a part of this," said Floyd County Museum Director Carolyn Hardy. "It is an honor for Floyd County and the Floyd County Museum to receive recognition in this promotion."

"It will attract even more people to our town and to our Museum. The Coronado Expedition history that we have recorded here has attracted a lot of attention and given us a great deal of recognition."

"In fact, we are expecting a large crowd this Saturday afternoon (3:30 p.m.) from the West

Texas Historical Assoc. who will be touring our Museum. Dr. Donald Blakeslee, who coordinates the Coronado archeological dig in Blanco Canyon, will accompany the group."

As the sixth heritage region in the Texas Historical Commission award-winning Texas Heritage Trails Program, the 52-county Texas Plains Trail Region (which will include Floyd County) will receive state-assisted development and promotion of the area as a heritage tourism destination.

The program promotes tourism, revitalizes local economies and fosters community leadership through historic preservation.

## Floydada Council passes stronger dog ordinance

The Floydada City Council met Tuesday, March 21, and passed an amended animal control ordinance pertaining to aggressive large dogs being kept in the City limits.

Several citizens spoke to the council during the Public Hearing held prior to the council's meeting. "They asked some good questions about muzzles, fencing and leashes. We now have the Police Department behind us on this issue," said Animal Control Officer Roy Moreno.

In the regular council session, Council Member Jon Nielson asked several questions concerning aggressive dogs in the City limits, such as "changing ownership of the dog and moving the dog to a new location."

Police Chief Darrell Gooch said, "We will follow the animal (dog's) location. Three citations will be issued to the owner, with ten days between each citation. If the new ordinance is not complied with, we will then pick up the dog, wherever it is."

The new amended ordinance defines a "large dog" as 35 pounds, or over, in weight. "Aggressive" is defined as "acts aggressively toward a person or another animal without provocation for such action."

A "leash" is defined as no longer than 5 feet held by someone 18 years of age or older.

A "privacy fence" is described as 6 to 8 feet high, and a chain link fence does not qualify as a privacy fence.

In other matters, the council cancelled the City's May 13, 2006 General Election due to no opposition and no write-in candidates. The City council's uncontested positions are: Bettye King, District 1; Jon Nielson, District 4; Monte Williams, At Large; and Clar Schacht, At Large.

The council voted unanimously to reject all bids concerning the purchase of, and the demolition of, the surplus electrical equipment at the City's old power plant. City Manager Gary Brown told the council, "There is probably \$90,000 to \$110,000 worth of (copper and steel) metals in the equipment. I do not recommend we accept any bids at this time."

## Palo Duro Basin Oil and Gas Update

PetroGlobe, Inc.: On March 23, 2006, PetroGlobe, Inc. made a news release outlining their plans in the Palo Duro Basin for 2006. PetroGlobe, Inc. stated they plan to drill four wells in 2006 in the Palo Duro Basin to test the Pennsylvanian Shale; also testing the Uphole Zones.

**Floyd County:** Although BASA Resources, Inc. has not yet filed a plugging report (RRC Form W-3) for the L.N. Johnson Lease Well #1, which was plugged on September 27-28, 2005, the information from the plugging operation has been obtained. The L.N. Johnson Well #1 was located 660 feet from the North Line and 660 feet from the West Line of Section 13, Abstract-996, Block B-5, Beaty, Seale and Forwood Survey, 4 1/2 miles Northeast of South Plains. The L.N. Johnson Well #1 was drilled to 9500 feet with 13 3/8 inch surface casing set to 704 feet, 9 5/8 inch intermediate casing set to 4,025 feet, and 7 7/8 inch open hole to 9500 feet. The formation tops that were reported are the : Wolfcamp 5590, Canyon Lime 7048, Strawn Lime 8040, Atoka 8450, Mississippian 9263. The plugs set in the L.N. Johnson Well #1 were: 1st plug) 9200-9100 feet; 2nd plug) 60 sacks of cement set from 7500-7400 feet; 3rd plug) 80 sacks of cement set across the shoe of 9 5/8 casing from 4075-3975 feet; 4th plug) 45 sacks of cement set from 2000-1900 feet; 5th plug) 45 sacks of cement set across the shoe of 13 3/8 casing from 754-654 feet (top of plug tagged at 654 feet); 6th plug) 45 sacks of cement set across Fresh Water Zone from 400-300 feet; 7th plug) 5 sacks of cement set for surface plug from 13-3 feet. The setting of the second, third, fourth, and fifth plugs were witnessed by the Field Technician for the Railroad Commission of Texas, Oil and Gas Division, District 8A. The plugging operation started at 11:50 p.m. on September 27, 2005 and concluded after 8:00 a.m. on September 28, 2005.

**Floyd County:** Completion work began Monday March 27 on the BASA Resources, inc. Foster Lease Well #1.

## LISD Trustees renew certified staff contracts

Lockney ISD Board of Trustees met March 23 and approved contract renewal of all certified staff in LISD.

Because there are no contested races for the school board the 2006 School Board Election for District 1 and 2 were cancelled.

Trustees Jesse Garza and Cheryl Edwards will continue to serve in those positions.

The Board accepted the resignation of Jill Wuensche and discussed the upcoming resignation of Coach Brannon Rodgers.

Rodgers has let the Board know that he has accepted a position as Athletic Director with Crosbyton ISD. The trustees expressed their disappointment at losing Rodgers but wished him the best in his new endeavors.

Campus principals gave reports. Elementary Principal Jean Anne Williams reported an enrollment of 287.

Junior High Principal Todd Hallmark reported enrollment of

134 and discussed work on the upcoming TAKS tests.

High School Principal Thompson reported 192 students.

Superintendent Phil Cotham told the board that \$1,279,445.72 had already been collected in taxes. "This is excellent," said Cotham. "We are ahead of where we usually are by now. We only lack about \$51,000 of having it all collected."

The March financial report showed a balance of \$462,466.65 with investments of \$3,553,109.70, for a total of \$4,015,576.35.

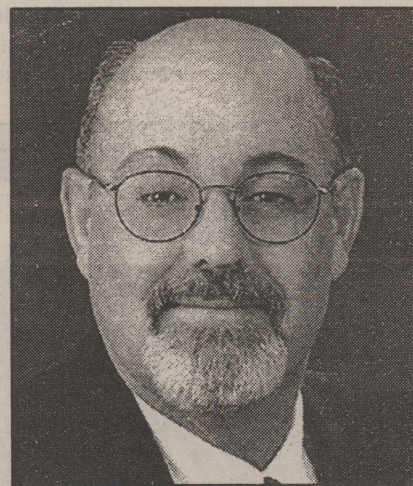

## Council donates to Senior Citizens

Following a request by Margarette Word, who spoke on behalf of the Floydada Seniors Citizens, the council approved a motion to continue paying the electricity and water utilities for the Senior Citizen building for another two years, then review it again.

Word told the council, "This is a very important activity in our community for our seniors. It is a wonderful place where they can get a hot meal and socialize. We served 56 seniors today. We ask for a \$3 donation for each meal from our members and \$5 for visitors. Our dues are \$15 per year."

Following a request by citizen Ray Morales, the council also donated \$750 to the Peewee Football Program. The money will be used for safety helmets for the 30+ kids in the program, according to Morales. "The helmets cost around \$80 each," said Morales. Mayor Bob Gilliland said, "This is good program and it gives the kids something to do."

The council also voted unanimously to continue funding the Little League Baseball Program with their annual \$1500 donation. "This money is in our budget for this purpose and there are over 200 kids in this program," said City Manager Brown.

Floydada Chamber of Commerce Director Rachael Castillo gave the annual review of the chamber. She thanked the council for their support, the office space in City Hall, the dollars generated by the sales tax and for the City employees' courtesy to her.

Castillo gave a review of the year's planned events, which includes Old Settler's Day, the City Wide Garage Sale, Trunk or Treat, Punkin Day and Christmas on the Square. "We had visitors from Alaska, Oklahoma and New Mexico for our biggest event, Punkin Day."

The council approved a request by Harvey and Margaret Garza to operate the City swimming pool again for this 2006

season. The pool will be open during the summer months, Tuesday through Sunday, 1 p.m. to 5 p.m., plus other hours for parties, and with certified lifeguards, according to the Garzas.

An Xcel Energy/SPS Franchise Agreement was approved by the council. Brown said, "This agreement has in it everything we

had asked for. I have been assured the SPS will sign the agreement once it is submitted to them."

The council approved a \$1 increase in the meal prices for the Formby Unit workers when they work here in Floydada. The old meal price was \$7. It will now be \$8, with a \$5 tip.

# Whirlwinds win against Olton but lose to Lockney

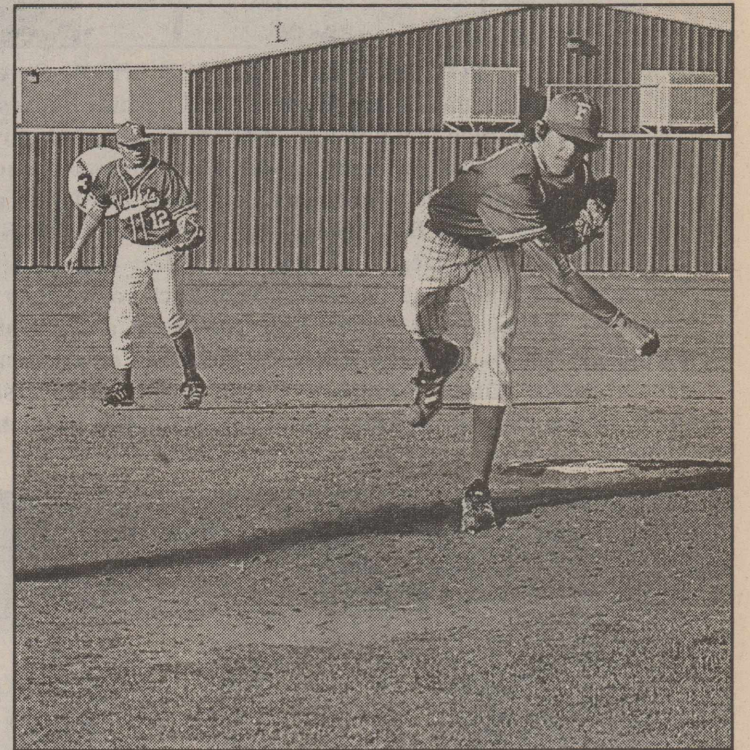

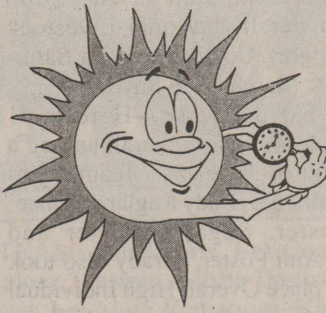

A WHIRLWIND SLIDING IN to home plate against the Longhorns in last week's game. The Longhorns won the game 15-7. Staff Photo



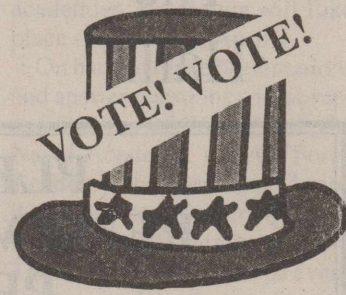

Discussing farm policy with the man many feel will be the pivotal leader during development of new U.S. Farm Policy is a rare and valuable opportunity.

Texas commodity groups were afforded such an opportunity March 23 during a Texas Ag Policy Forum held at the Texas Tech University Museum in Lubbock with current Senate Agriculture Committee Chairman Saxby Chambliss of Georgia.

Also participating in the forum to gather information and prepare for their participation in the House Agriculture Committee's Farm Bill development process were current Ag Committee members Rep. Randy Neugebauer of Lubbock and Rep. Mike Conaway of Midland.

During the event representatives from 15 Texas commodity groups provided Chambliss a comprehensive and uniform message about what they want to see in the 2007 Farm Bill. Chambliss was visiting Lubbock at the invitation of former Lubbock Congressman Larry Combest and took the opportunity to rub elbows with Texas ag groups and hear their comments about the next Farm Bill.

The common theme of the day's presentations was the importance and value that Texas agriculture sees in the programs of the 2002 Farm Bill and that they would like to see those programs carried forward in the 2007 Farm Bill.

Plains Cotton Growers President Rickey Bearden presented cotton's perspective for the next Farm Bill and included comments on a variety of issues including the WTO and crop insurance.

In regard to the 2007 Farm Bill, Chambliss said that he intends to do more of what he was doing in Lubbock, and he would be going around the country to listen to the recommendations of producers, try to identify any holes that need to be filled and work toward pulling together a good Farm Bill for U.S. agriculture.

He added that budget issues would impact the Farm Bill debate, as would the WTO situation. Commenting directly to those two issues Chambliss said that there would be money available to write the next Farm Bill even though it might not be as much as many, himself included, would like to see. He reiterated that his number one priority is to continue to provide a safety net for U.S. agriculture.

On the WTO, Chambliss also said that he does not intend to let the WTO situation dictate what will be included in the 2007 Farm Bill.

Chambliss noted in his remarks that in his view the WTO situation is definitely a concern, but should also be recognized as an opportunity for agriculture. Chambliss said that he has made it very clear that he will not stand by and willingly allow U.S. agriculture to be unilaterally disarmed in this process.

Summing up his WTO position, Chambliss noted that he has personally told the U.S. trade Representative's office, and the European negotiators, that he is much "more concerned about farmers in Paris, Texas than he is with the farmers in Paris, France."

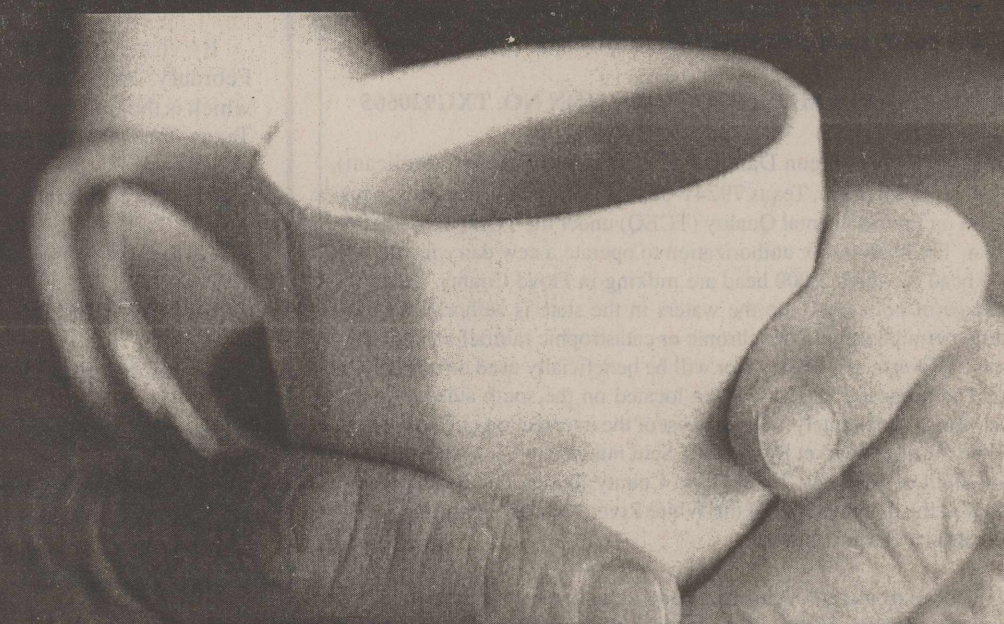

## 20th anniversary of Don't Mess with Texas

2006 is the 20th Anniversary of the statewide Don't Mess with Texas campaign.

Adopt-a-Highway groups in 17 West Texas counties will be participating in the 20th annual Don't Mess with Texas Trash Off scheduled for Saturday, April 1. More than 300 volunteers from Adopt-a-Highway groups in the Lubbock District will hit the highways that Saturday morning to help keep Texas clean.

In Floyd County, the Floydada High School National Honor Society and the Floydada Masonic Lodge #712 will participate.

The 2006 20th Anniversary campaign will carry a special message. The Texas Department of Transportation (TxDOT) is issuing a mantra to combat the state's stubborn littering tendencies- "Real Texans Don't Litter." "There aren't many things that are universally cool, and it's cool not to litter. I'd never do it," said Matthew McConaughy in an exclusive interview. McConaughy is one of the newest celebrities to appear in TxDOT's famous Don't Mess with Texas PSAs.

"Though recent research indi-

cates roadside litter has dropped by a third, we've also discovered that more than half of Texans admit they litter and that's just not acceptable," said TxDOT Travel Division Director Doris Howdeshell. "We're grateful to the celebrities who have joined with TxDOT during this milestone year to be prime examples of Real Texans who Don't Litter."

TxDOT launched the campaign back in '86 because of skyrocketing litter pickup costs," said Howdeshell. #### ORDINANCE NO. 06-1

AN ORDINANCE OF THE CITY OF FLOYDADA, TEXAS AMENDING CHAPTER 2, ANIMAL CONTROL OF THE CODE OF ORDINANCES BEING AN ORDINANCE OF THE CITY OF FLOYDADA, TEXAS, WHEREAS THE CITY OF FLOYDADA DESIRES TO AMEND ANIMAL CONTROL RELATING TO THE KEEPING OF LARGE DOGS, BEING DOGS OVER 35 POUNDS IN WEIGHT, AND AGGRESSIVE DOGS; AND PROVIDING FOR REPEAL OF CONFLICTING PROVISIONS; PROVIDING A PENALTY OF NOT LESS THAN FIFTY (\$50.00) DOLLARS NOR MORE THAN TWO THOUSAND DOLLARS (\$2,000.00) FOR VIOLATIONS; PROVIDING THAT EACH DAY VIOLATIONS ARE PERMITTED TO EXIST CONSTITUTES A SEPARATE OFFENSE; PROVIDING FOR AN EFFECTIVE DATE FOR THIS ORDINANCE; AND PROVIDING FOR PUBLICATION.

#### Part 2. Penalties

Any person, firm or corporation who shall violate any of the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction shall be fined not less than FIFTY DOLLARS (\$50.00) nor more than TWO THOUSAND (\$2,000.00) DOLLARS for each offense and each and every day's violation shall constitute a separate offense.

#### Part 5. Effective Date

This Ordinance as amended shall take effect upon completion of publication as provided by law. The City Secretary is hereby authorized and directed to cause the publication of the descriptive caption hereof together with the civil and criminal penalty provisions for violation thereof.

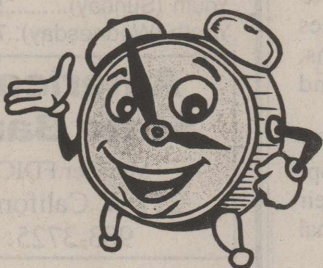

**CHARLES BREEDING**

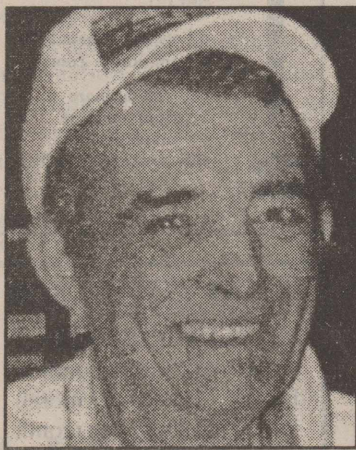
Charles Breeding, 70, of Lubbock, died on Saturday, March 25, 2006 at Covenant Medical Center in Lubbock.

The first Demonstration Club in Floyd County was organized in the Harmony and Sandhill communities in 1924.
