Lance Barrow to speak at Gala

Lance Barrow, the coordinating producer and lead game producer of "The NFL on CBS" and the coordinating producer for CBS Golf, will be the key note speaker for the Floyd County Friends Gala, March 24th.

Barrow, who has also been dubbed the "Quarterback of the Super Bowl Broadcast", is also known (believe it or not) as the Floydada Chamber of Commerce Manager from 1978-1982.

He may not have learned everything about producing sport spectaculars from serving as Chamber Manager in Floydada, but some local residents are proud to assume they may have had a very small part in furthering his career.

Barrow produced his first Super Bowl XLI in February 2007.

Before that he was replay director for CBS Sports' coverage of Super Bowl XXXV and Super Bowl XXXVIII.

He has produced sports' coverage of ski jumping nordic combined at the 1994 Olympic Winter Games and was the associate

director of the primetime broadcasts at the 1992 Olympic Winter Games.

He has also served as producer for coverage of NCAA basketball, college football and auto racing. Barrow produced coverage of the 1998 Daytona 500 for which he received an Emmy nomination. An eight time Emmy winner, he has also earned Emmys for his work on NCAA Men's Basketball Championship the NFL, and for CBS Sports' coverage of the 2004 Masters.

He was the recipient of the first Gene Sarazen Spirit Award presented by the Professional Caddie Assoc., in 2007.

Barrow attended Abilene Christian University, where he played football and baseball. He earned a communications degree in 1978.

He currently lives in Colleyville, Texas. He is married to Melissa and has two daughters: Katie, a sophomore at ACU, and Caroline, a sophomore at Fort Worth Christian High School.

Barrow worked his first Mas-

ters in 1977 as a spotter for Pat Summerall, a position Barrow says he just talked his way into. Barrow worked his way up to the position of Coordinating Producer of the NFL on CBS and lead game producer in May 2004 with the No. 1 NFL announce team of Jim Nantz and Phil Simms.

The years of training paid off when Barrow was named the coordinating producer of Super Bowl XLI.

In a recent Dallas Morning News interview, Barrow said putting on a live game of this magnitude on the air was a "structured, fast paced exercise in the ultimate of reality television."

To try and understand what exactly Barrow did as the Super Bowl producer, the Dallas Morning News writer, Barry Horn, wrote, "Mr. Barrow will be in charge of every second of action that an estimated 45 million viewers will see and hear from the Bears-Colts kickoff to the game's end."

Barrow's eyes scanned 120 monitors during the game. He was responsible for overseeing camera angles and deciding which replays and graphics viewers see and when they see them.

He decided commercial breaks and made sure every commercial paid for was broadcast.

"In addition," Horn wrote, "he'll be responsible for providing the NFL with every camera angle in his arsenal for replays of challenged on-field calls."

And to think--he learned at least some of his managerial skills as Floydada's Chamber of Commerce Manager.

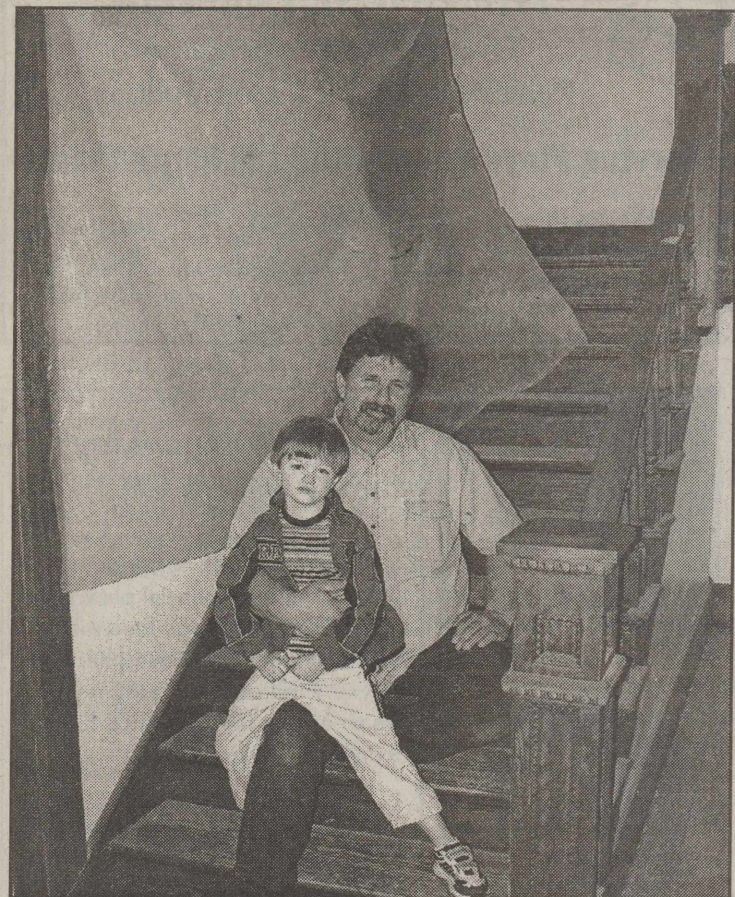

The 94 year old Lamplighter Inn, formerly the Commercial Hotel, is being renovated and remodeled on the lower floor by the new owner Monte Covington of Slaton. The entire outside of the building will receive a face lift, according to Covington.

Covington hopes to rent or lease rooms, or groups of rooms, to the wind energy construction workers, to the future ethanol plant workers and to the oil and gas workers coming into Floyd County.

Covington told the Hesperian-Beacon, "I am working closely

on this project with the Floydada Economic Development Corporation and its Executive Director Dora Ross."

"My plans are for the large open areas downstairs to be rented out for anniversary reunions, quinceanias parties, meetings for clubs and church functions," said Covington.

A history of the Lamplighter Inn was published in the May 24, 1990 edition of the Hesperian-Beacon. W.P. Daily constructed and opened the two story Commercial Hotel in 1913, according to its history.

City's 100th to be celebrated at Lockney's Chamber Banquet

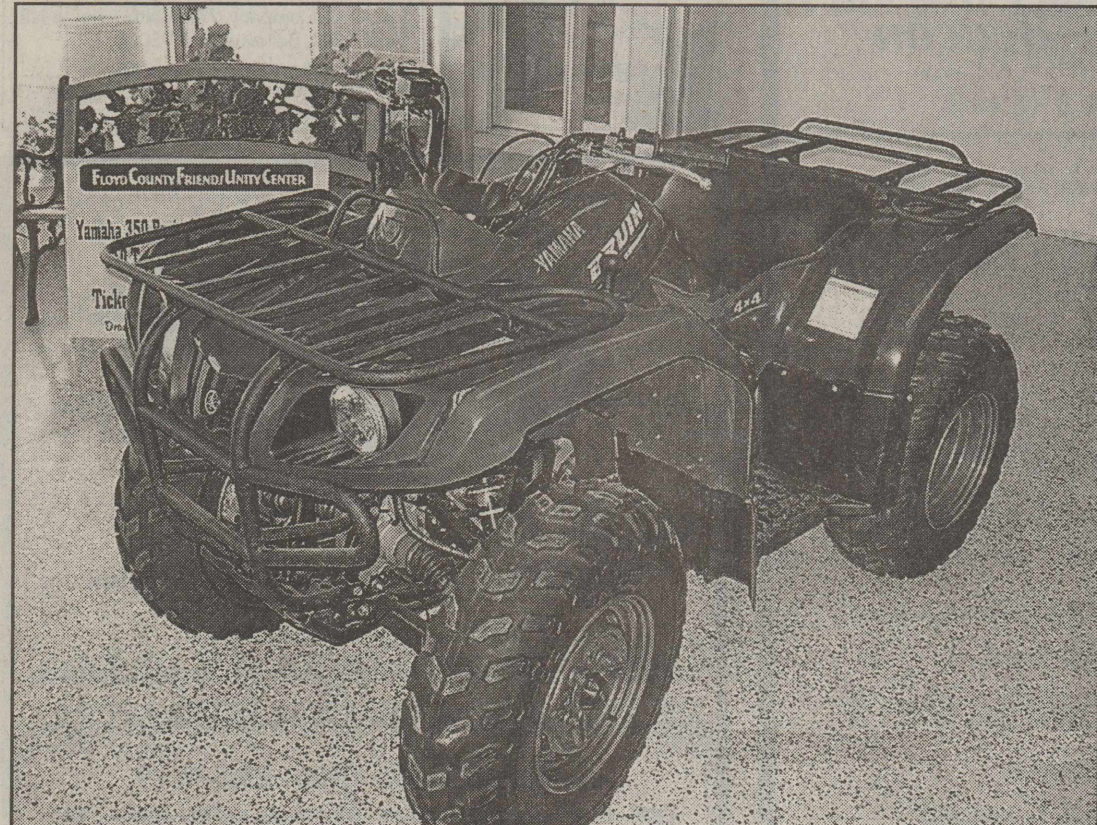
The Lockney Chamber of Commerce will celebrate the 100th birthday of the City of Lockney at the annual Chamber Banquet, March 31st.

"We are going to have a party to celebrate the City's incorporation 100 years ago," said Lockney Chamber Director, and upcoming Chamber President, Denise Doucette.

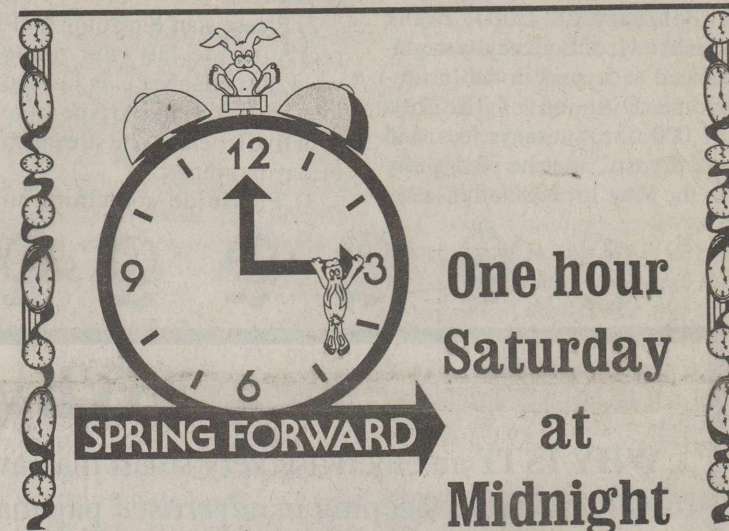
The Lockney Longhorn Band will be the featured entertainment at the Banquet.

Whirlwinds lose at Quarterfinal Playoffs

"Third time's the charm" is an old adage that many times proves correct except when it comes to the Floydada Whirlwinds in basketball. For the third consecutive season and the fifth time since 2000, the Whirlwinds bowed out of the Class 2A playoffs at the Regional Quarterfinals (3rd round) by losing to the Shallowater Mustangs 75-68 in overtime on Tuesday, February 27 at Lubbock Monterey H.S. Ironically it was the third loss of the season to #3 rated Shallowater.

Floydada (18-14) had lost both of their District 3-2A encounters with Shallowater by scores of 43-41 and 64-41. The Mustangs won District 3-2A with a perfect 10-0 record, and Floydada tied for 2nd place with Abernathy at 7-3.

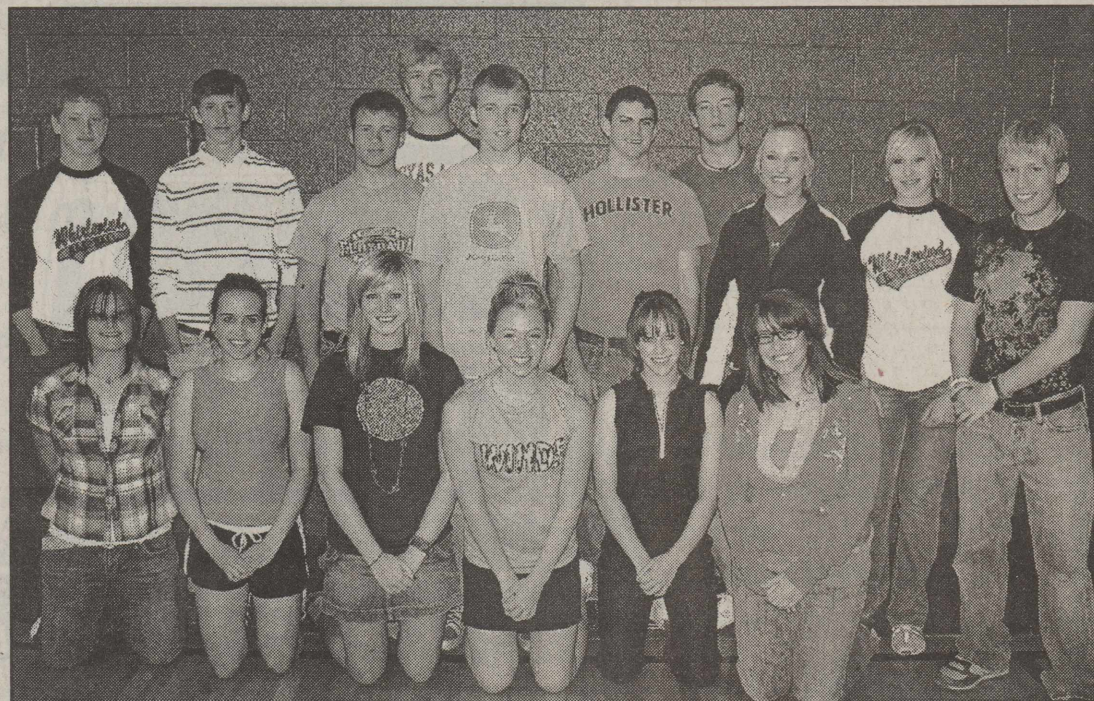
Shallowater (25-3) jumped out

to a 22-16 first quarter lead and pushed the margin to double digits of 38-28 at intermission. Sophomore guard Andrew Morris and 6'7" senior post Wes Dippery led the Mustangs with 14 and 12-points respectively in the first half.

But Floydada was determined not to go down without a fight by coming out and outscoring the Mustangs 16-8 in the third quarter to cut Shallowater's lead to 48-46 going into the fourth quarter. 6'3 junior Payte Beedy and 6'5" junior Troy Reedy connected on a pair of field goals apiece, and 6'1 sophomore Titus Miller drained a pair of 3's in the third quarter comeback.

The fourth quarter saw many lead exchanges and tied scores before Floydada built up a 6-point with nearly 3-minutes left in the game. Shallowater had the

The hotel housed Daily's family and was the scene of many Christmas parties and reunions. The hotel was passed down to family members and it survived two world wars and the Great Depression.

In the early years, Daily met trains as they stopped in Floydada. He brought his guests to the hotel in a horse drawn surrey. Traveling salesmen displayed their wares in the hotel lobby and tent shows and medicine shows set up their tents across the street from the hotel.

The Dailys retired in 1941 and their daughter, Ethel and her husband, E.J. Moorehead, purchased the hotel and operated it and a coffee shop in the hotel until 1964. The Mooreheads sold the hotel to their daughter, Dorothy and her husband, John Hotchkiss and they operated the hotel throughout the 60's, 70's and 80's.

On May 23, 1987 the Lamplighter Inn received the Distinguished Historical Marker. The marker was placed and dedicated by the Floyd County Historical Committee, with all three families attending the dedication ceremony.

make my computer screen feel like newsprint. It would make it a more authentic experience.

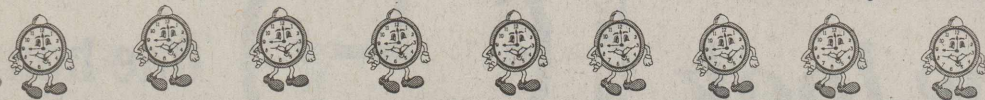

Panhandle Plains Land Bank to mail out cash patronage checks

AMARILLO--Panhandle Plains Land Bank, FLCA, CEO Robert R. Williams Jr. announced the mail out of the 2007 cash patronage approved by the board of directors at their January meeting. The cash payment will arrive at a time when Panhandle and South Plains operators find more bills than checks in the mailbox.

The Association board met January 18, 2007 in Amarillo to review end of year numbers from 2006 and approve the 2007 business plan that includes the cash patronage payment.

Association Board Chairman Wayne Garrett explained, "the 2007 cash patronage of \$3.35 million will return \$.25 of every dollar our customers paid in interest during 2006. This year's payment will again be 100% cash, and in our stockholders'

hands before tax time," said Garrett. "For example, a loan with a \$100,000 balance, paying interest at 7.25% during 2006, paid about \$7,250 interest. Their cash patronage will be \$1,812.00."

CEO Williams elaborated on the cash patronage. "This association is continuing our philosophy of Providing Value to Membership with the best possible service at the lowest possible cost. Interest rates remain steady as we move into 2007 with our variable product still 1% under the Prime Rate. Competitive fixed rates are available as well."

Williams explained that excellent portfolio performance, strong new loan growth, and efficient operations must come together for a return of this magnitude to happen. "We are committed to being the best choice for

long-term real estate mortgages on farm and ranch land, rural recreational tracts, rural homes, and agribusiness."

Floyd County: 3,324 barrels of oil and zero mcf of casinghead gas was produced during the year of 2006 in Floyd County. There were three producing oil wells in Floyd County during 2006, the Adams Lease Well #1 of the Stanley Gray (Canyon) Field, the E.M. Carmickle "A" Lease Well #1 of the Arick Field, and the W.D. Miller Lease Well #1 of the Wildcat Field. Reported County Production does not include test production that has not yet been reported to the Railroad Commission of Texas such as the 3,316 mcf of gas flared during the test of the McIntosh Lease

Well #1077.

Hale County: 2,079,046 barrels of oil and 919,748 mcf of casinghead gas was produced during the year of 2006 in Hale County. 2,077,752 barrels of oil and 919,748 mcf of casinghead gas was produced from the one hundred and twenty-eight producing wells on the twelve leases of the three Permian Basin Anton-Irish Fields (the Anion-Irish Field, the Anton-Irish Wolfcamp Field and the Anton-Irish Wolfcamp Upper Field) in Hale County. 1,294 barrels of oil and zero mcf of casinghead gas was produced during the year of

2006 from the one well of the Palo Duro Basin Lutrick Field in Hale County.

Motley County: 39,746 barrels of oil and 1 mcf of casinghead gas was produced during the year of 2006 in Motley County. There were nineteen producing oil wells located in the six producing oil fields of the Birnie (Congl.) Field, the Gupton (Canyon) Field, the Matador (Wolfcamp) Field, the Roaring Springs (Permo-Penn) Field, the Roaring Springs West (Permo-Penn) Field, and the Wolf Flat (Cisco) Field of Motley County.

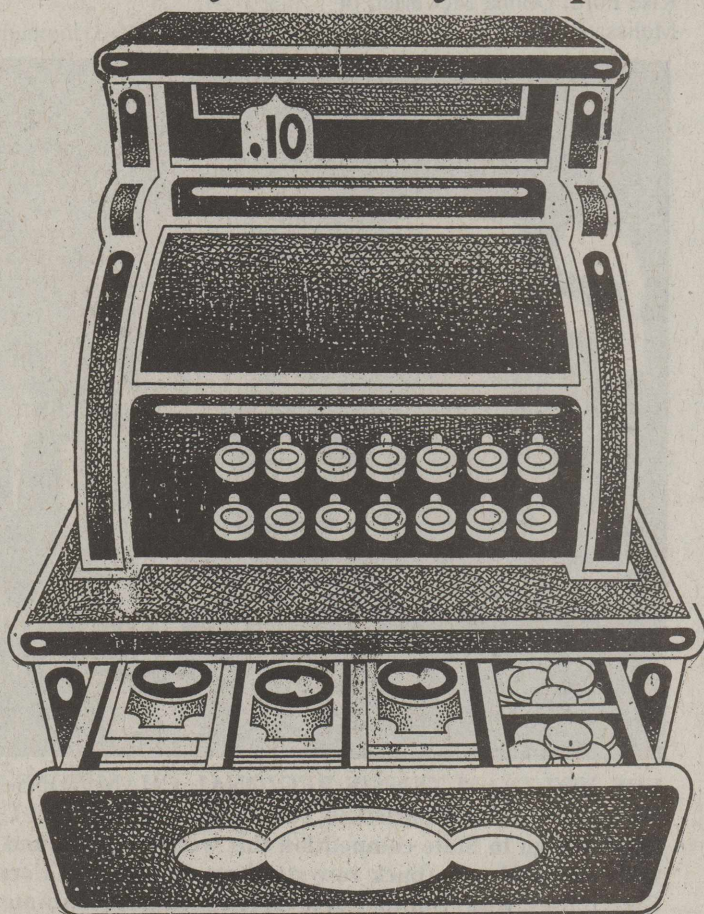

Aid and Attendance Benefits help with cost of assisted living

The Dallas Morning News published an article recently about decades old, but little known Department of Veterans Affairs benefit called Aid and Attendance. After reading the story, Melvin Lloyd of Shepherd's Meadow Assisted Living, began researching for more information about the benefit.

Lloyd discovered that the benefit is gaining notice because it allows seniors to move into assisted living properties that may have been a burden financially without it.

Many seniors believe that Medicare covers assisted living care. Neither Medicare nor Medicaid covers assisted living. Medicare will cover a limited time in a nursing home for rehab after a hospital stay.

Most seniors prefer the privacy and independence that assisted

living provides. This is where the federal benefit comes into play for some seniors.

Called the "aid-and-attendance" pension benefit, it pays up to \$1,470 a month to a qualifying veteran, \$945 a month to a surviving spouse, or \$1,743 a month to a couple to defray the expense of long-term care.

To qualify, veterans must have served in wartime, show a financial need and prove they can not live by themselves. A surviving spouse who hasn't remarried can apply for the benefit.

The VA benefit has several advantages over Medicaid funding. First, the veteran doesn't have to exhaust their assets, as required by Medicaid which only helps with nursing home costs. A veteran may have \$80,000, and a home, car and personal possessions aren't counted.

Next, veterans can transfer assets, usually to their children, to

reduce their net worth and qualify for the pension benefit, Mr. Lloyd said. Anyone applying for Medicaid funds faces strict limits on asset transfers.

Finally, applicants can usually prove a financial need showing their expenses exceed their income.

According to Mr. Lloyd, the biggest drawback to the benefit is the application process. "The government requires many documents, including military discharge papers and a physician's written evaluation and you've got to do everything exactly as requested".

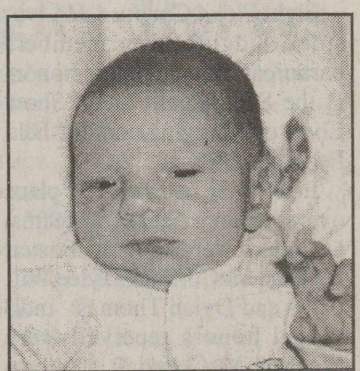

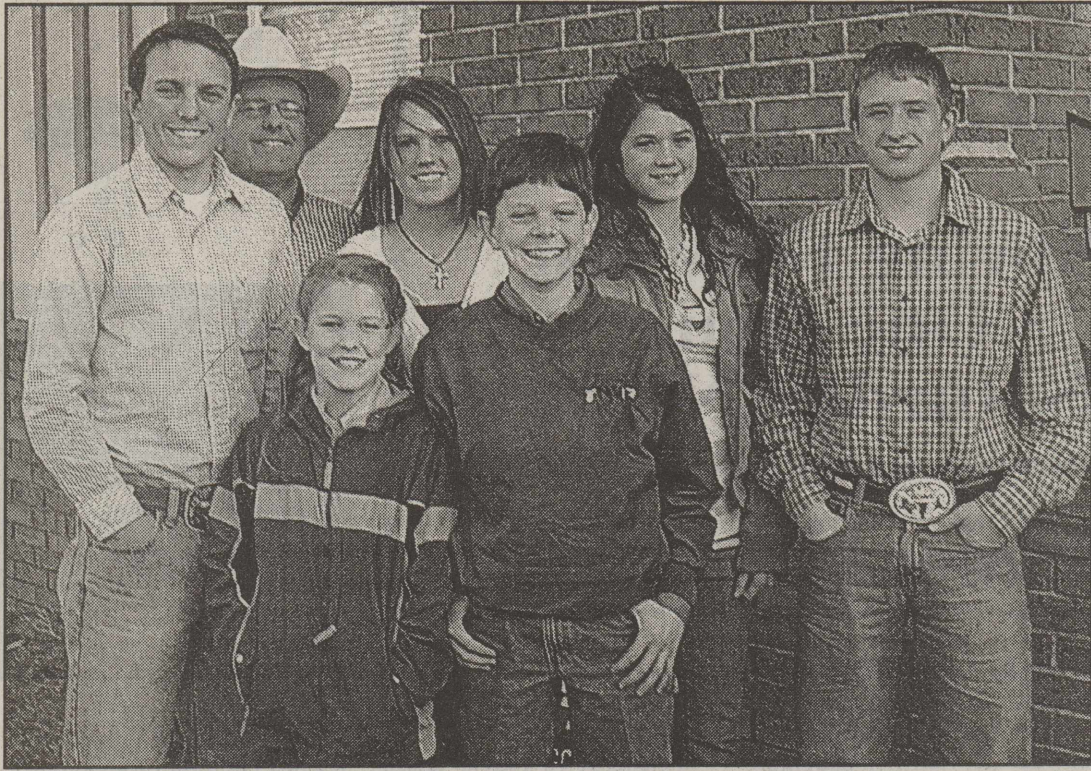

The Whirlwind baseball team wrapped up the Sweetwater

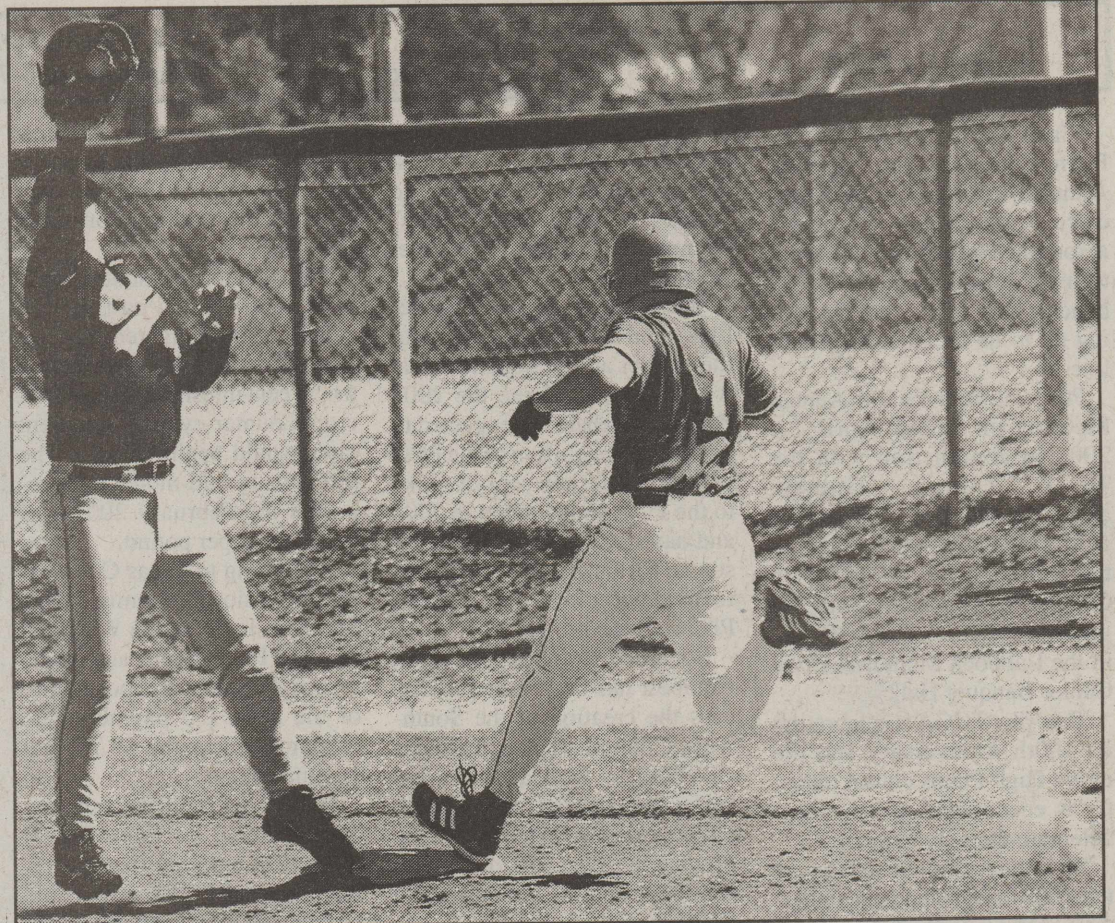

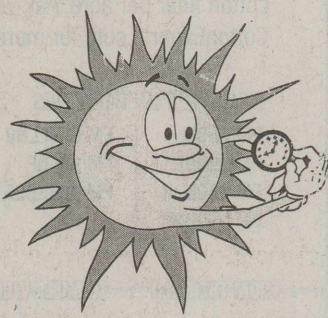

Plans are underway for the Plains Cotton Growers, Inc. 50th Annual Meeting and cotton producers and industry people across the High Plains will want to make arrangements to be on hand to hear from what is shaping up to be an all-star speaker line-up.

PCG will hold its 50th Annual Meeting on Friday April 13, 2007 in conjunction with the Texas Cotton Ginners associations' Annual Meeting and Trade Show, April 12-13, at the Lubbock Memorial Civic Center. PCG's meeting will begin with registration at 8:30 a.m. in the Lubbock Memorial Civic Center Banquet Hall.

This year TCGA is celebrating its 100th Anniversary and the entire High Plains cotton industry is encouraged to help them celebrate their centennial.

With the preliminary stages of the 2007 farm Bill debate underway, interest in the information that will be presented at the Plains Cotton Growers Annual Meeting should be high.

PCG Executive Vice President Steve Verett says the goal for this year's Annual Meeting is to provide High Plains cotton growers an opportunity to get both an insider's view of the 2007 Farm Bill process, as well as a thorough analysis of the mechanics shaping the debate.

Two other speakers have also been confirmed for the PCG meeting, both of whom will be intimately involved in the farm Bill development process although in very different ways.

Accepting invitations to address the PCG membership are Washington-based Farm Policy analyst James R. Wiesemeyer and former Lubbock area Congressman Larry Combest.

Wiesemeyer, who has covered farm policy in Washington, DC

more than twenty years is Vice President, Washington Bureau, for Informa Economics and writes the "Inside Washington" column for Agweb's Pro Farmer newsletter.

Wiesemeyer's high-energy delivery and incredible insight into the politics and personalities that will ultimately shape the 2007 Farm Bill debate are expected to be a must-see portion of the PCG program. Wiesemeyer last spoke to the PCG membership in 2005 and has since become a familiar source for farm policy news and information for many High Plains cotton producers.

Former Congressman Combest has been asked to discuss the creation of the Southwest Council of Agribusiness (SWCA) as well as share his views on the status of the SWCA effort to seek an extension of the provisions of the 2002 farm Bill. Combest, and his co-workers in Combest Sell & Associates, are representing the SWCA during the 2007 Farm Bill debate.

Combest Sell & Associates is a consulting firm dedicated to promoting sound U.S. farm policy that maintains and grows economic opportunity and jobs in rural America by keeping America's farmers and ranchers strong and competitive.

Verett notes that the PCG staff is ironing out the remaining details for this year's program and working with Chairman Peterson's staff to secure his participation. Once completed a final agenda will be released prior to PCG's April 13 meeting.

Upland Cotton average price received by growers through January 2007

Cumulative Upland cotton marketings for the first six months of the 2006 marketing year totaled 7.882 million bales according to information released February 28 by the USDA National Agricultural Statistics Service.

That figure is 2.295 million bales off the pace set through the same period last season and reflects the relatively stagnant nature of the export market for U.S. cotton.

According to USDA estimates January 2006 cotton marketings totaled 1.557 million bales with an average selling price of 49.70 cents per pound. So far the 2006 Upland Cotton Weighted Average Price calculated through January 2006 stands at 47.81 cents per pound.

January prices continued to reinforce the notion that prices are slowly creeping up, but no

one has yet been able to determine what it will take to move prices to a level that can start breaking this year's cotton out of the loan.

With the first six months of the marketing year now past, the calculated 2006 Weighted Average Prices is still 4.19 cents below the 52 cent threshold where 2006 crop Counter-cyclical payment rates would begin to drop. The preliminary mid-month price reported for February 2007 was 48.90 cents per pound.

According to Texas Cooperative Extension Economist Jackie Smith, a slowly rising Weighted Average Price might cause some to wonder about the possibility of the 2006 CC payment rate dropping below the 13.73 cent maximum rate.

When posed with this question Smith offered the following, "I think it is unlikely that the remainder of the 2006 crop could be sold at a high enough price to increase the average price received enough to result in a loss of more than the first two to three cents of the CC payment. At the current level of cotton futures, it would just be too costly to try to protect the two to three cents that I think is possibly at risk."

Smith noted that if the market were to dip into the low 50s in the next few weeks, it would make it less costly to purchase call options to protect the loss of the first few cents of the CC payment. He cautioned, though, that such a drop in price could also result in significantly lower planted cotton acres, which could allow prices to bounce back in mid summer.

According to Smith cotton futures prices would have to move all the way back into the mid 60s with a commensurate level of marketings to actually see as much as three or four cents of the CC payment disappear.

A move up to that level seems unlikely, concludes Smith, given the expected U.S. and world ending stocks for the 2006 crop year and that the prediction of fewer planted acres which would have more impact on next year's price.

The following table shows the average price received each month by farmers and the associated weighted average price based on prices and cumulative marketings from August 1 through January 31, 2007.

The 2006 Counter-cyclical payment rate authorized under the 2002 Farm Bill will be based on the 12 month Weighted Average Price Received by growers. For cotton the 12 month

Weighted Average Price will reflect price and marketings for the 2006 marketing year. The 2006 cotton marketing year began August 1, 2006 and ends July 31, 2007.

Waste pesticide collection dates announced

The Texas Commission on Environmental Quality, Texas Department of Agriculture and Texas Cooperative Extension are getting together to clean up the Texas countryside during the month of March.

As always these Agricultural Waste Collection Program events are free of charge and open to all Texas residents, not just farmers and ranchers. Participation is voluntary and confidential.

The joint effort is made of a series of six waste pesticide collection events across Texas. Three of this year's scheduled collection sites are located in the West Texas region.

Statewide, collection dates have been set up for Bryan, Huntsville, Carthage, Pampa, Plainview and Brownfield beginning March 13 and ending March 29.

High Plains residents will be most interested in the Pampa (March 26), Plainview (March 28) and Brownfield (March 29) collection dates.

The Agricultural Waste Collection program will accept leftover banned or unwanted agricultural pesticides, home chemicals including pesticides, paints and thinners, antifreeze, household batteries, aerosol cans, photographic chemicals, mercury thermometers, herbicides, gasoline, cleaners, pool chemicals, fluorescent bulbs used motor oil and oil filters, lead acid batteries and other automotive products.

The program cannot accept used tires, radioactive materials, explosives, compressed gas cylinders, herbicides containing 2,4,5-TP (Silvex), pesticides or wood preservatives containing pentachlorophenol in quantities greater than five gallons or nutrient materials that are neither hazardous nor contain pesticide admixtures.

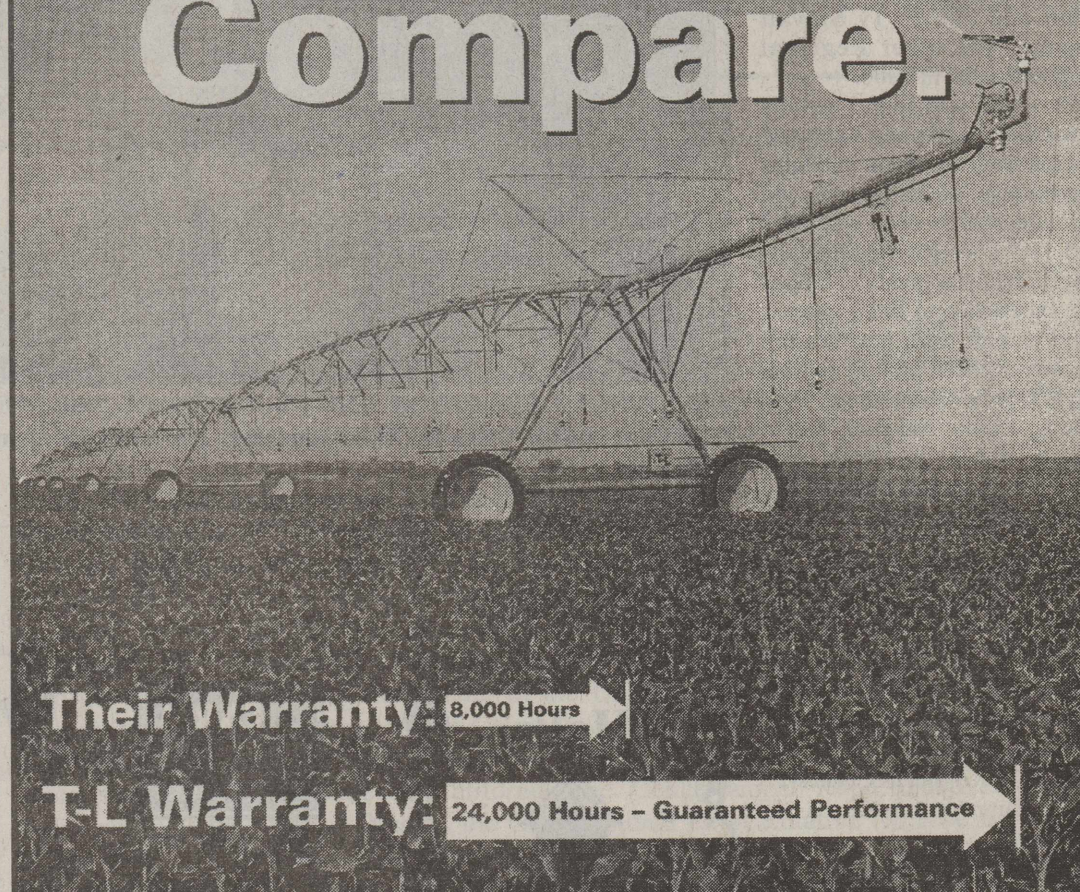

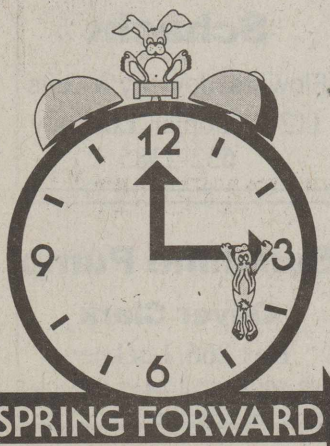

In accordance with Article IV, Section 4.06 of the Bylaws of Lighthouse Electric Cooperative, Inc., the Board of Directors has appointed a Committee on Nominations to prepare a list of nominations for Directors to be elected at the annual membership meeting of the Cooperative on April 27, 2006. Three (3) Directors, one each from District 2, District 5 and District 8, will be elected in 2006. Although Directors are nominated from the District which they represent, all members in attendance at the annual meeting vote on all candidates who may be properly nominated.

SECTION 4.02 QUALIFICATIONS:

No person shall be eligible to become or remain a director of the Cooperative who is a close relative of an incumbent director or an employee of the Cooperative, or is not a member in good standing of the Cooperative and receiving service within the District he represents; PROVIDED, that the operating or chief executive of any member which is not a natural person, such as a corporation, church, etc., or his designee, shall be eligible to become a director, from the Directorate District in which such member is located, if he or such designee (1) is in substantial permanent occupancy, direction or use of the premises served by the Cooperative, and (2) is a permanent and year-round resident within or in close proximity to an area served by the Cooperative; BUT PROVIDED FURTHER, that no more than one (1) such person may serve on the Board of Directors at the same time. No person shall be eligible to become or remain a director of, or to hold any other position of trust in, the Cooperative who does not have the legal capacity to enter into a binding contract or is in any way employed by or financially interested in a competing enterprise, or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to, among other, the members of the Cooperative. No person shall take or hold office as a Director who is the incumbent of or candidate for an elective public office in connection with which a salary is paid.

SECTION 4.05 DIRECTORATE DISTRICTS

The territory served by the Cooperative shall be divided into nine (9) Directorate Districts. Each District shall be represented by one director and the Districts are described upon the map on the territory served by the District attached to the Bylaws and made a part hereof.

SECTION 4.06 NOMINATIONS

It shall be the duty of the Board of Directors to appoint, not less than thirty (30) days nor more than one hundred (180) days prior to the date of the meeting of the members at which directors are to be elected, a Committee on Nominations, consisting of not less than five (5) nor more than eleven (11) members. The Committee shall prepare and post at the principal office of the Cooperative at least twenty (20) days prior to the meeting a list of nominations for directors to be elected, listing separately the nominee (s) for each Directorate District from or with respect to which director must, pursuant to this Article, be elected at the meeting. The Committee may include as many nominees for any director to be elected from or with respect to a Directorate District as it deems desirable. Any fifteen (15) or more members of the Cooperative, acting together, may make additional nominations in writing over their signatures, listing their nominee (s) in like manner, not less than fifteen (15) days prior to the meeting, and the Secretary shall post such nominations at the same place where the list of nominations made by the Committee is posted. The Secretary shall mail to the members with the notice of the meeting, or separately, but at least ten (10) days prior to the date of the meeting, a statement of the names and addresses of all nominee (s) for each Directorate District from or with respect to which a director must be elected, showing clearly those nominated by the Committee and those nominated by petition, if any. The chairman at such meeting, after all nominations so made have been duly announced, shall call for additional nominations from the floor and shall ascertain and announce, after any nominations made from the floor, the particular Directorate District from or with respect to which any additional candidates have been nominated.
