# Lockney J.P. arrested for shooting husband

Lockney Justice of the Peace Michelle Araujo, 33, was arrested Saturday, March 10, for allegedly shooting her husband, Romeo Araujo, 39. She was brought before Judge Penny Golightly at approximately 3:15 p.m. Saturday, and charged with Aggravated Assault with a Deadly Weapon.

Because Araujo is an elected official, the Floyd County Sheriff's Office turned the investigation over to the Texas Rangers. Ranger Marshall Thomas is handling the investigation.

Only a few details of the shooting are available for publication because of the ongoing investiga-

According to Law Enforcement authorities, the Floyd County Sheriff's Department was notified by W.J. Mangold Memorial Hospital that a shooting victim had been brought to the hospital by

Mr. Araujo was then taken by helicopter to UMC Hospital in Lubbock where he underwent surgery for multiple gunshot wounds to the abdomen area.

Mr. Araujo was able to give a statement to authorities and Michelle was later arrested at home after law enforcement spoke

The shooting allegedly took to the Floyd County Grand Jury. place at the Araujo's home, approximately 7 miles north of Lockney on FM 378.

According to District Attorney Becky McPherson the charge of Aggravated Assault with a Deadly Weapon is a 2nd Degree Felony. "This is the same degree as attempted murder and from the initial investigation we know she intended to shoot him but we need further investigation to determine if she was trying to kill him."

A person convicted of a 2nd Degree Felony can be sentenced to 2-20 years in prison and a fine up to \$10,000.

After arraignment, Michelle Araujo immediately bonded out on a \$25,000 bond set by Judge Golightly. Usually a bondsman requires 15% of the bond.

According to McPherson, Randall County District Attorney James Farren will present this case

"It will go before a Grand Jury," said McPherson.

Michelle Araujo also serves as the City Judge of Lockney.

She was appointed Justice of the Peace in October 1999, by the Floyd County Commissioners. She was then elected and has served in that capacity since then.

She is the daughter of Robert and Libby Delgado, of Lockney. She graduated Lockney High School in 1992, and attended Ranger Junior College for one year on a track scholarship.

She then transferred to South Plains College in Levelland and received her Associate of Arts degree in Criminal Justice. She then attended Texas Tech and received a Bachelor of Arts degree in Political Science with a minor in Spanish and Business Manage-

The Araujos have been married

for 14 years and have 4 children.

Romeo is the son of Angel and Emma Araujo, of Lockney. He is a farmer. He is currently listed in stable condition.

#### CAN ARAUJO CONTINUE TO SERVE?

Many questions have been posed on the legality of Araujo serving as Justice of the Peace after being charged with a felony.

According to District Attorney Becky McPherson, "According to Art. 16, Section 2, an elected official would be automatically removed from office if convicted of a felony. The arrest itself is not grounds for an automatic re- of the Local Government moval."

However, the County Attorney of a County, can initiate a removal suit of an elected official based on certain-criteria.

Two citizens can also bring a petition for removal of an elected

official to a County Attorney. However the decision to move forward with the petition would ultimately be up to the County Attorney.

When questioned on the grounds or procedures to remove an elected official, Floyd County Attorney Lex Herrington said, "I've never had any cause to research that. I don't know what the grounds are to remove an elected official and I have no idea where to find it right

now.' The grounds for removal can be found in Chapter 87

The code states an elected official can be removed for incompetency, official misconduct, or intoxication caused by drinking alcoholic beverage.



# County accepts resignation of Budget Finance Clerk and discuss job's future

The Floyd County Commissioners met Monday, March 12, and accepted the resignation of Budget Clerk Gayla Griffin, consolidated voting boxes for the next election and reappointed Preston Belt as the Floyd County Emergency Coordinator.

The commissioners accepted the letter of resignation by recently hired Budget/Finance Clerk Gayla Griffin.

In a related matter, the Budget/Finance Clerk position was discussed by the commissioners. Commissioner Lennie Gilroy pointed out that with the new software installed maybe the position was not even needed to be filled. "Perhaps we could hire an auditor quarterly for checks and balances," said Gilroy.



# County prepares for 911 conversion

County to be trained to help in the conversion of rural addresses to house numbers for 911 emergency purposes.

Brosch told the court, "We have a year to convert all the rural routes in the county over to 911 (house numbers).'

Upon the recommendation of Judge Golightly, the commissioners unanimously approved County Judge Secretary Angie Gonzales to be trained and reimbursed for time and travel in this county-wide 911 change over.

Commissioner Jon Jones stated, "I want to go on record that this is a non-funded mandate by the federal government meddling in our (the county's) business and forcing us to have to do

Concerning the May 12, 2007 General Election, the court approved the consolidation of two voting boxes in Pct. 24, South Plains voting box and Mt. Zion Baptist Church voting box, to be at one voting box located at the Mt. Zion Baptist Church in Floy-

The other three voting boxes in Floyd County will be at: Pct. 23, Floyd County Courthouse; Pct. 1, Massie Center, W. Georgia; and Pct. 18, First United Methodist Church, 102 W. Poplar, Lockney. The county has a constitutional amendment to be voted on in this election. There are no candidate positions to be

The commissioners gave permission to Judge Golightly to sign an agreement with Jerry Lux, representative with a Christian Radio Station, to lease space on the county's radio tower just west of Floydada.

Following a lengthy discussion, the court unanimously voted not to open the courthouse basement to the public to be used as a storm shelter. Some of the reasons for not opening the basement to public was: lack of ventilation, lack of restrooms, lack of handicapped facilities and lack of accessibility from the outside.

Melissa Long, Floyd County Extension Agent, gave the com-

missioners a report concerning her training classes she has given the past month, such as, Food Protection Management classes, Better Living for Texans and Do Well Be Well with Diabetes

The commissioners approved a Family Protection fee of \$15 for fines collected and to be used locally with the Children's Welfare Board and the court approved an agreement for the Drug and Alcohol Program.

The commissioners voted to sell some of their surplus equipment by holding a county auction in the near future.

The court unanimously approved the low bid of \$22,172.00 presented by Oden Chevrolet of Floydada for the purchase of a 2007 Chevrolet Silverado extended cab, 4-wheel drive, pickup to be used by the sheriff's

In a related matter, the commissioners approved the bond for Sheriff Deputy Trey Dolloff and the deputation of Cory Speed, as bailiff/transporter. Judge Golightly told the court

that she had been asked to serve on the board of the Work Source of the South Plains. "I am happy to represent Floyd County," said Golightly.

County Treasurer Martinez presented to the court the February, 2007 Financial Report. The report showed a Beginning Balance of \$998,592.88, Receipts of \$204,933.28, Transfers In and Out of \$177,997.04, Disbursed at \$158,513.35, leaving an Ending Balance of \$1,045,012.81.

The court transferred \$48,200 from the Road & Bridge Fund into the four precincts at \$12,000 each, with \$200 going into the

Law Library. Five farm contracts were approved. They were: Pct. 4, 4 miles east of Floydada on Highway 70, to clean out waterways, by Louis Cervera; Pct. 4, 14 miles and 5 miles north of Floyfurrows, by Zane Colson; Pct. 2, 4 1/2 miles northwest of Floydada, to clean our drainage ditch, by the Carthel Brothers; Pct. 4, road, by Jon Jones; Pct. 4, southwest of Dougherty approximately 3 miles, to blade dirt away from fence line, by Jason Everett.

In other matters, Dr. Davor Vugrin, project director of the Lubbock/South Plains Colon Cancer Prevention Task Force, and Nancy Henderson of Lockney both spoke to the court about an awareness campaign in 2007 to inform the public about colon cancer prevention.

Henderson told the court, "I appreciate your participation in this awareness proclamation for the prevention of colon cancer." According to Henderson, her husband, Randy, has had a ten year struggle with colon cancer.



Trip to Iraq

I have just returned from my most recent trip to Iraq where I made stops in Baghdad, Fallujah, and Ramadi. During my trip, my goal was to determine if the new strategy - the Baghdad Security Plan - is working. As I have done in the past, I will post my "Iraq Journal" on my website where constituents can read about who I met with and what I saw on my trip.

This was my third trip to the region since December of 2003, and each time I go to Iraq I see a country that is better than my previous trip. Our troops' efforts are making a difference. From security in neighborhoods to irrigation systems on farms, Iraq is slowly getting on its feet. To be sure, significant obstacles remain and setbacks will occur along the way, but I believe our troops can successfully complete their mission.

Supporting a Taxpayer Bill of Rights

While serving in Congress, I have been part of the fiscally responsible Republican Study Committee (RSC), which is a group of members who put a high priority on spending taxpayer dollars wisely. The RSC has often stood up against irresponsible policies that expand government spending and create or continue wasteful federal programs. Each year, more and more taxpayer dollars get poured into these programs in a seemingly unending cycle of budget mad-

We at the RSC believe there is a better way. Therefore, this week the RSC will launch the "Taxpayer Bill of Rights." The goal of this initiative is to reform how taxpayer dollars are spent and develop solutions to current budget challenges. If successful, it will lead to policies that help protect taxpayers from over-spending, over-taxation, and budget deficits. More details on this initiative will be unveiled in the days and weeks ahead, and I will be sure to include them in future Roundups.



# FISD Superintendent presents goals

The Floydada ISD Board met Tuesday, March 6, and approved a 2007 superintendent's evaluation list of district goals and approved an election agreement between FISD and Floyd County.

The five 2007 district goals approved by the board and presented by Superintendent Jerry Vaughn were:

(1) The board will see improved curriculum alignment across grade levels within subject areas, such as, new programs, program modifications, new strategies and special programs as required by the state.

(2) The superintendent will work toward improving communication from the district to the board, staff, students and community members, including an FISD newsletter and weekly ra-

(3) The superintendent will ensure the continuation, maintenance and upgrade of the technology immersion project and enhancement of instruction throughout the district.

(4) The superintendent will work with the board, architect and staff to ensure successful construction and renovation of the A.B. Duncan Elementary project that meets the needs of the district, including progress and any restraints or changes needed.

(5) The superintendent will work toward the development of a special education program to meet the needs of all FISD special needs students within the fiscal limitations of the district, including personnel and complying with all federal and state regula-

Board Members Bart Greer and Kerry Pratt both questioned the wording, "within the fiscal limitations of the district," of number 5, concerning the special needs students.

Superintendent Vaughn assured them, "Whether we are in a co-op, or not, these services have to be provided within our budget."

will offer a regional workshop for current and newly recruited 4-H shooting sports leaders and coaches in West Texas in 2007. The workshop is set for April 27-28 at the National Guard Armory, 301 East Regis in Lubbock.

Workshops will encompass archery, pistol, rifle, reloading, shotgun, black powder and coordinators training-instruction specifically geared for coordinating a local shooting sports club or program. "Instructors will address teaching and coaching techniques, the fundamentals of safety and firearms nomenclature, and strategies for success in youth program leadership", said Dr. Brad Davis, 4-H youth specialist based at Lubbock.

"We will also offer handloading and reloading classes if there is sufficient interest," he said. "Reloading classes will require a minimum of five participants, but we would prefer at least 10. The workshops feature hands-on instruction in all sessions. All courses are dedieated to teaching marksmanship in each shooting sports discipline."

"Those who complete the archery training can qualify for National Archery Development Association instructor certification," Davis said.

"All volunteers who attend are trained by certified state instructors," he said. "Volunteers who complete this training and demonstrate experience with a local club can qualify to serve as state 4-H shooting sports instructors and coordinators.

The registration deadline is April 5th for the Lubbock event. 
So far in the baseball season, Winds faced a tough 3rd state ranked New Deal team at New Deal on Saturday, March 10th.





The schedule for the Plains Cotton Growers 50th Annual Meeting was enhanced this week with confirmation that Congressman Jerry Moran (R-Kansas), Ranking Member of the House Agriculture Committee's General Farm Commodities and Risk Management Subcommittee, will present the keynote address at the organization's membership meeting April 13.

The PCG Annual Meeting is being held in conjunction with the Texas Cotton Ginners Annual Meeting and Trade Show, April 12-13, at the Lubbock Memorial Civic Center. PCG's meeting is set to begin with registration at 8:30 a.m. in the Lubbock Memorial Civic Center Banquet Hall.

"We are excited to have the commitment of Rep. Jerry Moran to present this year's keynote address to the PCG membership," says PCG Executive Vice President Steve Verett.

Verett added that PCG's goal for this year's meeting is to provide an in-depth view of issues involved in writing the 2007 Farm Bill. He said that accomplishing that goal meant a short list of possible participants that included only Rep. Collin Peterson, Chairman of the House Agriculture Committee, and Rep. Moran, the Ranking Member of the General Farm Commodities and Risk Management Subcommittee.

Verett notes that the organization is honored to have Rep. Moran to head this year's agenda based on his past chairmanship of the General Farm Commodities and Risk Management subcommittee and his thorough knowledge of the issues that will shape this year's Farm Bill debate. Chairman Peterson was unable to participate in the PCG meeting due to other commitments.

As previously reported, two other speakers have also been confirmed for the PCG meeting, both of whom will be intimately involved in the Farm Bill development process although in very different ways.

Previously accepting invitations to address the PCG membership are Washington-based farm policy analyst James R. Wiesemeyer and former Lubbock area Congressman Larry

Wiesemeyer, who has covered farm policy in Washinton,, DC for more than twenty years is Vice President, Washington Bureau, for Informa Economics and writes the "Inside Washington" column for Agweb's Pro Farmer newsletter.

Wiesemeyer's high-energy delivery and incredible insight into the politics and personalities that will ultimately shape the 2007 Farm Bill debate are expected to be an excellent compliand 2007 growing seasons.

ment to the presentations of Rep. Moran and Combest.

Former Congressman Combest has been asked to discuss the creation of the Southwest Council of Agribusiness (SWCA) as well as share his views on the status of the SWCA effort to seek an extension of the provisions of the 2002 Farm Bill. Combest, and his co-workers in Combest Sell & Associates, are representing the SWCA during the 2007 Farm Bill debate.

Combest Sell & Associates is a consulting firm dedicated to promoting a sound U.S. farm policy that maintains and grows economic opportunity and jobs in rural America by keeping America's farmers and ranchers strong and competitive.

Disaster Assistance moving forward in House

Democrate leaders in the House of Representatives formally announced plans for a Crop Disaster Program to be included as part of the pending Iraq war supplemental appropriations bill that will be considered later

The House proposal would cover the 2005-2006 and the early part of the 2007 growing seasons (to include recent citrus losses) and provide growers the option to receive benefits for losses incurred in one of those three years.

The Democrate's plan, which carries a \$4.3 billion price tag, includes a few new wrinkles but is essentially expected to be a clone of the 2003/2004 disaster

The most striking difference between the House proposal and past disaster programs is that program eligibility would be directly tied to whether or not a producer purchased crop insurance and had coverage in place when disaster struck.

During the press conference announcing the program, House Agriculture Committee Chairman Collin Peterson noted that the crop insurance requirement was a "fiscally responsible" element and would reflect how future disaster relief will be struc-

The only other concrete piece of information available regarding the House proposal is that the reimbursement rate for eligible losses will be two-thirds of the established price. Additional details of the House proposal, including how payment rates will be established, will be passed

along as they become available. For now, the announcement is another piece of good news for growers and tangible evidence that Congress is moving forward with a crop disaster program to offset the devastating effects of weather during the 2005, 2006





**PUBLIC NOTICE** BRIEF EXPLANATORY STATEMENT CONSTITUTIONAL **AMENDMENT** SPECIAL ELECTION MAY 12, 2007

**PROPOSITION 1** (SJR 13)

SJR 13 would amend the Constitution to authorize the legislature to adjust the public school ad valorem tax or tax rates for taxpayers who are aged 65 or older, or are disabled, and who are owners of an exempted homestead. The amendment would thereby allow the legislature to provide tax relief to such elderly or disabled taxpayers who did not receive tax relief as a result of the school tax rate reduction passed in the 79th Legislature, 3rd called session.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for public school purposes on the residence homesteads of the elderly or disabled to reflect any reduction in the rate of those taxes for the 2006 and 2007 tax years."
