## Record crowds enjoy Floyd County Gala

Twelve Galas have been held at the Floyd County Friends Unity Center, and this last one on March 24 is being called "the best ever".

The Unity Center recorded a record crowd for the Gala with 340 guests in attendance.

Money raised for the Center was reported at approximately \$30,000 through ticket sales and auction purchases, etc.

Elaine McNeill won the \$1,000 cash after her "horse" came across the finish line first in the first "Floyd County Stick Horse Race" ever held at the Unity Center. The money was donated courtesy of First National Bank of Floydada.

Otto Schacht won the Yamaha 4-Wheeler and then donated the vehicle back to the Floyd County Friends.

Janice Lloyd was the winner of a Tom-Tom GPS.

CBS Sports Producer Lance Barrow was the guest speaker at the Gala and spoke of his love for, and this fond memories of, Floydada.

Barrow recounted his story of his rise in CBS Sports Production and working with Pat Summerall.

"Lance Barrow was more than expected," said Co-Emcee Nick Long. "His stories of his sports coverage was fascinating and his humor was very timely. But I think what touched the audience so much was his sincere appreciation of the people in Floydada and Floyd County during his 4-year stay here from 1978-1982. He reminded us how fortunate

we are to live in a place like this, and he was impressed with the Unity Center."

Alexis Hall and Tate Greer provided musical entertainment.

"Tate Greer and Alex Hall were something else," said Co-Emcee Nick Long. "Tate was not 100% because of a sore throat and almost could not perform. It was very touching how Tate and Alex supported each other behind the scenes."

Tim Assiter was the auctioneer in charge of the Live Auction.

The top auction item was a child size 110 CC 4-Wheeler which sold for \$1,000 and homemade fudge from Lesca Durham which sold for \$600.

As in years past an entertaining game was invented to pick the grand prize winner of the \$1,000 cash.

This year a stick horse race was used. The race was broadcast by Nick Long, Tim Assiter, and CBS Sports Producer Lance Barrow.

After being questioned on his knowledge of broadcasting a horse race, Barrow replied that this would be his first time.

The broadcasters provided play by play action, and Barrow took charge of calling for close ups and commercial breaks.

In the cash drawing it was eventually narrowed down to 4 people who would compete in the Floyd County Derby: Elaine McNeill on "Barwise Bouncing Betty", Marty Covington, on "Dougherty's Dizzy Dan", Joyce Henderson on "South Plains Simply Delicious", and Cynthia Bybee on "Providence Prancing Prince".

Colored vests were used to match up jockeys with the colors on their horses.

John Quebe, also known as "Paddock Pete" rode his steed, "Muncy Mighty Midget" onto the track and led the other jockeys and their horses across the stage and into the "gate".

Giant dice were rolled to move the horses down the field.

The audience participated by putting their bets in buckets to pick who they thought would win the race. At the end of the race, one name was drawn from each bucket and cash prizes were given to the bet placers.

Elaine McNeill and Bouncing Betty came across the finish line first, bringing her a \$1,000 prize.

Dee Chance's name was drawn from the winning bucket and she earned \$300, courtesy of Assiter and Associates.

The name from the 2nd place bucket was Travis Jones and he won \$150 courtesy of Banker's Petroleum.

Sylvia Ortega won \$100 courtesy of Petro Globe after her name was drawn from the 3rd place bucket.

Regina Smith won a consolation prize of an umbrella.

Martin Stoerner, President of Floyd County Friends, said he believed it was the "best Gala ever".

"The amount of people who came made it the success it was," said Stoerner. "We enjoy putting on the Gala when there is a large crowd there to enjoy it. Five percent of the whole county was there to support the Gala. It was humbling to see," said Stoerner.

## Lockney ISD considers use of wind turbine for power

The Lockney school Board met Thursday night, March 22, in the Lockney High School Library and voted to place a refundable deposit for one E 15 wind turbine for LISD. The deposit locks in a price and gives the trustees time to further study the prospect of putting up a wind turbine.

A power point presentation was made to the public by Company Directors Charles Newcomb and John Brown, of Entegrity Wind Systems, regard-

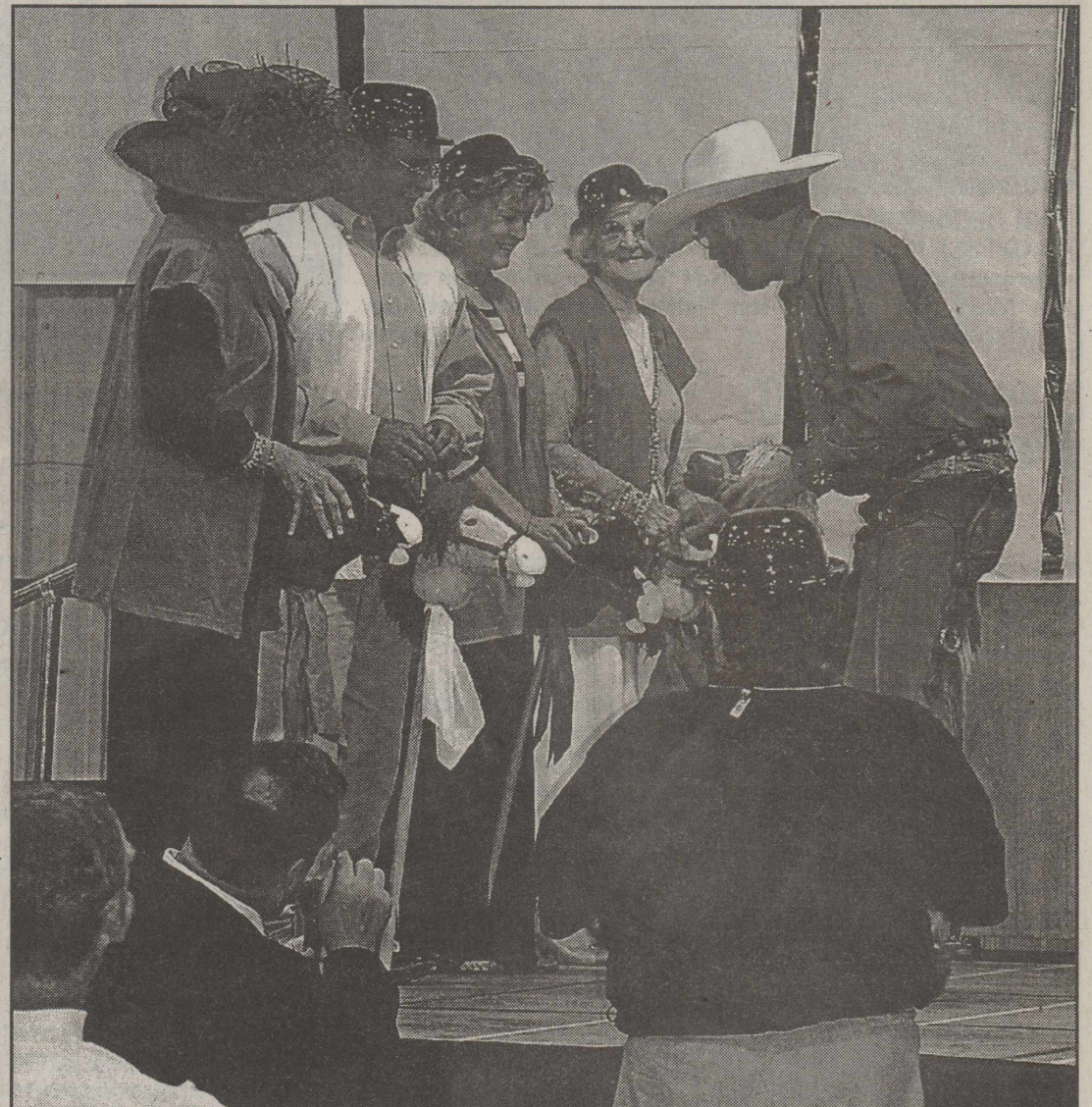
ing the possible installation of an intermediate size wind turbine (hub height at 102', 50' rotor diameter). Also present was Terry Coleman who installs and maintains the wind turbines.

The company was asked to do an analysis for Lockney Independent School District, based on utility bill data and a visit to the district. A dozen interested citizens attended in addition to the School Board Trustees, Superintendent Phil Cotham, High School Principal Dean Thompson, Junior High Principal Todd

Hallmark, Elementary Principal Jean Ann Williams and Coach Joe Robertson.

Brown and Newcomb said the best economic case for a wind turbine, according to their analysis, within the Lockney ISD would be at the Elementary School behind the meter. The annual consumption of the facilities serviced by this meter is approximately 350,000 kWh/year. Based on this value, as well as seasonal usage and wind production, the project is economically

## Araujo faces another misdemeanor charge

Lockney Justice of the Peace, Michelle Araujo, is now facing another Class A Misdemeanor Charge.

March 23, in County Court, Araujo was charged with Official Oppression (Texas Penal Code 39.03).

County Attorney Lex Herrington filed the complaint based on an affidavit filed by Sheriff Paul Raisse.

According to the affidavit, Floyd County Justice of the Peace of Pct. 2 & 3, "acting under the color of her office and employment, did intentionally deny or impede (name withheld) in the exercise and enjoyment of her right or privilege or power or

immunity, to wit: her right to free speech and right to travel."

The complainant in this case (whose name is being withheld because of fear of reprisal) told The Hesperian-Beacon she had received a threatening phone call from Araujo a few days before Michelle Araujo allegedly shot her husband, Romeo Araujo.

The complainant said, "She (Michelle Araujo) told me she had the authority to do whatever she wanted to do with me... and that she could make my life miserable."

According to the Penal Code a "public servant acts under color of his office or employment if he acts or purports to act in an offi-

cial capacity or takes advantage of such actual or purported capacity."

Michelle Araujo was arrested March 10 with Aggravated Assault with a Deadly Weapon after she shot her husband, Romeo, several times in the abdomen area. This is a 2nd Degree Felony.

The J.P. was also charged March 16, out of Briscoe County, for selling alcohol to a minor. This complaint, filed by the Texas Alcohol Beverage Commission, came after a "minor" sting in Bruskie's Liquor Store, located on Hwy. 378 in Briscoe County. Bruskie's is owned by Michelle and her husband, Romeo.

## Passport processing slow

As the local Passport Acceptance Agency, the District Clerk's office in Floyd County, recently received a notice from the National Passport Service reporting delays in processing passports.

If routine service is requested, it is currently taking up to 10 weeks for the passport to be processed. It is taking approximately 3 weeks after they receive the application for their system to start tracking the application and for customers to be able to track their application online. If expedited service is requested, it is now taking 3 to 4 weeks for the passport application to be processed and returned.

Passports are required for all U.S. citizens flying out of the country. Passports are also required for any U.S. citizen planning to leave the ship at any foreign port while on a cruise. U.S. citizens can still cross into Mexico and Canada by land without a passport but the process to re-enter the United States is taking longer, sometimes up to three or four hours.

It had also been reported earlier that U.S. citizens under the age of fourteen would not need passports for land crossings. The National Passport Processing Service has notified Acceptance Agencies that this rumor is not true. All U.S. citizens regardless of age will be required to have a passport.

If you are planning a trip out of the country this summer, plan early and start the passport application process as soon as possible.

Passport applications can be picked up at the Floydada Post Office and the District Clerks Office. Along with the application, you will need a certified copy of your birth certificate or certificate of citizenship, two passport photos, a photo ID and the processing fee.

The processing fee is \$97.00 for individuals 16 and older and \$82.00 for individuals under the age of 16. The fee to expedite service is \$60 per application. The District Clerks Office is the only Passport Acceptance Agency in Floyd County.

## Palo Duro Basin Oil and Gas Update

**Floyd County:** The Right of Way Agreements between the landowners and PetroGlobe Energy U.S.A. Ltd. for the pipeline connection from the McIntosh Lease running South four miles along Floyd County Road 271 to the Atmos pipeline have been filed and recorded in the official public records of the Floyd County Clerk's office.

**Floyd County:** Last week the Patterson-UTI Drilling Rig #712 began moving to the Basa Resources, Inc./Tyner Texas Operating Company Joint Venture Maurice Campbell Lease Well #1. Due to recent rains there have been some delays in getting all of the equipment on location, rigging-up and spudding the well. As conditions dry up rig opera-

tions and drilling will proceed. The Maurice Campbell Well #1 is located 467 feet from the South Line and 467 feet from the West Line of Section 50, Block 1, AB&M Survey, 12 miles East of Floydada and 3/4 mile North of the PetroGlobe Energy U.S.A. Ltd. McIntosh Lease Well #1077.

**Motley County:** Drilling has been completed on the Bankers Petroleum (US) Inc. Cogdell "64" Lease Well #1, and completion work is anticipated.

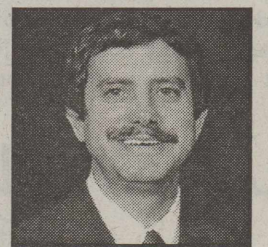
The speaker at the banquet will be Michael RunningWolf. Judy Schacht, of Schacht Catering, will provide the meal.

# Lockney ISD considers wind turbine

viable for a single EW 15 50kW Wind Turbine.

Entegri Wind Systems, Inc. (EWSI) considers placement of the wind turbine at Lockney Elementary to be a strategic opportunity for both the school district and the company. They are offering LISD a discounted price of \$155,000 including shipping, installation and commissioning. This represents a \$10,000 discount from the standard rate.

According to EWSI the single turbine project will produce 150,000 kWh/year and meet approximately 40% of the Elementary School's annual electricity needs. Under Xcel Energy's Net-Metering tariff, project sizing is important and the single turbine ensures that all energy produced by the unit is valued at retail rate (currently averaging \$0.08/kWh). With the assumption of no increase in the future price of electricity, the simple payback on the project is 12 years. If conservative escalation rates are assumed and 'Green Tags' are sold for \$0.02/kWh, payback decreases to 9 years. In any case, the cost of electricity generated by the wind turbine is fixed at \$0.03/kWh throughout the life-span of the project (30 years) and savings exceed \$800,000. From an operational standpoint the turbine saves \$12,000/year in utility costs in year 1, increasing to \$17,000/year in year 5.

The company provided the board with a financial summary sheet summarizing the business case for the turbine and listing all underlying assumptions.

EWSI thinks the project offers LISD a unique opportunity to continue its leadership in the community by promoting and supporting clean energy and energy independence while also saving money for the district.

According to EWSI, "Our production guarantee and maintenance plan during the first five years eliminate risk and our analysis shows conclusively that distributed wind is a cost-effective business strategy."

In order to proceed in developing the project including all pre-engineering, interconnection agreements and permits, as well as to secure the "Early Adopter" price, the LISD would be required to pay a fully refundable deposit of \$25,000 by April 19, 2007. The deposit is refundable if LISD elects not to proceed with the project for any reason at any time before June 30, 2007. The company does not charge for pre-engineering and design services. Instead, they ask for an initial commitment (refundable deposit) from the customer to keep the project moving forward.

Brown and Newcomb fielded questions after their presentation. The following are a few that were asked.

**Where is the proposed location?** The proposed site would be behind the stands west of the track field. This site was recommended to place as much distance as possible between the tower and the closest existing houses. Plus, it would be close to an existing transformer. (It cost \$10 a foot for every foot of distance the tower is placed from the transformer.)

**What noise level are we looking at?** If you are a city block to a block and a half away from the tower, in a quiet surrounding, you would have to listen for it to hear it.

**Over the time you have been erecting these wind turbines, how many tower failures have there been?** There have been two but it was proven the failures resulted from improperly constructed footing, not the tower

itself. The lattice towers are designed to withstand sustained winds of 133 miles per hour.

**How often will it run?** The turbines are designed to kick in at a wind speed of 9 miles per hour and shut down at a sustained wind speed of 50 miles per hour.

**What about safety for the children?** A simple chain link fence topped with barbed wire installed close to the foot of the tower has proven sufficient.

Could some of the preparation work be done by locals? Yes, Mr. Coleman said he welcomed any help in preparing the site for construction.

**What about a mono pole style versus the proposed lattice tower style?** Citizen's choice, based on the price and look wanted. However the lattice has a quieter, more efficient wind use and tends to fade into surroundings better. Should the district choose to go with a mono pole style the price increase would be \$5,000, if, the current proposal was accepted.

After the question and answer session was over, the public was dismissed and the board retired to the regular board room to resume the remainder of meeting.

After discussion of income that would be lost versus savings to be gained, the board voted unanimously to place a refundable deposit for one E 15 wind turbine. This was done in order to lock in Entegri Wind Systems' current offer and to give the board time to further study the financial end of it.

The board also considered and passed unanimously (1) revisions to Lockney ISD policy DEC (Local) and (2) extending LISD'S depository contract for 2 years.

Administrator's reports followed. Principal Williams said, "There were only three out of the third grade that did not pass their TAKS test on the first try, for an 82% passing rate. Five out of the

fifth grade did not pass their reading portion of the test on their first try, for an 89% passing rate. The average in the fifth grade was the highest ever. I feel certain most of these will pass on their second try. Enrollment remains at 276."

Principal Hallmark said, "We have an enrollment of 134 and we are getting ready for TAKS tests. Teachers are working with students on objectives - our main focus. In February we did some bench marking which is a help in finding problem areas. The teachers and students have really worked hard and I'm really pleased."

Principal Thompson reported, "We have an enrollment of 191 students, with what looks at this time like 40 graduating seniors. We have not gotten back the writing portion of our TAKS tests. Seven seniors have not passed all portions of TAKS; 6 need science, 3 need math and science and 1 needs science only. Starting day before yesterday, Mrs. Fulton and Mrs. Morris are each working two days a week with students. Our exit level TAKS for Juniors will be next month. We have been really busy after spring break. This Sunday the band will be doing a 2:00 pm concert in the new gym consisting of their concert material. The eighth grade meeting had around 25 or 26 folks and we discussed the new 4x4 program. It went very well. Tutorial period seems to be doing well for the kids who need extra help. We'll know when the report cards come out. April 5 the 5th six-week period ends."

Coach Joe gave his report,

"Baseball, track, tennis and golf are cranking up! My biggest fear is for something to be postponed for rain as we have little or no make-up time left! Baseball players are doing well and I've enjoyed watching them play and get better."

Phil Cotham gave the superintendent's report. Regarding activities with Caprock SSA, discussion continues. As to an update on the repair of glass doors, the least expensive place found was still more expensive

than Plainview Plate and Glass.

Concerning the offer made by Floydada Country Club to sponsor golf memberships for the LISD staff in 10 member slots, Mr. Cotham told the board, "There were only 3 that signed up, so the issue is dead in the water."

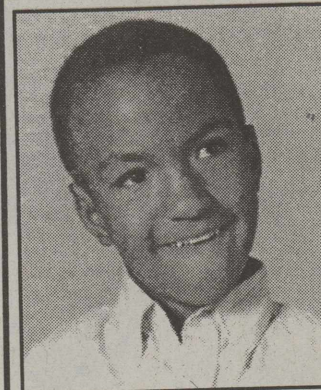
"As far as on-line viewing of student's grades, at some point parents will be given a password and they will then be able to check on their kid's grades," Cotham said.

Regarding the update on student drug testing Cotham said, "Yes, a swab of the mouth may be used if a student can't go to the restroom during a drug test."

The financial report showed as of March 22, 2007 a balance of \$337,895.38 with CD investments of \$3,609,174.10 for a total balance of \$3,947,069.48.

The board went into closed executive session concerning contract renewal of professional personnel.

## City of Floydada appoints Emergency Coordinator and cancels two elections

The Floydada City Council met Tuesday, March 20, and appointed a new City Emergency Management Coordinator and cancelled two election positions for the May 12th General Election.

The council unanimously appointed long time Floydada Fire Department veteran J.E. (Dinks) Eckert as the Floydada Emergency Management Coordinator for the City. Eckert will be replacing Carroll Sims, who passed away March 7, 2007.

City Manager Gary Brown told the council, "Dinks is familiar with our computers and can find the reports needed."

Councilmember Monte Williams added, "He (Eckert) has a lot of experience and he is here in Floydada."

Floydada Mayor Bobby Gilliland said, "He (Eckert) will be very good at that position."

Two City council election positions in the May 12 General Election were cancelled by the council due to the lack of opposition. They were the At Large Mayor position held by Incumbent Bobby Gilliland and the District 3 Councilmember position held by Incumbent Sheldon Sue.

The District 2 Councilmember position held by Incumbent Ruben Barrientoz is being contested by Sam Green and will be on the May 12, 2007 Election ballot.

Early voting in person at City Hall will be from April 30 - May 8.

In a related matter, the council appointed Donna Henderson as Election Judge and Mary Martinez as Alternate Election Judge for the May 12th elections.

In other matters, the council donated \$1500 to the Floydada Little League Baseball Association. "This is already built into our budget for the year," said Brown.

Councilmember Jon Nielson said, "This money will be spent on putting in break-away bases at the Minor League diamond this year and they are expensive."

The council discussed re-adopting a City ordinance on curfew hours for minors.

City Police Officer Reuben Ramon told the council, "I recommend we keep the curfew the

same as before, which is for those 17 years old and under, Sunday through Thursday, 11 p.m. to 6 a.m., and Friday through Saturday, 12 p.m. (midnight) to 6 a.m. The only exceptions if for going to work or to school."

According to City Secretary Karen Lawson, this ordinance must be adopted every three years. She said it would be on the agenda for next month's meeting to adopt following the posting of public notices.

Another item on the agenda, but no action taken by the council, was the parking of semi-trucks on personal property or on City streets.

According to Mayor Gilliland, "There is no City ordinance for parking trucks on personal property, but there is one against parking trucks on City streets."

The Farm Labor Housing rehabilitation grant was discussed, but City Manager Brown told the council, "Sudy (Cochran) has not heard back on this final project. It has been over three years since it was started."

The council voted unanimously to allow Harvey and Martha Garza to operate the City swimming pool again for the 2007 summer season.

The council appointed Philip Smitherman to another two year

term on the Mackenzie Municipal Water Authority Board and Jim Covington to a two year term on the Floydada Airport Board.

The council voted unanimously to adopt a resolution showing support to allow Texas cities the ability to have some say in natural gas prices.

Following discussion, the council took no action on charging a fee at the City landfill for the cost involved in the loading of dirt given away to Floyd County residents.

City Manager Brown said, "With the cost of fuel and the wear and tear on our equipment, I agree with this idea. We give away around 40 to 50 loads per year. Maybe we should charge \$2.00 per (frontend loader) bucket of dirt."

Councilmember Jon Nielson said, "We should think about this more. Are we going to charge people in the county more because they get many loads, than those from the City who get maybe only one load? That doesn't seem fair."

The council approved the 2006 Audit Report, ending September 30, 2006, as presented by Dianne Washington, CPA.

Washington told the council, "You have a good system going and you have done well this past

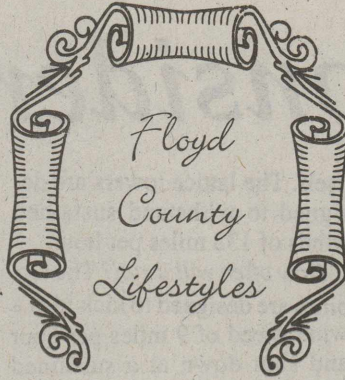

We got up at 5:00 a.m. and went to Mass each day at 6:30 a.m. to help us prepare for the next day.

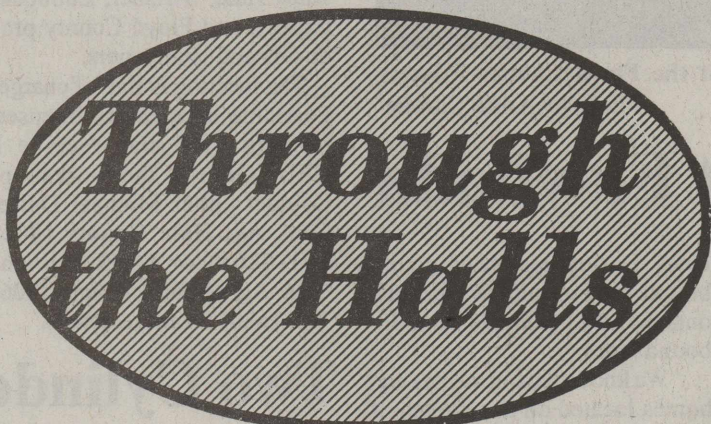
and Madolyn McCormick.

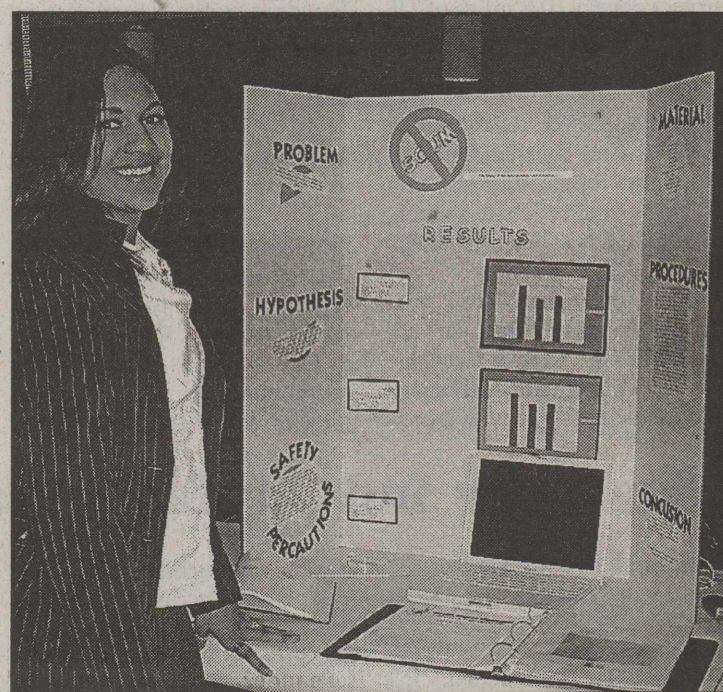

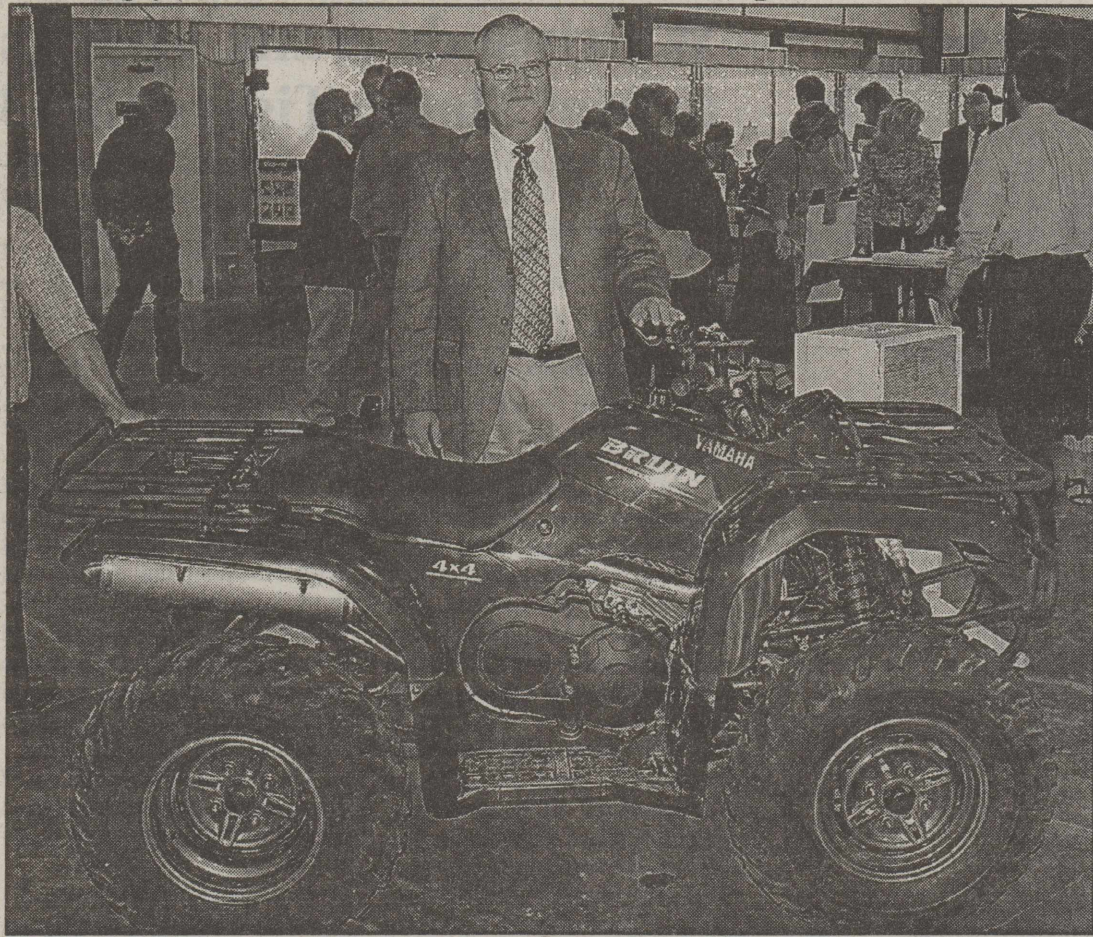

## TxDot project to impact Floydada

The Texas Department of Transportation (TxDOT) will begin a \$14.8 million road improvement project on US 62 in Floyd County on Monday, April 2. The project covers 10.8 miles of US 62, from US 70 in Floydada to the Crosby County line.

Enhancements to the roadway include complete rehabilitation of the existing four-lane section, pavement repair, and hot mix overlay of the two-lane section, said Mike Craig, P.E., TxDOT's Plainview area engineer.

The improvements will change the current in-town section of US 62 from a four-lane divided highway with medians to a five-lane roadway with a con-

tinuous left turn lane. Landscaping and aesthetic enhancements at the "Y" are also part of the project.

"TxDOT and the City of Floydada worked together to include trees and colored textured concrete at the intersection's medians," Craig noted.

"Work will begin with the rehabilitation of northbound US 62 in the city limits, from just south of Crockett Street to US 70. Northbound US 62 will be detoured onto the southbound lands reducing traffic to one lane in each direction," Craig said.

Once work is completed on northbound US 62, crews will then move to the southbound

lanes. During this phase, southbound traffic will be detoured onto the newly refurbished northbound lanes.

"We know that businesses and homes located on this stretch of US 62 have little access other than the highway, so we're going to try to minimize the inconvenience to the businesses, residents and the traveling public," Craig said.

The project is expected to take 22 months to complete. Duinick Bros. Inc., of Roanoke, Texas, is the project contractor.

year by ending with an increase of \$222,172.00."

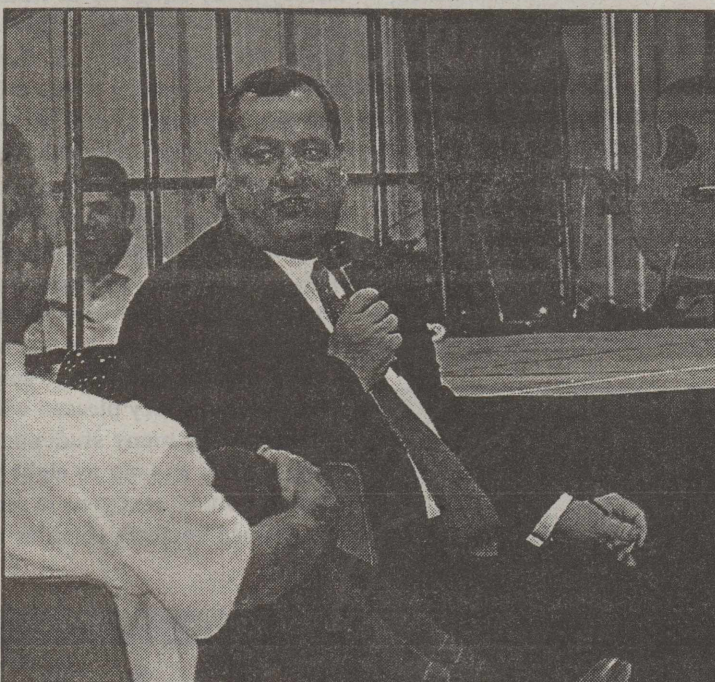

In the City Manager's report, Brown told the council, "Highway construction on the Ralls Highway will begin in April at the 'Y' intersection and go south to the county line. It should take around 22 months to complete.

"We still do not have a pole rental contact with Blue Moon Solutions concerning their wire-

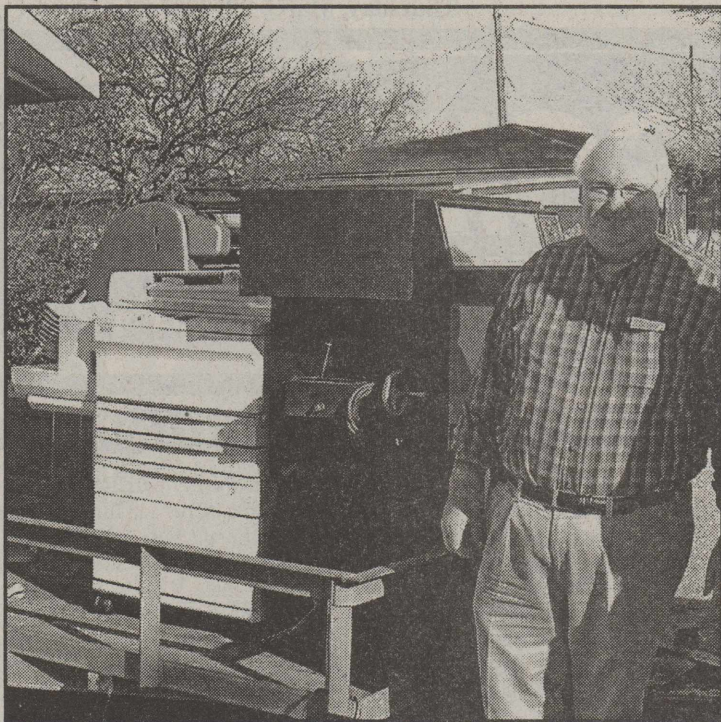
