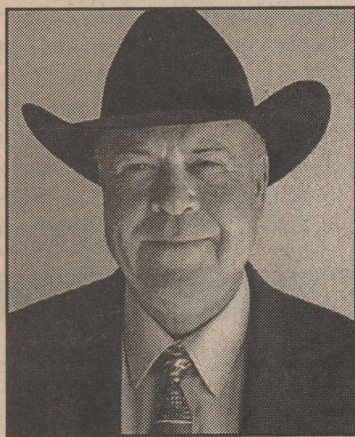


## Commissioner Profiles

Democrat.

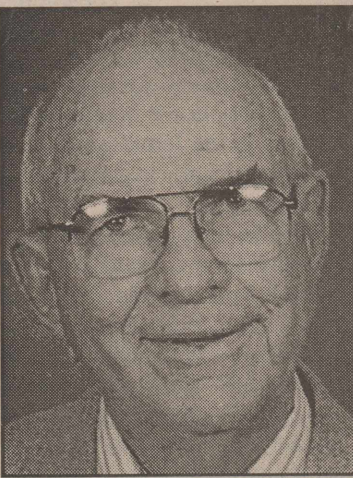

## What is a Delegate and Super Delegate?

Delegate selection process explained

The Democratic Party has three types of delegates; two types are elected at state level and the third is the less understood "super delegate".

Texas Democrats use the primary election and precinct caucuses to pick their delegates. The State also has 32 super-delegates.

Right now a total of 193 delegates are up for grabs in Texas. The primary election will choose 126 of them--from each of the 31 State Senate Districts. Each district gets two to eight delegates based on the turnout of the Democrats in past elections.

The delegates in each Senate district in Texas will be allocated proportionally.

If your Senate district had a large turnout of voters then your district gets more delegates.

A problem may arise for a candidate who may be popular with Hispanic voters in a South Texas district. The district may be heavily Hispanic but have a lower voter turnout, so their delegate strength will be less.

For instance, an AP wire story by Kelley Shannon, "a state Senate district in Austin, where 30 percent of residents are Hispanic, will have 8 delegates, but a state Senate district in the border city of Brownsville, where the population is 91 percent Hispanic, gets only three."

Sixty-seven delegates will be awarded based on attendance at precinct caucuses held after the primary. Delegates are then elected to the county and state senate district conventions March 29, which in turn elects

delegates to the state Democratic convention June 6-7.

The Democratic party also has a third type of delegate--the super delegate. A super-delegate is a leader in the national Democratic Party who has a vote at the national convention; they are not selected by state party members.

Super delegates are not required to stay pledged to a specific candidate. In 2008, the Democratic party has designated 796 super delegates (32 from Texas). An estimated 4,049 total delegates will vote at the national convention, including super delegates.

A candidate needs a total of 2,025 delegates to win the party's nomination.

## Delegate process for Republican is different from Democrat process

The Republican Party's allocation of delegates is different, and some say much simpler, than the Democrat process.

For the National Convention, each state selects six at-large "base" delegates; three delegates for each member it has in the U.S. House of Representatives-known as "district delegates"; and bonus delegates.

Bonus delegates are earned by each state by the following requirements: the state cast a majority of its votes for the previous Republican presidential candidate, the state elected Republicans to the U.S. House or Senate; the state selected a Republican Governor or state legislative majorities, and/or the state holds

a primary/caucus convention.

Congressional district delegates are elected by congressional district caucuses, and at-large delegates are elected by the state convention. Congressional districts are allocated by the primary results within each district. At-large delegates are allocated by the statewide primary results. These delegates are awarded on a winner-take-all basis if a candidate received a majority of votes cast. If there is no majority winner, delegates are allocated on a proportional basis to the presidential candidates who receive 20% or more of the votes cast in the presidential primary.

In Texas there are 138 total delegates: 96 Congressional District and 42 At Large, chosen by

Voters must bring your Voter Registration card or proof of identification.

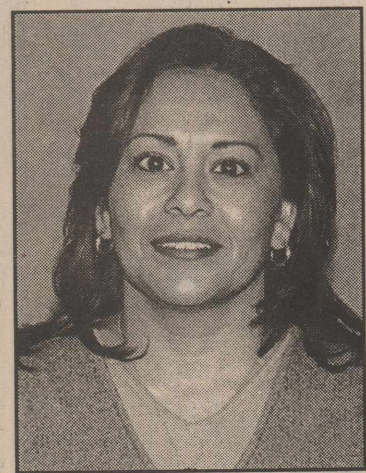
The election will be held March 4.

Your vote would be greatly appreciated.

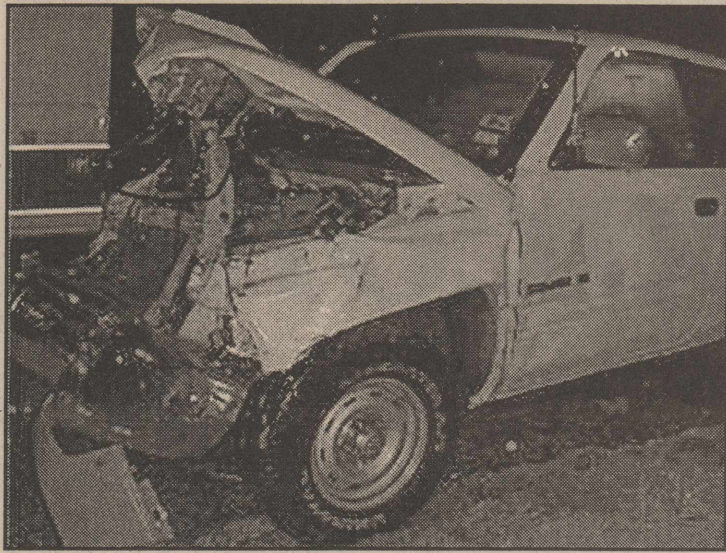


**DELIA SUAREZ**

One can learn a lot by simply reading. It's not always uplifting, but it beats all the alternatives.

As noted before in these columns, each day we try to read news stories from around the world, usually beginning with the Israeli press. Experience has shown that usually anything that affects the United States will first involve the Israelis, and quite often the Israeli newspapers are first to comment on the matter, one way or another. And most stuff that gets printed in the Israeli newspapers is reported here in America on the Internet.

So today we learn that a new situation has evolved in Jerusalem. Some sort of law in Israel

requires Jews to visit the Western Wall, also called the wailing wall, for 40 consecutive days in order to have their prayers answered. At least one couple has come up with the idea of praying for anyone who has the cash. They will go to the wall for you, pray for you, and all you have to do is pay them for their time and effort. They will do this for you out of gratitude for your donations, and if they have to hire surrogates for the job, you can at least know you are helping some rabbi get through school.

Whether they got the idea from American television preachers, or Chinese mourners, or indigenous religious Jews, is anybody's guess. All we know is that the practice is booming, according to the Jerusalem Post, a sister publication to a newspaper in Chicago.

Also in Asia, we note that according to the Manila Times (which was founded back in 1898, about the same time the Hesperian was founded here in Floydada), there is a certain amount of political turmoil going on at the moment. Down on Mindanao Island they are still having problems involving Muslims and Catholics, and on Luzon Island (the largest island in the archipelago), the Speaker of the Philippine House has been booted from his position. As far as we know, religion had nothing to do with his departure. That could never happen here, simply because Tom Craddick wouldn't

accept any motion to remove him. And, as far as we know, religion has nothing to do with the turmoil surrounding either Craddick or the guy if Manila either. Craddick simply likes the perks that come with the Speaker's chair. In that respect, he is no different from Pete Laney, who held on to the position as long as the lobby was supportive. We never could figure out just exactly why the lobby decided Craddick was preferable to Laney. Maybe the elections had something to do with it.

Back here in this country, we still have what we might call a "fluid" situation involving America's search for a new President. The last time we checked, it appears John McCain is going to win the Republican nomination, although Mike Huckabee went quit, evidently, until the March primary in Texas is over. Who the Democratic nominee is going to be is anybody's guess. About the only thing certain was that the black 'bloc' was going for Obama and most Hispanics were going for Hillary. Hillary doesn't have the Hispanics locked up, by any means, and while the group (Hispanics) are still being fought over by the 'leadership' of both parties, Republicans seem happy that their

message is finally getting across to the rank and file. According to Republicans, the Democrats have taken the Hispanics for granted for many years.

In the meantime Bill Clinton, our former (and our first 'black' President), has headed for East Texas, where there is a substantial black vote, while the other half of that twosome is campaigning among potential Hispanic voters in El Paso and the Rio Grande Valley, not to mention San Antonio. ## Council hears Racial Profile Report

The Lockney City Council met Thursday morning, February 14, and received Chief of Police Casey Wallace's Annual Racial Profiling Report.

The report read as follows:

**# Contacts:** 454, with a breakdown of 22 Blacks, 232 Hispanics, 196 Whites, 1 Asian, 3 Other, 316 Male and 137 Female.

**# Searches:** 15, with a breakdown of 2 Blacks, 10 Hispanics, 3 Whites, 0 Asians, 0 Other, 13 Male and 2 Female.

**W/Contraband:** 4, with a breakdown of 0 Blacks, 4 Hispanics, 0 Whites, 0 Asians, 0 Other, 2 Male and 3 Female.

**# Citations:** 36, with a breakdown of 1 Black, 29 Hispanics, 5 Whites, 0 Asians, 1 Other, 29 Male and 7 Female.

**# Warnings:** 407, with a breakdown of 19 Blacks, 194 Hispanics, 191 Whites, 1 Asian, 2 Other, 277 Male and 129 Female.

**# Arrests:** 11, with a breakdown of 2 Blacks, 9 Hispanics, 0 Whites, 0 Asians, 0 Other, 10 Male and 1 Female.

There were no informal or formal complaints made on officers.

George Meriwether of Williams, Meriwether, Smith & Co., L.L.P. presented the Council with the annual audit of the City's 2007 Budget.

"I'm pleased to say you've

received a 'Clean' opinion. It is an overall good report and I can tell you've gotten better each year we've served you," said Meriwether.

"My main concern is the bottom line," said Mayor Stapp. "This Council has been willing to hold expenses down and to raise rates when necessary. I'm pleased we stayed in the black."

On October 1, 2006, the beginning balance of the General Fund was \$325,328 and the ending balance on September 30, 2007 was 398,297.

No action was taken on item B. Accepting Excel Energy Franchise Agreement, as the City had not received the corrected document.

In other business, the Council passed a request for variance for an existing fence at 627 S.W. First Street.

The item concerning adjusting garbage rates was for discussion only. The Council decided to let Abel Luna come up with a chart considering base rates, mileage and fuel. They could then consider the information and handle it as a future agenda item.

City Secretary Charlotte Hooten informed the Council the City would have to proceed at this time as if a City election would definitely take place, then cancel it if necessary.

The Council went into executive session to discuss personnel.

## Super Delegate process explained

Super delegates include: elected members of the Democratic National Committee, Democrat Governors, Democrat Senators and US Representatives, party leaders (current and former Presidents and Vice Presidents; former Democratic leaders of the Senate and House; former DNC chairmen, unpledged "add-on's" chosen by the DNC.

Former President Clinton is a super delegate.

Democrats instituted the Super Delegates in 1984 to prevent fringe candidates from taking the nomination.

For instance George McGovern was nominated in 1972 and took only one state and had only 37.5 percent of the popular vote.

According to one way of thinking Super delegates were designed to act as a check on ideologically extreme or inexperienced candidates and to give power to the people who have a

vested interest in party policies, such as elected leaders. These people see the system as a safety valve.

Others see the Super-Delegate system as being set up to prevent candidates from winning that don't represent the "party establishment."

Super-delegates are not bound to vote for any particular candidate and those opposed to the system say Super delegates decide based on personal loyalty and promises of future favors.

Super delegates make up 40% of the delegates needed to win the nomination and 20% of the total delegates. A candidate who comes to the convention with 12% of the delegates from the primaries and the caucuses could get the nomination if that candidate got all of the super delegates.

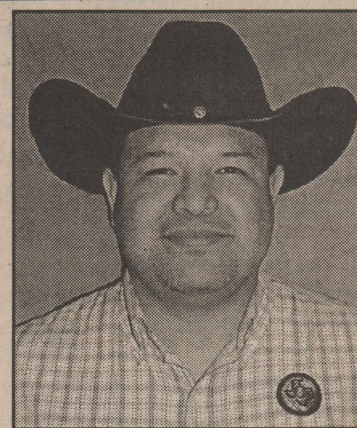


**Mary Guerrero**

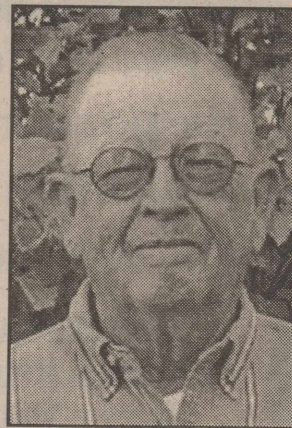

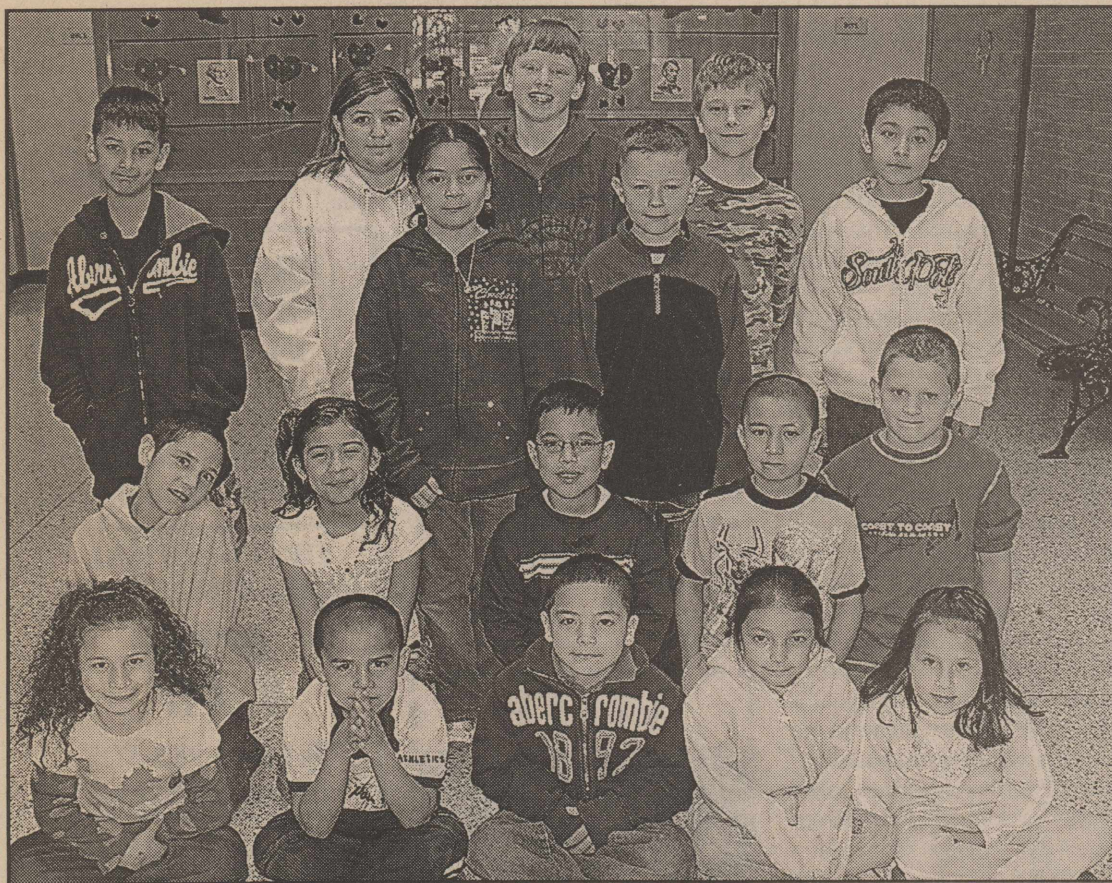

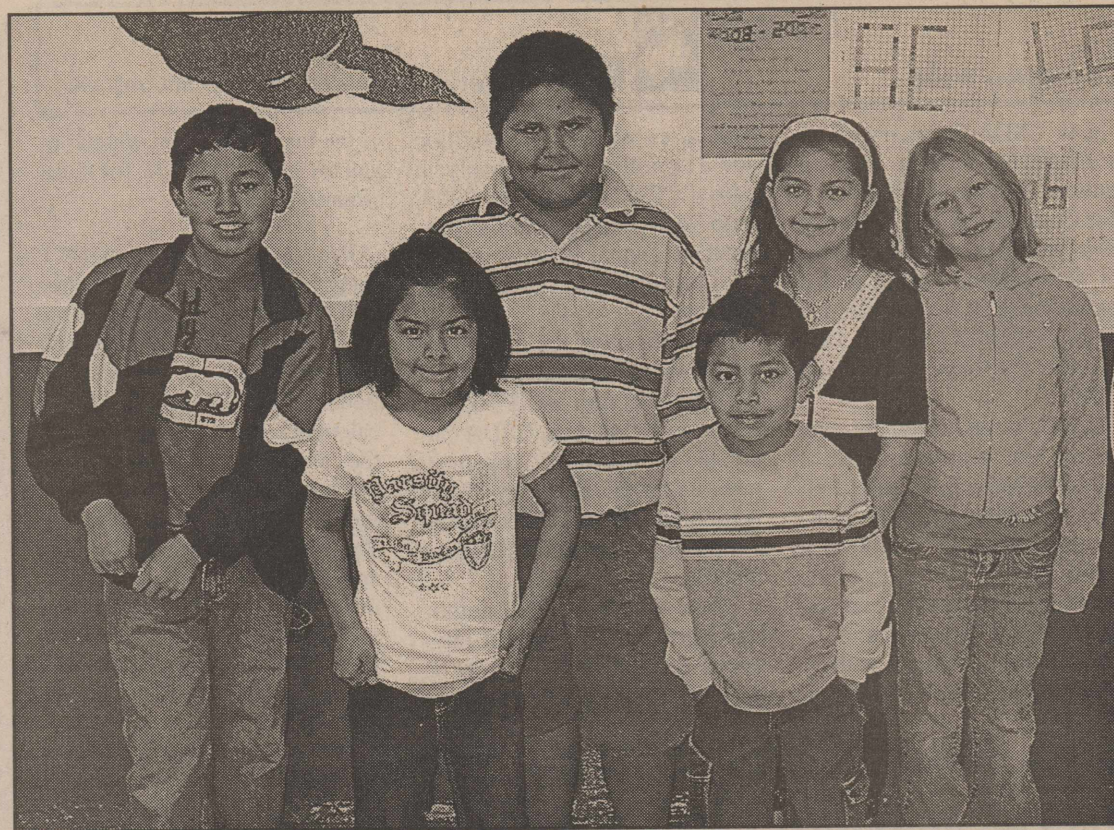

New USDA Secretary of Agriculture Ed Schafer has announced that partial 2007-crop-year Counter-cyclical (CC) payments would be issued to producers with upland cotton and/or peanut base acres enrolled in USDA's 2007 Direct and Counter-cyclical Program (DCP).

Schafer's announcement came during the National Cotton Council's Annual Meeting February 9 in Memphis, TN. Since that time some \$315 million in partial 2007 CC payments have been delivered to cotton and peanut producers nationwide.

USDA says producers with enrolled upland cotton and peanut

base acres received \$300 million and \$15 million, respectively, in partial CC payments. The 2007-crop year projected partial payment rates equal 40 percent of the projected final CC payment amount.

Payment rates for the partial payments are \$0.0309 per pound for upland cotton and \$7.60 per short ton for peanuts. USDA calculated the partial CC payment rates using the February World Agricultural Supply and Demand Estimates, released on February 8, 2008.

The 2002 Farm Bill authorized preliminary partial payments for the 2007 crop to be made six months after the start

of the marketing year, which began on August 1, 2007, for these commodities.

Producers enrolled in DCP may receive CC payments when "effective" prices for eligible commodities are less than their respective "target" prices specified in the 2002 Farm Bill. USDA calculates CC payments based on the calculated rate and on historical base acreage and payment yields, not current production. The 2002 Farm Bill requires that any overpayments to producers must be repaid. More information on DCP is available at local FSA offices and on FSA's Web site at: <http://www.fsa.usda.gov>.

## High Plains Underground Water Conservation District schedules public meeting at Unity Center

The High Plains Underground Water Conservation District has scheduled a series of meetings in February and March to receive public comments regarding the setting of desired future conditions for the Ogallala aquifer within its 15-county service area.

Residents in High Plains Water District Directors' Precinct Five are invited to attend a March 4 meeting, beginning at 7 p.m. at the Floyd County Friends Unity Center, Highway 70 and FM 786, in Muncy. District Directors' Precinct Five includes the portion of Floyd County within the district and Hale County.

According to district officials, setting desired future conditions for aquifers could be the most important challenge groundwater conservation districts in Texas have faced. Therefore, they encourage all interested persons to attend this meeting to learn more about the process and offer comments.

"As a result of House Bill 1763 passed by the Texas Legislature in 2005, and codified in Texas Water Code Section 36.108, water conservation districts within their respective groundwater management area(s) are required to work together to determine and agree upon a desired future condition for groundwater within their respective groundwater

management area," said High Plains Water District Manager Jim Conkwright.

"Each water district will submit a proposed desired future condition to their groundwater management area group. Once a final desired future condition is agreed upon by the GMA, the information will be delivered to the Texas Water Development Board in Austin (TWDB). The TWDB, in turn, provides estimates of managed available groundwater to the districts for use in their groundwater management plans and to the regional water planning groups for use in their regional water plan," Conkwright said.

Water conservation districts are required by law to reconsider desired future conditions at least every five years. They may revise the DFC, sooner if necessary.

"The High Plains Water District's board of directors believes that it is important to set an initial desired future condition that both agricultural producers and municipalities can work with. Once set, the desired future condition will influence how water districts manage groundwater," Conkwright said.

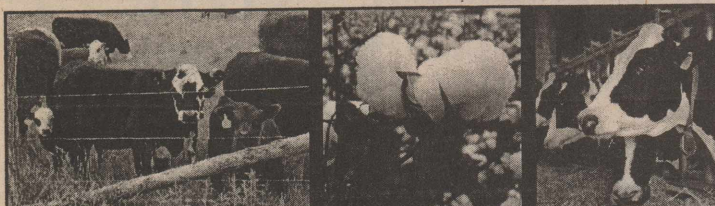

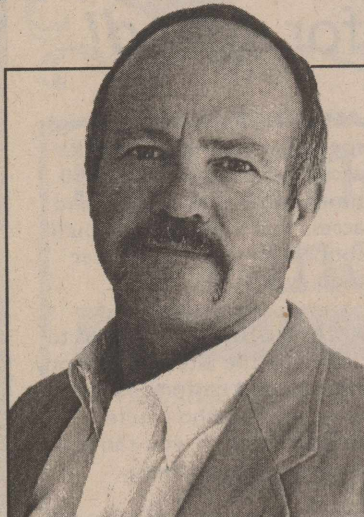
