

The Floyd County Hesperian-Beacon and Blackburn Media Group are pleased to announce the addition of Jeff Blackmon as associate publisher.

Blackmon recently served as owner and publisher of the Wellington Leader newspaper for the past two years.

"It's great to be a part of the publication here in Floyd County, and I look forward to continuing the task of covering the news here," Blackmon said.

Blackmon has been in the newspaper business since 2000, starting as a sports editor at the Hereford Brand daily news (2000-2001) and then as sports editor for the Hood County News (2001-2004). He won awards from both the Panhandle Press

Association and North and East Texas Press Association for his coverage of the Hereford Whitefaces and Granbury Pirates.

He also has served as associate publisher for the Llano News (2004-2005), news editor for the Andrews County News (2005), and publisher for the newspaper group of the Cameron Herald, Thorndale Champion and Rosebud News (2005-2006) before heading up to Wellington to own and operate the paper there.

"I decided a few years back I wanted to learn every single bit of the newspaper business, so I moved around to soak up as much information about running a paper as I could," Blackmon said. "I was very blessed to have known a lot of different newspa-

per publishers and owners who didn't mind me coming on board to learn the ins and outs of the trade.

"Learning how to do it all has definitely helped me grow tremendously, and it really helped when I decided to own and run my own paper."

Blackmon is a 1999 graduate of Abilene Christian University and is married with two children, Will (4) and Nora (2). Jeff and his wife Angela are expecting another addition to the family in December.

"I'm excited and eager to jump in and begin helping the Floyd County Hesperian-Beacon persist in being a publication its readers can be proud of," Blackmon says.

## Trustees propose tax rate and hire personnel LISD changing out lights

In a regular meeting, July 24, LISD Trustees voted on a proposed tax rate of \$1.14. The tax rate and budget will be voted on in the August 28 meeting.

The board approved a bid of \$61,853.79 for retrofitting of elementary school lights from Digital Air Control. More energy efficient lights will be installed in classrooms, offices, cafeteria, kitchen, gymnasium, library, and hallways.

Instead of choosing a "performance contract" and paying out the cost over a period of time, the Trustees decided to pay for the

lights all at one time. "We believe the new lighting will pay for itself in 6 years," said Superintendent Phil Cotham.

The board accepted the resignations of Buster Brown, a government and economics teacher and coach; Rob Schmucker, math teacher and coach, and P.E. teacher and coach, Sheena Schmucker.

The board then hired Jeff Dunn as math teacher and coach, Ryan Dollar as head basketball coach and social studies teacher, and Keegan Reynolds as P.E. teacher and assistant girls coach. Cotham said the field house

construction has started with concrete currently being poured for the foundation. The projected completion date is September 25, 2008.

Cotham also told the board that the resurfacing of the tennis courts was completed.

A milk bid from Gandy Diaries was approved and endorsed Melanie Morris in her candidacy for TASB Board of Directors.

The financial report showed a balance of \$4,114,762.16, which included: a bank balance of \$391,956.15 and CD investments of \$3,722,806.01.

## County proposes tax increase

Floyd County Commissioners met on Monday, July 29 to adopt a proposed tax rate of .67220

Public hearings will be held on August 11, 2008 at 9:00 a.m. and

August 27, 2008 at 9:00 a.m. on the proposed increase.

The appraised value for Floyd County is down by approximately 17 million dollars. The effective

tax rate for the coming budget year is .62241. This is the rate that will bring in the same revenue as last year.

Commissioners voted unanimously for the tax increase.

Also discussed by the court was a proposed 5% pay increase to county employees and elected officials, with the exception of the commissioners who will not receive an increase. Motion was made by Commissioner Gilroy and supported by Bearden and Jones. Bill Quattlebaume voted against the motion.

Floyd County Clerk Marilyn Holcomb requested funds from the court to update her computers. Holcomb had funds in reserve to purchase the computers but needed commissioner approval for the purchase. Commissioners were unanimous in the approval to purchase the computers.

The commissioners approved a farm contract for Doyle Walls to bury a barn to put land back in production in the Fairview community. Four contracts were approved to grade roads for soil conservation in the McCoy community for Rick Reddy.

## City works on grants

The Floydada City Council met July 24 and approved pursuing grants for the airport and downtown and private individual wind generator guidelines.

City Manager Brown then brought the council up to date on the progress of two grants the city is applying for. Brown reported the needed paper work on the Downtown Revitalization Grant has been completed and the completed grant application would be shipped over night Friday. The council approved four resolutions pertaining to this grant.

Brown also discussed the Texas Community Development Block Grant. This grant is not due until late fall but work on the grant is being done. This grant will be for funds to replace the water booster house and pumps. The city has applied for this grant several times but has not been lucky enough to receive funding.

The electric system upgrade was discussed. Brown reported he had not received any numbers from the engineer. The upgrade will increase the reliability of the system plus reduce line loss throughout the town.

The council heard two recommendations from the airport board. The first recommendation was for the city to apply through TxDOT for a RAMP grant. If funded, the money will be used to lay a water line from the north city limits to the office area of the airport. The line is needed to have fire fighting ability in and around the structures at the airport plus provide approved water for consumption. The council voted unanimously for the grant.

The second recommendation from the airport board was for the city to enter into negotiations with Mitch Probasco for the sale of the hangars. Probasco currently owns the hangars which have had some negative effects on the use of grant funds. All council members voted to move forward.

The regulation of wind gen-

erators was discussed by council because there has been some interest shown by individuals wanting to put up generators for individual houses. A very good discussion was held and the council voted unanimously for the city staff to develop some guidelines.

After a lengthy discussion about the need for a procedure establishing how an item is placed on the agenda, a procedure presented by City Attorney Karen Houchin and Brown was approved.

The procedure calls for the person making the request to have an item placed on the agenda to fill out a form and have the form signed by the mayor and a council person. The form is available at City Hall.

The council considered the request from the Floydada Economic Development Corporation to amend their 2007-2008 budget. After a lengthy discussion and several questions that no one could answer, Councilman Nielson made a motion to table the item until someone from the FEDC could meet with the council and explain the need for the budget to be amended. The motion passed unanimously.

The resignation of Floydada Economic Development Corporation Director Dora Ross was discussed by the council. The resignation was approved unanimously.

Council members also discussed trash pick-up and disposal.

Brown reported with rising costs of fuel, trucks and containers it might be time for the city to take bids on this service. After looking at the good and the bad of using a private hauler, Councilman Green made a motion for the staff to advertise for bids. The second to the motion came from Councilman Barrientoz. The vote was 3 to 1 for the motion with councilman Nielson casting the negative vote.

On a motion by Councilman

Nielson and a second by Barrientoz, the council voted to deny Southwestern Public Service a rate increase. This action was requested by SPS so that a uniform rate can be adopted for all customers of SPS instead of individual rates for each town SPS serves.

Green led a discussion on the subject of semi-truck parking in residential areas of town. The council provided several ideas that the city staff is to research and then develop into an ordinance to be considered at a future council meeting.


Council discussed the regulation of digital signs and after several questions were answered the council decided to take no action.

In other matters City Attorney Houchin advised the bids received for the vehicles were not properly advertised and therefore should not be opened. The filing deadline had been extended without proper notice.

Brown then discussed the development of the 2008-2009 city budget. He explained the first edition was a long ways from being a balanced budget and that both expenses and income were going to have to be adjusted. After answering several questions Brown stated he would get a second edition worked out and hopefully the numbers would look much better.

After a presentation by Van Breedlove of the Mackenzie Municipal Water Authority 2008-2009 water supply budget the council moved to approve the budget.

With the City of Floydada approaching its 100<sup>th</sup> birthday, Brown asked for thoughts on how much money the council would be willing to spend to hold a birthday party. The council asked Brown to get with the centennial committee and ask them how much they felt would be needed. The council did not approve an amount.

Many Americans, politicians and corporations have given up on rural America. Some of us have not. Some of us realize where the crops are harvested, where the oil is pumped and where the wind blows. Some of us realize where the best hunting and fishing is. We know where friendly people reside and if we get a flat tire or hit a deer, someone is going to pull over and help us out.

It is true, we live in a brave new world. I believe that new world includes rural America and BMG intends to make sure those big-city types know we're out here!

Parks and Wildlife Department are working together to offer the two-day conference at the Ambassador Hotel, 3100 W. Interstate 40, in Amarillo.

The program will begin with registration at 7:30 a.m. and run through 5 p.m. on Aug. 8. The second day will also begin at 7:30

a.m. with coffee and doughnuts, followed by an 8 a.m. departure for a tour of Wildorado Wind Ranch.

"Getting an impartial handle on all of the ins and outs, the pros and the cons, the advantages and disadvantages, is a daunting task," said Ken Cearley, AgriLife Extension wildlife specialist in

Canyon.

The meeting is aimed at objectively educating landowners and the general public about the many issues associated with wind energy opportunities that should

be considered before signing a contract, including the impacts on wildlife, Cearley said.

Some of the topics covered will be: the history and current state of wind energy; its future and viability; what is known about its impact on wildlife; power transmission issues; and land appraisals and the impact on real estate value by wind energy development.

Discussion panels will include landowners, operators and state-elected officials. Panels also will include representatives from universities, agricultural organizations, conservation organizations, the wind energy industry and state and federal agencies.

A visit to the Wildorado Wind Ranch will provide participants with an up-close introduction to the day-to-day operations of a wind-energy project, as well as what is involved in site determination and construction, Cearley said.

## Neugebauer pleased with CRP compromise

WASHINGTON, DC - Congressman Neugebauer says he is pleased with the recent compromise surrounding the temporary restraining order imposed on farmers and ranchers' ability to either hay or graze their animals on CRP land.

"I was pleased to hear that the Temporary Restraining Order (TRO) that prevented farmers and ranchers from haying and grazing on CRP land was lifted," said Neugebauer.

"Judge Coughenour's ruling will allow farmers and ranchers to immediately resume usage to feed and forage on their CRP acres during a time when live-

stock feed is very costly and hard to come by.

When USDA announced the critical feed use (CFU) program in May, producers in the 19th District and across the country began investing time and money in preparing their operations for this program. While the court ruling makes some changes to the CFU program, it removes the total ban the National Wildlife Federation was seeking, which would have had catastrophic consequences to livestock producers."

The final ruling will allow CRP contract holders who ap-

plied and were approved for the CFU program before the July 8, 2008, to immediately resume haying and grazing until November 10, 2008.

Applications that were received prior to July 8th but were not yet processed by the Farm Service Agency will continue to be processed, and those that are approved will be allowed to hay through September 30, 2008, or graze through October 15, 2008. Furthermore, producers still wishing to apply can do so if explain they had relied on the CFU program and have invested more than \$4,500 preparing their land.


