## City, County Jails Combined

No prisoners have been booked into Lubbock City Jail since 7 a.m. Jan. 1.

It's part of a cooperative agreement between city and county governments to avoid duplication of services and save tax money.

Consolidation of the city and county jail was first recommended a year ago by management consultants. They noted the duplication of costs to book most prisoners into the city jail and a day

or two later book the same prisoners into the county jail after charges had been filed.

All persons arrested by Lubbock police are now being booked directly into County Jail, leaving empty cells and booking rooms available for remodeling when planned use of the space is determined and funding is available.

City prisoners are fingerprinted by sheriff's deputies on cards furnished by the police department. Mugsshots on color film are

shot on a camera furnished by the city using film furnished by the city.

Reduced operating costs are resulting by eliminating a \$450 to \$900 to \$1800 per month bill for meals, a \$6,000 per year fee for doctor's visits and the personnel cost for jailers.

On the other hand, the city is losing an estimated \$85,000 a year in revenue from fines for Class C misdemeanors that will be paid in County Court at Law.

## Opting for Direct Deposit

Since 1975, all Social Security beneficiaries have been offered the option of having those payments deposited directly into personal accounts at banks or other financial institutions, if they chose to do so.

The Direct Deposit Program was expanded in 1976 to include Railroad Retirement Annuity and Civil Service Annuity payments. This fall, Veteran Administration compensation and pension payments have been interlinked with the electronic funds transfer system.

To date, more than six million persons who receive federal checks issued by the Department of the Treasury have elected to participate in the Direct Deposit Program. The Treasury Department anticipates that 40 percent of such benefit payments will be handled by direct deposit by the close of the 1980 fiscal year.

### DDP Advantages

The Direct Deposit Program has resulted in a substantial reduction in Treasury's payment operating costs.

Periodically, SS and SSI beneficiaries are reminded that direct deposits can be advantageous for them, also.

For example, one SSA brochure pointed out:

"You don't have to go to your financial organization and wait in line to cash or deposit your check.

"You don't have to worry about losing your check after you receive it or having it stolen.

"Even if you are away from home when your check is due, your money is available in your personal account instead of sitting in your mailbox.

"You don't have any problem in cashing your check because it goes directly into your account."

### Credit Notification

Surveys show that most banks or savings associations provide either positive or negative notification systems, regarding receipt of the direct deposits. In other words, a customer is either informed routinely that his/her payment has been deposited, or a customer is notified if a payment fails to arrive for deposit, as expected.

According to a Treasury Department recommendation, an individual who wishes to participate in the Direct Deposit Program should ask his/her financial organization what its policy is concerning credit advices, so there will be no misunderstandings.

Persons who do not have, but wish to establish checking or savings accounts, for direct deposit purposes, can find out from Social Security offices-which local financial institutions offer direct deposit services.

## The Consumer Alert

AUSTIN—Besides trying to make ends meet, some Texas farmers also have to contend with unscrupulous businesses that prey on the farming community.

Our Consumer Protection Division attorneys say one of the consumer rip-off schemes plaguing Texas farmers is the use of high pressure telephone solicitations in the sale of herbicides, pesticides or other chemicals such as "soil conditioners." The Texas Department of Agriculture, which our office represents in legal matters, reports that many inquiries are received from farmer-consumers who have been contacted by telephone sales people trying to sell "miracle" products.

Reports received by our office indicate that some of these firms attempt to sell their products by making false, deceptive, or misleading claims in their telephone sales pitches. Our attorneys point out that this could be a violation of the Deceptive Trade Practice-Consumer Protection Act or of the Texas Pesticide Control Act. For example, it is a Class "C" misdemeanor punishable by a \$200 fine for any person to sell or offer for sale any pesticide that has not been registered with the Agriculture Department. It is also a violation of the Deceptive Trade Practice-Consumer Protection Act for a person to claim that a pesticide is registered with the Department if it is not.

The lawyers in our Consumer Protection Division offer the following suggestions to farmers who are solicited to make a purchase by telephone:

Take note of the salesperson's name, the name of the product, and its manufacturer.

Pay attention to claims made about the performance of the product, or any claims that it is "approved by the

product, tell him you will examine it and then make a decision about a purchase.

Be very suspicious if a claim is made that the product will "take care of all your pests for two or three years" or if the caller says "this product is industrial strength but may also be used on pastures or croplands."

Reputable, established agriculture supply firms in Texas can provide information and advice to the farmer-consumer on any pesticide or herbicide product that won't perform as advertised, call our Consumer Protection Division in Austin, Houston, San Antonio, Dallas, El Paso, Lubbock, or McAllen. 

**CLAUDE DOLLINS ANUNCIA CANDIDATURA PARA PUESTO EN BOARD DE LA ESCUELA**

After two years of thought and consideration, both as to the responsibilities and the opportunities involved, I am today announcing that I will be a candidate for Place 2 on the Lubbock Independent School District Board in the coming elections. I feel anyone seeking such an office has an obligation to share with the voters both his background and basic objectives in seeking such service.

In terms of educational background, I hold college degrees from Hardin-Simmons University, Southwest Baptist Theological Seminary and Texas Tech University. The last five (5) years my primary employment has been as a marriage and family counselor and, probably equally important, I have twelve years experience as a classroom teacher. I believe that the skills I have acquired and the experience I have had both as a teacher and counselor will bring an added dimension to the Board and would enable me to make a positive and useful contribution.

As a member of the School Board, I would practice fiscal responsibility, support the neighborhood school concept, and encourage emphasis on the basic reading, math and communication skills. This is my basic posture and platform, but I am interested in the whole picture of education.

As a Board member, I would have several primary concerns. To begin with, I feel we must have a consistent, continuing evaluation of the Lubbock Public Schools' Priorities. If such evaluation is to be done intelligently, it requires that a school Board member actively solicit ideas and suggestions, and understand the concerns of parents, teachers, taxpayers and also the children affected. I would feel that it is essential that, as a Board member, I first listen, try to obtain all of the information

possible concerning a particular decision and then vote basically on what I feel is best for the educational need of Lubbock children.

Secondly, I feel that we need better communication within the Lubbock public school system. I realize that the term "better communication" is an over-used word, but that fact does not make it any less true that the communication process within our school

system need significant improvement. Specifically, a consistent effort to improve communication among Board members would enhance the decisions they make on behalf of the entire system; better communication between School Board and Administration personnel is an on-going need, and I have strong feelings that more open communication should be encouraged. In addition, there needs to be an acknowledgement that improved communication between the school and the home could be of great benefit to the students who are, after all, the focal point of all of our efforts.

My key role as a family counselor is teaching and encouraging better and more open communication among family members. Hopefully this sort of professional skill would be useful in my service as a Board member.

Third, I feel that an effective Board member needs to be an effective problem solver with a minimal bias and rigidity. A recent Federal Court decision had faced us with some perplexing and difficult problems of implementation. As a professional problem solver, I am experienced in dealing with complex, emotionally charged and often painful decisions that occur in family crises.

From a good deal of experience, I understand that the professional problem solver never assumes that he has the only or even the best answer--which is fortunate because he usually doesn't! He is, however, trained to listen, to help develop alterna-

**Aging Conference Set for Feb. 20**

Gov. Dolph Briscoe has announced plans for a 1978 Texas Governor's Conference on Aging to be held Feb. 20, 1978, at the San Antonio Convention Center.

The one-day meeting is to be sponsored by the Governor's Committee on Aging and the state's 28 Area Agencies on Aging.

"Maturing Speaks: Let's Listen" has been selected by a 23-member steering committee as the official theme for the conference.

"A major goal of those involved in planning the meeting is to make it a conference for the elderly and not a conference about them," the Governor said.

Forms for conference registration and hotel accommodations are to be available in December at regional Area Agencies on Aging throughout the state. Registration deadline is Jan. 30, 1978.

# Peticion Sobre Pasaportes

Desde el mes de Noviembre se esta circulando una peticion contra las tarjetas de identificacion "nuevas" propuestas por el Departamento de Inmigracion.

Hace casi un año que el Departamento de Inteligencia Militar le diseño a la Migra un sistema de identificacion para usar con los residentes (o inmigrantes legales).

Bajo tal sistema toda informacion sobre el residente (descripcion fisica, residencia, lista de parientes en E.U.) se guardaria en una computadora. Las tarjetas que ahora llevan los residentes serian cambiadas por unas que llevarian la foto, huella digital, y informacion sobre el residente y sus familiares.

Cada tarjeta seria una "extension" de la maquina computadora y tal sistema le daria la habilidad al gobierno de mantener una estricta vigilancia de los residentes. Un sistema de este tipo es usado en Africa del Sur, donde la minoria blanca fuerza la mayoria negra a llevar tarjetas especiales cuales estan coordinadas con un sistema de vigilancia.

Un aspecto negativo tambien es que el residente lleve su huella digital en la tarjeta. Esto hace a muchos sentirse como que llevan un poster de criminal en minatura. Esto es una forma de descriminacion.

La peticion cita esas razones por

lo cual estas tarjetas no se deberian dar.

Para llevar acabo este proyecto La Migra a invertido mas de \$14,000,000. Y esto es solamente para construir el sistema. Todavia falta ponerlo en practica.

Para hacer esto comenzara en tres ciudades fronterizas (El Paso, San Diego y Laredo). El Paso tiene mas de 44,000 residentes (inmigrantes con pasaporte).

La razon que la Migra da a la prensa por este sistema es que quiere "detener la falsificacion de pasaportes de residencia." Sin embargo, el problema de la falsificacion es minimo. El propio Departamento de Inmigracion estimula que el 5 al 10% de los pasaportes son usados falsamente. Entonces porque ha invertido mas de \$14,000,000.

La respuesta esta en lo que dijo Ray Marshall, Secretario de Labor, hace unos meses:

"Creo que estamos creando un nuevo movimiento de derechos civiles de los 1980s teniendo esta clase de gente que ha venido ha este pais sin poder protegerse y muy facil de explotar..."

Marshall, hablaba de los inmigrantes. Los inmigrantes, con o sin documentos son la gente mas pobre y explotada de este pais pues aun siendo parte integra de esta sociedad no se les garantiza derechos iguales.

Es miedo que los inmigrantes algun dia, tal vez con una revolucion social en Mexico, encabezen un movimiento por

sus derechos. Cuando E.U. fue a la guerra con Japon, encarcelo a los Japoneses de este pais en campos de concentracion. Cuando triunfo la Revolucion China (1949) la Migra comenzo una estricta y severa vigilancia contra el pueblo chino en este pais. Es evidente, que para los Mexicanos y otros inmigrantes de paises pobres, que este gobierno esta preparando los metodos de vigilancia y control.

## Social Security Reform?

In its mad dash to look for the most expedient way to restore financial solvency to the Social Security System, the Senate voted on November 4 to implement drastic tax increases on individuals and businesses alike. While action must be taken to restore fiscal health to Social Security, the Congress, in its haste, neglected viable alternatives, and by so doing, has done a grave disservice to the American people by passing such foolhardy legislation.

Any congressional solution should maintain the sharing relationship which has existed since the beginning of the System. It should not fall too heavily nor inequitably upon certain sectors of the economy. It should not attempt to mask the underlying monetary cost of making the System sound. Unfortunately, the provisions of the Senate bill violate all of these principles.

Based on the responses of over 150,000 Texans polled on Social Security issues in June, I offered an alternative financing proposal during Senate debate on the bill that would have provided an interim financing formula to meet the most immediate needs of the System while appointing a special commission to study methods that would keep Social Security fiscally sound, without resorting to the use of general revenues from the Treasury or to differing wage bases for employers and workers.

My amendment was defeated in favor of legislation that breaks the historic 50-50 sharing ratio of employer-employee contributions. As voted by the Senate, wage base increases -- four \$600 increments in 1979, 1981, 1983, and 1985 will be experienced by the employee. The employer, however, will have to pay social security taxes on the first \$50,000 of individual covered wages, with an increase to \$75,000 by 1985. The tax rate by this time would have

increased from the scheduled 6.05% in 1978 to 7.05%.

The Senate measure does, however, improve present law inequities by doubling the allowable outside earnings for those individuals aged 65 to 69, while removing the ceiling entirely for those 70 or older.

The Senate and House are presently meeting in conference committee in an effort to work out the differences in their respective legislation. It is hoped that the conference committee will not approve legislation that includes the many counterproductive provisions of the Senate-passed measure, and in its place, will give Americans a more responsible and equitable solution to the difficult problem of saving our Social Security System.
