Remodeling helps beautify Main Street

Donnie Bybee is fulfilling a dream and improving his beloved hometown by taking on a project of grand proportions. He purchased an ugly eyesore on South Main in Lockney, and is personally transforming it into an attractive property.

Bybee said, "I would walk to church every Sunday morning past this thing. I thought it was awful, and I determined to buy it and fix it up."

According to Bybee, Arch Crager, a former undertaker in Lockney, had turned the house, attached apartment in back and garage into a funeral home. He parked the hearses in the garage, prepared the bodies in the back apartment and placed them in the central part of the house to lie in state. His wife, Mae, had a beauty shop in one of the front rooms of the house. "As a boy, I used to wash his hearses and mow his grass," Bybee reminisced. "What's left of one of the hearses is still out back! I do not know for sure when the house was built, as I did not get an abstract with it. The closest I can figure, is around 1905."

According to the earliest Funeral Home records at the Floyd County Historical Museum, the Funeral Home was operational in

1932.

Both lifelong Lockney residents, Donnie and his wife, Vera Jo have three grown children, Dara Faries of Plano; Becky McPherson and Louie Bybee both of Lockney. Donnie has worked as an electrician, farmed and ran a rural mail route. He is now more or less retired.

"I approached my grandson Slim about taking the house, but I guess he doesn't want it since he hasn't shown up to help me work on it," he laughed! "In the beginning, I had more of a historical restoration in mind, but plans had to change. Since the garage is beyond repair, it will be torn down."

"I offered the owner, Gordon Alsworth, a price for it," Bybee said. "One week later he came by to say he would sell it to me, and all Vera Jo said was, 'What are you going to do with it?'"

Never one to be put off by hard work or a challenge, Bybee began his project.

Where to start? "I'm deciding as I go," he chuckled. "First thing was cleaning the mess, ripping and tearing and hauling (lots of hauling). The wooden floors are all sound and no termites. We're working our way around the house replacing windows, pouring cement to enlarge the porch

and doing some painting outside."

He laughed, "Vera Jo is my designer and I'm the carpenter. Women just seem to have a better feel for these things. I remember when I was working on our home, Vera Jo would come home from work and if what I'd done wasn't what she had in mind--I tore it out and changed it!"

"I figure it'll take 10 years to finish. W.L. Thomas stopped by one day and told me he'd never live long enough to see me get this mess cleaned up, let alone fixed up!" Bybee quipped.

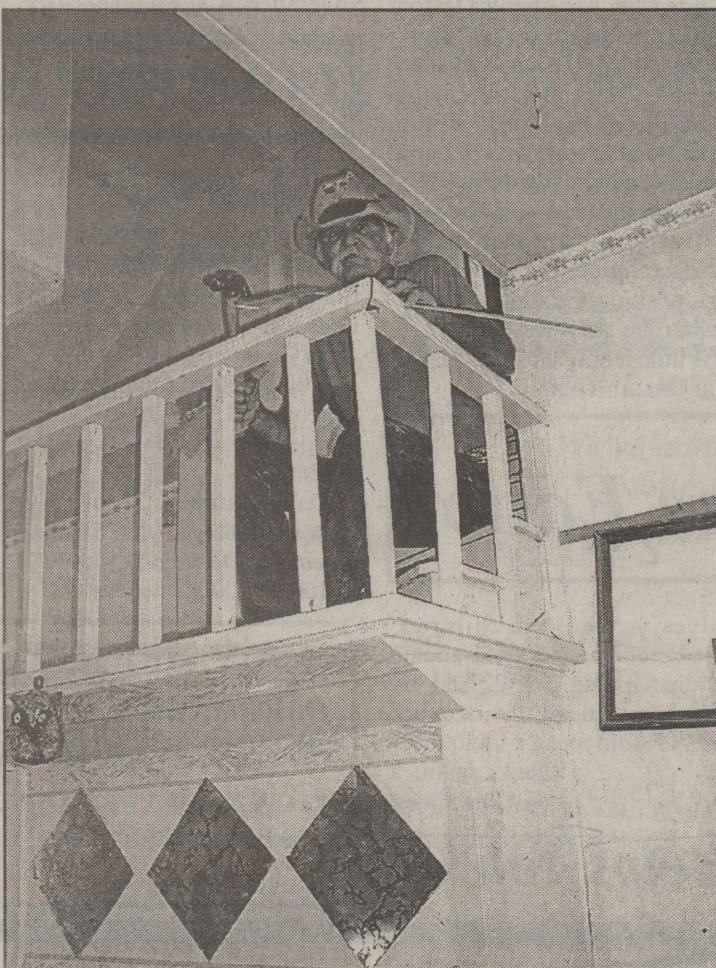
He was making good headway until health problems last year slowed him down for a while, but he didn't stop his special project.

Bybee has added eyebrow windows under the eaves, not for architectural interest, but as he puts it, "I needed some light up in the attic." He has already added a whimsical touch--cowboy and cowgirl shutters on one of the upstairs windows, an idea he got from some he saw in Plainview.

"When I'm not doing anything else, I come down here and work on this place," he said. "I know what I would like to do with the house once it's finished, but I'm not ready to say just yet."

LISD to propose tax increase

During their regular board meeting, July 15, Lockney ISD trustees voted to propose a new tax rate of \$1.50 and hire a new High School English teacher to replace Ms. Meredith Miller.

The trustees voted unanimously to propose an increased tax rate of \$1.50. Last year's rate was \$1.45. "We'll still have a deficit budget," said Superintendent Raymond Lusk, "but we can't afford to not go ahead and increase taxes for our long term goals. We have cut our expendi-

tures as much as we can and we are in good financial shape."

Lusk gave the financial report to the trustees. The report showed a bank balance of \$2,757,600 in the bank as of July 15th.

The trustees approved the resignation of Jessie Walker, an English Teacher at Lockney High School, and hired Arthur Woolever as a High School English Teacher.

Woolever will replace Ms. Meredith Miller, who resigned to teach elementary English in Plainview.

School board members voted to renew TASB property/casualty insurance, whose rates had come down from the previous year.

The Board also agreed to give tuition assistance to students who are chosen to participate in the Lockney Leadership Program. Students who participate will pay \$50 and LISD will assist with an additional \$50.

Trustees continued their discussion of the 2004-2005 budget, and set the date of August 26th to adopt the budget and set the tax rate.

Lockney to enforce new city ordinance

During their July 15, 2004 regular meeting, the Lockney City Council in a continuing effort to clean up Lockney's alleys and lots, unanimously passed an amendment to City Ordinance #43 on cleaning lots and alleys in the city of Lockney. The motion was made by Junior Brotherton and was seconded by J.D. Copeland. The amended ordinance reads as follows:

Article 1. From and after this date all owners of lots and alleys will be required to keep such property clean of weeds, rubbish, trash and the grass mowed. If the owner of such property fails to comply with the provisions of this article, the City will have the work done charging the expense to the said property owner and the amount to be added to the water bill or a lien will be filed on said property.

Article 2. All persons mowing lots, alleys or parcels of ground are hereby requested to keep the same free of weeds, rubbish and decaying matter of any kind and immediately cleanse said property of such things when notified by the City of Lockney to do so.

Anyone violating this article shall be notified by Certified Letter and will be given 10 days from the date of the letter; the deadline will be stated in the letter. If

the violation is not taken care of by the deadline the City will clean the property and the owner will be fined not less than \$125.00 and not more than \$1,000.00.

In other business, the Council heard a complaint by Beth Kropp on behalf of her employee, concerning the handling of a late payment on a water bill.

As Department reports were being given, Lockney Volunteer Fireman Joe Marks reported the Fire Department's new truck was in, and the Department is, "Really happy with it."

City Secretary Ron Hall addressed the numerous calls on why the City was not spraying mosquitoes by plane. "First, boll weevils are no longer being sprayed outside city limits, allowing more infiltration of mosquitoes into the City; second, a wet early summer made things worse. The City is spraying three times a week from the back of vehicles for the cost of one spraying by plane - approximately \$2,000. Environmentally safe pellets are also being used in ponds to control the development of mosquito larvae," stated Hall. "I think citizens are more sensitive to the mosquito situation because of the threat of West Nile Virus."

In regard to the City's sanita-

tion cost, Hall informed the Council Floydada has gone up on the cost per ton of garbage taken to the landfill to \$25. There will be an annual increase in cost per ton over the next five years of \$1, bringing the cost per ton of garbage delivered to \$30. Options were discussed.

Manual DeLeon addressed the Council regarding a lot he owns, roadwork being done and questions about a traffic stop involving him personally. No action was taken regarding the lot in question pending research of zoning laws. He was assured by the Council work on his road would be completed in a timely manner. In regard to the traffic stop, Chief of Police Jerry Edwards assured Mr. DeLeon anyone observed failing to maintain a single lane would be stopped, first to check for DWI and second to offer assistance should the driver have a medical condition requiring it. Edwards recounted a former incident where the life of the driver had been saved because he was stopped and determined to be in urgent need of medical attention.

Kellie McElhone of S.P.A.G. addressed the Council concerning a Downtown Revitalization grant that would require approximately 20% cash and in-kind

FISD discusses tax rate and approves raises

The FISD board met Tuesday, July 13, and voted unanimously to give FISD teachers a \$600 per year increase in salary starting this 2004-2005 school year. The board also voted to pay for a \$10,000 life insurance policy for each employee and they discussed the preliminary school budget and tax rate.

Concerning the teachers' pay raise, Superintendent Jerry Vaughn told the board, "We already pay \$700 above the base pay for first year teachers with a B.A. degree and \$1,000 above the base pay for first year teachers with a Masters degree. We lose teachers to Lubbock ISD because they start their first year teachers out at the four year level, but it is frozen there for four years. Our teachers will appreciate this raise."

Regarding the \$10,000 life insurance policy, Vaughn said, "This term life policy through TASB for all our employees will be good through 2007 and the total cost to FISD will be \$2,976. Each employee can buy, at their expense, more coverage if they want it."

In the \$8,014,104 preliminary budget, some general expenditure items were: \$4,199,065 - (Instructional, teachers, travel and supplies), \$1,149,339 (buildings), \$376,120 (administration) and \$146,233 (library).

The estimated preliminary revenues of the budget showed \$7,984,508 at the present \$1.44344 tax rate based on 95 percent collection.

FISD Business Manager Sharon Rainwater told the board, "In our preliminary budget, we

will show a \$29,596 deficit, if we leave the tax rate at last year's rate of \$1.44344 (per \$100 property valuation). But we could cut some expenses to balance this budget (at last year's rate)."

According to Rainwater, last year's balanced budget was set at \$7,886,719. Delinquent revenues last year amounted to \$52,000, while interest was around \$20,000. "\$35,000 of that was used in our budget last year," she said.

Vaughn said, "We are looking pretty good at leaving the tax rate at \$1.44344. Our goal is to leave the tax rate the same. However, if we set the tax rate too low, then we won't collect all our state Tier II money. Right now, we are maximizing our Tier II money and our Fund Balance is going up nicely. This year's tax rate will set the base for the next two years. Last year we set the proposed tax rate at \$1.50 and then came back down to \$1.44344 for the final rate adoption."

Board Secretary Bill Dean stated, "I know there is no way to know for sure, but I hate to vote on a proposed tax rate at \$1.50, when we are shooting for \$1.44. When you read it in the paper, people think we are raising taxes. We did that last year and then approved \$1.44 and they didn't understand why. I would rather set the (proposed) rate at \$1.44, or \$1.45. We can live with that for a year or two."

Vaughn responded, "If we do that, then we cannot go higher if we need to. Once you set the proposed tax rate, you can only go lower, but not higher."

Following more discussion,

Vaughn told the board they must adopt the new budget at the next scheduled board meeting on August 10.

In a related matter, Rainwater presented the board a Cash Flow report. It showed an Ending Cash Fund Balance for June, 2004 at \$4,356,708.49. Last year's Cash Fund Balance on September 1, 2003 was at \$3,651,389.37. This shows a projected increase by September 1, 2004 to be \$927,422.84. The average FISD monthly expenses for the past four years was at \$566,993.71.

In other matters, the board approved the purchase of computer software for the CCLC alternative school. The cost will be split almost in half with Ralls ISD, according to Vaughn. "This coming year we will have less staff there and that should help make up this cost."

A 2004-2005 transportation supply low bid by Cornelius Conoco was approved by the board.

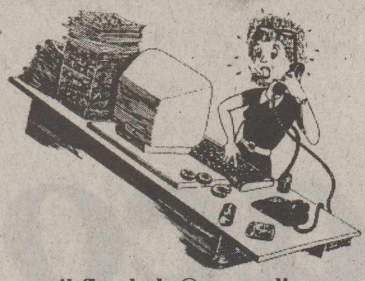

Ballots from Americans living overseas has always been a sought-after commodity by domestic politicians, and for good reason. In close elections they can spell the difference between winning or losing.

Increasingly, however, the influence of foreign opinion leaders on the American electorate has come to be a factor to be reckoned with. For as long as we can remember, American political organizations have sought to register Americans living overseas, and urge those individuals to vote when the time comes. But now, judging from what we read hither and yon, the Kerry camp, at least, is counting on foreign governments and foreign citizens to impact, as best they can, the American presidential elections. The Bush camp would be advised to take heed.

A story in the Tel Aviv newspaper Haaretz, moved worldwide by the Reuters wire service (but one we missed in any U.S. publication), indicates that the Kerry camp has dispatched the Democratic nominee's brother, Cameron, to Israel to reassure the Israeli Prime Minister, Ariel Sharon, that Israelis have nothing to fear from a Kerry win in November. A President Kerry

would be every bit as sympathetic to Jewish aims and claims as the current Republican President, George W. Bush, said Cameron Kerry, himself a convert to the Jewish faith. (He converted, the story notes, to Judaism in the 1980's, before marrying a Jewish wife.) Prior to that time, we assume he was raised as a Roman Catholic, as was his brother John F. Kerry.

Neither Bush, who has tailored American foreign policy in the Middle East to satisfy Israeli interests, nor Kerry, who, as the Democratic standard-bearer could traditionally count on the bulk of Jewish votes and money, are worried about the votes of Americans living in Israel. They are worried about, instead, the influence of Israeli politicians and political leaders on the large Jewish vote in New York, Florida, California, and a few other places. The Reuters story could well have summed up the situation by noting that: "While campaigning for his party's nomination, Kerry angered Israeli supporters last October when he told an Arab-American group the vast array of walls and fences being built through occupied land was a "barrier to peace."

"Kerry's campaign has since

taken pains to stress his pro-Israel voting record in the Senate, and Israeli government analysts have concluded there is nothing to fear if he is elected to the White House."

Still, Sharon indicates a degree of worry. A "confident" of the Israeli Prime Minister was quoted by Reuters as saying that a change in American Administrations "might" mean a change in American policy toward Israel, which might jeopardize the promise by Bush to allow Israel to keep some of the West Bank land it seized from the Palestinians back in the 1960's. Obviously, Sharon is milking the situation for all he can, which is natural, and for which we do not blame him. After all, that's what a political leader is supposed to do...look after the interests of his own people. And Sharon's got whatever votes he might need in the American Congress, by virtue of the same people who bankrolled Cameron Kerry's trip to visit Sharon, the well-heeled American-Israeli Public Affairs Committee. (We just thought we would give AIPAC a little plug there. They deserve some public mention in the gentile press, having spent as much money as they have in funding expense-free

trips to Middle East for American newsmen, though none with us.)

And while candidate Kerry's brother was in Tel Aviv asking for support for the Democratic nominee, his sister, Diana Kerry, was in Mexico, also asking for support. Diana, the story said, is chairman of the campaign's Overseas Americans for Kerry. Diana said her brother "would be a friend of Mexico."

The story did not note any concerns Kerry might have with Mexico, either in terms of immigration or trade. Or, if it did, the reference was well hidden. All we saw was to the effect that the two countries had much in common, and Mr. Kerry would "deliver on his promises."

A promise to deliver on a promise can be a worrisome thing. Quite often that means a guy has two chances to lie: one on the promise and then, two, on the promise to keep the promise. This time, however, given Kerry's tendency to flip-flop, we're sure he means it. In fact, the Democratic contender's tendency to forget what he promised, or forget things he has said, may well be the country's saving grace.

Mosley promoted to director of athletics at ACU

ACU president Dr. Royce Money has announced that former ACU basketball standout, and Lockney graduate, Jared Mosley has been promoted from associate director of athletics to director of athletics.

Mosley, the seventh director of athletics in ACU history, is about to begin his fourth year on the ACU athletics staff after serving one year as an assistant basketball coach and two years as the associate director of athletics for operations.

"ACU has one of the great athletics traditions in all of NCAA Division II, and we look forward to that continuing in the 2004-05 school year and beyond," Money said. "I am very confident in Jared and the abilities that he brings to the job, and I'm looking forward to seeing him lead our athletics department into the university's second century."

ACU vice president Dr. Gary McCaleb, who had served the last two years as the chief athletics administrator, said, "We're pleased to have someone with

Jared's background in this position. Jared was an outstanding student-athlete who knows the importance of continuing the kind of program he was a part of while he played here."

Mosley has direct ties to the last two directors of athletics in ACU history as he was a student-athlete when Stan Lambert was the director of athletics and played for and worked under Shanon Hays who was the basketball coach from 1996-99 and the director of athletics in 2002-03. Mosley has been responsible for the athletics budget, compliance, facilities, student-athlete development, game-day operations and special projects, making him well-equipped to lead the athletics department.

"I've always envisioned myself in this job, and it's always been a job I wanted," Mosley said. "The last two years have been a good experience for me, and they've allowed me to establish a good relationship with our coaches and staff. I'm excited about this opportunity, and it's a

job I can see myself doing for a long time."

One of Mosley's first duties will be to hire a full-time NCAA compliance coordinator, a job that Mosley had performed as part of his associate director of athletics duties.

"Once we find that person, I'll go out with (director of athletics emeritus) Wally Bullington and begin developing relationships with our lettermen so they can begin to get to know me," Mosley said. "I want our lettermen and donors to feel comfortable and familiar with me."

Mosley is one of the most-decorated basketball players in ACU history. He finished his career in 1999 as the 11th-leading scorer and eighth-leading rebounder in school history, and in his senior season (1998-99) he led the Wildcats to the NCAA Division II south central region championship game.

Mosley earned several honors during his senior season, including first team GTE academic all-America, first team all-south cen-

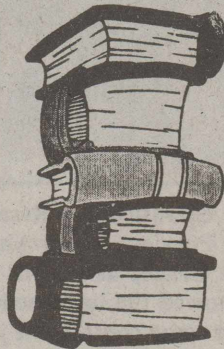
tral region by the NABC, second team all-region by Daktronics-CoSIDA, Lone Star Conference South Division MVP and first team academic all-LSC. He was also awarded a \$5,000 NCAA Post-Graduate Scholarship.

Mosley, who graduated with a 3.88 GPA, was also a three-time academic all-LSC pick, two-time all-LSC first team selection and all-tournament selection at the south central region tournament. He and his wife, Trish, have been married five years and have a son, Jaden.

Mosley said his experience inside ACU athletics should make his transition an easy one.

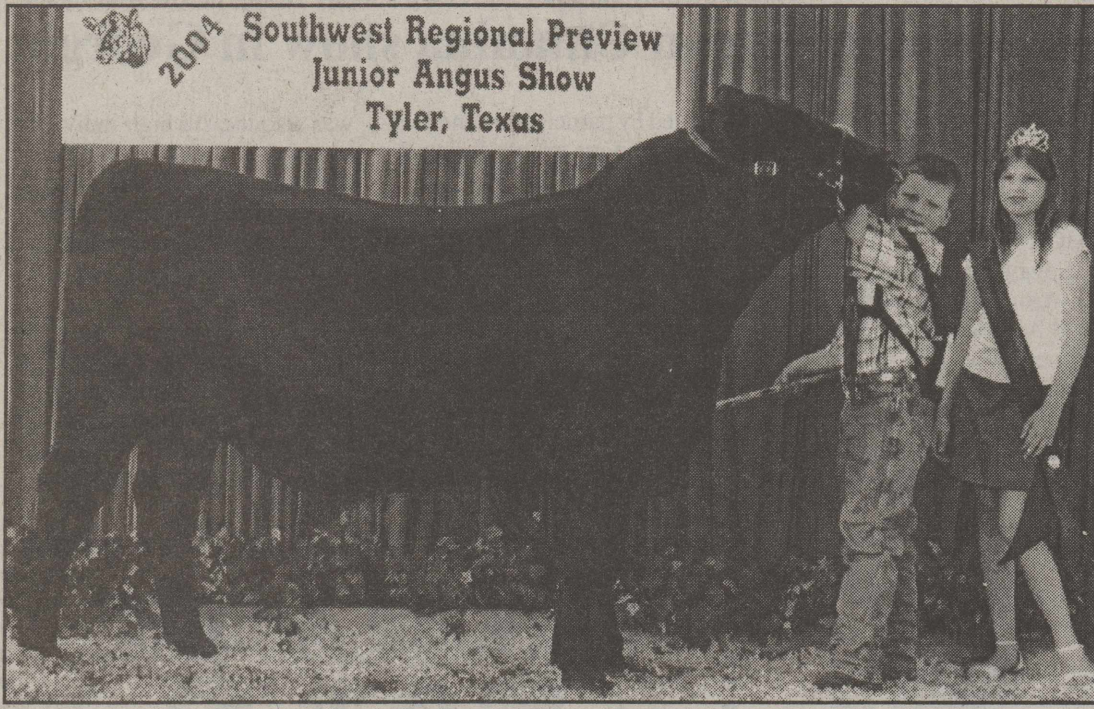

Vegetable and weed control field day set

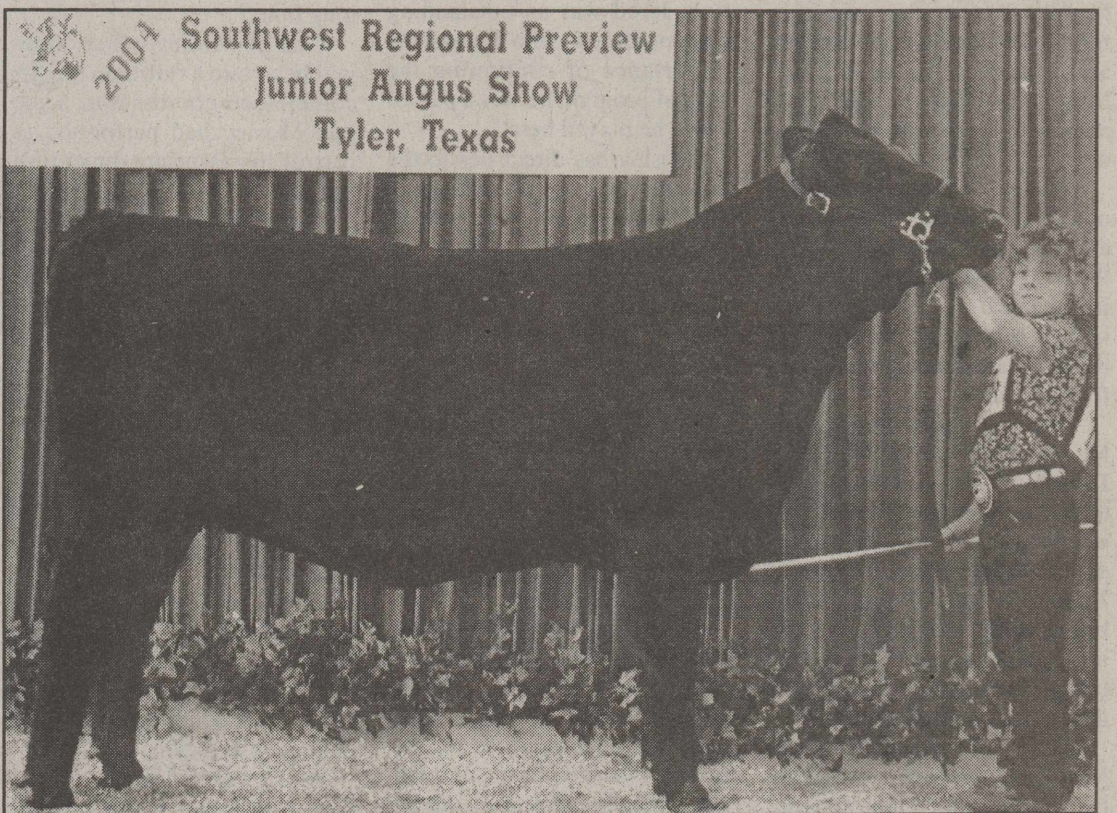

Persons who are interested in vegetable production and weed control options for vegetable crops should mark August 10 on their calendar. That's the date for the 2nd Annual High Plains Vegetable and Weed Control Field Day at Texas A&M's Agricultural Research and Extension Center. The center is just north of the Lubbock International Airport off of Interstate Highway 27: take exit 11 off of I-27 and drive east approximately one-half mile. "We will discuss general weed control practices for vegetable growers, and new herbicides

which may be labeled for vegetable crops," said Russ Wallace, Texas Cooperative Extension vegetable specialist headquartered at Lubbock. "The field day will also feature a walking tour of the vegetable research plots here at the center. "The walking tour will include the statewide watermelon variety trial, cantaloupe and tomato variety trials, and bio-fungicide research for powdery mildew control in cantaloupes. We will also look at our herbicide research trials for pumpkins, cantaloupes, chili peppers, black-eyed peas, sweet corn and snap

PCG President Rickey Bearden and Vice President Mike Hughes traveled to Washington, DC July 12-14 with cotton producers from across Texas to discuss cotton issues and reinforce the importance of the current Farm Bill to USDA officials and members of Congress.

Bearden and Hughes were in Washington as part of a Texas Cotton Producers group seeking to discuss current cotton related issues and to reinforce the strong working relationship the cotton industry has with USDA personnel and Texas Congressional representatives.

During the trip Bearden and Hughes joined the TCP group to visit congressional staff and hear reports from key USDA agency representatives.

The TCP group met with several members of the Texas Congressional delegation including: Representatives Max Sandlin (District 1), Chet Edwards (District 11), Mac Thornberry (District 13), Ron Paul (District 14), Charles Stenholm (District 17), Randy Neugebauer (District 19),

Henry Bonilla (District 23), Solomon Ortiz (District 27), and Senator John Cornyn. Representatives from the House and Senate Agriculture Committees also briefed the TCP group.

Jim Butler, USDA Deputy Under Secretary for Farm and Foreign Agriculture Services; David Hatch, Associate Administrator of the Risk Management Agency; Al Jennings, Director, Office of Pest Management Policy; Scott Sanford, Farm Service Agency Fibers Analysis Group; and, Carol Skelly, USDA World Outlook Board, provided USDA updates on cotton related programs and issues.

The TCP group concluded their trip with a luncheon at the

National Cotton council's Washington office attended by Special Assistant to the President Christopher Smith.

In addition to their TCP schedule, PCG's officers also met with representatives of the Risk Management Agency to discuss the current deferred appraisal period for non-emerged seed and find a solution that meets the needs of the producer in the field and the Federal Crop Insurance Program.

During the meeting several options were discussed and progress made toward development of an equitable solution. The ultimate goal is to develop a solution that can be initiated in 2005 crop year.

Anyone violotating this article shall be notified by Certified Letter and will be given 10 days from the date of the letter; the deadline will be stated in the letter. If the violation is not taken care of by the deadline the City will clean the property and the owner will be fined not less than \$125.00 and not more than \$1000.00.

MARY J. HARRIS

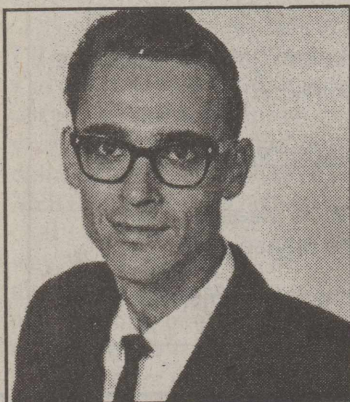
Mary John Harris, 82, a former Silvertown resident, died July 13, 2004, at Abilene Convalescent Center in Abilene, Texas.

He obtained a business school education as well as an insurance license and nursing home administrator license. He was employed by Challenge Homes until his health caused him to retire.

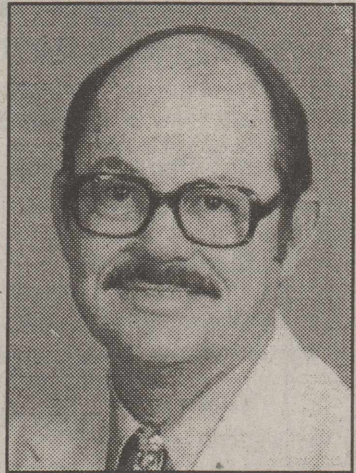
He moved to California with his daughter, Terri, and her family. In August 2000, he moved to Wildomar Senior Leisure Community.
