

# **Moore County Gin** Reaches Million-Bale Mark

Moore County Gin, LP, located near Dumas, recently ginned their millionth bale of cotton since they began serving growers on the Northern High Plains of Texas. The gin began operations in 2005, being only the second gin north of I-40 in Texas. The plant started with four gin stands and one bale press, and then in 2011 added another complete gin plant directly north of the existing one for a total of eight gin stands and two bale presses. On average, both gins can produce 120 bales an hour. Before the 2017 cotton crop, the gin's record was 103,349 bales produced in one

"We are in the midst of a record crop at finishing up a little over 260,000 bales," Moore County Gin General Manager Leighton Stovall said, adding that they expect to finish ginning in about four weeks.

The Texas panhandle is known for early freezes, but due to the development of shorter season varieties, growers can produce a bountiful crop in a 150-day period. Growers in the northern Texas Panhandle have found that cotton is a great crop to introduce into crop rotations to add nutrients back into the ground as well as reducing water output.

"This year alone we had a total of 39 producers trying cotton for the first time and many of those will be returning this next year," the gin's Marketing Manager Alexa Reed said. "With new and returning customers, we had roughly 135,000 acres of cotton that has come to the gin this year."

# **Combined Response Training** held over the weekend

The ALERT LEVEL II Combined Response Training was held at the Mary Allen Elementary School on Saturday, and Sunday, April 16th, and 17th. There were eight instructors for the Alert Program from Randall County Sheriff's Office, Amarillo Police Department, and Randall County Fire Department, who provided the course through Amarillo College and Frank Phillips College.

The Active Threat Combined Response Training brought regional Law Enforcement, Fire and EMS personnel together to build response capabilities. The course covered point-of-injury medical interventions and establishing/deploying rescue task forces during a hostile critical incident while law enforcement actively neutralized the threat. The course included scenarios where the students had to neutralize threats, conduct hasty triage, treat injuries, establish secure casualty collection and extraction points, and learn to integrate with Law Enforcement/EMS/Fire personnel.

There were just over 50 officers, firefighters and EMS personnel from Sherman County Sheriff's Office, Stratford P.D, Cactus PD, Texhoma PD, Stratford Fire and EMS, and Dalhart Fire and EMS. It was great having all these entities involved and training together for in all likelihood they would be responding to an actual incident.

Stratford Grain cooked steaks for lunch on Saturday, and Happy State Bank provided lunch on Sunday from Poppy's Pit. Mr. Farnsworth and 9 students from Stratford High School volunteered as role players for the scenarios.

Capt. Forbis remarked that this was one of the better attended classes he has taught. I want to commend all in attendance for their continuing commitment to keep Sherman County safe.







# **Dear Editor: Protect Access to Health Coverage for Cancer Patients**

I am a cancer survivor and my health coverage is my lifeline. Access to timely treatment, affordable medications and regular screenings and checkups are essential and the reason why I am alive today. Any breaks in coverage could mean delayed care for my cancer and dire consequences for my health.

That's why I'm so concerned to see that Health and Human Services Secretary Alex Azar proposed a regulation that could significantly weaken the health insurance marketplaces and threaten access to health coverage for cancer patients, survivors and anyone at risk of developing the disease.

American Cancer Society research shows individuals without health insurance are more likely to be diagnosed with cancer at later stages when the disease is more expensive to treat and chance of survival is reduced. Yet, this proposed regulation would increase the availability of short-term plans that can skirt patient protections and allow these plans to be more available for much longer periods than they were designed to be offered. If this regulation is finalized as is, it will likely weaken the insurance marketplace which many cancer patients and survivors rely on, make plans unaffordable and could lead to more bare-bones plans that can deny coverage based on someone's health history or cap coverage if an individual runs up too many bills.

Texans and all Americans deserve better than this. US Representative Thornberry, for the health of citizens in your district, please oppose these efforts to weaken or strip patient protections from plans. Urge

Secretary Azar to stop this flawed regulation from moving forward.
