





Education system knows what to do in advance of swine flu season

AUSTIN-Texas school officials have plans to carry out if the H1N1 "swine flu" influenza virus hits schools this fall.

Here's a brief version of a set of federal/state guidelines schools are to follow if flu drowned in pools were last conditions are about the same as they were last spring:

1. Stay home when sick 2. Separate ill students and staff

3. Wash hands frequently with soap and water and cover nose and mouth with a tissue when coughing or sneezing (or a shirt sleeve or elbow if no tissue is available)

students and staff touch often 5. Treat high-risk students and staff early



# Let's Talk Plants

By Brandon Carr Soil Conservationist James E. 'Bud' Smith Plant Material Center, Knox City

Who doesn't enjoy the taste of fresh, homegrown vegetables? Have you been wondering what it takes to grow your own produce? When should I plant? What should I plant? How long will it take for the vegetables to mature?

These are questions to consider before you plant any garden. Agriculture Secretary Tom Vilsack has declared Aug. 23-29 as National Community Gardening Week. This is a chance to get out and learn how to produce your own gardens. For many that have already mastered this art, you have the chance to educate others. Community gardens can provide positive benefits in many different ways. They give individuals the opportunity to get outside, maybe get some needed exercise. They give neighbors the chance to visit and work together as a team. They provide fresh food for our families. And finally, they allow us to teach our children and grandchildren how to live off the land.

While many may think that because the summer is winding down, there is no time left for a garden this year. Actually, August is a great time to plant a vegetable garden.

All REPs are required to offer deferred payment plans to eligible customers who express an inability to pay. Many REPs also offer balanced billing plans, which allow eligible customers to pay an average amount each month year-round.

Additionally, many community action agencies may be able to help with electric bills or energy efficiency programs. Application forms are being distributed to all households with a letter informing households of the availability of free and reduced-price meals for their children. Applications also are available at the principal's office in each school. To apply for free and reduced-price meals, households must fill out the application and return it to the school. Applications may be submitted anytime during the school year. The information households provide on the application will be used for the purpose of determining eligibility and verification of data. Applications may be verified by the school officials at any time during the school year.

For school officials to determine eligibility for free and reduced-price benefits, households receiving food stamps of Temporary Assistance for Needy Families (TANF) only have to list their child's name and food stamp or TANF case number. An adult household member must sign the application.

Households that do not list a food stamp or TANF case number must list the names of all household members, the amount and source of the income received by each household member, and the Social Security number of the adult household member who signs the application. If the adult who signs the application does not have a Social Security number, the household member must indicate that a Social Security number is not available by writing the word "None," "No Number," or some indication that the person does not have a Social Security number. The application must be signed by an adult household member.

Under the provision of the free and reduced-price meal policy, The District PEIMS Coordinator will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the reviewing official on an informal basis. Parents wishing to make a formal appeal for a hearing on the decision may make a request either orally or in writing to Superintendent, Haskell CISD, P.O. Box 937, 605 North Avenue E St., Haskell, TX 79521, 940-864-2602.

If a household member becomes unemployed or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for benefits if the household's income falls at or below the levels shown above.
