RICHARD CANDELARIA

After spending forty-one years in any profession, many would be thinking of not one thing, retirement. Not so for the new Chief of Police in Haskell, Richard Candelaria.

Candelaria, whose first day as Police Chief was Jan. 16, was born and raised in the El Paso area. He graduated from Socorro High School. He earned an

Associate Degree from El Paso Community College, and then began working toward a bachelor's degree from Sam Houston State University through the Bill Blackwood Law Enforcement and Management Institute of Texas.

Upon completion of his education, he went to work for the El Paso County Sheriff's Office, where he remained for eight and one half years. During some of this time, on his days off, he also worked as a U.S. Customs officer.

The next stop in his law enforcement career was with the Kermit Police Department. When he had been there about six months, he was recruited by the Midland Police Department.

After thirty-two years with the Midland Police Department, he has amassed a very impressive list of

accomplishments. Beginning as a patrol officer, he later established the bike patrol, moved onto the SWAT team, and then was a part of the Crime Prevention team. Candelaria worked fifteen years in traffic, patrol and investigations. He transferred to the property division where he investigated white collar crimes, and his last twelve years with the department, were spent in the Crimes Against Persons Unit.

His experience includes several different aspects of law enforcement. In addition to investigating violent crimes, he was a team leader on the hostage negotiation squad, as well as working in the gang suppression unit. In fact, he started a gang information unit, where various law enforcement agencies could exchange information in their efforts to suppress gang activity. Candelaria was also a team leader with the honor

guard.

He is married to wife Terissa, who is a captain with the Midland County Sheriff's Office. Although the date is still uncertain, she will be moving to Haskell upon her retirement. He is the father of three grown daughters, and the proud grandfather of two.

His favorite pastime is sports. He played baseball, football and basketball in high school, and later played semi-pro football and baseball with an A club. Sports continued to be a part of his life, as he officiated high school and college football and basketball for twenty-five years.

While he is most certainly a very dedicated law enforcement officer, he is just as passionate about being a part of the Texas Law Enforcement Torch Run.

Candelaria says, "A friend was organizing the run for our area, and asked me to run a portion of the relay. I did, and after attending the opening ceremony in San Marcos, I was hooked for life." The Torch Run raises money for Special Olympics, usually \$50 to \$60 thousand each year. He has served as the state director for the organization, is a member of the International Torch Run serving on the exchange committee and is also the regional director.

A member of the Texas Homicide Investigators Association and the Texas Hostage Negotiators Association, he has been recognized for his outstanding work. In addition to being named Officer of the Year by several organizations, he was also named Officer of the Year by the Crime Stoppers organization. Candelaria was recently given a citation by the Director of the FBI for his work with the Midland division of the FBI in the gang suppression unit.

Early on in his career, being a Police Chief was on his bucket list of things to accomplish. He says when the opportunity in Haskell arose, he knew it was time. Although he is just getting acquainted with the department and community, he already has in mind some things he

would like to implement. One very important aspect of his plan is to see the police department and community work together, and build trust.

He wants people to be able to depend on the department and feel comfortable coming to any officer with a problem or information. He would like for his officers to be proactive and present themselves to the community as the professionals they are. The other side of that coin is, of course, the department needs the help of all citizens to be successful.

Candelaria also plans to add new programs, such as neighborhood watch, programs for schools, Cops on Patrol, and a volunteer program. He realizes it will take time to meet these goals, but adds that issues will be addressed as they come up, and changes will be made as needed. He is adamant about continuing the working relationship with all law enforcement agencies in the area, as well as Crime Stoppers and the District and County Attorneys. He knows working as a team will best get the job done.

He acknowledges that the department, which includes the chief, Sergeant Jeff Caparoon and Officer Dan Kaszuba, are working short handed, but the search is on for another officer to join them.

Chief Candelaria is pleased to be in Haskell, and looks forward to leading the Haskell Police Department, toward soon being one of the best small departments in the country.

It's almost that time again-time to celebrate "Texas Independence Day Haskell County Style." This year's celebration will be held Sat., March 3 around the Courthouse and city square.

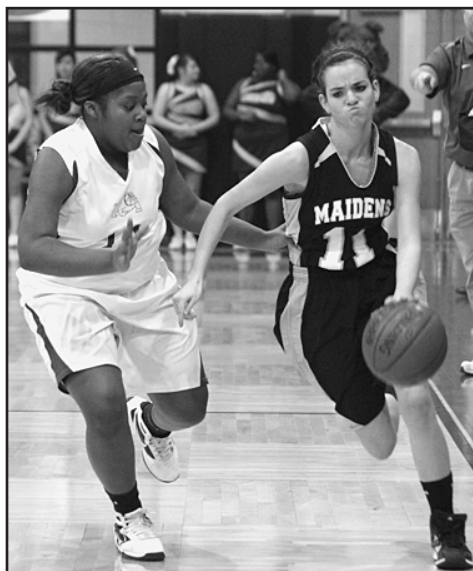

games, which were a big hit with the kids last year and many others. This year some new attractions and even some contests are planned.

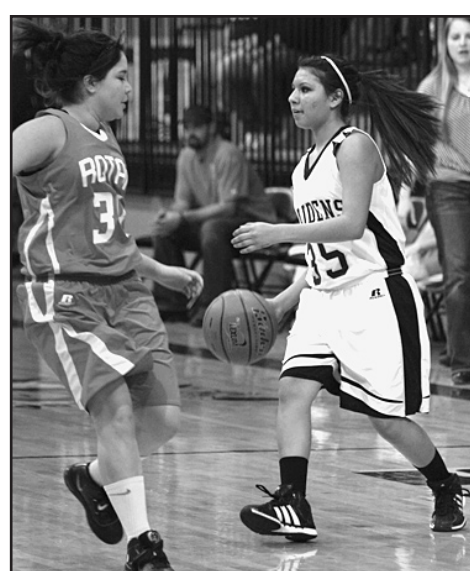
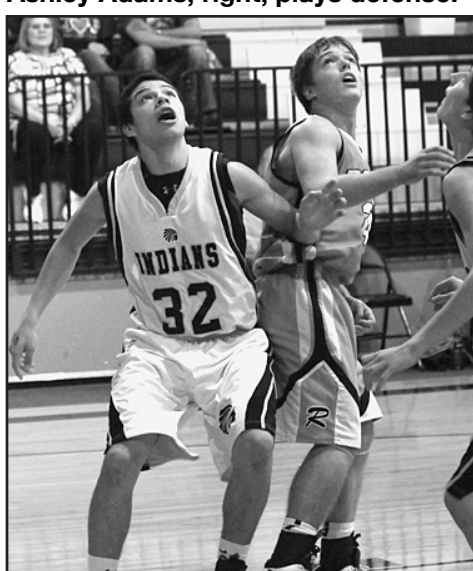

Homer Burl LeClaire

Funeral services for Homer Burl LeClaire, 91, of Dallas were held Mon., Jan. 23 at Lakeland Baptist Church in Lewisville. Interment was at Restland Cemetery in Dallas under the direction of Mulkey-Mason Funeral Home of Lewisville.

Born Jan. 29, 1920 in Olden, he was the son of the late Robert Edward Lee LeClaire and Ollie Annie Clark LeClaire of Haskell. He grew up on a cotton farm, graduating from Haskell High school in 1938, joined the Army Air Corp the week

after Pearl Harbor, graduated flight school in March 1942 and was a pilot during World War II. He flew three trips across the North Atlantic to England in B-17s and five trips across the South Atlantic to North Africa and India in B-25s. In 1944 he was assigned to the China-Burma-India (CBI) Theatre of War. He flew 26 trips across the Himalaya Mountains, known as The Hump and later as The Aluminum Trail for all the many planes that crashed traveling over the mountains. They carried gas, ammunition and supplies to the front lines in China. He was reassigned April 1945 to the 1352nd AAF Search & Rescue unit at Chabua, India helping numerous downed pilots to safety. After crashing a B-24 in Cairo Egypt in a sand storm, he returned to the States. He was a flight instructor for B-25 pilots at Love Field in Dallas until he was honorably discharged Dec. 10, 1945 at Sheppard Field in Wichita Falls. When asked what was the fastest plane he ever flew he said without hesitation, a P-38 "Lightening." He was active in the American, European, North Africa and Asiatic Pacific Theatres of War. He was awarded the Asiatic Pacific Ribbon with two Bronze Stars, the Distinguished Flying Cross with an Oak Leaf Cluster,

the Air Medal with an Oak Leaf Cluster and the Victory Medal. LeClaire stayed in the Air Force Reserves until 1969 and retired as a Lt. Colonel.

He married Ivy Jo (Jody) Huckabee in 1946 and lived in Dallas. They had three sons, Gene, Doug and Glen. Jody died in 1963.

He remarried in 1966 to Ann Elizabeth Avikainen and moved to Flower Mound. They happily celebrated their 45th anniversary Nov. 5, 2011.

He retired in 1982 from Associated Aircraft Supply after 20 years and he and Ann traveled all over the U.S. He was a member of The Great Generation who could make and fix anything!

He is missed as a husband, father, grandfather, great grandfather and friend by all that knew him. The void left will be filled with the many stories and memories of his life and what he meant to us all.

He was preceded in death by his parents, brother Paul and sisters Alphas and Annie Merle.

Survivors include his devoted wife Ann; sons Gene and wife Anita, Doug and wife Ellie, Glen and wife Michelle; eight grandchildren, seven great grandchildren, nieces, nephews and many friends.

WHO HAS TO FILE A 2011 INCOME TAX RETURN?

Taxes are a frequent topic of conversation at this time of year, and a common question is, who has to file a tax return? The rules for filing 2011 tax returns are straightforward for most people.

Single taxpayers (including those who are divorced or legally separated): If you're under 65 and had gross income of at least \$9,500 in 2011, you must file. If you're 65 or older, the cutoff is \$10,950.

"Head of household" taxpayers (generally, unmarried people who provide a home to a child or other dependent): If you're under 65 and had income of at least \$12,200, you'll need to file. If you're 65 or older, the cutoff is \$13,650.

Married taxpayers filing jointly: Filing is required if both spouses are under 65 and income is at least \$19,000. If one spouse is 65 or older, the cutoff is \$20,150. If both spouses are 65 or older, gross income must be at least \$21,300 to require filing. If you were married but not living with your spouse at the end of 2011, filing is required if you have income of \$3,700 or more, regardless of your age.

Married taxpayers filing separately: If you made at least \$3,700, you must file, regardless of your age.

Different IRS rules govern filing for certain widows and widowers, dependents, those who owe special taxes (e.g., self-employment tax), children under age 19, and aliens. If you have a refund coming, you will want to file regardless of your income level.

It's worth looking into your filing requirements. This year you may not have to file at all. The IRS doesn't want people to file income tax returns that aren't necessary. The reason is simple: Processing tax returns takes time and money. The IRS doesn't want to use its resources handling returns that weren't required in the first place. 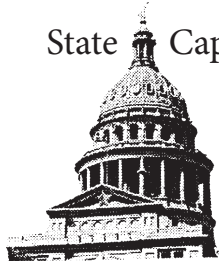

High court says San Antonio court erred in redistricting

The U.S. Supreme Court on Jan. 20 struck down the interim redistricting plans for the state of Texas authored by a three-judge panel of the San Antonio-based U.S. District Court, Western District of Texas.

Last year, the panel was tasked with drawing state House, Senate and congressional district boundaries after the 82nd Texas Legislature's enacted redistricting plans failed to be pre-cleared by D.C. Circuit Court. Texas' maps must earn preclearance as required under Section 5 of the U.S. Voting Rights Act, a law meant to cure a list of states and other jurisdictions from their historical record of discriminatory practices in election processes. Texas gained four congressional seats largely due to a huge increase in the Hispanic population, as tabulated in the 2010 U.S. Census.

On Jan. 20, the U.S. Supreme Court directed the U.S. District Court in San Antonio to follow the Texas Legislature's intent but did not elaborate on a methodology to use moving forward.

Texas Attorney General Greg Abbott reacted, saying, "The (U.S. Supreme) Court made clear in a strongly worded opinion that the district court must give deference to elected leaders of this state, and it's clear by the Supreme Court ruling that the district court abandoned these guiding principles."

In any case, a new set of redistricting plans, once drawn, must be submitted for preclearance. Meanwhile, the San Antonio District Court, in response to the U.S. Supreme Court striking down the court-drawn interim redistricting maps, set a scheduling order calling for a hearing on Feb. 1.

But Abbott's office filed a motion to reconsider because, Abbott said, the court's schedule appears to delay when Texas primary elections could take place. The primaries are currently set for April 3. Abbott's office said it wants all legal matters settled in time for new maps to be issued by the end of this month.

Perry ends presidential bid

Gov. Rick Perry on Jan. 19 publicly announced the decision he made to end his presidential campaign.

Perry, who was polling in single digits in South Carolina two days before that state's Jan. 21 Republican primary, immediately endorsed rival

Newt Gingrich, an author, political consultant and former speaker of the U.S. House of Representatives (January 1995-January 1999).

With Perry's departure, the GOP field of presidential aspirants is reduced to four: Gingrich, U.S. Rep. Ron Paul of Texas, former Massachusetts Gov. Mitt Romney and former U.S. Sen. Rick Santorum of Pennsylvania.

While Perry outperformed the field on fund-raising, his performance in live, televised debates proved to be his weak suit. The Paint Creek native is in the second year of his third four-year term as governor. So far, he has served more than 11 years as Texas' chief executive.

Jobless rate drops in December

The Texas Workforce Commission on Jan. 20 reported Texas' seasonally adjusted unemployment rate fell to 7.8 percent in December, down from 8.1 percent in November and down from 8.3 percent in December 2010.

Also in its monthly report, the agency stated the civilian labor force grew by more than 17,000 in December, and now stands at more than 12.3 million Texans.

According to statistics published by the U.S. Department of Labor, the national unemployment rate is 8.5 percent.

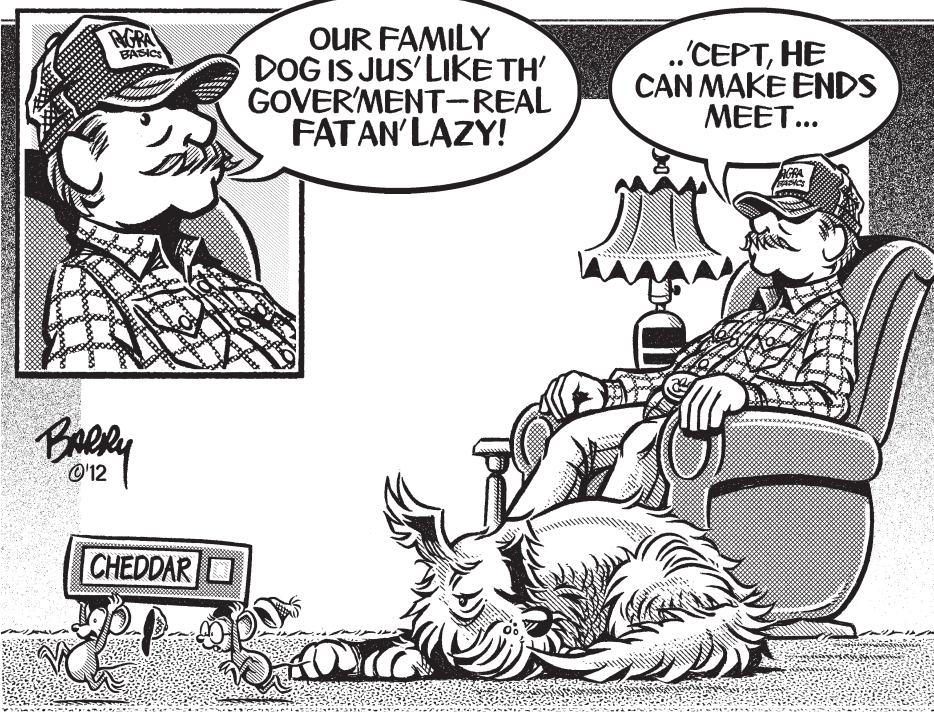
Patterson at front of opposition

Earlier this month, the state's General Land Office announced Texas Land Commissioner Jerry Patterson is leading an effort to unite 23 western states to oppose the federal government's process for adding "birds, bugs, lizards and other critters to the list of protected endangered species."

According to a Land Office news release, the Western States Land Commissioners Association, whose members manage about half a billion acres of public land and mineral rights for public education, passed a resolution urging Congress to alter the Endangered Species Act at its annual winter conference in Austin.

Flu vaccinations still urged

The Texas Department of State Health Services recently reminded citizens to get vaccinated against flu and said the flu season is near its typical peak. State Health Commissioner Dr. David Lakey said, "We usually see a significant increase in influenza in Texas in January and February, so this is the time to protect yourself."

Ask the Mayor

I've been meaning to visit New Mexico again but Sunday afternoon New Mexico blew right past my window...saved me a trip! We're liable to see much more of the same since we've received precious little rainfall. However, I read in the newspaper that the rainfall should approach normal as well as the temperature starting in late spring to early summer of this year. I certainly hope this weather forecaster knows what he is talking about.

Saturday was a sad day for us. We drove to Bronte to say goodbye to an old friend we'd first met in New Mexico, Ruidoso in particular. When we first started visiting the races, Tuny Glenn, a good Aggie '43, encouraged us to buy our table in section C-2. We did and there began a great friendship with many scattered across Texas who happen to love horse races.

Six members of Section C-2 were in Bronte for the funeral. It was said, "He was the kindest man I ever knew." That certainly will never be said of me. No one can ever remember Tuny saying a bad thing about anyone, and there was opportunity. There may be something about the Six

Degrees philosophy because we looked up and there was Morris Johnson, pastor of Cornerstone Baptist Church in Haskell. Johnson beautifully sang several hymns. It turns out he was pastor of First Baptist Church Bronte for 12 years and knew our dear friend.

Haskell has begun again tearing down some "falling down" houses. We drove by four on Thursday night and I'm told there is a total of about fifteen coming down. One was the house my wife's grandparents lived in when she was young. It's sometimes easier to put a memory out of its misery than to watch it deteriorate slowly. We'd taken pictures, but in truth it did not resemble anything it did when there were huge mulberry trees all around it and a wooded lot beside it where her grandmother raised an orphan calf by bottle. I understand that some of the houses are part of a grant received and these people will get a new home. Others just need to be gone and the landscape retrieved.

I'd like to share with you an idea that could utilize all this old lumber, rubble. Briefly, in

Stuttgart, Germany the citizens took all the "rubble" from the bombed out buildings during World War II outside the city limits. There, they piled it all up and then put soil on top, planted grass, trees, made a park and call it Rubble Mountain. It is a memorial and a tribute to the German people who withstood and survived World War II. If we didn't want to fill up our landfills, could we do something like this on a much smaller scale?

Stopped by Post and asked the City Hall what was the magic of their shiny windows. Simple, they use the cleaner in the "blue and white can." It started by a few people taking pride and charge and began with their own windows and then others joined in.

We've had occasion to pass through many small towns this past year and Haskell stacks up very well. We're not as good as we can be, but we're such a far cry ahead of a lot of other small towns. Some of the comments made by the people who "judged" our city for the award we won last spring were we needed more directional signs, more street signs and some obvious eyesores needed to be gone.

Latest report on junked cars is very encouraging. A driving tour of about 15% of our town showed a significant reduction in the number of vehicles that are considered junk. There were 46 vehicles identified in just this area last year judged "junk." As of last week, it was reported that 31 of the 46 had disappeared just in the small portion of town that was checked. I want to congratulate everyone who has done their part to rid our town of these eyesores. By the way, it is very seldom that one can take an eyesore and get money for it.

I received some really exciting news this week. Police Chief Richard Candelaria is being recognized by the Midland Crimestoppers as the 'Officer of the Year.' Chief Candelaria will be honored at a luncheon at the Petroleum Club in Midland on Fri., Jan. 27. We are so pleased and honored to have Candelaria as our Chief of Police just as Midland was proud to have him as one of their law enforcement officers. Our congratulations to Candelaria and I feel certain that he will be as effective for us as he was for Midland.

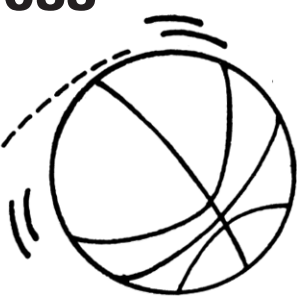

APPLICATION AND PRELIMINARY DECISION. City of Haskell, 301 South First Street, Haskell, Texas 79521, has applied to the Texas Commission on Environmental Quality (TCEQ) for a major amendment to TPDES Permit No. WQ0010728001 to authorize the disposal of treated domestic wastewater via irrigation of 68 acres of non-public access land, and to continue the authorization to discharge treated domestic wastewater at a daily average flow not to exceed 700,000 gallons per day. TCEQ received this application on May 2, 2011.

The facility is located approximately one mile south and 0.25 mile east of the intersection of U.S. Highway 277 and U.S. Highway 380, in Haskell County, Texas 79521. The treated effluent is discharged to Rice Springs Branch; thence to Mule Creek; thence to Lake Stamford in Segment No. 1235 of the Brazos River Basin. The unclassified receiving water use is high aquatic life use for Rice Springs Branch. The designated uses for Segment No. 1235 are high aquatic life use, public water supply and contact recreation.

In accordance with 30 TAC § 307.5 and the TCEQ implementation procedures (January 2003) for the Texas Surface Water Quality Standards, an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action. Numerical and narrative criteria to protect existing uses will be maintained. A Tier 2 review has preliminarily determined that no significant degradation of water quality is expected in Rice Springs branch, which has been identified as having a high aquatic life use. Existing uses will be maintained and protected. The preliminary determination can be reexamined and may be modified if new information is received.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at Haskell City Hall, 301 South First Street, Haskell, Texas. This link to an electronic map of the site or facility's general location is provided as a public courtesy, and is not part of the application or notice. PUBLIC COMMENT/PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public

meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision.** A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name; address, phone number; applicant's name and permit number; the location and distance of your property/activities relative to the facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are germane to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission will only grant a contested case hearing on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on issues that were raised in timely filed comments that were not subsequently withdrawn.

EXECUTIVE DIRECTOR ACTION. The Executive Director may issue final approval of the application unless a timely contested case hearing request or request for reconsideration is filed. STATEMENT OF BASIS/TECHNICAL SUMMARY AND EXECUTIVE DIRECTOR'S PRELIMINARY DECISION DESCRIPTION OF APPLICATION

Applicant: City of Haskell; Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0010728001, TX0026891

Regulated Activity: Domestic Wastewater Permit

Type of Application: Major Amendment

Request: Major Amendment to include option to irrigate Authority: Federal Clean Water Act (CWA) § 402; Texas Water Code (TWC) §26.027; 30 Texas Administrative Code (TAC) Chapters 30, 305, 307, 309, 312, and 319; Commission policies; and EPA guidelines.

EXECUTIVE DIRECTOR RECOMMENDATION

The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The proposed permit includes an expiration date of **March 1, 2015** according to 30 TAC § 305.71, Basin Permitting.

REASON FOR PROJECT PROPOSED

The applicant has applied to the Texas Commission on Environmental Quality (TCEQ) for an amendment of the existing permit to authorize the option to dispose of treated domestic wastewater via irrigation on 68 acres of non-public access land, and to continue the authorization to discharge treated domestic wastewater at a daily average flow not to exceed 700,000 gallons per day. The existing wastewater treatment facility serves the City of Haskell.

PROJECT DESCRIPTION AND LOCATION

The City of Haskell Wastewater Treatment Facility is an activated sludge process plant operated in the extended aeration mode. Treatment units include bar screen, oxidation ditch, final clarifier, six sludge drying beds, and chlorine contact chamber. For the purposes of irrigation, the application rates shall not exceed 4.14 acre-feet per year per acre irrigated on 68 acres of non-public access land. The facility is in operation.

Sludge generated from the treatment facility is hauled by a registered transporter and disposed of at a TCEQ permitted landfill, City of Haskell Landfill, Permit No. 1604B, in Haskell County. The draft permit authorizes the disposal of sludge at a TCEQ authorized land application site or co-disposal landfill.

The plant site is located approximately one mile south and 0.25 mile east of the intersection of U.S. Highway 277 and U.S. Highway 380, in Haskell County, Texas 79521.

The disposal site will be located approximately 0.64 mile south of the wastewater treatment plant.

The treated effluent is discharged to Rice Springs Branch; thence to Mule Creek; thence to Lake Stamford in Segment No. 1235 of the Brazos River Basin. The unclassified receiving water use is high aquatic life use for Rice Springs

Branch. The designated uses for Segment No. 1235 are high aquatic life use, public water supply and contact recreation. The effluent limitations in the draft permit will maintain and protect the existing instream uses.

In accordance with 30 TAC § 307.5 and the TCEQ implementation procedures (January 2003) for the Texas Surface Water Quality Standards, an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action. Numerical and narrative criteria to protect existing uses will be maintained. A Tier 2 review has preliminarily determined that no significant degradation of water quality is expected in Rice Springs Branch, which has been identified as having a high aquatic life use. Existing uses will be maintained and protected. The preliminary determination can be reexamined and may be modified if new information is received.

Effluent limitations for the conventional effluent parameters (i.e., Biochemical Oxygen Demand or Carbonaceous Biochemical Oxygen Demand, Ammonia Nitrogen, etc.) are based on stream standards and wastewater allocations for water quality limited streams as established in the Texas Surface Water Quality Standards and the State of Texas Water Quality Management plan (WQMP).

The effluent limitations in the draft permit have been reviewed for consistency with the WQMP. The recommended limits are contained in the approved WQMP. A Waste Load Evaluation has not been prepared for Segment No. 1235.

The discharge from this permit action is not expected to have an effect on any federal endangered or threatened aquatic or aquatic dependent species or proposed species or their critical habitat. This determination is based on the United States Fish and Wildlife Service's (USFWS) biological opinion on the State of Texas authorization of the Texas Pollutant Discharge Elimination System (TPDES, September 14, 1998; October 21, 1998 update). To make this determination for TPDES permits, TCEQ and EPA only considered aquatic or aquatic dependent species occurring in watersheds of critical concern or high priority as listed in Appendix A of the USFWS biological opinion. The determination is subject to reevaluation due to subsequent updates or amendments to the biological opinion. The permit does not require EPA review with respect to the presence of endangered or threatened species.

Segment No. 1235 is not currently listed on the State's inventory of impaired and threatened waters (the CWA §303(d) list).

SUMMARY OF EFFLUENT DATA

The following is a summary of the applicant's Monthly Effluent Report data for the period from January, 2006 through June, 2011. The average of Daily Avg value is computed by averaging of all 30-day average values for the reporting period for each parameter.

PROPOSED PERMIT CONDITIONS

The draft permit authorizes a discharge of treated domestic wastewater at a volume not to exceed a daily average flow of 0.7 million gallons per day.

The effluent limitations in the draft permit, based on a 30-day average, are 10 mg/l CBOD₅, 15 mg/l TSS, 3 mg/l NH₃-N, 126 CFU or MPN of *E. coli* per 100 ml and 5.0 mg/l minimum dissolved oxygen (DO). The effluent shall contain a chlorine residual of at least 1.0 mg/l and shall not exceed a chlorine residual of 4.0 mg/l after a detention time of at least 20 minutes based on peak flow.

The permittee shall comply with the requirements of 30

TAC § 309.13 (a) through (d). In addition, by ownership of the required buffer zone area, the permittee shall comply with the requirements of 30 TAC § 309.13(e).

The facility does not appear to receive significant industrial wastewater contributions. Permit requirements for pretreatment are based on TPDES regulations contained in 30 TAC Chapter 315 which references 40 CFR Part 403, "General Pretreatment Regulations for Existing and New Sources of Pollution." [rev. Federal Register/Vol. 70/No. 198/Friday, October 14, 2005/Rules and Regulations, pages 60134-60798] The permit includes specific requirements that establish responsibilities of local government, industry, and the public to implement the standards to control pollutants which pass through or interfere with treatment processes in publicly owned treatment works or which may contaminate the sewage sludge. This permit has appropriate pretreatment language for a facility of this size and complexity.

The draft permit includes Sludge Provisions according to the requirements of 30 TAC Chapter 312, Sludge Use, Disposal and Transportation. The draft permit authorizes the disposal of sludge at a TCEQ authorized land application site or co-disposal landfill.

SUMMARY OF CHANGES FROM APPLICATION

The applicant requested an amendment to add the option to dispose of treated wastewater via irrigation. However, the draft permit includes *E. coli* effluent limitations.

SUMMARY OF CHANGES FROM EXISTING PERMIT

Effluent limitations and monitoring requirements in the draft permit remain the same as the existing permit requirements with the exception of *E. coli* limits in the draft permit.

E. coli bacteria limits have been added to the draft permit in accordance with the recent amendments to 30 TAC Chapters 309 and 319.

The draft permit authorizes the disposal of treated domestic wastewater via irrigation of 68 acres of non-public access land, and to continue the authorizations to discharge treated domestic wastewater at a daily average flow not to exceed 0.7 MGD.

Other Requirements, Item 5 in the existing permit have been deleted since it is no longer applicable.

The Standard Permit Conditions, Sludge Provisions, and Other Requirements sections of the draft permit have been updated.

BASIS FOR PROPOSED DRAFT PERMIT

The following items were considered in developing the proposed permit draft:

1. Application received May 2, 2011 and additional information received June 30, 2011.

2. TPDES Permit No. WQ0010728001 issued April 27, 2009.

3. The effluent limitations and conditions in the draft permit comply with the Texas Surface Water Quality Standards, 30 TAC §§ 307.1-307.10, effective August 17, 2000.

4. The effluent limitations in the draft permit meet the requirements for secondary treatment and the requirements for disinfection according to 30 TAC Chapter 309, Subchapter A: Domestic Wastewater Effluent Limitations.

5. Interoffice memoranda from the Water Quality Assessment Section of the TCEQ Water Quality Division. Interoffice memorandum from the Storm Water & Pretreatment Team of the TCEQ Water Quality Division.

6. Consistency with the Coastal Management Plan: The facility is not located in the Coastal Management Program boundary.

7. "Procedures to Implement the Texas Surface Water Quality Standards," Texas Commission on Environmental Quality, January 2003.

8. Texas 2008 Clean Water Act Section 303(d) List, Texas Commission on Environmental Quality, April 1, 2008; approved by the EPA July 9, 2008.

9. TNRCC Guidance Document for Establishing

Monitoring Frequencies for Domestic and Industrial Wastewater Discharge Permits, Document No. 98-001.00-OWR-WQ, May 1998.

PROCEDURES FOR FINAL DECISION

When an application is declared administratively complete, the Chief Clerk sends a letter to the applicant advising the applicant to publish the Notice of Receipt of Application and Intent to Obtain Permit in the newspaper. In addition, the Chief Clerk instructs the applicant to place a copy of the application in a public place for review and copying in the county where the facility is or will be located. This application will be in a public place throughout the comment period. The Chief Clerk also mails this notice to any interested persons and, if required, to landowners identified in the permit application. This notice informs the public about the application, and provides that an interested person may file comments on the application or request a contested case hearing or a public meeting.

Once a draft permit is completed, it is sent, along with the Executive Director's preliminary decision, as contained in the technical summary or fact sheet, to the Chief Clerk. At that time, Notice of Application and Preliminary Decision will be mailed to the same people and published in the same newspaper as the prior notice. This notice sets a deadline for making public comments. The applicant must place a copy of the Executive Director's preliminary decision and draft permit in the public place with the application. This notice sets a deadline for public comment.

Any interested person may request a public meeting on the application until the deadline for filing public comments. A public meeting is intended for the taking of public comment, and is not a contested case proceeding.

After the public comment deadline, the Executive Director prepares a response to all significant public comments on the application or the draft permit raised during the public comment period. The Chief Clerk then mails the Executive Director's Response to Comments and Final Decision to people who have filed comments, requested a contested case hearing, or requested to be on the mailing list.

This notice provides that if a person is not satisfied with the Executive Director's response and decision, they can request a contested case hearing or file a request to reconsider the Executive Director's decision within 30 days after the notice is mailed.

The Executive Director will issue the permit unless a written hearing request or request for reconsideration is filed within 30 days after the Executive Director's Response to Comments and Final Decision is mailed. If a hearing request or request for reconsideration is filed, the Executive Director will not issue the permit and will forward the application and request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting. If a contested case hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If the Executive Director calls a public meeting or the Commission grants a contested case hearing as described above, the Commission will give notice of the date, time, and place of the meeting or hearing. If a hearing request or request for reconsideration is made, the Commission will consider all public comments in making its decision and shall either adopt the Executive Director's response to public comments or prepare its own response.

DCP & ACRE sign-up underway

Haskell County USDA Farm Service Agency (FSA) Executive Director Glenn R. Brzozowski, announced that sign-up for the 2012 Direct and Counter-cyclical Program (DCP) and the Average Crop Revenue Election (ACRE) Program began Jan. 23 and continues through June 1, 2012.

"I encourage producers to make an appointment with our office to sign-up for program benefits," said Brzozowski. Call 940-864-2617 ext. 2 to schedule your appointment.

Eligible DCP participants receive a direct payment and/or a counter-cyclical payment. Direct payment rates are established by statute regardless of market prices. FSA reminds producers that the 2008 Farm Bill does not authorize advance direct payments. Counter-cyclical payments vary depending on market prices, and are issued only when the effective price for a commodity is below its target price (which takes into account the direct payment

rate, market price and loan rate).

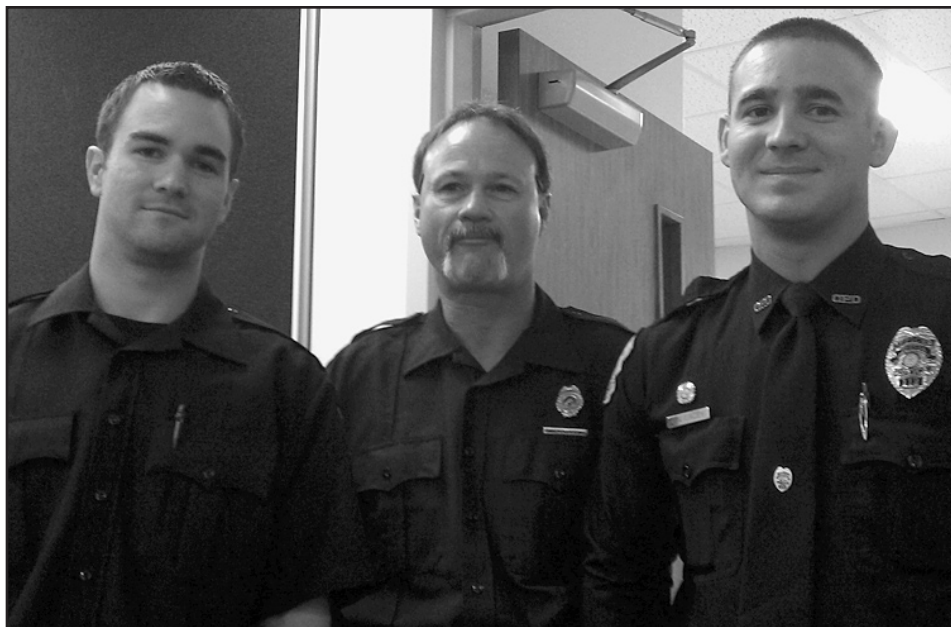
ACRE protects producers from farm market revenue declines when revenue triggers are met for a commodity at both the state and farm level. Farms that are already enrolled in the Direct and Counter-Cyclical

Program (DCP) for a crop year can elect to switch to ACRE before the end of sign-up.

Both DCP and ACRE participants must sign annual contracts to be eligible for program benefits. All signatures of producers who will receive a share of

DCP and ACRE payments must be on file by the June 1, 2012 deadline.

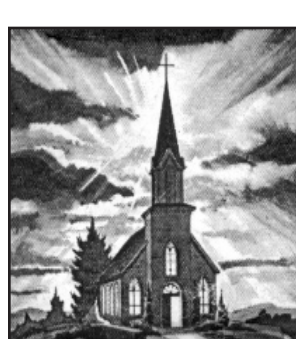
