SPEARMAN - Texas restaurants are required by law to have certified food managers. To train these service professionals, Texas A&M AgriLife Extension Service of Hansford County will offer a manager certification course called "Food Safety: It's Our Business" on June 4-5.

The event will be at the Fellowship Hall of Spearman Church of Christ, 121 S. Haney in Spearman. The deadline for registration is May 29.

"This hands-on learning experience equips participants with the latest food safety principles and practices to prepare for the examination," said Peggy Winegarner, AgriLife Extension family and consumer science agent in Spearman.


The course fee of \$125 includes training, materials and the state food manager certification examination. A test-only option is available but recommended only for those with a strong food safety background. Cost for the test without the training is \$65. New food manager certificates are valid for five years.

Each year, one in six Americans will become sick, 128,000 will be hospitalized, and 3,000 will die due to a foodborne illness, according to statistics.

During the training, Winegarner said foodservice managers will identifying about potentially hazardous foods and common errors in food handling, and preventing contamination and cross-contamination of food. Other topics will include teaching and encouraging personal hygiene for employees, complying with government regulations, maintaining clean utensils, equipment surroundings, and controlling pests.







Helping Children Cope after a Disaster

Adults worry about their children when disasters occur. They may feel that they don't want to discuss the events such as tornadoes or explosions that have occurred. However, parents shouldn't worry that talking about disasters will make children afraid. More often, children are more frightened when information is whispered or not discussed. It is important to allow children to talk about the disaster and especially the questions that puzzle them such as, "What will happen if there is a flood and I am in school," or "What will happen to my dog." Try to answer questions and address the concerns with solid and easy to understand information.

Often children can have a difficult time coping with the trauma of a disaster. They may be sad or afraid and reenact the disaster over and over to make sense of it. Sometimes their behavior may regress; they may have trouble eating, stomach aches and nightmares. To help young children under 5 you can do the following:

- Reassure them and give them physical comfort.
- Return to a normal routine as soon as possible including bed time.
- Encourage them to talk about their losses, such as the death of pets or loss of toys.
- Monitor their exposure to news media reports about the disaster.

To help older children:

. Give them extra attention and consideration. Temporarily relax your expectations of their performance at home and school

- Set gentle but firm rules for acting-out behavior.
- Give them structured, but undemanding home chores and other activities. • Encourage children to express their thoughts and feeling and be willing to listen.

Some children may suffer long term affects such as depression, prolonged grief and stress. This may include persistent sadness, irritability, loss of interest in activities they once enough, sleeping problems. If a child is having a difficult time, for a period of time, it is best to seek help from a qualified health professional.

Parents can help children be prepared for a disaster such as a fire, tornado or flood. Practice with them before a disaster and how to respond. Explain that when a disaster occurs there may be people hurt, no electricity, water, or telephones.

Teach children how and when to call for help. Teach them how to call 9-1-1. Be prepared to answer questions about things that happen and is seen on the television.

Give information that is helpful to them and discuss how they can be prepared.

Tell children that when a disaster occurs, that there are many people who can help them including the American Red Cross, a police officers, a neighbor.

If you are not with your child when a disaster occurs, teach children how to contact you and have someone they can call such as a neighbor, friend or relative, if they cannot call you. Help your children to memorize the important phone numbers and quiz them every couple of months to help them remember.



Berry Summerour has been named a director for the Houston Livestock Show and Rodeo. He is the son of Buzz and Nell Summerour. He has been very involved with this organization for a number of years and loves working with and for the kids. He was awarded a Houston scholarship in 1985 in the amount of \$8,000.00 for his college education at Texas A&M. The amount of the scholarships is now up to \$18,000.00 - all due to the work of the HLSR organization. Since its beginning in 1932, the Houston Livestock Show and Rodeo has committed more than \$330 million to scholarships, research, endowments, calf scramble participants, junior show exhibitors, School Art participants, and other educational youth programs. In 2013, the total educational commitment totaled over \$24 million. Currently, more than 2,000 students are on Show scholarships, attending more than 100 different Texas colleges and universities. The value of these scholarships is approximately \$30 million.

Sherman County Appraisal District Board of Directors met March 15, 2013

The Sherman County Appraisal District Board of Directors met on Friday, March 15, 2013 in the appraisal district board room. Board members present were Roger Wells, Dana Buckles, Brad McBryde, Tom Moore and Valerie McAlister. Tim Hudson, Mel Yates, and Mike Grotegut were not present. Chief Appraiser Teresa Edmond was also

The meeting was called to order by Board Chairman Wells at 7:15 a.m. Moore moved to approve the minutes of the previous meeting. McBryde seconded the motion, and the motion passed.

January and February financial reports and bills were presented along with the bills for the first part of March. After discussion, Buckles moved that the reports be approved and the bills be paid. Moore seconded the motion, and the motion passed.

Chief Appraiser Edmond reported that 8.80% of the appraisal district's 2012 budget is being returned to the

Consideration of Service Contracts included in the 2014 budget was next on the agenda. Contracts remaining the same amount for 2014 are Insect Control, Mapping, and Website. The rent, audit expense, mineral valuation, and computer contracts will increase for 2014. McBryde moved that the increases in service contracts for 2014 be approved, and Buckles seconded the motion. The motion passed.

Edmond presented the proposed 2014 budget along with information about staff qualifications and several salary surveys. After discussion, Buckles moved that the board go in to executive session. Moore seconded the motion. The motion passed and the board went into executive session at 8:13 a.m. Tim Hudson joined the meeting during executive

At 8:35 a.m., executive session was closed and normal session resumed. Moore moved that the proposed 2014 budget be approved with a 2% salary increase. McBryde seconded the motion, and the motion passed.

Edmond reported that tax collections are continuing as well as appraisals for the 2013 tax rolls.

Buckles moved the meeting be adjourned. Hudson seconded the motion, and the meeting adjourned at 8:45

Safe Food Preparation

Every year, about one In six Americans get sick, 128,000 are hospitalized and 3,000 die from foodborne diseases, according to the Centers for Disease Control and Prevention.

- "One would think foodborne diseases should be declining," says John Bowman, MS., RPI1, associate professor of pharmacy practice at the Texas A&M Health Science Center Irma Lerma Rangel College of Pharmacy. "While illness from many microbes has declined due to improved monitoring, increases are still observed, especially in chickens and oysters.' To help curtail these diseases, food safety tips are online (www.foodsafety.goy). Included are safe internal cooking

temperatures for various types of meat, along with details on proper food storage and handling. Along with the food safety website, Bowman says to follow these recommended steps for food preparation: Clean. Wash your hands with soap and running water for a full 20 seconds. Wash surfaces and utensils after each use, as bacteria can spread from one food to another. Wash fruits and veggies but not meat, poultry or eggs. Why? Washing them can actually spread bacteria because their juices can splash onto your sink and countertops. Commercial eggs are washed before sale and safe.

Separate. Use separate cutting boards and plates for produce and for meat, poultry and seafood. Keep meat, poultry, seafood and eggs separate from all other foods at the grocery when bagging, and keep them separate in the fridge. Cook Use a food thermometer to be sure your food is cooked enough. Color and texture alone will not tell you whether the food is done. Keep food hot after cooking (at 140 F or higher) because bacteria multiply when the temperature drops lower than this level. Microwave food thoroughly (to 165 F).

Chill. Refrigerate perishable foods within two hours. Never thaw or marinate foods on the counter. Know when to throw food out.



USDA Seeks Applications to **Upgrade Rural Rental Housing**

TEMPLE, TEXAS, May 23, 2013 - Agriculture Secretary Tom Vilsack announced today that USDA is seeking applications from qualified organizations (intermediaries) to preserve or renovate rural rental housing. The United States Department of Agriculture (USDA) remains focused on carrying out its mission, despite a time of significant budget uncertainty. Today's announcement is one part of the Department's efforts to strengthen the rural economy.

"USDA's housing programs are an important part of the Obama Administration's policies for strengthening the rural economy. They make a real difference in the lives of thousands of rural Americans nationwide," Vilsack said. "As the President said in his radio address last week: 'Our economy and our housing market are poised for progress but we could do so much more if we work together.' Revitalizing rural rental housing helps create construction jobs, while maintaining safe and stable rural communities.

"USDA Rural Development is committed to preserving and revitalizing rural, lowincome, multi-family housing and migrant and farm labor housing throughout Texas," said Paco Valentin, USDA Rural Development State Director. "We are pleased to assist rural Texans in meeting their housing needs, a critical goal to the long term sustainability of our communities."

Selected intermediaries will establish revolving loan programs to construct or make repairs that meet USDA Rural Development design and construction standards. Tenants must have very low or low incomes. Generally, households that qualify for U.S. Department of Housing and Urban Development Section 8 assistance or Low-Income Housing Tax Credit assistance meet this income standard.

USDA Rural Development plans to make up to \$5.3 million available for this program. Demonstration program loans will have an interest rate of one percent or lower. The interest and principal payments may be deferred for up to three years. Loans may not exceed \$2,125,000. Since the Preservation Revolving Loan Fund began as a demonstration program, USDA has made 22 selections for funding. This program provided funding to housing finance agencies and national or regional non-profit affordable housing groups.

Eligible intermediaries include: Non-profit organizations;

State and local housing authorities;

Organizations with experience revitalizing low-income, multi-family housing properties, and Organizations that have loan-making and loan-servicing experience.




Full Weekend Planned for WTAMU Alumni Summer Reunion June 7-9
