Stratford ISD Old Bus **Barns for Sale**



Sales Tax Funds available to assist **businesses**

If you lived here in 1996 you may remember City of Stratford voters approved the $^{1/2}$ cent sales tax called the 4B Tax; recently the name 4B tax was changed to Type B tax by the State Legislature. The 1/2 cent sales tax is added to any taxable purchase in the city limits and is used to help with economic development. The Stratford Sales Tax Board (SSTB) was appointed by City Council in 1996 and when there are vacancies, Council appoints replacements.

Since the SSTB does not have an active office, they maintain a contract with the Sherman County Development Committee (SCDC). The SCDC Office is paid a fee by the SSTB to handle inquiries, applications, etc. for Type B funds. These funds are available as loans to new businesses as well as current operating businesses. There are guidelines that applicants must follow and they are required to have an investment in their project also. After all "legwork" is completed by the SCDC Office the application is presented to the SCDC Board for their approval or disapproval, then the application and the recommendation from the SCDC Board is taken to the Sales Tax Board. This process is similar to a bank's loan application and is handled as privately as possible. Both boards are required to sign Confidentiality Agreements before the information is presented to them.

If you have an idea for a new business or would like to expand your current operation check into the funds that are available through the Type B Economic Development Funds. Applications are available at the SCDC Office at 301 N. Main St. You can call the office and ask for the information and/or application to be mailed to you; office phone number is 806.366.2897 or 806.753.6897 and you can email your request to scdc@xit.net.

Exemption Information Available From Appraisal Office

Sherman County Appraisal District offers property owners a pamphlet called "Property Taxpayer Remedies". Published by the State Comptroller's Office in Austin, the "Remedies" pamphlet explains the appraisal protest process.

Homeowners may file for various property tax exemptions offered by taxing units on residence homesteads. In Texas, a homestead is generally the house and yard used as the owner's principal residence. The Appraisal District can explain each exemption and how to apply for it. Homeowners do not need to reapply for the exemption this year if they received the exemption last year.

For example, all homeowners may file for a \$15,000 general exemption from their principal home's value for school taxes. In addition, certain disabled homeowners and those aged 65 or older may qualify for an additional \$10,000 exemption from the value of their home.

Disabled Veterans with a service-connected disability may present the Appraisal District with proof from the Veterans Administration to qualify for exemptions based on their percent of disability. Veterans designated 100% disabled or unemployable may qualify for a 100% homestead exemption. Productivity appraisal is another type of tax relief available to agricultural landowners.

Appraisal District staff can offer more information about special land appraisal, tax rendition and exemptions. We urge all property owners to read the pamphlet and learn about possible property tax relief.

Remember, taxpayers must file an exemption application with the Appraisal District office no later than April 30. The "Remedies" pamphlet and all exemption forms are available at the Appraisal District office, 402 N. 3rd in Stratford or by calling (806) 366-5566.

Multi-use exemption applies to some taxpayers.

Remember to "Render!" Taxable property renditions are due April 16.

Does this apply to you?

If you own tangible personal property that is used to produce income, such as the equipment or inventory owned by a business, it does.

What is a rendition?

A rendition is a report to your county appraisal district that lists all of the taxable property that you owned or controlled on Jan. 1 of this year. This often applies to furniture, fixtures, equipment or inventory owned by a business.

What are the advantages of filing?

- You give your opinion of your property's value.
- You record your correct mailing address so your tax bills will go to the right address.
- If your property's value depreciated, you can file a report of decreased value.

What is the deadline?

- The last day for filing 2012 renditions is April 16.
- An automatic extension is available if requested in writing by the April 16 deadline
- The chief appraiser may grant an additional 15 days after the deadline for an owner who shows good cause in writing.

REMEMBER!!

Filing is your responsibility. If you render late, don't render or file an incomplete or false rendition, you may face a 10 to 50 percent penalty.

Texas Property Tax Code Sec. 11.254, provides for an individual to exempt one passenger car or light truck from personal property taxes if the vehicle is used for both business and personal purposes.

11.254. Motor Vehicle Used for Production of Income and for Personal Activities

- (a) Except as provided by Subsection (c), an individual is entitled to an exemption from taxation of one motor vehicle owned by the individual that is used in the course of the individual's occupation or profession and is also used for personal activities of the owner that do not involve the production of income.
- (b) In this section, "motor vehicle" means a passenger car or light truck as those terms are defined by Section 502.001, Transportation Code.
- (c) A person who has been granted or applied for an exemption under this section may not apply for another exemption under this section until after the application or exemption has been denied.
- (d) This section does not apply to a motor vehicle used to transport passengers for hire.

To qualify for the exemption individuals need to fill out an application form available from the appraisal office at 402 N. Third Street in Stratford. The exemption form must be filed prior to April 30. Annual Renewal of this exemption is no longer required (Sec.11.43c). However the exemption is for a specific vehicle, so if you change vehicles or replace the tag you must file a new exemption form. Income producing vehicles are and continue to be taxable. The law allows the local taxing jurisdictions to choose to tax personal vehicles. The legislature did not exclude the multi-use exemption in jurisdictions that tax vehicles for personal use.





XIT Rural Telephone Cooperative Celebrates 61 Years...

A warm and sunny day greeted approximately four hundred XIT Rural Telephone members, invited guests, and employees as they gathered at the Rita Blanca Lake Coliseum in Dalhart, Texas, on Wednesday, March 14th to celebrate XIT Rural Telephone's 61st Annual Meeting of the Membership. One hundred and twelve were voting members. Members and invited guests were served a delicious roast beef dinner by XIT's management and employees. The meal was catered by Bar H Steak House of Dalhart.

Round tables were draped with royal blue and lime green tablecloths, the Cooperative's company colors. The stage was set with blue draping and a white banner depicting XIT's organization in 1951. Ficus trees and colorful tulips in white pots helped to create an inviting setting for the meeting.

The invocation was delivered by XIT Director, E.H. Little.

XIT Board President, J.W. McClellan, welcomed the members and recognized the guests. Among the guests were former XIT General Manager, Jimmy R. White, who served the Cooperative for nearly 30 years before his retirement, and Ruby V. Smith, who served as office manager/bookkeeper for 33 years.

Board Vice President and Marketing Committee Chairman, Walter E. Lasley, Assistant Manager, Kathy Duggan, and Sales and Customer Relations Representative, Trena Howell, presented the 2012 XIT Rural Telephone Educational Program recipients and their families to the membership. The 2012 scholarship winners are: Sarah Diller, Dalhart High School senior; Rhyan Burton, Stratford High School senior, and Katlyn Boyer, Felt High School senior. Each student received a \$2000 scholarship to the college of his or her choice. The funds will be divided over the number of semesters to be attended by the students. 2012 marks the 13th year for this program, and since its inception, XIT has awarded a total of \$83,750.00 in scholarships.

President McClellan then called on XIT's General Manager, Darrell Dennis, to present his annual report to the membership. Dennis began by expressing his appreciation to the City of Dalhart's employees for their assistance in setting up the tables and chairs for the meeting and to Bar H employees for a job well done in catering the meal.

Dennis continued by saying that it had been a busy year for the Cooperative as it has placed over 206 miles of cable in its rural serving area during the year. He explained that currently over 50% of XIT's rural members are served by fiber optic plant. Dennis relayed to the membership that where the Cooperative has placed fiber, the trouble calls have dropped to almost nothing. He went on to say that fiber provides the best medium for broadband services, and that in the long run, fiber should provide the lowest cost to operate. This, in turn, is in agreement with the Cooperative's mission statement ... "To provide high quality telecommunication services at the lowest possible cost to its members".

Manager Dennis explained that the Cooperative serves high speed Internet services on both fiber and copper plant and that the Cooperative operates about 1900 miles of buried cable, with a density per mile of .6 customers. Dennis further explained that fiber offers the most future proof, reliable means to provide broadband in rural America.

Dennis relayed the importance of Universal Service Funding to the Cooperative. He said that USF has traditionally been a cost recovery mechanism. Rural areas were recognized as expensive to serve, and to encourage investment in rural networks, there had to be a means of cost recovery. Dennis stated that whether you are a Cooperative or an independent family-owned telephone company, no one can afford to invest if it does not make a profit. In short, you have to invest money to make money. In the past few years; this cost recovery has been re-branded as a subsidy.

Dennis went on to say that the issue of USF funding has been in play for years; however, industry dynamics are forcing the issues ... loss of access lines due to the use of cellular phones is one issue; loss of long distance and access revenues based on the fact that many wireless plans include long distance is another, and the overall change occurring in the market place is another. He explained that many of our policy makers have questioned whether or not a terrestrial network is even necessary with the acceptance of wireless. While it is true that wireless has replaced the home phone for many customers, and it is true that wireless can provide data connectivity, it is also true that if it were not for the landline networks of XIT Rural Telephone and its subsidiary, XT&T, and Windstream, not one cell phone would work north of Amarillo. The landline network still provides the largest, most reliable pipe to the Internet and private line circuits for business and utility companies.

Manager Dennis informed that Congress and the FCC must grapple now with how to reform USF. He encouraged the membership to talk with our state and federal

Tax Deferral available for elderly homeowners

Texans aged 65 or older can postpone paying delinquent and current taxes on their homes. They can take advantage of a tax option called "over-65 deferral" by signing an affidavit at the Sherman County Appraisal District office.

If the affidavit is on file, an older homeowner cannot lose a homestead because of delinquent taxes. Once a homeowner files an over-65 tax deferral affidavit with the appraisal district, no taxing unit can start or continue a lawsuit for delinquent taxes as long as that person owns and lives in that home. The tax deferral only postpones paying delinquent taxes on the home; it does not cancel them.

Dennis concluded by telling the membership, "Currently, the Cooperative is in good shape, both financially, as well as technically, since most of our system has been modernized, but changes in the Universal Service Fund may dictate that we make changes in our organization in the future."

Manager Dennis then introduced Doug Schoppe, Comptroller, and asked him to give the financial reports of the Cooperative and its wholly-owned subsidiary, XIT Telecommunications & Technology, Ltd.

President McClellan, called on Jim Gustin, Chairman of the Nominating Committee, to present the report on the nominations for directors for the ensuing three-year term. Those nominated were District I, Dallam County — E.H. Little; District II, Hartley County — Gary Finch, and District III, Sherman County— Steven Baskin.

The election process was then turned over to president, J.W. McClellan. McClellan called for nominations from the floor. (NU) - Here's a scary number to keep in mind if you're just getting your tax receipts together: \$1 billion.

No, it's not the amount that Warren Buffet's secretary – let alone Buffet personally - paid the IRS in her lifetime. It's how much taxpayers approximately wind up forfeiting each year to the government because of self-inflicted tax errors like: failing to claim tax credits and deductions legally due them; choosing the wrong filing status; and not bothering to send in a return at all.

Well, guess what? A slew of recent changes in the tax law won't make things any easier this year.

'At a time when taxpayers are hurting, it really doesn't make sense to leave money on the table," says Elaine Smith, master tax advisor at H&R Block, the giant tax preparation firm (www.hrblock.com).

Here are some things - good and bad - to watch out for:

Casualty losses. Hurricane Irene. Midwest tornadoes. Texas wildfires. Mother Nature went a little nutty last year, and -if the president declared your area a disaster – you could be able to claim your loss as an itemized deduction on your 2011 return or on an amended 2010 one

Reduction in the Energy Savings Home Improvement Credit. At its height, this was a 30-percent credit on the cost of high-efficiency windows, furnaces, central AC and the like. It's now 10 percent. Plus, the maximum lifetime credit went from \$1,500 to \$500. "That means if you spent a total of \$5,000 on IRS-approved upgrades in 2011," says Smith,

'you can claim a \$500 credit. Unless, that is, you'd already maxed out in prior years.

Expiration of the tax credit for hybrid cars. If you bought a Prius last year, you did so without the feds' help. However, the green cars du jour-i.e., the electric-drive Chevy Volt and Nissan Leaf - will score you a \$7,500 credit. And there are goodies for things like conversion kits, too.

New cost-basis reporting requirements. Apparently, some of you were inflating the price you paid for stocks to reduce the taxes owed on capital gains. Or at least the government fears that was happening. So look out for a mandatory statement from your broker reporting your "cost basis" for stocks and securities held in taxable accounts - as opposed to 401(k)s and IRAs-that you sold in 2011

Of course, with the April 17 filing deadline approaching, those worried about becoming a member of the \$1 Billion Club might want to consult a professional like those at H&R Block, which offers in-person services at its retail offices nationwide as well as the only faceto-face online preparation through Block LiveSM.


