

While we try to list as many species that are available for this area, we cannot list them all. If you have any special wants or wishes as far as trees go this year, please call the office at 396-5517 ext. 3 and we will be happy to try and find what you need.

The District can also fill requests for drip irrigation supplies. We keep some drip supplies in stock, and will help in the design of your system and order exactly what is needed for you if we do not have it. Delivery is usually within three working days. You can also help your investment with the installation of weed barrier. We have this available also. This is especially important in windbreaks because we do not want the newly planted seedlings to have to fight with weeds and grass for water. The barrier will help prevent the growth of weeds and grass and keep the moisture in the ground. If you need a Tree Order Form, want to place an order for trees, irrigation supplies, weed barrier or just have any questions regarding the trees or need help planning for your particular needs, please do not hesitate to contact the District or the NRCS at 396-5517 ext. 3. The Sherman County Historical Commission met Tuesday January 24 at 2:00 p.m. in the Commissioners Courtroom. The commission is looking for pictures of early to present activities in Sherman County: celebrations, school activities, business, agriculture, weather. We found a great picture on the front cover of The Oklahoma Panhandle" book of the Stratford Flour Mill being moved in the early 1900's from Stratford to Boise City. How did they do that, watch for the picture in the Stratford Star. Commission members present were: Alfred Pronger, Jill Pronger, Mattie Baskin, Katy Allen, Ann Wells, David Brown, Kent Cartrite, Ginger Roach, Judge Terri Carter and Gaynelle Riffe.

Rocky Sprott was the guest presenter on the Confederate Veterans buried in the Stratford Cemetery. He identified nine Confederates, two Union and a number of able bodied men that might have been in the War Between the States. The nine confirmed Confederate Veterans are: Jefferson Levi Davis, Gilmer D Engle, Alfred Marion Gladish Lemuel I Hensley Alexander Campbell Jackson William Thomas McKenn Walter G. O'Brien, ARC Salon, Alexander Foxworth. Some of these were members of the UCV Bedford Forest Camp 1678 in Stratford. The two Union Veterans are Carl Shy and Levie S. Shuum. Mr. Sprott brought attention to the fact that Sherman County History is at the Cemetery. A project of the commission is to update John Wood's "Stratford Cemetery Book" and to place permanent stone markers for unmarked graves. The next Sherman County Historical Commission meeting will be February 14 at 2:00 p.m. in the Commissioners Court Room. The public is invited to all Commission meetings and anyone interested in helping with pictures, updating the Cemetery Book or presentations of family histories at the cemetery is welcome.





American Academy Of Ophthalmology Warns Parents And Teens About Buying Decorative Contact Lenses Without A Prescription

(NAPS)—Obtaining decorative lenses including colored contacts and novelty or costume lenses without a prescription is dangerous. And circle lenses, which are one of the latest fads with teenage girls, are not FDA approved and may cause serious eye-health risks.

Websites often advertise decorative contacts as if they were cosmetics, fashion accessories or toys. With whimsical, playful packaging and names like Dolly Eyes, their targets are often teens and young adults.

For this reason, the American Academy of Ophthalmology is warning parents and teens that purchasing any contact lenses without an eye examination and a prescription from an eye care professional such as an ophthalmologist—a medical eye doctor—can cause serious eye disorders and infections, which may lead to blindness. Even if someone has perfect vision, he or she needs to get an eye exam and a prescription from an eye care professional in order to wear any kind of contact lens.

"Most people believe that decorative lenses do not require the same level of care or consideration as a standard contact lens because they can be purchased over the counter or on the Internet. This is far from the truth," says Thomas Steinemann, M.D., professor of ophthalmology at Case Western Reserve University in Cleveland and a clinical correspondent for the American Academy of Ophthalmology. "In fact, permanent eye damage can result from buying contacts without a prescription. Many of the lenses found online or in beauty salons, novelty shops or in pop-up Halloween stores are not FDA approved and are being sold

illegally. All contact lenses are medical devices that require a prescription and proper fitting by an eye care professional."

In 2005, a federal law was passed that classified all contact lenses as medical devices and restricted their distribution to licensed eye care professionals. Illegal sale of contacts can result in civil penalties of up to \$11,000 per violation. Consumers should only buy decorative contact lenses from an eye care professional or a seller who asks for a prescription.

Laura Butler of Parkersburg, W.V., purchased decorative lenses from a souvenir shop while on vacation. "I was unaware of the dangers involved in buying these lenses over the counter or of the harm that could result," Butler said. "After wearing the contacts for a total of 10 hours, I experienced extreme pain in both eyes. Because I had not been properly fitted by an eye care professional, the lenses stuck to my eyes like a suction cup. Removing them resulted in a corneal abrasion and a painful infection. I was in severe

pain and on medication for four weeks and couldn't see well enough to drive for eight weeks. I now live with a corneal scar, vision damage and a drooping eyelid. I want to share my story in the hopes that others will not have to live through this nightmare."

To protect the eyes, an eye care professional measures each eye in order to properly fit contacts for the patient. There is no such thing as a "one size fits all" contact lens. Lenses that are not properly fitted may scratch the eye or cause blood vessels to grow into the cornea. Additionally, the eye care professional instructs the patient on appropriate contact lens care. Lenses that are not cleaned and disinfected increase the risk of eve infection. Not all patients are good candidates for contacts (prescription or decorative lenses). Patients who have frequent eye infections, severe allergies, dry eye that is resistant to treatment, a very dusty work environment, or an inability to handle and care for the lenses may not be suitable candidates for contacts. An eye care professional can assist in helping patients make a decision that is right for them.

FSA Accepting Emergency Loan Applications

Sherman County was declared eligible for Farm Service Agency (FSA) disaster emergency Loans on August 15, 2011 and again on August 18, 2011. Generally, that means that farmers who have lost at least 30 percent of their production or suffered any physical losses caused by wildfires beginning April 6, 2011 and ending May 3, 2011, are eligible for FSA loans. Proceeds from crop insurance and/or hazard insurance are taken into consideration when determining a producer's eligibility and total loss.

FSA Farm Loan Manager, James M. Heck, is urging farmers who are interested in receiving an emergency loan to submit their applications into FSA as soon as possible. The deadline for filing under these designations is April 18, 2012.

Flush and refill the cooling system according to the service manual's recommendations. The level, condition and concentration of the coolant should be checked periodically. (Make sure the engine has cooled down before removing the radiator cap.)

A qualified auto technician should check the tightness and condition of belts, clamps and hoses, but you can look for signs of wear, cracking or fraying.

Replace other filters (air, fuel, PCV etc.) as recommended in the service manual.




