


### Powell speaks to citizens


# The Seven Project







#### **2011 Constitutional Amendments**

Nov. 8th, 2011, Texans will have the chance to vote on 10 proposed amendments to the state's constitution.

PROPOSITION 1: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a 100 percent or totally disabled veteran."

PROPOSITION 2: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$6 billion at any time outstanding."

PROPOSITION 3: "The constitutional amendment providing for the issuance of general obligation bonds of the State of Texas to finance educational loans to students.'

PROPOSITION 4: "The constitutional amendment authorizing the legislature to permit a county to issue bonds or notes to finance the development or redevelopment of an unproductive, underdeveloped, or blighted area and to pledge for repayment of the bonds or notes increases in ad valorem taxes imposed by the county on property in the area. The amendment does not provide authority for increasing ad valorem tax rates."

PROPOSITION 5: "The constitutional amendment authorizing the legislature to allow cities or counties to enter into inter-local contracts with other cities or counties without the imposition of a tax or the provision of a sinking fund."


PROPOSITION 6: "The constitutional amendment clarifying references to the permanent school fund, allowing the General Land Office to distribute revenue from permanent school fund land or other properties to the available school fund to provide additional funding for public education, and providing for an increase in the market value of the permanent school fund for the purpose of allowing increased distributions from the available school fund."

**PROPOSITION 7:** "The constitutional amendment authorizing the legislature to permit Conservation and Reclamation Districts in El Paso County to issue bonds supported by ad valorem taxes to fund the development and maintenance of parks and recreational facilities."

PROPOSITION 8: "The constitutional amendment providing for the appraisal for ad valorem tax purposes of open-space land devoted to water-stewardship purposes on the basis of its productive capacity."

PROPOSITION 9: "The constitutional amendment authorizing the governor to grant a pardon to a person who successfully completes a term of deferred adjudication community supervision."

PROPOSITION 10: "The constitutional amendment to change the length of the unexpired term that causes the automatic resignation of certain elected county or district officeholders if they become candidates for another office."



#### **USDA Announces Disaster** Assistance Sign up for 2010 Crop Losses

(Stratford, TX) - October 24, 2011 - Sherman County USDA Farm Service Agency (FSA) Executive Director Rebecca Hemphill today announced that the Supplemental Revenue Assistance Payments (SURE) program enrollment for 2010 crop year losses begins November

14, 2011. "Producers across the state experienced several natural disasters during the 2010 crop year that caused hardship

and financial losses to many agricultural Operations," said Hemphill. "The SURE program provides assistance to producers when disaster strikes, so I strongly encourage producers with 2010 crop losses to contact the Sherman County FSA office to learn more about the program," she

To qualify for a SURE payment, the producer's operation must be located in a county that was declared a disaster

#### **USDA Authorizes Emergency** Grazing of CRP Acres -92 Texas Counties are Eligible for the **Fiscal Year 2012 Authorization**

(Stratford, TX) — October 24, 2011 - Sherman County USDA Farm Service Agency (FSA) Executive Director Rebecca Hemphill today announced that in response to drought conditions, the Texas FSA State Committee authorized emergency grazing use of Conservation Reserve Program (CRP) acres for 92 Texas counties effective November 1, 2011, for the fiscal year (FY) 2012 winter/spring period. Emergency grazing for FY 2011 ends on October 31, 2011.

"The 2012 CRP emergency grazing period begins on November 1, 2011, and ends on January 29, 2012," said Hemphill. "CRP land previously hayed or grazed, either managed or emergency use, during the previous 12 months is excluded from the FY 2012 grazing authorization," she said.

The FY 2012 CRP emergency authorization permits grazing only. No haying of CRP acres is allowed at this time. Additionally, there will be a 25 percent CRP payment reduction on the 2012 annual payment for CRP acres used for grazing under these emergency provisions. To take advantage of the emergency grazing provisions,

authorized producers can use the CRP acreage for their own livestock or may grant another

livestock producer use of the CRP acreage.

The eligible CRP acreage is limited to the acreage located within the approved counties. Eligible producers who are interested in grazing CRP under the emergency authorization and current CRP participants who choose to provide land for grazing to an eligible livestock

producer, must first request approval to graze eligible acreage; obtain a modified conservation plan from the Natural Resources Conservation Service (NRCS) to include grazing requirements, leave at least 25 percent of each field or contiguous CRP field ungrazed for wildlife, or graze not more than 75 percent of the stocking rate as determined by NRCS.

## A Medical Warning for **Video Gamers**

(NU) - Video gamers who parbe putting their health at risk.

In May 2011, a 20-year-old video gamer from England died when a blood clot formed in his leg and moved to his lungs. The man often remained in the same position playing video games for 12 hours straight.

'Movement is essential for proper blood flow," said Anil Hingorani, MD, a member of the Society for Vascular Surgery. "Sitting in the same position for long periods of time - whether playing video games or cramped in a car or on an airplane - can result in pooling of the blood in the veins. Blood clots known as deep vein thromboses (DVT) can form."

The 2011 Centers for Disease Control and Prevention statistics reveal that 300,000 to 600,000 Americans die each year from blood clots in the lungs. In 2003, 39-year-old NBC News reporter David Bloom died when a blood clot in his leg traveled to his lungs. The clot formed after weeks of driving around Baghdad in a cramped military tank

'Stand up and stretch," advises Dr. Hingorani. "Walk around. Raise and lower your heels and toes. Tighten and release your leg muscles. This will help promote blood flow.'

DVTs usually occur in persons who are sick and have had long hospital stays. The risk factors for DVTs include the following:



Sitting in one position for long stretches of time playing video games can increase the risk for blood clots.

- a history of heart attacks
- congestive heart failure

inflammatory bowel disease Women who are pregnant, nursing or taking birth control pills are also at increased risk for

Half of DVT patients do not experience the warning signs, which include:

- swelling
- tenderness
- a sensation of warmth skin that turns blue or red

Ultrasound tests can detect blood clots. Treatment options typically use anticoagulant med-






