


#### Don't Crowd the Plow campaign kicks-off in Stratford

#### STRATFORD HOSPITAL DISTRICT NEWS

I would like to begin by introducing myself, my name is Katie Page, and I am the CEO/District Administrator for the Stratford Hospital District. I have been working with the district since July and am very happy to have the privilege of working in and with the Stratford community. I would like to share a little about myself, but look forward to meeting everyone in person. My family is my pride and joy. My husband is a sales and customer service representative for Cargill, and we have a beautiful two year old daughter. We have officially hit the terrible twos so our house can be a very... interesting...place to be at

As for my background, I grew up in a very small town called Knott, Texas, which is about 20 miles north of Big Spring. I received my Agribusiness degree from Texas A&M and then went on to the University of Nebraska, where I received my MBA. Upon the completion of my master's degree, I moved back to Texas and went to work for Cargill. I worked for Cargill for the last seven years in various production and administrative roles both in Plainview and in Dalhart.

Needless to say, I have experienced a very steep learning curve having moved from an Agribusiness production environment to the health industry. As the District Administrator of the Stratford Hospital District, I must balance both monetary and community implications of any decision. It is my responsibility and goal to ensure that every dollar we spend is in the best interest of the tax payers within the district. Upon analyzing office visits and their respective income from January 1, 2011 through October 31, 2011, we have discovered that we average only two office visits at the clinic after 3pm on Friday afternoons. When the income generated is compared with the labor expense of being open from 3pm to 5pm on Friday afternoons, it costs the clinic in excess of \$3000 over a year's time.

Now that we understand the monetary implications of closing the clinic two hours early on Friday, we must discuss the community implications. Obviously, the two people with office visits after 3p.m. on Friday afternoon are the most affected by this decision. The clinic staff will be doing everything possible to make sure that patients are scheduled before 3 p.m. on Fridays.

Currently the Elk Pharmacy is not utilizing a phone system that has the ability to take messages during or after hours. I understand there were many complaints regarding the answering system being used during office hours. I want to make it very clear that the answering machine will only be utilized after hours.

The income at the pharmacy is dependent on the number of prescriptions filled. The pharmacy is open from 9:00 a.m. - 5:30 p.m. each weekday. Any calls received outside of these hours are currently unanswered. If someone calls after hours and are not able to leave a message with their needs, it is possible that they may decide to use a different pharmacy. If someone forgets to call in a refill during office hours, it will now be possible to leave a message and be condiment that the prescription will be filled the following business day. I truly believe that having an answering machine after hours will be a convenience for both the people of the community as well as doctors' offices that are calling in prescriptions.

I want to assure you that the Stratford Hospital District continues to provide the best medical care possible through each of our entities. If anyone has any questions or concerns regarding the two policy modifications or any other issue relating to the hospital district or its entities, feel free to contact me at 806-396-5568. #### **Insects Seek Winter Homes**

By Brad Easterling

Insects are beginning to look for a place to spend the winter. Most of the insects are just looking for a place to overwinter and are not establishing permanent residences.

These insects will be a nuisance and most of the time do not present a great danger to the homeowner. It is not uncommon for insects to enter attics or garages through cracks in the foundation, open windows or spaces around doors.

Mechanical control is possible by caulking all cracks to prevent insect entry. Caulking also makes the structure more air-tight and should help lower heating costs. Steel wool, hardware cloth, and wire screen can be used to plug any larger holes or cracks in siding, soffits, and other exterior parts of the house. Expandable foam also works well and helps to insulate.

Store firewood away from the house to help eliminate hiding places for the pests. Homeowners should store firewood as far from the house as possible and take only the amount needed for immediate use into the house. Firewood stacked beside the house may be handy but as the wood warms, spiders, scorpions and other pests such as termites may leave the wood and escape to other areas of the house.

especially our church family of First Christian Church. We know that we can depend on our extended family if we were ever in need, and as your Sheriff, I hope that you would know that you could depend on me in the same way.

I would like to take this opportunity to answer for you some of the questions Mr. Powell posed in his newspaper

My total years of experience in law enforcement is a little over 5 years. In those five years I've been employed by only two agencies and both of which are Sheriff's Office's and in the great state of Texas. When I attended the police academy my only goal was to be a TEXAS Peace Officer and upon graduating I committed myself to being just that. My experience, having worked for a Sheriff's Office near the border of Mexico, includes search and seizure of multiple narcotic traffickers and loads of illegal narcotics, as well as 1 terrorist with 3 stolen vehicles on Interstate 10 by myself as there were many miles between me and back up. #### Don't Pay For A Purebred—Adopt One

(NAPS)-Are you looking for a certain kind of furry family member? Consider adoption as an option. Despite popular belief, not all pets needing homes are mixed breeds. In fact, as many as 25 percent of the 8 million dogs and cats in the care of animal welfare agencies are recognizable breeds. All kinds of pets end up homeless for a variety of reasons—frequently due to "people issues" rather than problems with the pets themselves. As a result, local animal shelters and breed-specific rescue groups are great options for people interested in adding a specific breed of pet to their family.

For example, when Destini Hollis decided to get a dog, she had her heart set on a Bouvier des Flandres, a large dog originally bred in Belgium. Rather than turning to a breeder, Destini sought out rescue groups that specialized in caring for homeless dogs of her preferred breed. She soon found her match: Baku, a 113-pound gentle giant whose family could not

keep him in their small apartment. "We did our research," Destini said, "and we found exactly what we wanted. I highly recommend searching out a purebred rescue group if you want a specific type

Narrowing down your options can be tough, but some online tools can help prospective pet parents with their search for the right pet and the right adoption agency. The PetSmart Charities Adoptable Pet Locator, found on its People Saving Pets website (www.peoplesavingpets.org), allows you to search for local adoptable pets based on criteria such as size, gender and breed.

Many homeless pets end up that way because their original

owners couldn't provide what they needed. Every breed has websites that can help you find the right match for you. Here are some basic criteria to consider:

1. Space: Some pets do just fine in an apartment; others need more room. Energy is the key, rather than size. Many large-dog breeds spend lots of time sleeping and are content with daily outings and play, while some small and medium breeds need more opportunities to run and explore.

2. Time and energy: Herding, hunting and other types of dogsand several cat breeds—need to keep their brains and bodies busy. Some others are napping professionals. The time needed for training, attention, play and outings can vary depending on breed type.

3. Coat: Some dog and cat breeds must be professionally groomed to stay healthy and to keep you happy. Almost all dogs and cats shed, so ask yourself how

much hair you are ready to handle.

Most pets available through adoption come spayed or neutered, vaccinated, licensed and often microchipped for a very affordable adoption fee. You can find a listing of local adoption agencies by using your zip code to search on www.peoplesavingpets.org.
