Sherman County Farmer Wins \$2,500 for **Lollipop Junction through America's** Farmers Grow CommunitiesSM Program

STRATFORD, Texas (April 4, 2011) - Mike Yanke of Gruver, Texas has been selected as a winner in the America's Farmers Grow CommunitiesSM program, which gives farmers the opportunity to win \$2,500 for their favorite local nonprofit organizations. 

Storm Spotter Class



New regulations must consider impact on people, not just water

LUBBOCK, Texas (March 25, 2011) - The process of drafting new water use restrictions must consider the lives of people as well as the water in the aquifer, David Gibson, executive vice president of the Corn Producers Association of Texas, said Thursday at a public meeting on proposed water regulations.

"If this process is only about water, with no consideration for people, then something has gone tragically wrong with our system of government," Gibson said.

The meeting in Lubbock was one of five public meetings held by the High Plains Underground Water Conservation District #1 to hear comments on draft regulations approved by the district board on Feb. 22.

"These draft rules have the potential to diminish economic activity, eliminate jobs, reduce land values, affect loan repayments, reduce revenue to school districts, cities and counties and crush prospering farms that hardworking families have worked for generations to build.

Gibson requested that the board delay final adoption of the rules to allow time for affected individuals, businesses and communities to work with the board on modifications to the draft.

"Agricultural producers recognize that something must be done to conserve water and slow the decline of the, Ogallala Aquifer. We realize the time has come and we are ready and willing to work with the board members to ensure the new rules will be fair and effective," Gibson said. "There is no required deadline the board must meet to adopt new rules so there is no reason for not taking the time to get this right."

"All we ask is that you give us some time and let us work with you to make modifications to these draft rules so that they can be implemented fairly and reasonably without devastating consequences."

If residents are unable to attend these meetings to present comments, Gibson said written comments must be submitted directly to the water district by 5 p.m. April 1. For more information about the proposed regulations, <http://www.TexasCorn.org> visit





Fertilizing Lawns

By County Agent Brad Easterling

Spring is here and that means that lawns are greening up and starting to grow again. If you have not put out your first application of fertilizer yet it is still not too late. There are several things to keep in mind when putting out fertilizer each time. You should have a routine soil test run on your lawn each year to determine what the fertilizer recommendations are, this will prevent over fertilizing or under fertilizing your lawn. Soil sampling bags and forms can be picked up at the Texas AgriLife Extension office. If no soil test is going to be run then fertilizers with a ratio of 3-1-2 or 4-1-2 should be used in most instances as they will supply the nutrients needed without dramatically increasing phosphorous levels. A common example of a 3-1-2 ratio is 15-5-10, and a common example of a 4-1-2 is 16-4-8. For both common and hybrid Bermuda grass 4 split applications in spring, early summer, late summer, and fall are the best times to fertilize.

Many people will use the rule of the 4 holidays, Easter, Memorial Day, 4th of July, and Labor Day as an easy way to remember when to fertilize their lawn. For St. Augustine grass 2-3 applications are sufficient to maintain fertility throughout the growing season. St. Augustine grass that is mostly shaded by large trees will not require as much fertilizer and can get by with only 2 applications. Annually Bermuda grass requires 4-6 lbs. of nitrogen for lush green growth whereas St. Augustine grass will require 2-4 lbs. with shaded lawns requiring less. High traffic turf such as playing fields, golf courses, or if your lawn is the neighborhood football field will require more nitrogen to maintain growth throughout the year.

Approximately 50% of the nitrogen source in the fertilizer should consist of a slow-release form. Using a fertilizer that has all its nitrogen in a soluble source can create too much quick and lush growth. This excessive growth can lead to too much thatch, decreased root depth, and low resistance to disease and harmful insects.

Another option many homeowners may want to consider is purchasing a fertilizer with a pre-emergent herbicide mixed in to control unwanted weeds before they germinate this spring. For Bermuda grass, products containing 2,4-D and dicamba do a good job of controlling most broadleaves and many grasses. In St. Augustine grass, atrazine is labeled for use and works well on most broadleaves and grasses. For more information contact the Extension office or visit http://aggieturftamu.edu
