Severe Weather Awareness Week in Texas will be observed February 20-26, 2011. If variety is the spice of life, we're sure spicy in our region of Texas! Severe weather can mean different types of events depending on the season of the year. It could be blizzards, ice storms and snow. It might be bitter cold. It might also mean tornado producing thunderstorms with a little (or a lot of) hail and high winds thrown in. Or it could even be a threat of wildfire due to extreme dry conditions.

Whatever the event is, we should begin to prepare now. Getting ready doesn't mean living in fear. It just means doing all you can to take good care of your family, friends, and neighbors. Knowing you're prepared for an emergency can help you and those you love stay calm and act effectively.

So, how do we begin to prepare? A good start is by making safety a way of life. Think and plan ahead of an event so that you don't have to scramble around trying to make critical decisions in the middle of the mayhem. You should have a plan that considers each person in your household or your circle of friends. What are each person's age and special needs? What do you need to know if you must evacuate or shelter in place? Where should you find access to reliable information? Do you know our community's warning signals? What's the difference between a watch and a warning? If you must do without services such as, gas, electricity, water, and phone for at least 3 days, what would you do? Could you cope?

During the next few weeks, I'll begin a series of articles that will help answer some questions about preparedness. 
Bill Pool, formerly of Dumas, passed away in Regina, SK on Sunday, February 6, 2011 at the age of 55 years.

### "Cottonwood" to perform at Country & Western Dance



### Panhandle CASA Programs Support Sufficient Resources For Services for Abused, Neglected Children

AUSTIN, Texas - Four volunteers from Court Appointed Special Advocates (CASA) programs braved last week's Arctic front to join more than 300 children's advocates from around the state at the Texas Capitol on Tuesday, Feb. 1, to speak up for children in the foster care system.

Debbie Ferguson, a volunteer with CASA 69, Inc. in Dalhart and president of the Texas CASA board of directors, and Janet Watts, executive director for CASA of the High Plains in Pampa, and Lisa Blanford and Carrie Johnson from the Pampa program, attended CASA Day at the Capitol. The event was to raise awareness about funding needs for children in the Texas foster care system. The bad weather forced a team from Amarillo Area CASA to cancel their travel plans.

Last year, nearly 43,000 children were in the custody of the Texas Department of Family and Protective Services because of evidence of abuse and neglect. Despite projections that the figure will grow to more than 51,000 children by 2014, the proposed budget before the Texas House of Representatives recommends cutting \$467 million from an agency that is already overburdened and underfunded. CASA advocates want to make sure there are sufficient resources for Child Protective Services caseworkers, services and CASA volunteers to keep children safe.

The CASA advocates from the Panhandle joined other child advocates from across Texas in leaving pacifiers, toys and other items at a poignant memorial in the Capitol honoring the 227 Texas children who died from abuse and neglect in the 2010. More than 80 percent of those children were under the age of 5.

"Our volunteers speak up for the best interests of abused and neglected children in our courts," said Ferguson. "I wanted to make sure these children's voices are also heard at

"I believed it was necessary to go to Austin and share stories about the children we stand up for who have suffered in ways we don't want to think about. We want our elected officials to know that there are vulnerable children, more than half who are under the age of 6, who will be directly affected by their decisions," said Ferguson. "The safety of our children must be a priority for our state."

"With the \$27 billion shortfall, we understand that legislators have difficult choices to make for our state," said Ferguson. "But we think/that at a time when every eight minutes a child is abused in the state of Texas and we average 19 children a month dying from abuse and neglect, this is not the time to cut Child Protective Services funds."

"We do think it is important to invest in high-impact programs like CASA, which not only are good for children, but are good for taxpayers because we have a track record of helping children move through the foster care system and into safe loving homes as quickly as possible," said Ferguson.

The abused and neglected children that are represented by CASA programs in the Panhandle deserve a voice at the Capitol, said Joe Gagen, chief executive officer of Texas CASA, a network of 69 local CASA programs that serve foster children in 204 Texas counties.

"In partnership with these programs, we are speaking up for foster children's needs and adequate funding to meet those needs - enough caseworkers, services, and CASA volunteers to keep children safe and placed in permanent homes as soon as possible,"

Debbie Ferguson, representing Amarillo Area CASA, CASA of the Rolling Plains (Childress), Great Plains CASA for Kids (Hereford), CASA of the High Plains (Pampa) and CASA 69, Inc. (Dalhart), met with Rep. Walter "Four" Price of Amarillo

to share concerns about funding for foster children and CASA programs. The five CASA programs in the Panhandle recruited, trained and supported 216 volunteers who spoke up in court for 598 children in the foster care system in 2010.

CASA volunteers are specifically trained to advocate for children in foster care. Volunteer advocates get to know the child and speak to everyone involved in the child's life, including their family members, teachers, doctors, lawyers, social workers

The information they gather and their recommendations help the judge overseeing the cases make informed decisions. CASA volunteers commit to a child until the case is closed and the child is in a safe, permanent home.

Statewide, 6,619 CASA volunteers advocated for 20,861 foster children last year. Only half the children in the Texas foster care system have CASA volunteers. For more information about CASA, visit www.BecomeACASA.org or call (877) 894-



### Sherman County Appraisal District Board of Directors Met Friday, January 21, 2011

Friday, January 21, 2011

The Sherman County Appraisal District Board of Directors met on Friday, January 21, 2011 in the appraisal district board room. Board members present were Roger Wells, David Jackson, Tim Hudson, Jeff Crippen, Mel Yates, Tom Moore, Chet Everett and Valerie McAlister. Chief Appraiser Teresa Edmond was also present.

The statement and Oath of Office were signed by new board members Tom Moore and Chet Everett and David Jackson who is starting a new term of office.

The meeting was called to order at 7:00 a.m. by Chairman Roger Wells. Wells opened the floor for nominations for board chairman. Hudson nominated Wells for chairman, and Yates seconded the motion. The motion passed. Crippen nominated Tim Hudson for secretary. Everett seconded the motion, and the motion passed.

Yates moved that the Consent Agenda be approved. Hudson seconded the motion, and the motion passed. There was no Old Business. The preliminary December 2010 Financial Report was presented and discussed. Hudson moved that the December 2010 Financial Report be approved and the bills be paid. Crippen seconded the motion, and the motion passed.

An engagement letter from Doshier, Pickens & Francis was presented. After discussion, Everett moved that Doshier, Pickens & Francis be engaged to do the appraisal district's 2010 audit. Jackson seconded the motion, and the motion passed.

The fund balance for Legal Bills is \$5,950. The 2010 budget has \$2,300 for legal bills that has not been spent. Edmond explained that a law suit is still pending. After discussion, Jackson moved that the 2010 budget amount of \$2,300 for legal expenses be retained in the legal fund balance. Everett seconded the motion, and the motion

Line item adjustments for the 2010 budget were presented and discussed. Crippen moved that the adjustments be approved as presented, and Hudson seconded the motion. The motion passed.

Appraisal Review Board members whose terms expired at the end of 2010 are Craig Cartrite, Cindy Miller, and Joe Morris. They are all willing to serve another term if appointed. Remaining members are Jo Hinds and Martha Mitts. One new member needs to be appointed to replace Chet Everett. Everett is no longer eligible to serve on the Appraisal Review Board since he was elected as a Stratford School Board Member. It was agreed that Edmond would go down the list of possible ARB members, and the first one who agrees to serve would be appointed. It was also agreed that those members whose terms expired at the end of 2010 be appointed for another term.

No executive session was held, since the district's attorney reported there were no new developments in the law suit to discuss.

Meeting dates for 2011 were selected. Board meetings will be at 7 a.m. on the third Friday of March, May, and December and the second Friday of September. These dates are March 18, May 20, September 9 and December 16.





# Attention All Producers of Groundwater in the North Plains Groundwater Conservation District

Your 2010 production reports are due in the Dumas

office by 5 pm on March 1.

Submitting your reports by the March 1 deadline is especially important this year, since 2010 is the beginning of the District's Conservation Reserve Program. The District's Conservation Reserve Program will allow you to reserve unused allocation from 2010 and apply it to your 2011 or 2012 crop. Only producers who submit their completed reports by the March 1<sup>st</sup> deadline will qualify for the District's Conservation Reserve Program for 2010. Remember, annual allowable production will decrease in 2011 from 24 inches-per-acre to 21 inches-per-acre, and then to 18 inches in 2012. If you want to have the option of applying unused allocation from 2010 to your 2011 or 2012 crop year, your 2010 production reports must be in the Dumas office of the:


