The USDA Natural Resources Conservation Service (NRCS) and the Soil and Water Conservation Districts (SWCDs) are inviting the public and any agencies with an interest in conservation issues to participate in a Local Work Group (LWG) meeting that will be held at the Happy State Bank in Stratford TX on April 15, 2015 at 9:00 am.

The purpose of the public meeting is to receive input from farmers, ranchers, local agencies, organizations, local agricultural leaders, businesses and other individuals that have an interest in natural resource concerns. Input received will allow the LWG to identify and prioritize the resource concerns that need to be addressed for eligible practices and ranking for county based funding.

Recommendations provided by the LWG meetings will be reviewed by the State Technical Advisory Committee (STAC) to help implement conservation programs offered by NRCS. Through stake holder meetings, the public is given an opportunity to help local conservation leaders set natural resource concern priorities in their counties.






Don Gurley April 27, 1930-March 29, 2015

The Good Shepherd: Not of This World

"I am the good shepherd. The good shepherd lays down his

life for the sheep. (John 10:11 NIV)

Jesus Christ came to Earth as the Son of God to rescue his people from the consequences of sin: "For sin shall no longer be your master, because you are not under the law, but under grace." (Romans 6:14 NIV). Christ establishes himself as savior: "For the wages of sin is death, but the gift of God is eternal life in Christ Jesus our Lord."(Romans 6:23 NIV). The Pharisees, keepers of the law, resisted God's message of salvation and plagued Jesus with unrelenting challenges to his authority attempting to expose him as a fraud in order to retain their positions of religious authority. One such example is John chapter nine. They announce he is not from God because he is a Sabbath lawbreaker, and point to themselves as true disciples of Moses.

The Good Shepherd is the true owner of the flock--as opposed to these "wolves in sheep clothing." Jesus came to lead mankind out of the Mosaic Law into his grace. In response to their many criticisms Jesus makes the following declarations: "You are from below; I am from above. You are of this world; I am not of this world. (John 8:23 NIV). "I am the way and the truth and the life. No one comes to the Father except through me. (John 14:6 NIV). The words I say to you I do not speak on my own authority. Rather, it is the Father, living in me, who is doing his work. Believe me when I say that I am in the Father and the Father is in me." (John 14:10 NIV).

(John 15:9 NIV) Greater love has no one than this: to lay down one's life for one's friends. (John 15:13 NIV). I have made you known to them, and will continue to make you known in order that the love you have for me may be in them and that I myself may be in them." (John 17:25-26)NIV).

USDA Extends ARC and PLC Deadlines

Farmers Have Until April 7 to Update Yields, Reallocate Base Acres, and Make Final Selections

WASHINGTON, March 27, 2015 - Agriculture Secretary Tom Vilsack today provided farm owners and producers one additional week, until April 7, 2015, to choose between Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC), the safety-net programs established by the 2014 Farm Bill. The final day to update yield history or reallocate base acres also will be April 7, 2015.

"This is an important decision for producers because these programs help farmers and ranchers protect their operations from unexpected changes in the marketplace," said Vilsack. "Nearly 98 percent of owners have already updated yield and base acres, and 90 percent of producers have enrolled in ARC or PLC. These numbers are strong, and continue to rise. This additional week will give producers a little more time to have those final conversations, review their data, visit their local Farm Service Agency offices, and make their decisions," said Vilsack.

If no changes are made to yield history or base acres by the deadline, the farm's current yield and base acres will be used. If a program choice of ARC or PLC is not made, there will be no 2014 crop year payments for the farm and the farm will default to PLC coverage for the 2015 through 2018 crop years. Producers who have an appointment at their local FSA offices scheduled by April 7 will be able to make an election between ARC and PLC, even if their actual appointment is after April 7.

These safety-net programs provide important financial protection against unexpected changes in the marketplace. As part of the strong education and outreach campaign launched by the U.S. Department of Agriculture (USDA) in September, to date more than 5 million educational postcards, in English and Spanish, have been sent to producers nationwide, and more than 5,00-) events with more than 430,000 attendees, including training sessions and speaking engagements, have been conducted to educate producers on the programs. The online tools, available at www.fsa.usda.gov/arc-plc, which allow producers to explore how ARC or PLC coverage will affect their operation, have been presented to more than 3,400 groups.

Covered commodities under ARC and PLC include barley, canola, large and small chickpeas, corn, crambe, flaxseed, grain sorghum, lentils, mustard seed, oats, peanuts, dry peas, rapeseed, long grain rice, medium grain rice (which includes short grain and sweet rice), safflower seed, sesame, soybeans, sunflower seed and wheat. Upland cotton is no longer a covered commodity.

Producers need to contact the Farm Service Agency by April 7. To learn more, farmers can contact their local Farm Service Agency county office. To find local offices, visit http://offices.usda.gov.

The 2014 Farm Bill builds on historic economic gains in rural America over the past six years, while achieving meaningful reform and billions of dollars in savings for the taxpayer. Since enactment, the U.S. Department of Agriculture has made significant progress to implement each provision of this critical legislation, including providing disaster relief to farmers and ranchers, strengthening risk management tools; expanding access to rural credit; funding critical research; establishing innovative public-private conservation partnerships; developing new markets for rural-made products; and investing in infrastructure, housing and community facilities to help improve quality of life in rural America.
