




The appraisal district is supported solely by payments from the local taxing units served by the appraisal district.

### Xcel Energy names Ronnie Walker to manage Texas Panhandle community relations Pat Rendon retires after 31 years of service

AMARILLO, Texas – Xcel Energy has promoted Ronnie Walker to the position of regional manager for its Texas Panhandle Community and Economic Development group, succeeding Pat Rendon, who is retiring April 15 after 31 years of service with the company.

In his new role, Walker will oversee community relations activities and local government relations in 42 cities and 22 counties in the Texas Panhandle. Walker most recently served as senior project manager with Xcel Energy's transmission organization that oversees the planning and construction of hundreds of miles of new high-voltage lines across the region.

"Ronnie is a native of Amarillo and the Texas Panhandle, with 37 years of service to Southwestern Public Service Company and Xcel Energy," said Brenda Holland, director for Customer and Community Relations in Amarillo. "He has extensive knowledge of the transmission and distribution grid that serves the region, and he's been actively involved in community activities for many years."

Walker started with Southwestern Public Service Company in 1978 as a substation electrician journeyman with the company's Construction Services group. In 1986 he transferred to Plainview as a lineman journeyman and moved back to Amarillo in 1993 to serve as a safety and claims specialist, and later claims supervisor. In 1999 he was named substation construction supervisor, and in 2001 took the role as senior project manager in transmission.


Walker is a 1978 graduate of Palo Duro High School in Amarillo, and earned a bachelor's degree in business administration from Wayland Baptist University in 1993.

It would take pages and pages if I were to capture each treasured memory I have of growing up in Stratford. I moved to Stratford in 1962 when I was 2 <sup>1</sup>/<sub>2</sub> years old with my parents, Dave & Shirley, and two older brothers, David & Tom. My sister Emily was born in 1963. Dad was the editor and publisher of The Stratford Star until 1980. I started first grade in 1966 and graduated from SHS in 1978.

My first memory is the day we moved to Stratford. I was standing in the front seat of the station wagon by Dad, it was raining, and we pulled into the hotel where we stayed for a few days until our rent house was ready. We first lived in a little house next to Mrs. Butler behind the courthouse. Then, we moved to 3rd Street.

My first school memory is being nervous as Mom walked me down the first grade hallway. I was keeping my fingers crossed that I would not get Mrs. Warden; I had seen her the year before when my brother was in first grade and I thought she looked mean and scary. That's when I learned the lesson to not judge a book by its cover! I ended up loving and adoring Mrs. Warden. Don't get me wrong, she was firm, fair and consistent but her heart spilled with kindness and compassion. I got to witness that as I regularly peeked up from nap time and she had one of my best friends on her lap patting her chest and back to help her breathe (Debbie had CF).

Mr. Galloway was one of our principals in elementary. He was a very sweet man and he was tall. He was a quiet man but he kept us in line. I also remember the day we moved into the brand new elementary building. We first reported to our rooms in the old building then we gathered our things out of our desks, loaded onto buses, then moved into our new rooms at Mary Allen Elementary. I remember thinking it was amazing that there was a picture of the real Mary Allen hanging up in the hall.

Oh my, music totally rocked in elementary. Mrs. Mehner was the greatest!! We sang, we played instruments, we danced, she taught us how to play the autoharp... She could always brighten up the darkest day with her happy spirit and timeless energy. No wonder so many of us built on her musical foundation by being in band our middle school and high school years. Mr. Gilley. Need I say more? Talk about also being firm, fair, and consistent! (No wonder that is now my mantra as a teacher.) First, there is Mr. Gilley's legendary but mythical electric paddle. Being the dad of one of my best friends, Mr. Gilley was always there. He always knew. Oh my; I didn't like to get into trouble at school and he is a big reason. We always thought he was picking on us but later I realized that he just really cared deeply about each and every one of us; in fact, he still does!

Mr. Bass taught us many things through his shining example; one being to treat everyone the same no matter their job. He also modeled that it took a team to have a successful school: students, custodians, teachers, support staff, cooks, bus drivers, parents, and community members. He exemplified the Elk Spirit and I am so glad the football field was renamed in his honor. He set the bar for any superintendent I have worked for since and believe me; only one has come close to matching Mr. Bass' greatness, leadership, dedication, and compassion.

I have tried to model the best out of every teacher I had at Stratford as I work with my students. Since this is supposed to be a short article, I better not list each by name.

With Dad owning the newspaper, we attended every school function, no matter its location. I am proud that the school was and still is the focus of the town. Each Stratford student benefits not only from the wonderful Stratford ISD staff but also from each community member.

I earned a Master of Arts in Education – Educational Leadership from the University of Texas of the Permian Basin and a Bachelor of Science in Elementary Education from Oklahoma Panhandle State University in Goodwell, OK where I was voted Student Senate President my senior year. I was also editor of the college newspaper and was the mascot.

My husband Miles and I met in college and have been married since June 7, 1980. We were married in the First United Methodist Church at Stratford. We have two married children, a son Matthew and his wife Kathleen, a daughter Haley and her husband Wylen McAllister, and four grandchildren: Westin (6), Hadley (4), Payton (3), and Emmerson (1 month). 





(NU) - In less than two months, new water heater efficiency standards will take effect and may end up hitting homeowners with an unexpected (and costly) expense.

To grasp the coming regulations, as imposed by the U.S. Department of Energy (DOE), homeowners need to understand the impetus behind it—which is that, according to the DOE, by replacing residential water heaters, pool heaters and direct heating equipment, consumers will save up to \$10 billion and prevent the release of up to 164 million metric tons of carbon dioxide over 30 years.

"These energy-conserving appliance standards are a critical part of the Administration's overall efforts to save energy in homes and businesses nationwide," said former DOE Secretary Steven Chu. "By raising the energy efficiency requirements of our everyday appliances, we will save money for American families and companies, reduce carbon pollution, and enhance our energy security for decades to come." While no one is arguing the

While no one is arguing the benefits of going green, the down side is the upfront cost to the consumer.

"Our customers could face price increases of up to 15 percent to 35 percent," said Mary Kennedy Thompson, president of Mr. Rooter Plumbing. "Not only will the cost of water heaters increase an average of \$120, but installation and maintenance costs will likely rise as well. As a result of new regulations that re-




Homeowners need to be prepared for new water heater regulations.

quire a more complicated installation and increased amount of system parts necessary, homeowners could face a hefty replacement fee in the short run."

The added expense, says Thompson, comes in the form of the larger size of the new water heater units. Electric hot water heaters larger than 55 gallons—the minimum required for most residential homes—will require a minimum of 128 cu. ft. with a duct to a larger space in order to comply with the new standards. This means that homeowners will have the added burden of not only replacing a water heater, but potentially also undergoing a major renovation involving construction.

To combat a potentially highpriced situation, homeowners should consider checking the age of their hot water heaters. If they are getting close to the 10-year mark, they can be replaced before the new regulations take effect.

> **National Public Safety Telecommunicators Week** April 12 - 18, 2015

Each year, the second full week of April is dedicated to the men and women who serve as public safety telecommunicators. It was first conceived by Patricia Anderson of the Contra Costa County (Calif.) Sheriff's Office in 1981 and was observed only at that agency for three years. Members of the Virginia and North Carolina chapters of the Association of Public-Safety Communications Officials (APCO) became involved in the mid-1980s. By the early 1990s, the national APCO organization convinced Congress of the need for a formal proclamation. Rep. Edward J. Markey (D-Mass.) introduced what became H.J. Res. 284 to create "National Public Safety Telecommunicator Week." According to Congressional procedure, it was introduced twice more in 1993 and 1994, and then became permanent, without the need for yearly introduction.

The official name of the week when originally introduced in Congress in 1991 was "National Public Safety Telecommunicators Week." In the intervening years, it has become known by several other names, including "National Public-Safety Telecommunications Week" and "International Public Safety Telecommunicator's Week." The Congressional resolution also stated there were more than "500,000 telecommunications specialists," although other estimates put the number of dispatchers at just over 200,000. The Congressional figure may include support personnel and perhaps even those in the commercial sector of public safety communications.






