



Thinking and learning about being Christ's new creation makes me feel all tingly inside. As an added bonus, I can still recite the entire list of Presidents thanks to Coach Fletcher! During my junior year, I was introduced to Mrs. Carter. Under her guidance I developed a philosophy that I would one day adopt as my own in the classroom--be strict, be fair, but make it fun!






Lady Elk #23 Madison Mungia goes up with the layup in the Lady Elks 35-61 loss to Canadian.




J.V. Lady Elk Rabecca Couch goes up for two in the Lady Elks 24-30 loss to Canadian on Tuesday, February 3, 2015.




8th grade Elk #21 Luis Mendoza goes up with the shot in the Elks loss to Canadian on Monday,




8th grade Elk #13 Victor Torres scores for the Elks in their loss to Canadian on Monday, January


Stratford Elk #33 Tanner Stone drives in and goes up for the shot in the Elks 56-63 loss to Canadian.






Remie Seward drives to the basket for the 8th grade Lady Elks against Canadian on Monday, January 26, 2015.

NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN AIR PERMIT RENEWAL

**PERMIT NUMBER 73352** 

APPLICATION DCP Midstream, LP, has applied to the Texas Commission on Environmental Quality (TCEQ) for renewal of Air Quality Permit Number 73352, which would authorize continued operation of the Hudson Booster Station located near Stratford in Sherman County, Texas 79084. The applicant provides the following directions to the site: From US-287 (Poplar Street) and US-54 in Stratford, Texas, drive 13.8 miles south on US-287, turn east and drive 6.8 miles on Ranch Road 1573, turn north and drive 0.6 mile on CR-16 to the booster station on the left. This link to an electronic map of the site or facility's general location is provided as a public courtesy and part of the application or notice. The existing facility and/or related facilities are authorized to emit the following air contaminants: organic compounds, nitrogen oxides, sulfur dioxide, carbon monoxide, particulate matter including particulate matter with diameters of 10 microns or less and 2.5 microns or less, hydrogen sulfide and hazardous air pollutants.

This application was submitted to the TCEQ on November 13, 2014. The application will be available for viewing and copying at the TCEQ central office, TCEQ Amarillo regional office, and the Sherman County Library, 719 North Main, Stratford, Sherman County, Texas, beginning the first day of publication of this notice. The facility's compliance file, if any exists, is available for public review in the Amarillo regional office of the TCEQ.

The executive director has determined the application is administratively complete and will conduct a technical review of the application. In addition to the renewal, this permitting action includes the incorporation of the following authorizations or changes to authorized facilities related to this permit: alterations and amendments. The reasons for any changes or incorporations, to the extent they are included in the renewed permit, may include the enhancement of operational control at the plant or enforceability of the permit. The TCEQ may act on this application without seeking further public comment or providing an opportunity for a contested case hearing if certain criteria are met.

PUBLIC COMMENT You may submit public comments, or a request for a contested case hearing to the Office of the Chief Clerk at the address below. The TCEQ will consider all public comments in developing a final decision on the application. The deadline to submit public comments is 15 days after newspaper notice is published. After the deadline for public comments, the executive director will prepare a response to all relevant and material, or significant public comments. Issues such as property values, noise, traffic safety, and zoning are outside of the TCEQ's jurisdiction to address in the permit process.

After the technical review is complete the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. If only comments are received, the response to comments, along with the executive director's decision on the application, will then be mailed to everyone who submitted public comments or who is on the mailing list for this application, unless the application is directly referred to a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING You may request a contested case hearing. The applicant or the executive director may also request that the application be directly referred to a contested case hearing after technical review of the application. A contested case hearing is a legal proceeding similar to a civil trial in state district court. Unless a written request for a contested case hearing is filed within 15 days from this notice, the executive director may act on the application. If no hearing request is received within this 15 day period, no further opportunity for hearing will be provided. According to the Texas Clean Air Act § 382.056(o) a contested case hearing may only be granted if the applicant's compliance history is in the lowest classification under applicable compliance history requirements and if the hearing request is based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission may only grant a hearing on those issues raised during the public comment period and not withdrawn.

A person who may be affected by emissions of air contaminants from the facility is entitled to request a hearing. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) applicant's name and permit number; (3) the statement "[I/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; and (6) a description of how you use the property which may be impacted by the facility. If the request is made by a group or association, the one or more members who have standing to request a hearing and the interests the group or association seeks to protect must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns. Requests for a contested case hearing must be submitted in writing within 15 days following this notice to the Office of the Chief Clerk at the address below.

If any requests for a contested case hearing are timely filed, the executive director will forward the application and any requests for a contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. Unless the application is directly referred to a contested case hearing, the executive director will mail the response to comments along with notification of Commission meeting to everyone who submitted comments or is on the mailing list for this application. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact relating to relevant and material air quality concerns raised during the comment period. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.

Those on the mailing list will receive copies of future public notices (if any) mailed by the Office of the Chief Clerk for this application.
