



Eleven Exhibitors from Sherman County 4-H Compete at the Tri State Fair in Amarillo

Exhibitors from all over the state including the surrounding states came to compete at the Tri State Fair and Rodeo.

On Saturday, September 19th, a total of 96 heifers came to compete. Katelin Berry placed 2nd with her Main Tainer heifer, Payton Berry won 1st with her heifer in the ORB class, Jaci Brown placed 4th with her ORB lowline heifer, and Turner Smith placed 2nd with his Chimaine.

Monday, September 21st, was the Youth Market Goat Show, which five exhibitors showed a total of ten goats. Baxter Merry started the show off with a light weight goat placing 5th. Wyatt Merry placed 9th with his medium weight goat and his sister followed behind him with a heavy weight goat placing 10th in her class. Levi Springer also showed a heavy weight goat in the same class placing 5th, and Holly Sladek was in the next class, also with a heavy weight goat, where she placed 10th.

The Youth Steer Show was on Saturday, September 26th, with over 270 steers competing! Reid Rousser placed 4th in the first class of Angus Steers and his brother Rhett followed in class 2 of Angus Steers placing 3rd. Rhett also competed in the Livestock Judging competition on September 19th and placed 33rd overall as an individual competitor.

Overall, Sherman County 4-H had a great run at the Tri State Fair and Rodeo. We have a great group of kids that show dedication, hard work, and a desire for learning more about their animals. 

Not Going Anywhere For one thing, many have no


