

# Happy State Bank to acquire bank in Shamrock




#### **2015 Property Tax Rates**

This notice concerns 2015 property tax rates for the listed entities. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties listed in both years. This year's rollback rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.



The day before, brine the chicken: Dissolve 1 Tablespoon Kosher salt and 1 Tablespoon sugar in one can of Angry Orchard Crisp Apple cider. Mix in 1 Tablespoon chopped herbs and 1 clove chopped garlic. Submerge chicken in brine overnight, adding water (or

cider) if necessary.

Preheat oven to 300 degrees, or light a grill and set to low heat. Remove chicken from brine, rinse thoroughly and pat dry. In a small bowl, whisk together 4 ounces of Angry Orchard Crisp Apple cider, remaining herbs (whatever you can get your hands onthyme, sage, rosemary, etc.), remaining garlic, and olive oil. Rub dressing all over chicken, and season liberally with

remaining salt and pepper. Stand chicken straight up and nestle firmly on top of can; the chicken should remain vertical. Place chicken in a wide roasting pan or directly on the grill, and cook until the juices run clear and chicken is cooked through, approx. 30-40 minutes. Cooking times will vary based on heat and method.

Remove chicken from the oven and let rest for 10 minutes. Carefully remove the can of cider, and serve.



It is not too much longer and the Stratford schools will be open for business with hallways full of kids. A new school year brings optimism and energy to a community. There is something special about the first football game, cold front and the excitement of

kids returning to classes.

The district accountability ratings were released last Friday. The district and all of the campuses continue to perform well overall, although there are always places we would like to see improvements. This is a tribute to the fine faculty and great students that we have in our community.

We will have a number of new faces in the district for 2015-16. It is annual passage that valued employees leave the district and we are faced with the challenge to replace them with quality people. We feel that we have again found good teachers and quality people to put in front our student. The new professional staff includes Jon Murphy (JH SS/Coach), Penny Murphy (JH Math), Tanner Martin (HS SS/Coach), Kendra Martin (HS Ag), Ammon Farnsworth (HS Math), Macy Begley (JH ELA), Katherine Nusz (Band Director) Kaleb Horsford (HS Ag), and Tracy Hicks (2nd grade)... We are extremely pleased that these folks have chosen to work for the district.

We are continuing to work to get our campuses in shape for the new school year. There are a great number of people responsible in getting the district ready for the start of a school year - building principals, office staffs, custodial/maintenance, transportation folks, cafeteria staff, along with the instructional staff. It is comforting to know that we have competent, capable people in these key positions.

The board and administration continue to wrestle with the future of our facilities. Over the years, remodels and additions have been made, but the last campus built - Mary Allen Elementary - was built in the 1960s. The current high school facility is a 1931 model. Our facilities have served the community well and have been wellmaintained over the years, there are some needs in the near future. Our science labs are antiquated and Ag building is beginning to show the wear of 60 years of work. An auditorium remains on the list of a facility that many in our community would like to see.

We are always sensitive to the tax burden and providing quality services to our community. The district continues to be impacted by the state budget cuts from Spring 2011. Stratford ISD has worked with a loss of about \$1.6M combined over the past four years compared to previous years. It leaves our choices to live with the aging facilities or look to bond election to generate revenue for auditorium, science labs and/or Ag shop. This will be an ongoing conversation with the board and the community as we determine the best course for the district.

Elk football and the Big Blue Band began practices last week with a lot of participants in both programs. Cross Country should get started this week. The opening football scrimmage will be this Saturday at Dalhart - first whistle at 9 am.

We have a ballgame nearly every week at Sam Bass Stadium. We would love to have you come out and support these young people. If you have some years behind you, stop by the business office and pick up a gold card for home game admission.

The annual beginning of the year open house and hamburger feed has been schedule for August 21st. The campuses will run a staggered schedule for parents needing to visit multiple building. The hamburgers will be served in the main cafeteria at the junior high/high school. This is always an enjoyable time for the school administration and the school board to share a meal with our community.

It is an honor and a privilege for me to serve the community, parents, staff, and students of Stratford ISD. Stratford ISD has done a tremendous job of educating the kids of this community for many years. After completing graduation requirements, our kids

have doors opened to them to pursue employment, military options or further their education. This is possible because of the excellent staff, along with the great support of the community. It is my pledge to you to continue this tradition of excellence.

#### Media Release for Free and Reduced-Price Meals Sample

Texhoma ISD announced its policy today for providing free and reduced-price meals for children served under the attached current income eligibility guidelines. Each school/site or the central office has a copy of the policy, which may be reviewed by anyone on request.

Starting on 8/7/2015 will begin distributing letters to the households of the children in the district about eligibility benefits and any actions households need to take to apply for these benefits. Applications also are available at Texhoma ISD 402 Denver Street, Texhoma, TX 73960.

#### Criteria for Free and Reduced-Price Meal Benefits

The following criteria will be used to determine a child's eligibility for free or reduced-price meal benefits:

1. Household income that is at or below the income eligibility levels

Categorical or Automatic Eligibility

2. Household receiving Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF); or Food Distribution Program on Indian Reservations (FDPIR)

**Program Participant** 

- Child's status as a foster child, homeless, runaway, migrant, or displaced by a declared
- 4. Child's enrollment in Head Start or Even Start

For those households that qualify for free or reduced-price meals based on income, an adult in the household must fill out free and reduced-price meal application and return it to Lorena Whatley, Para Professional, 806-827-7400 Those individuals filling out the application will need to provide the following information:

- 1. Names of all household members
- 2. Amount, frequency, and source of current income for each household member
- 3. Last 4 digits of the Social Security number of the adult household member who signs the application or, if the adult does not have a social security number, check the box for "No Social Security number"
- 4. Signature of an adult household member attesting that the information provided is correct

**Categorical or Program Eligibility** 

Texhoma ISD is working with local agencies to identify all children who are categorically and program eligible. Texhoma ISD will notify the households of these children that they do not need to complete an application. Any household that does not receive a letter and feels it should have should contact Lorena Whatley, Para Professional, 806-827-7400.

Any household that wishes to decline benefits should contact Lorena Whatley, Para Professional, 806-827-7400.

Applications may be submitted anytime during the school year. The information households provide on the application will be used for the purpose of determining eligibility. Applications may also be verified by the school officials at any time during the school year.

**Determining Eligibility** 

Under the provisions of the free and reduced-price meal policy, Lorena Whatley, Para Professional, 806-827-7400 will review applications and determine eligibility. Households or guardians dissatisfied with the Reviewing Official's eligibility determination may wish to discuss the decision with the Reviewing Official on an informal basis. Households wishing to make a formal appeal for a hearing on the decision may make a request either orally or in writing to Steve Lenz, Superintendent, PO Box 10080, Texhoma, TX 73960.

**Unexpected Circumstances** 

If a household member becomes unemployed or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for benefits if the household's income falls at or below the attached current income eligibility guidelines.

But in good news, one company, Bay Alarm Medical, believes it has a responsibility to help seniors safeguard themselves from bullying tactics. The Bay Alarm Medical Code of Ethics establishes high standards for uncompromisingly ethical and transparent business practices. In addition, the company offers these 10 tips for seniors:

DO NOT provide personal information over the phone. Under no circumstance should

you divulge bank names, credit card numbers, birth dates or Social Security numbers.

DO NOT tolerate bullying,

coercion or intimidation tactics. A legitimate medical alert sys-

tem provider will never pressure you, limit time to respond, use threats or coercion to get you to make a purchase.

DO NOT believe that products or services are "free."

Scammers may say you've won a free gift or product in order to solicit personal information or insist you pay a fee, shipping and handling to redeem a prize.

DO NOT press any buttons if you receive an automated or recorded "robocall."


If you hear a recording when you answer the phone, you have received a "robocall" and should hang up. Even if instructed, do not press buttons to speak to a live operator or have your number removed from lists, as that could trigger future robocalls.

DO not entertain unsolicited sales or cold calls.

If you don't want to speak to an unsolicited telemarketer, just hang up the phone. Legitimate medical alert providers will never cold call noncustomers.

DO register your phone number with the National Do Not Call

The National Do Not Call Registry gives you a choice about

whether to receive telemarketing calls, and once your number has been on the registry for 31 days, you should not receive any. Register your home or mobile phone for free at www.donotcall.gov.

DO request information about the salesperson and company.

If you are being bullied or pressured by a telemarketer, request their name, business name, contact information and business license. and tell them you will call if interested. If they refuse to give you information, it is likely a scam.

DO research and verify the information.

With a simple online search. information about known scams can be found. The Better Business Bureau (www.bbb.org) and the state Attorney General's office can provide further insights.


DO seek counsel from friends and family.

If you are genuinely interested in a telemarketer's product or service and they are legitimate, request they call you at a time and date you prefer. This gives you time to discuss the information with your friends and family to aid your decision.

DO file a complaint or report the call to authorities if you've


