## Wide Interest In Launching of PC-530 Saturday Rockport Schools To Open 1941-42 Session Sept. 8

Girls from a number of other cities have registered to compete in the contest. The winner will have the honor of christening the submarine chaser in a ceremony beginning at 2 p.m. Saturday. The contest to pick the sponsor will be held at 10 a.m. Saturday.

### Lamar District Is Merged With Rockport School

#### Supt. Black Reports Three Teachers Needed to Complete Faculty

Vacation days will come to a close here for more than five hundred boys and girls on September 8 when school will begin for the 1941-42 term, according to an announcement by Superintendent R. E. Black.

There will be an increase in the number of students here this year with the merger of the Lamar Common School District No. 6 with the Rockport Independent School District, and through the transfer of additional students into this district. Many families have moved here during the past few months, including a large number of workmen who have found employment in the boat works here.

The Rockport system is losing six teachers this year through resignations. Mr. and Mrs. W. A. Smith will go to Corpus Christi, where Mr. Smith will be assistant principal of the Robert Driscoll Junior High. Mr. Smith was high school principal here last year and Mrs. Smith was also a member of the faculty. Miss Elizabeth Palm, Junior high teacher here last term, has accepted a secretarial position in San Antonio and will not be back here. Harry Morgan, coach here last term, has resigned to accept a position as coach and high school principal at Three Rivers. Miss Juanita Marshall, primary teacher here, has resigned to accept a teaching position at Brady.

Edwin Bell, industrial arts and math instructor in the high school, has resigned to continue his work as draftsman for the Westgard-Rice Brothers & Co., boat works. Mr. Bell will be replaced by Jim T. Mohley of Stephenville. Mr. Mohley has a master's degree and has had 14 years teaching experience, the past 8 years in Stephenville schools.

"Our budget is planned on the basis of sixteen teachers for the coming year," Supt. Black said, "and we lack one woman teacher for primary work and two men teachers for the high school."

The superintendent said that there was a shortage of men teachers, because of the draft taking out many of the young men and older men are finding more remunerative positions in other fields.

"Last year due to state aid we added all the teachers to which we were eligible and the state paid for additional teachers," Supt. Black said in explaining that two more teachers would be needed that could not be allowed under the present budget. "The valuations in the original Rockport district, contrary to all expectations, did not show a substantial increase."

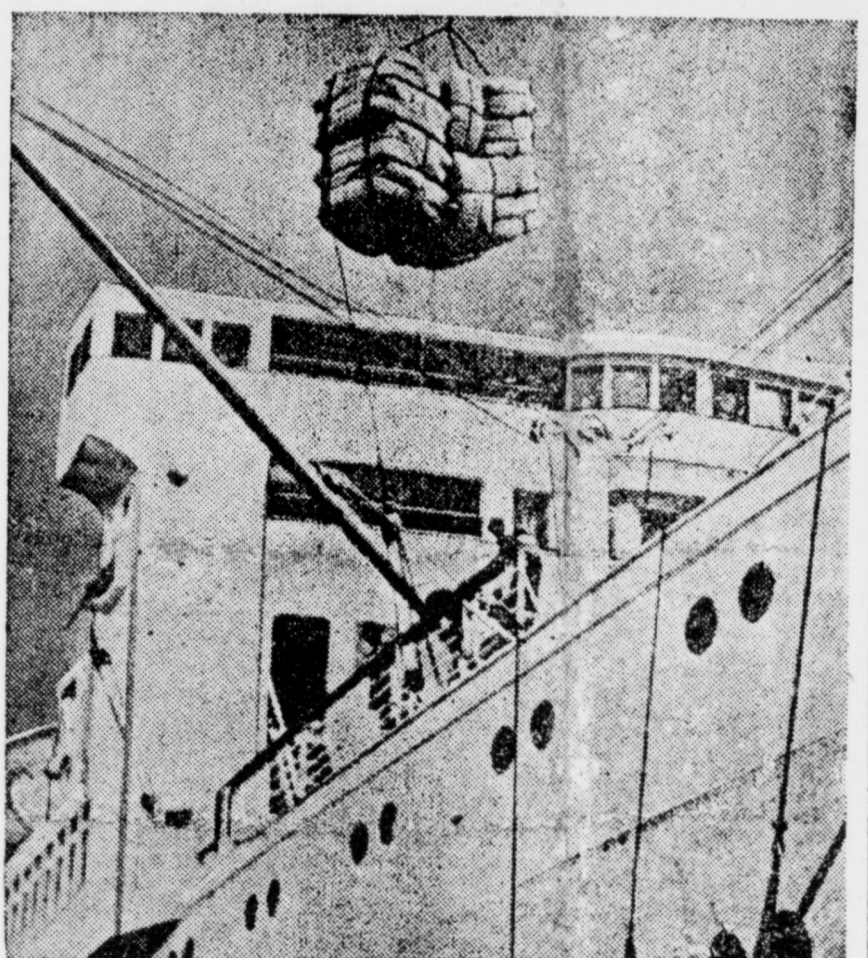
"The staff of 16 teachers this year puts us in better position than we were during the 1938-1940 term when we had only 14," the superintendent continued, "but the district really needs 18 teachers and will have them as soon as finances permit. The district is rather heavily in debt for buildings and 45-cents of every dollar is being used toward paying off bonded indebtedness."

"No departments of education are being sacrificed the coming year. The teachers are making up for the deficiency in number by carrying heavier assignments than in the past year."

Supt. Black said that a merger had been effected with the Lamar Common School District No. 6 through a contract. The Rockport Independent School District is now made up of Rockport, Rincon, Estes, Sparks Colony and Lamar. Three buses will be operated in carrying students this year and grades six through 12 of the Fulton school will be transported here to attend school.

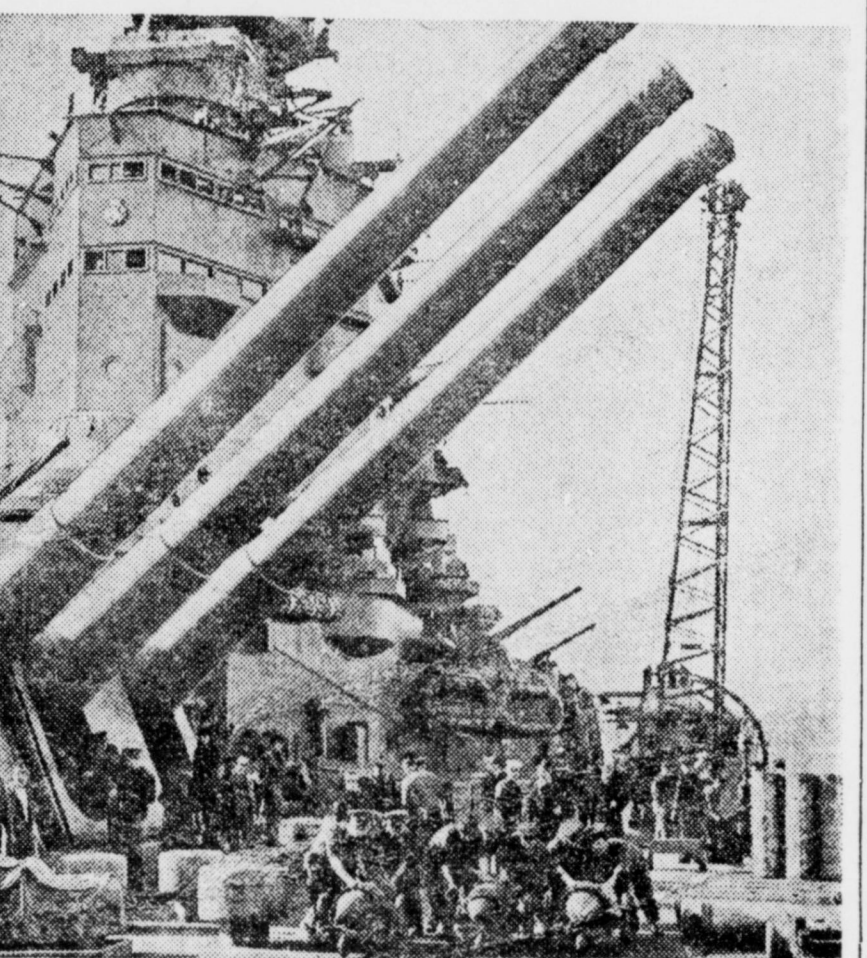

### Brownsville Ship Co. Official Visits Here

### Rockport School Asks Grant Under Defense Program

Application for a grant of \$128,368 has been made under the Defense Public Works program by the Rockport Independent School District for the purpose of constructing new buildings to take care of increased enrollment brought by new defense industries.

Supt. Raymond E. Black pointed out that the application was made under the Langham Act, designed to aid national defense centers.

"The request is being made for a 100 per cent grant, and there is no intention of increasing the bonded indebtedness of the district," he said.

According to present plans the grant would be used to construct a gymnasium, home economics room, science laboratory, typing room and class rooms.

Smith, Pitts and Weidner of San Antonio are the architects who prepared the preliminary plans for the application.

**WORLD EVENTS**

World events seem to be moving in more satisfactory fashion these days. One cannot help hoping that sometime before long we may read that people who once thought that war was the only way to bring about satisfactory solutions to world difficulties may have reached the conclusion that there are possibilities of mutual co-operation. Acceptance of the fact that we are dependent upon each other, not only as individuals but as nations, for our well-being and that the ultimate solution of world problems will require a willingness to agree to this precept, seems the first step forward toward a peaceful world.

In these closing days of the International Student Service Institute in Eastport, Maine, the question of the way to make democracy meet not only our own needs, but world needs, has been discussed by Dr. Eagleton and the students. Much interest and real thinking on the problem, I hope, will result.

I have, of course, spent a very short time with this group of young people and I have nothing whatsoever to do with the running of the institute. But one finds oneself receiving certain impressions. I have found first that after five weeks of hard work there is no real lessening of interest in the study of what democracy means and of how, as individuals, we can function to make democracy meet the needs of all the people.

**FINE LEADERSHIP**

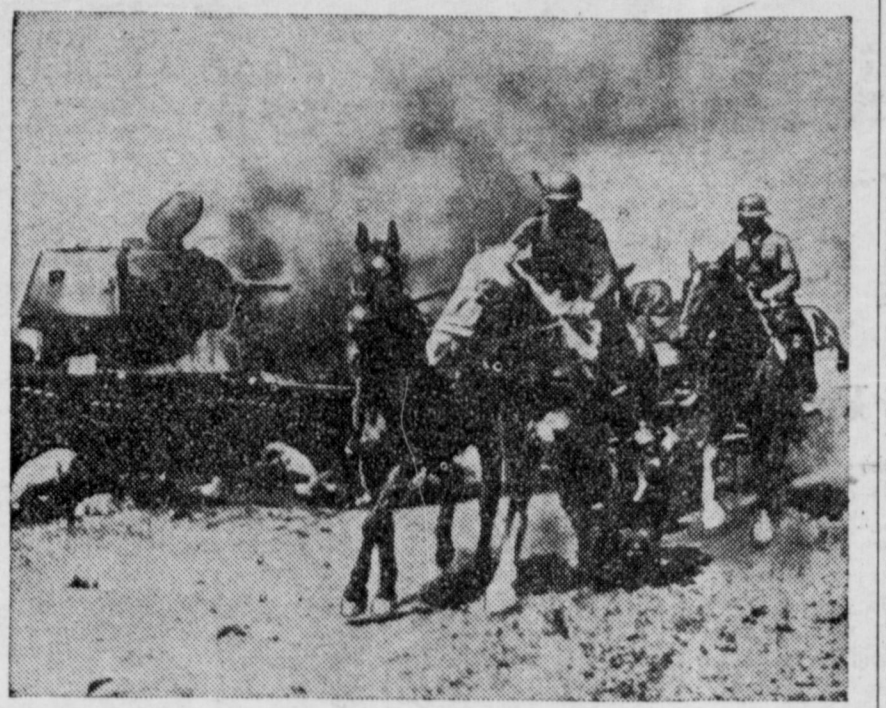
Dr. Neilson has made a deep impression on all of us. Perhaps the students who have been under his direction at Smith college will understand what I mean when I say that these young men and women have sensed the benediction of his presence. It is character that really gets across to other people and there has been a recognition of the fineness and the gentleness of a human being who has lived up to his ideals and used his abilities to the utmost. Example is far better than precept.

In addition, I think Mr. Joseph Lash, who has really done the day-by-day management of detail and curriculum on which hangs much of the success of an undertaking such as this, has gained the respect and the affectionate co-operation of all the young people under his care in a way which is only possible when there is realization of a fine spirit. People grow through experiences, if they meet life honestly and courageously. This is how character is built and young people recognize this ability to grow in those with whom they come in contact.

**British See Far East 'Squeeze Play' In Japan's Attitude Toward Thailand; Nazis Claim Big Victories Over Reds; Mussolini's Son Killed in Air Crash**

**FOOD FOR BRITAIN**

In the headlines, lend-lease aid to Britain is chiefly a story of planes, tanks, ships, guns and munitions. But these dramatic war supplies are only one part of the picture.

An equally vital, though little known, phase of this gigantic program is food.

Today, practically every ship leaving U. S. shores for embattled England carries stocks of food as part of its cargo. Also significant is the fact that this steady flow of food shipments differs markedly from those of World war days.

Then the foodstuffs were in bulk form—boatloads of grain and fresh meats. But now, with British and Allied shipping suffering terrible destruction, there aren't enough bottoms to transport both bulky armaments and bulky food across the hazardous Atlantic.

Since the cargo space for bulky armaments cannot be reduced, and with the British food situation becoming acute, food is being shipped in concentrated and dehydrated form. Thus it is carried in the same ships with arms and munitions, taking up relatively little space.

The extent of these shipments and what they meant to the American farmer is shown graphically by the following list of lend-lease food purchases in a very recent seven-week period:

American cheese, 20,483,175 pounds; corn starch, 35,820,000 pounds; frozen eggs, 36,648,630 pounds; dried eggs, 4,458,630 pounds; canned fish, 1,083,052 cases; dehydrated soup, 4,400,000 pounds; soy beans, 9,070,000 pounds; dried beans, 40,770,000 pounds; corn sugar, 5,696,000 pounds; enzymes, 3,360 pounds; dried apricots, 9,986,000 pounds; honey, 3,557,300 pounds; enriched flour, 399,000 pounds; concentrated orange juice, 92,302 gallons; vitamin A, 2,547,183 units; vitamin B<sub>1</sub>, 3,965 kilograms; peanut butter, 1,762,000 pounds; lard, 28,662,720 pounds.

**NOTE**—Management of the lend-lease food program is under the Surplus Marketing Administration, aided by the U. S. public health service, the British ministry of health and the Anglo-American food purchasing committee.

**FREEZING CHINESE FUNDS**

There was one unwritten chapter in the story of American freezing of funds of those two Oriental neighbors, Japan and China.

It was published that the funds of friendly China were frozen as well as the funds of unfriendly Japan. But unpublished was the fact that China for four months had been asking the state department to freeze its funds, but the state department had refused.

China's request was quite unusual, for most nations object strenuously to having their funds frozen. For instance, Switzerland, hearing that she would be included with Germany when Hitler's funds were frozen, argued for weeks.

But in the case of China, many of her funds are in the hands of big Chinese merchants and bankers in Shanghai, who for business reasons are playing with the Japanese. And they have been draining Chinese currency from the country.

So Roosevelt's special Chinese emissary, Lauchlin Currie, was requested by Chiang Kai-shek to ask Secretary of State Hull to freeze Chinese funds. This would have hamstrung the pro-Japanese Chinese.

However, Secretary Hull refused. Twice Chiang Kai-shek made the request, but both times it was refused. In fact the state department even denied that such a request was made, presumably on the ground that it came not through diplomatic channels, but through Mr. Currie who is only a White House secretary.

Finally, however, when Japanese funds were frozen, Chiang Kai-shek got his request fulfilled. But it took Japanese aggression in the South Pacific to do it.

**BOOTLEG GASOLINE**

The days of bootlegging from Canada may be coming back again. In this case, however, the bootlegging will be gasoline, not alcohol.

Canada has imposed a ban on sale of gasoline between 7 p. m. and 7 a. m. on weekdays, and all day Sunday. But this restriction does not apply to Americans.

Now comes the proposal of Oil Administrator Ickes to impose a similar ban on gasoline sales in eastern states. Result would be that a motorist would be unable to buy gasoline in Buffalo or Detroit, but could cross the river and buy it in Canada.

**MERRY-GO-ROUND**

Administration are quietly throwing their weight behind the candidacy of Francis Miller, militant New Dealer, for the Virginia legislature. Miller is being opposed by the Old Guard machine led by Sen. Harry Byrd.

To out-of-town friends who call on him, President Roosevelt is presenting copies of "America," absorbing booklet written by David Cushman Doyle. The President says he considers the booklet the best summation of the American creed he has ever read.

**CONGRESS: Big Work**

Three bills of huge importance were before congress, and although passage for all was predicted, the importance laid as much in what their final form would be as in whether or not they would become law.

These were the tax bill, the draft-extension bill, and the price-fixing bill, the latter linked inseparably with the "draft-industry" bill.

The tax bill, it was apparent, would be voted into existence minus the requirement that all married couples file joint income tax returns. Roughly, this will cut \$25,000,000 off the yield of the law, which will then have a ceiling of about \$3,200,000,000.

This is to be divided, roughly, into a billion for income taxes; a billion for miscellaneous and special taxes; and a billion and a third for corporation income taxes, a small balance coming from gift taxes.

The draft extension bill showed the opposition to the administration losing one battle after another, but reforming their lines with more support after each defeat.

When the administration's resolution calling for an extension of present draft terms by 18 months was brought to a vote, the senate passed the measure by a vote of 45 to 30. This meant that total term of draftees, National Guardsmen and reserve officers would all serve a total of 2 1/2 years. The bill went from the senate to the house following the vote.

The price-fixing and draft-industry bills were chartered under a more difficult course. The latter passed the house, but immediately there started in the opposition press a battle, claiming that there was a threat to the freedom of the press and freedom of speech through radio—as these businesses, too, might be seized by the government.

As to price-fixing, Leon Henderson seemed the center of this fight, and many in congress declared they would feel more kindly toward the bill if they felt more confidence in Henderson's ability to carry it out. Indeed, the house appointed a special committee to oversee the enforcement of this legislation.

**DEATH: To a Youth**

From Rome came the report that Bruno, the second son of Benito Mussolini, had been killed in an air crash while on a plane testing flight near Pisa. He was 22 years of age and ranked as a "Captain of Aviation." He had seen action in three wars. In Ethiopia, in the Spanish war and in the present war he had engaged in what Italian sources described as "daring" and "risky" actions.

**GERMANY: Makes Claims**

The Germans, who had been pictured fairly hopelessly stalled on the Eastern front, with the Reds growing in strength and in some points taking the offensive, came out finally with a statement in which they made the largest claims thus far.

They claimed 895,000 prisoners taken, and "many times more" in killed and wounded; the entire Russian resistance shattered; no semblance of order in the Red army; and pictured Moscow as without any clear picture at all of the situation, blindly believing its army still fighting.

When it came to giving details of places, the communique, while a lengthy one, was not very communicative.

But from it one could picture the front through the German eyes, with Smolensk, in the center, a sort of island of doomed Russian battalions, still holding out, although surrounded.

Leningrad, on the north, was a hopeless city, menaced from the south and the north, with another small "island" of surrounded Red troops still holding out in the vicinity of Tallinn, Estonia.

Kiev, on the south, was shown in this document as partially surrounded, with two huge pincers having pierced the Stalin line north and south of the city itself, which is an integral part of that line.

The claims were contained in four special communiques from the headquarters of Adolf Hitler himself, and were broadcast throughout the German nation.

**RUSSIANS: Their Version**

Completely ignoring the claims of the Germans, the Reds, admitting Nazi pressure on the south, say that they are counter-attacking and were using the same tactics "which threw the Germans back in the central front."

In fact, the Russian reports considered the front from Smolensk to Bel-Tserkov, a distance of 350 miles, as a single unit, rather than a definite pincer movement, and said that there was mobile fighting going on all along this front.

In fact, the Reds asserted they were holding the Germans in two other sectors, that of Kholm, 180 miles south of Leningrad, and on the Estonian front—where the Germans had claimed important advances.

The Russians also reported taking many prisoners, and revealed that many of them are either 17 years old or the older type reservists, showing that the Nazis are drawing heavily on their reserves.

**JAPAN: Warned Again**

London warned Japan that if she moved against Thailand in any way, she would find that Britain would consider such a move as a definite threat to Singapore, and would act accordingly.

This was seen as a sort of confirmation that the British are sending expeditionary forces of occupation into Siamese territory, and that any Japanese effort to cut the Burma road will bring the world war to the Far East.

The statement came from Foreign Secretary Eden, making it in the house of commons. It had been rumored that 10,900 British troops would be sent to Thailand from eastern bases, and that a considerable British fleet already was in those waters.

And it also was believed that Japan was committed to move against Thailand in its agreement with the other Axis powers. This was visioned as part of a squeeze play against India.

Eden said: "Every fresh move on the part of Japan naturally has the result of bringing China and ourselves closer and closer together."

"That friendship and that collaboration with China will continue and I pray that it will grow."

"Men and materials are pouring out to strengthen our forces in the Middle East for their next forward plunge, and these will strike their blows for the independence of the countries in the Middle East as much as for our own independence."

Maine is so remote that many of the affairs of vital interest to other people in the country may mean little here. But the Battle of the Atlantic is very close to these people. 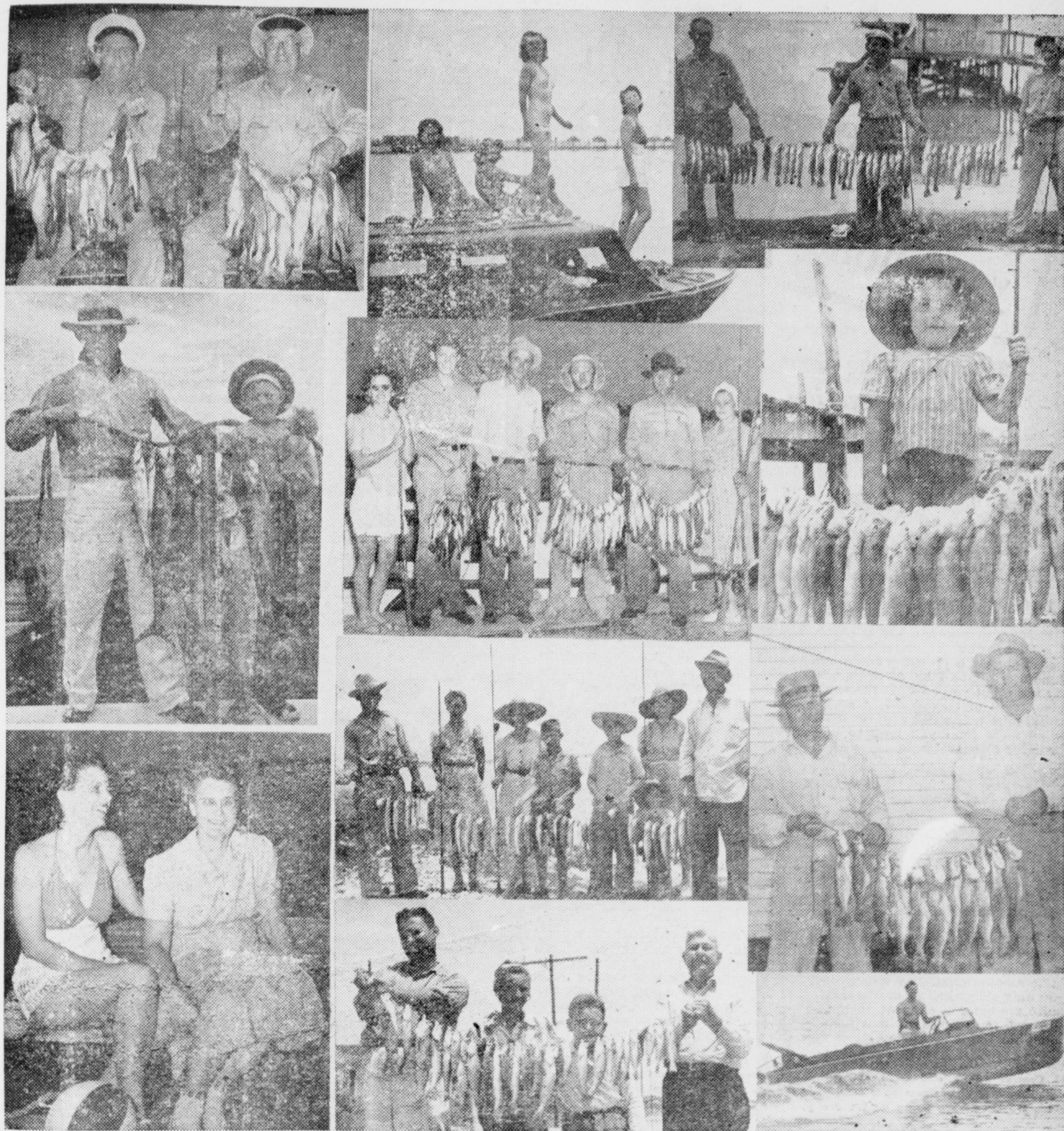
