

## Collier Not to Stand for Re-election to New Term

## Agreements Near On Building Of Marine Laboratory Here

### State Offered Cooperation By Local Officials

#### Picton Says No Reason Why Problems Cannot Be Worked Out

Chas. T. Picton, chairman of the Aransas County Navigation Commission, said today that he could see no reason why "we can't get" the proposed state marine laboratory here.

Picton said that he gave assurance to Howard Dodgen, executive secretary of the State Game, Fish and Oyster Commission, that local interests would cooperate in every way with the state in locating and building the proposed \$25,000 marine laboratory here.

"I assured Dodgen that we wanted the laboratory here and that we would help him in every way possible," Picton said. "He will draw up a lease agreement for the site, along with tentative plans for the building and bring them to Rockport."

Picton said after his conversation with Dodgen that he felt sure everything could be worked out when the state officials meet with officials here and make known their exact needs and desires in the matter.

Mayor Albert Collier stated that he had also talked with Dodgen, and was informed that the game commission secretary would seek advice of the attorney general in drawing up a lease agreement. Collier said that Dodgen was enthusiastic over the prospects of getting all details worked out at an early date for the start of building the laboratory.

It is proposed to build the laboratory on the Rockport harbor near the break-water, where scientific researchers would have bay water available for their work. The laboratory would serve as a research station for the whole Texas coast, where methods of propagating and conserving marine life would be studied.

### Palm Courts Doesn't Have First Inter-Com

Fred Bracht, owner of the Model Grocery, challenged a statement in last week's Pilot that Palm Courts had installed the first inter-communications system in Aransas county.

H. H. Roberts of Palm Courts probably has the first inter-communications system in a tourist court set-up here, but Bracht has had a similar system installed in his store since new building was completed in 1943. The first of these systems, however, was probably installed at the shipyard as inter-communication between various departments during the peak of war-time ship building days.

The Palm Courts system was installed by the Rockport Electric Company.

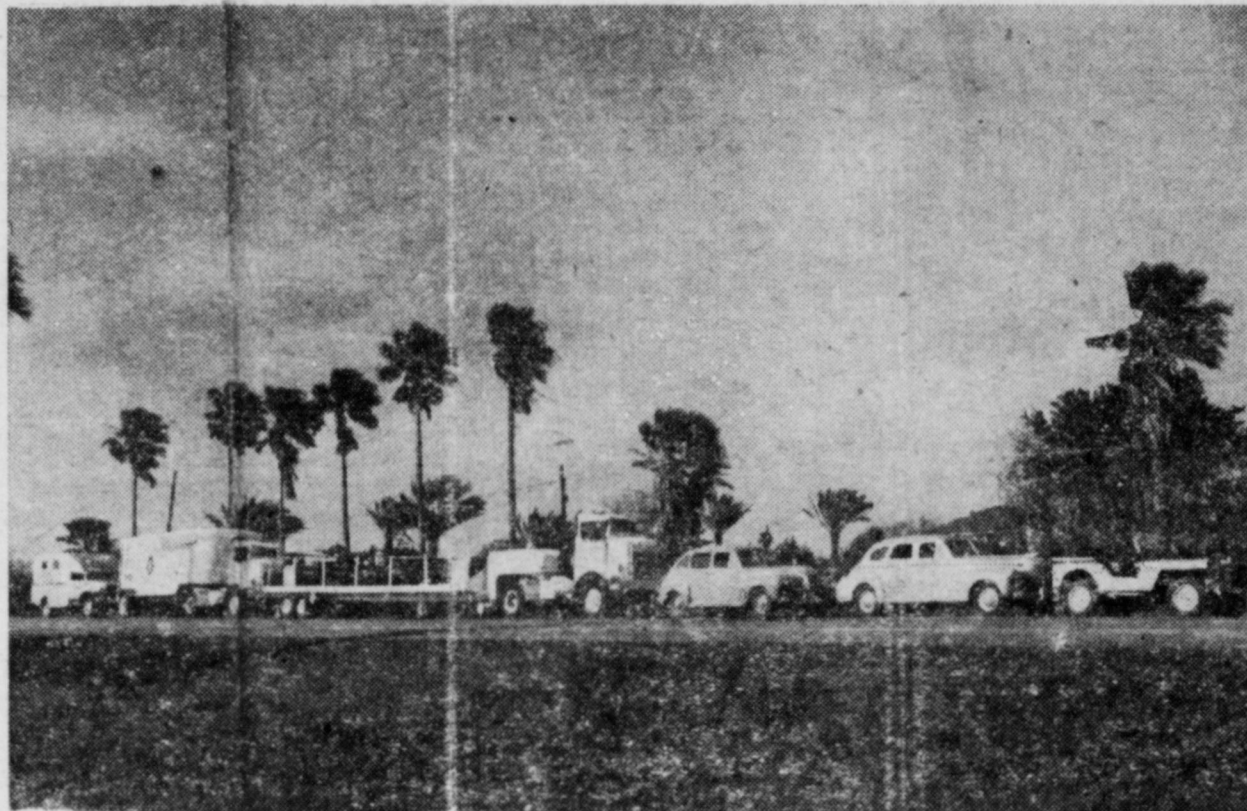

An example of the way the Red Cross dollar is spent was the work carried out in Aransas county following hurricanes in 1942 and 1945, when a total of \$13,000 was spent in the county to rehabilitate people who lost homes and business and were unable to help themselves. The assistance was given under the supervision of a local advisory board.

### Silver Caravan Visits Rockport



The Army's silver and white caravan, with its many displays and exhibits aroused much interest during its short stay here Monday.

Captain Everett L. Edwards, in charge of the Recruiting Service Caravan, spoke briefly on the advantages of an enlistment in the Regular Army. He stressed the fact, "that after income tax and other deductions were taken from civilian salaries, the family allotments, reenlistment bonuses, cost of clothing, food and shelter, medical care and cash payments, early retirement features — with good pay which the new Regular Army provides, makes the salary of the Army man compare favorably with many jobs in civilian life paying good salaries."

In his talk Captain Edwards stated, "No young man who can pass the Army examination need now yearn for a college education because he is unable to finance it. For those who enlist by October 6, 1946, the U. S. Government will now pay all expenses of a 48 month college course, including \$500 per year for tuition, books, etc., and \$65 per month for subsistence, after a three year enlistment in the Army."

"In addition to the advantages offered enlistees, their services are urgently needed to replace battle-worn veterans — to preserve the peace we have won at a cost of so many lives and billions of dollars."

Working in conjunction with and in charge of the Air Corps Sec-

tion of the unit was Major Fred B. Ersky, who was accompanied by Captain Gordon C. Cook, Engineering Officer in charge of exhibits, and Lt. John W. Balchunis, Air Corps, personnel and recruiting officer.

Major Ersky stated that, "In order to keep what we have gained in this war, it is necessary to maintain the finest, best trained, best equipped Air Force on earth. There are over 420 specialties in the Air Forces, including radar, television, electronics, jet propulsion and meteorology in which young men may receive training."

### Collier Says Business Demands All His Time

#### No New Candidates for City Post at Election Set for April 2

Mayor Albert Collier stated today that he would not be a candidate for re-election to the office he has held since last fall. He said that due to pressure of his own business he would not be able to accept the office, even if he were elected after friends and supporters placed his name on the ballot.

"It was understood when I accepted the office several months ago to fill an unexpired term, that I would not be a candidate for re-election to the office," Mayor Collier said.

"I appreciate the honor of the office and wish to thank the many citizens who have given their cooperation in efforts of the council to bring about improvements," he continued. "Due to the pressure of my own business through the expansion of oyster farming activities, I will be unable to serve after my term expires in April."

"I feel sure that there are others among us who can take over the reins of city government and do a better job."

S. B. Daggett and Arlie Shivers, alderman, are up for re-election. They are also filling out unexpired terms. Neither has made a statement whether they will be candidates for re-election.

### AN APPEAL . . . From Your Fire Dept.

Editor's Note: Following is an appeal issued to you, as a citizen of Rockport, from your Fire Department. No city has a more unselfish group than its volunteer firemen. These men give their time to studying and practicing methods of fighting fire to protect your homes, your loved ones, and your places of business. They do not get paid. In fact, they pay to belong to the department, and their money is also used in various ways to provide protection for you. These public-spirited firemen run the risk of injury, and even death, in their volunteer work. They ruin good clothes, and neglect their own business. All this to bring you protection and a sense of security in knowing they are on the job 24 hours a day — every day. Read the appeal of your Fire Department, and give them your assistance and co-operation.)

Last year the City of Rockport had a very sizeable increase in its insurance rates. Up to this year we had a 25 per cent credit on our fire insurance rates, but this year we are paying a 15 per cent penalty. That is a difference of 40 per cent.

What caused this increase? This could probably be answered by saying we had two bad fires — the boat house fire and the school house fire. Both of these fires were several years ago, but insurance rates are based on a 5-year period. We now have practically two years behind the boat house fire and have three years to redeem our lower rates for the next 5-year period. We are going to do everything in our power to lower this rate for the city. BUT (and this is no small matter) we are going to need HELP — and lots of it.

Last year the Fire Department spent \$599.64 for repairs, gas, oil and all expenses necessary to operate the department. Of this amount \$85.00 was donated to the department. The balance of this operating cost was met by the Volunteer Firemen themselves. We not only gave our time, and paid our dues to belong to the department, but we also got out and raised about \$800 — and this we were very glad to be able to do, and not have to ask for a donation.

This year we have more men in the department. Most of the men who were in the services have returned and are back taking an active part in the department.

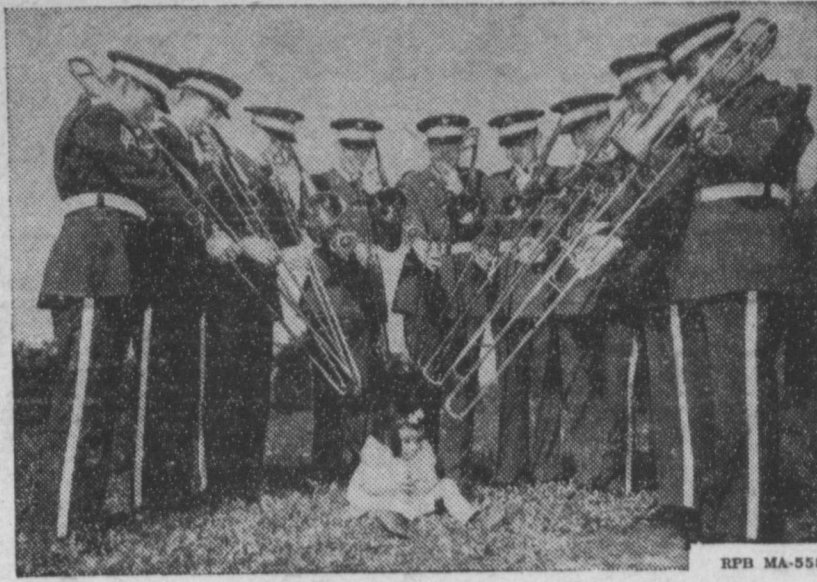

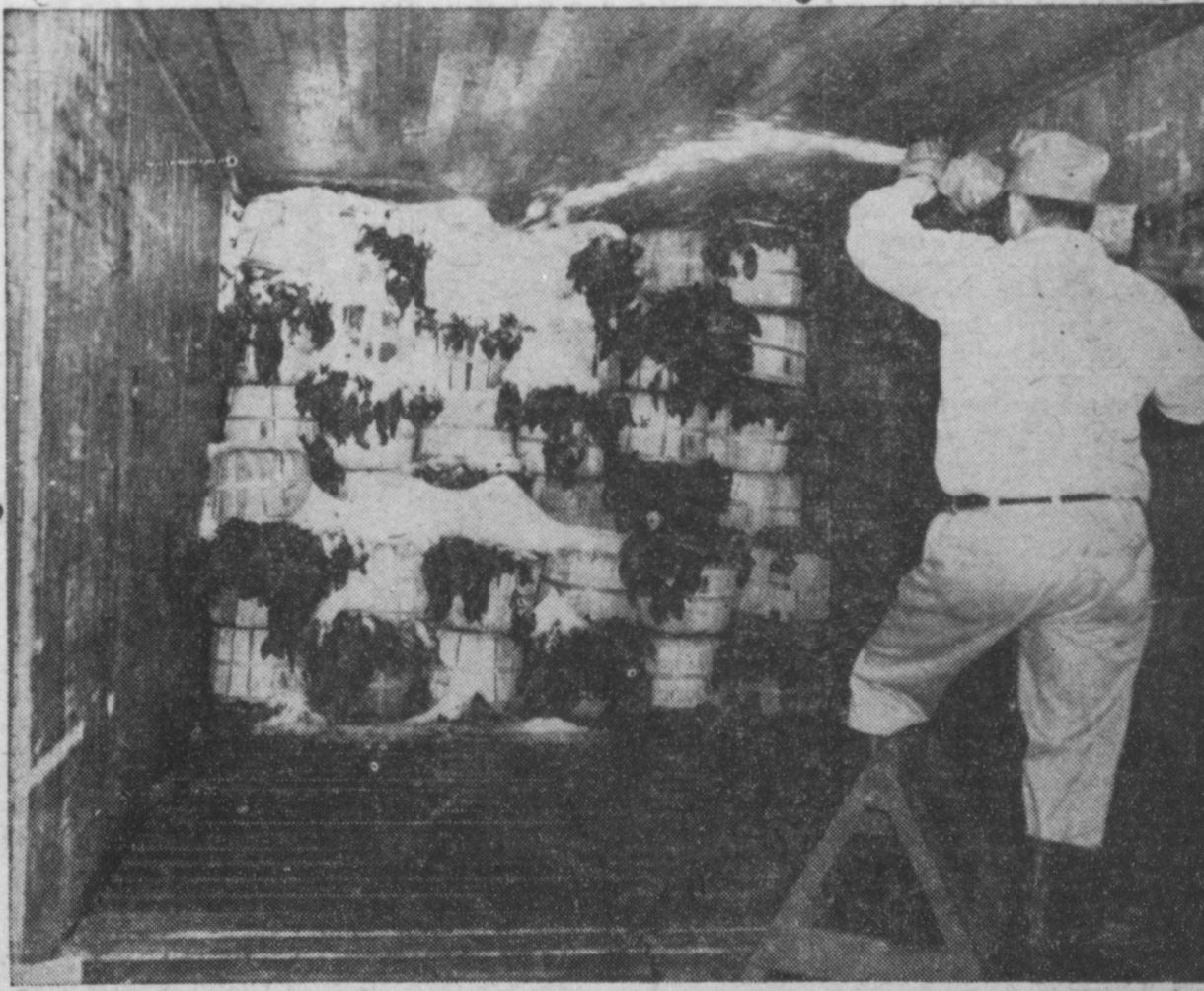

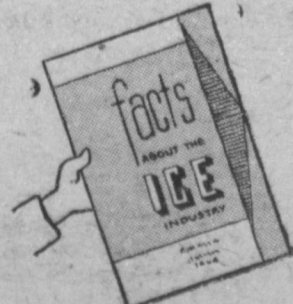

### Rockport Teachers Attend Meeting In Harlingen

Twelve teachers from the Rockport Schools, plus one trustee and his wife attended the South Texas Division of the Texas State Teachers association this past week end at Harlingen.

They heard such iminent speakers as Dr. Goslin, supt. of schools of Minneapolis, Minn., Dr. I. E. Stutsman, Supt. of San Antonio Public Schools, Dr. E. N. Jones, President of A. & I. College; Jeff Williams, humorist and philosopher from Oklahoma; and many others.

The theme for the entire program was built around Post war education, with emphasis on modern means of teaching and the wages of teachers.

"At your next convention, if I were you, I would assemble every business man I could muster, put them right down the middle row of seats, surround them with teachers, and tell them how little you are getting and ask them what they are going to do about it," said Jeff Williams of Oklahoma.

Dr. Goslin said that no more are teachers listening to the man on the street sympathizing with them and doing nothing about it. The teachers themselves are withdrawing from the profession — one that they originally chose as a "must" profession — because of the low pay.

Even those who have been suffocated financially for years and have given years to the profession are withdrawing and taking positions that earn them a living, he said.

The teachers went on a shopping tour of Matamoras during the short sessions on Friday. Administrators, homemaking teachers, and vocational teachers attend luncheons at various places throughout the city at noon Friday.

Principal Connolly from Harlingen was elected president for the ensuing year; H. L. Thormalien, supt. of county schools from Alice was elected vice-president; L. F. Cornell from Kingsville was elected permanent secretary. Morgan C. Wheeler was elected delegate from this area to the state conference next Thanksgiving.

Corpus Christi extended an invitation for the teachers to meet there for 1947.
