



Two New Homes Being Constructed

H. E. Hebison was issued a building permit at the city hall last week to construct a frame dwelling with 4 rooms and a bath on the south 18 feet of lot 15 and all of lot 16, block 62, S & W. The 24-foot by 28 foot home was estimated to cost about \$3,500.

Mrs. L. M. Bracht was given a permit to make an addition of a sun porch on her present home. The contractor is C. C. Fowled. The sun porch will be 15 by 20 feet and have frame flooring, with the outside or rock veneer and frame construction.
