



### **Administrative Cost Of** Social Security Is Low

The Social Security tax rate remains the same in 1952 as was last year, according to H. M. Cleveland, Manager of the Social Securit Administration in Corpus Christi.

Employees and their employer each pay 11/2% of wages, and the self-employed pay 21/4 % of their net earnings for social security. Under the old-age and survivors insurance provisions, the tax aplies to wages and net earnings up to \$3,600 a year.

When questioned about the finsystem, Cleveland explained that Social Security taxes have amounted to more than the benefits paid each year to date. In 1951, taxes amounting to \$3.4 billion were collected, and total benefit payments were \$1.9 billion.


