Deep Test Slated to 7,500 Ft.

An Aransas County wildcat three miles northwest of Rockport yesterday was rigging up preparatory to beginning operations on a 7,500-foot test.

Selby-Walker Corp. and Joseph T. Dawson No. 1 Travis Bailey is 467 feet from the south and 2,280 feet from the westerly east line of the 800-acre lease in Joseph Fessenden Survey, A-65. A Selby-Walker rig will drill the test.

A. O. Phillips and others No. 1 L. E. Sanders, wildcat in the Fulton Township, was coring for the "E" series Sand from 7,681-86 feet. Setting pipe was doubtful if good shows are not encountered in this section.

Earlier the test showed salt water in the "B" and "C" Sands. Test in the top of the B-2 Sands, from 7,104-23 feet yielded gas and distillate. Location is 210 feet west of Highway 35.

Phillips Petroleum Co. No. 1 Lamar (Preston Paul and others), wildcat eight miles north of Rockport, was drilling at 10,030 feet. This test is in State Tract 36 in M. Hunt Survey, A-79.

Humble Oil and Refining Co. No. 1 Aransas Bay State Tract 116, wildcat six miles northeast of Rockport, was drilling in shale at 8,500 feet on a 10,000-foot permit.

Western Natural Gas Co. No. 22 St. Charles Ranch Co., in Black-jack Field, will be 780 feet from the north line and 5,300 feet from the east line of Aransas County School Land Survey, A-5. Permit depth is 11,500 feet.

Sun Oil Co. has staked three projected 10,500-foot Lamar Field tests.

The firm's No. 1 Aransas State Tract 68 will be 660 feet from the south and west lines of Tract 68 in Aransas Bay Subdivision.

In the same tract, Sun's No. 2 Aransas State Tract 68 will be 660 feet from the south and east lines of the tract.

Sun Oil Co. No. 1 Aransas Bay State Tract 77 will be 660 feet from the north and west lines of State Tract 77 in Aransas Bay Subdivision.

Western Natural Gas Co. No. 1 St. Charles Bay State Tract 373, Aransas County wildcat six miles northeast of Lamar, ran log and set 9 1/2-inch casing at 7,540 feet. Permit depth is 11,500 feet.

LEST WE FORGET

This Saturday, as on one day of each May, the brightly colored, red poppy of America's veterans, will be offered to the public and will honor those who wear it.

Made by handicapped and disabled men, these small artificial flowers are created partly as a means of earning a livelihood, and partly to maintain the national home for orphaned children of this nation's fighting men.

Over the entire country on Saturday, Boy and Girl Scouts, volunteer workers, ladies auxiliaries and members of the Veterans of Foreign Wars will offer an emblem which in fullest measure, represents big heartedness, remembrance and understanding.

None of those who give their time and energies to distributing the flowers will in any way personally benefit; except of course in the knowledge of having helped at something worthwhile. Neither will any part of the money received locally be spent anywhere but at home. The flowers have already been paid for by Rockport Stewart-Wendell Post of the V.F.W. and all money from this sale will not be placed in a relief fund which cannot be used for any other purpose.

Should a veteran become ill, hurt, or die, the sale of poppies makes it possible for the local Post to meet some of the immediate obligations which misfortune usually entails. Ambulance service can be supplied, children cared for if needed, burial expenses met, or the veteran's home held together until other arrangements can be made. The relief fund is instantly available for distressed veterans or their families.

Although the community as a whole is seldom aware of it, misfortune of some kind occurs almost constantly. In Rockport and Aransas County last year there were about twenty cases in which the relief fund had to be drawn on to alleviate human suffering. The sale of Buddy Poppies made this relief possible.

CANDIDATES MUST MAKE FINANCIAL STATEMENTS

All candidates for public office are required (Chap. 13, Section 244, Texas Election Laws) to file a sworn statement of all gifts, loans, payments made to him and all debts incurred by such candidate at intervals of 20 days, beginning 60 days next preceding the date of the election.

The first statement of campaign expenses, receipts and expenditures, is due on May 27, 1952. Later sworn statements will be due June 16, 1952, July 6, 1952, and July 21, 1952.

All candidates must file these statements on or before the date specified with Jas. C. Herring, county clerk. Forms can be obtained in the office of the county clerk.

Sheriff's Department Reports Misdemeanors in Aransas County

On Thursday, May 15, Sheriff Arley Shivers and Deputy Sherman Mundine were called to Corpus Christi to pick up H. R. Wood, whom the Corpus Christi police had arrested on suspicion of giving eight hot checks in Aransas Pass. Shivers and Mundine returned him to Rockport and he was tried in county court and his bond set at \$1,000, which he has not made and is being held in the county jail.

On Monday, May 19, a cafe on the turning basin in Aransas Pass was broken into by two boys. The night watchman saw them and while he was calling the officers the boys ran away. He remembered their appearance and Tuesday morning they were arrested. One of the boys was an 18-year-old who was out on a five year parole from Montgomery County; the other boy was only 14 years old. This crime was also in Aransas County and Sheriff Shivers and Deputy Mundine returned them to Rockport and filed burglary charges against the older boy. The case will be tried in juvenile court.

Saturday evening the Highway Patrol arrested Richard Hessong of Fulton, and charged him with driving while intoxicated. He was fined \$50 and \$21 cost. His drivers license was suspended for six months.



PLUMBING ORDINANCE

AN ORDINANCE PROVIDING FOR THE FURNISHING OF INDEMNITY BONDS OR PERSONAL BOND BY ANY PERSON OR FIRM. THE MANNER AND WAY IN WHICH PLUMBING WORK SHALL BE DONE. THE KIND AND CLASS OF MATERIAL TO BE USED IN SUCH WORK PROVIDING FOR THE INSPECTOR OF PLUMBING, COMPELLING BUILDING UNDER CERTAIN CONDITIONS TO BE CONNECTED WITH PUBLIC SEWER AND PRESCRIBING PENALTIES FOR VIOLATION OF ANY OF THE PROVISIONS OF THIS ORDINANCE, REPEALING ALL ORDINANCES, AND PARTS OF ORDINANCES IN CONFLICT HERewith AND DECLARING AN EMERGENCY.

Be it ordained by the City Government of the City of Rockport, Texas, as follows:

Section 1
Each person or firm shall before engaging in the plumbing and gas fitting business execute to the City of Rockport, Texas, a good and sufficient bond in the sum of one thousand dollars conditioned to protect said City against all loss or damage occasioned by the negligence of the principal therein failing to properly execute and protect all work done by himself or under his supervision in any way whatsoever and further conditioned to observe and see all ordinances at any time enacted by said City relating to plumbing and gas fitting work. Said bond must be approved by the City Commission and shall run for a period of not less than one year and no plumber or other person shall do any plumbing or gas fitting work in the City of Rockport, Texas, unless he has executed such bond and the same has been approved by the City Commission.

Section 2
The inspector shall give the owner or inspector in charge of any building written notice of any defect in his or his principals plumbing, or changes or repairs necessary and such owner or agent shall within five days after such notice have made the necessary changes or repairs.

Section 3
The inspector shall be appointed by the City Commission. The Master plumber or Journeyman plumber shall pay the inspector of plumbing as inspection fees on the following basis: \$1.00 each for the first four fixtures and 50c for all over four fixtures and in no case shall the charge be for less than \$1.00, and \$1.00 for each inspection of a gas system. It shall be the duty of the inspector to inspect and pass upon all plumbing, to keep a record of all plumbing that has been installed and give the written notice provided in Section 2 of this ordinance, and for the purpose of inspection of any such plumbing said inspector shall have the right to enter any house or premises in the city at any time between the hours of 9:00 a. m. and 5:00 p. m. It shall be the duty of the inspector to investigate all alleged violations of the Plumbing Ordinance of the City of Rockport, Texas, and to file complaints where necessary.

Section 4
No plumbing work shall be covered or concealed until it has been accepted by the City inspector after inspection, which inspection shall be by inspector one day after he has received notice that the work is complete.

Section 5
The plumber in charge of any work shall be held responsible for the condition and completion of said work according to the ordinance and regulations governing plumbing and gas fitting in the City of Rockport, Texas.

Section 6
No person shall make any connection with or opening into any public or private sewer, nor lay any drains, nor do any plumbing within the City of Rockport, Texas, without first having procured a permit for the particular job of work to be done, from the inspector of plumbing and drainage of said City and the inspector of plumbing shall issue permits only after an application for same is made by the plumber.

Section 7
No person shall repair any plumbing work or make any extensions to plumbing or change the location of any fixture except, as hereinafter provided, until he has made application hereof and received a permit to do same from the inspector of plumbing describing the character of the plumbing work or repairing proposed to be

done, together with the number and name of plumbing fixtures to be repaired or put in providing that no application need be made and no permit issued for repairs of leaks in pipes, traps, drains, or cocks or opening of waste or supply pipes or replacing broken fixtures. No drain line shall be permitted to be installed in a clean-out opening unless a provision is made for the replacement of the clean-out opening.

Section 8
Permits to make connection with the sewer system will be issued only when the plumbing in the house or building to be connected is in accordance with the rules for plumbing herein prescribed and has been inspected and approved by the inspector of plumbing.

Section 9
All material used in the work of plumbing and drainage must be of good quality and free from defect. All work must be done in workmanship-like manner. When the soil waste and vent pipe within the building are in place, connected to the traps, and when such traps are below floor level, before being covered or concealed, they shall be filled with water to the top of highest fixture. If leaks are indicated, they shall be corrected by the contracting plumber and retested.

Section 10
All horizontal drains within the walls of the building shall not be less than 1 1/4 inches in diameter and shall be readily accessible for inspection while building. The house drain and soil and waste pipe shall have a fall of at least one-tenth of an inch to the foot in length and shall be provided with opening for cleaning purposes, which opening shall be closed with brass screw plugs and line extended through wall when clean-out is within 24 inches of wall.

Section 11
The house drain must be laid in a straight line, if possible. All changes in directions where changes are absolutely necessary shall be made with 1/4 bends or long sweeps or combination Y's and 1/2 bends or sanitary tee provided with clean-out plug.

Section 12
No rainwater or down spout pipe, steam boiler pipe or other pipe to convey or used to convey water or other substance of like character except necessary to plumbing system shall be connected to any sanitary sewer of the City of Rockport, Texas, except upon order of the City's official inspector of plumbing for the City of Rockport, Texas.

Section 13
Each building where four fixtures are installed must be provided with at least one three inch waste or vent stack and each branch of twenty feet or more in length within the building, same shall extend 1/2 size and bore of main stack through the roof, or brought back 1/2 size and connected into the main stack, all vents must not be more than 1/4 inch smaller in size than fixture outlet, except shower and tub baths which may be vented with 1 1/4 inch galvanized steel pipe, copper pipe, or galvanized wrought iron pipe. Lavatories and sinks must be serviced with lead arm, wiped on brass nipple or bushing, galvanized wrought iron pipe, copper pipe and fitting, or brass pipe and fitting. No lavatory or sink service shall be more than 48 inches from vent or waste stack. Showers and tub baths shall not be more than 60 inches from vent or waste stack. Vent to be cast iron or galvanized pipe, galvanized wrought iron pipe or copper pipe permissible above top drain connection.

Section 14
Where revent pipe is connected into main stack, it shall be at a point one foot or more above the highest fixture.

Section 15
No continuous revent shall be placed more than 48 inches from trap it serves and the center outlet between waste and outlet shall not be set below water seal of trap. All closets revented in the rough must have revent as close to floor line as possible and in no case shall a waste enter above the revent opening, should have a water seal trap placed as close to fixture as possible. Stack, vent and revent pipes shall extend through roofs and openings in roof shall be flashed with lead flashings. All drains must be the best quality of vitrified 4-inch clay pipe of the bell and spigot type or orangeburg pipe with swedge couplings. Pipe must be laid to a good grade without sag so as to drain quickly and completely. No drains shall be less than two percent if obtainable. All joints shall be well sealed with an approved type of sewer compound approved by the City of Rockport, Texas. Vitrified clay pipe can be used where it is at least six inches underground. Standard cast iron pipe can be used where it is less than 6 inches underground, such pipe shall be calked with molten lead and oakum. Only cast iron pipe shall be used under or in buildings for drains except as specified in Section 13, and must extend 12 inches outside of building.

Section 16
All water closets shall be set on

4 inch lead and iron ferrules except on concrete slab construction where cast iron closet flange may be used or brass closet flange soldered to lead and iron ferrule, except in two or more story construction where lead bends shall be used. Tub bath drains when trapped with 2 inch cast iron 'P' traps shall be connected with 2x 1 1/2 inch lead and iron ferrule soldered to lead ferrule on outlet of tub.

Section 17
No trapped plumbing shall be located in any room or apartment which is not properly ventilated.

Section 18
Every building in which plumbing fixtures are installed shall have a soil or waste stack, or stacks extending full size through the roof. Soil and waste stacks shall be as direct as possible and free from sharp angles and turns. No water closet shall discharge in a waste or drain line stack less than 3 inches in diameter.

Section 19
There shall be at least one clean-out plug in the house drain, at or near the base of the stack. The clean-out plug shall be the same size as pipes. All clean-out plugs shall be installed in cast iron clean-out tees, same size as stack. All vents installed in house waste line must be installed in sanitary tees or combination Y's and 1/2 bends.

Section 20
It shall be the duty of the plumber to notify the inspector of plumbing when work is ready for inspection and to make sure work will stand the test before giving the above notification. If the work will not stand the test the plumber shall renotify as above, and pay the sum of one dollar for each renotification. The equipment and labor necessary for the inspection and test shall be furnished by the plumber.

Section 21
All calked joints shall be firmly packed with oakum, shall be se-

cured only with pure lead, not less than one inch deep, when calked, no paint, varnish or putty will be permitted until after the joint is tested.

Section 22
Slip joints will be permitted only in trap seals or on the outlet side of trap.

Section 23
Bath tubs shall be trapped with cast iron 'P' traps on ground floors and lead 'P' traps, brass 'P' traps, or copper 'P' traps on second floors or other stories above second floor. All fixtures shall be trapped with 'P' traps and no 'S' traps shall be used unless it is an impossibility to trap fixture with a 'P' trap, and permission for use of 'S' trap shall be required from the inspector of plumbing for the City of Rockport, Texas.

Section 24
Where sewers have been connected all fixtures of the street disturbed must be restored to their former condition. The street must be filled as soon as possible after making connections or repairs. And in case it should be necessary to leave a trench open, the public shall be warned by red lights at night, and other proper means in the day time.

Section 25
The city inspector of plumbing shall at all times have the right to close up or disconnect from the public sewer any private, business or home sewer which has not complied with the Plumbing Ordinance of the City of Rockport, Texas.

Section 26
It shall be unlawful for any person or persons, to obstruct or in any way injure any of the pipes, drains, works or machinery belonging to or connected with any system of sanitary sewerage owned, used or operated in the City of Rockport, Texas, or to place or drop, or throw any substance whatsoever into any sink, water closet, bath tub, vessel, drain or other

receptacle belonging to or connected with any system of sanitary sewerage, owned, and used or operated in the City of Rockport, Texas, which may obstruct or injure same.

Section 27
That any person, firm, or association, or corporation who shall fail to comply with or violates any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any sum not less than five dollars nor more than fifty dollars. Each day constitutes a separate offense.

Section 28
All septic tanks in the City of Rockport, Texas must be of a type and size of an approved manufacturer or concrete septic tanks (built). They shall be of a type and size approved by the inspector of plumbing of the City of Rockport, Texas. And in no case shall a permanent septic tank be installed with a working capacity of less than 250 gallons. The only exception being for a trailer house which may use a smaller septic tank.

Section 29
It shall be unlawful for any person or persons to install or repair a septic tank or cesspool or to relay any drain lines from a septic tank or cesspool where such septic tank or cesspool is situated within reach of available sewer.

Section 30
All gas piping in private homes or businesses shall be tested with not less than ten pounds of air pressure and gas lines and gauge used shall be inspected and checked by the plumbing inspector of the City of Rockport, Texas. All gas openings within a building shall be provided with a stop-cock. All cook stoves and ranges shall be connected with rigid pipe or copper tubing of a size corresponding with that of the service line to which it is connected.

Section 31
All hot water heaters and boilers

installed must be provided with a pressure valve and temperature relief. All hot water heaters must be vented above roof and flashed with a galvanized flashing and rain cap and no 90° turns will be allowed in any heater vent whatsoever. All wall heaters and floor furnaces of the vented type shall be vented through the roof and flashed with a suitable flashing and rain proof.

Section 32
The following acts, work, and conduct shall be expressly permitted: (a) Plumbing work done by a property owner in a building owned or occupied by him as his home; provided however, that all such plumbing work, gas fitting and sewer installation and work, together with all such material and supplies used in connection therewith shall be subject to inspection and approval in accordance with the terms of this ordinance.

Section 33
All water service to a private home or business shall have a stop and waste valve installed in water lines. All hot water heaters shall have a valve on cold water inlet line.

Section 34
The inspector of plumbing and drainage shall have the right to make any change in material and style of work he thinks necessary for the better completion of the

work.


Area Humble Stations Will Celebrate Welcome Week May 23-30



New Book Reviewed By Mrs. Jack Hagar

Mrs. Jack Hagar has just completed reviewing George Williams' new book, "The Blind Bull."

In "The Blind Bull", George Williams gives us a very strong picture of Clem Sweeney's struggle with life, the struggle always against great odds.

The book is easy to read, the grammar beautiful, the description of nature on the Gulf Coast poetical, and the sequence most unusual.

The locals of Aransas Pass, Rockport and Houston fill most of the book, but the Island of Saipan is focal point from which the major's (Clem Sweeney) story is told.

Life as he sees and feels it, life as it touches the friends and families he knows, life as the Mexicans and fishermen know it, the gulf hurricane, the ambition of Clem's wife, the hurt he endures but never understands, a deep book, for adult readers only. Language you may not admire at times, but language whose meaning you will understand.

The book does not try to solve any of Clem's problems, each reader is left free to make his own solution.

George Williams is an English instructor in The Rice Institute, Houston, and has been most successful in teaching creative writing. Two text books by Mr. Williams are used extensively.


