cuses. Conviction not only means loss of money and time but carries the stigma of being on a permanent criminal docket of the Court in which tried. An outline of the law in question

follows herein, and it is suggested that those involved read it carefully:

· "It shall be unlawful for any person, firm, corporation, association, town, city or other political subdivision of this State, or any agent, officer, employee representative of any person, firm, corporation, association, town, city or other political subdivision of this State to pollute any public body of surface water of this State. "Pollute" is hereby defined to

be the throwing, discharging or otherwise permitting to reach or be introduced into any public body of surface water of this State any substance, material or thing in such quantity that the said water is thereby rendered unfit for one or more of the beneficial uses for which such water was fit or suitable prior to the introduction of such substance, material or thing, or is thereby rendered harmful to public health, game birds or game animals, fish or other edible aquatic animals, or endangers any wharf, or endangers or hinders the operation of any boat, or renders insanitary
