Lake managed access on February 1

Both gates up and ready

WINTERS - The gates on both ends of the Elm Creek Reservoir are up and ready, and the managed access to the Winters lake will start on February 1; from that date on anybody wanting to enter the lake premises will have to register and have a valid password.

According to the ordinance approved by the City Council last year, the Police Department built two gates, one is located at the East entrance of the lake, and at the other one, considered the main entrance, by the spillway on the West side.

The gates are already in place but will remain unlocked until the whole community is aware of the new access regulations. The gates are made of steel pipe, mainly donated to the city, labor was provided entirely by the Winters Police Department, and the total cost of the project was about \$2500.

The managed access program was approved on October 4, 2010, as a way to

face the dumping, reckless shooting and illegal hunting reported at the Elm Creek Reservoir.

"This measure will help the Winters community to balance a great asset between the groups that look forward to ban all hunting activity, and those who see the Winters lake as a hunting ground," said Winters Police Chief Nathan Johnson.

"The gates will help the people in Winters to become good stewards of their natural resources."

Discussion for this issue has been carried in several City Council meetings, focused on the details of the managed access to the lake premises.

According to the new ordinance the City will issue daily, yearly or special permits for the lake premises, and the hunters will have to register with the Winters Police Department in order to gain access to the lake.

Year round passwords or keys will be provided to law enforcement and Fire Department.

Neighbors complain about hunting dangers

WINTERS - To have an open season at the Winters lake still represents a danger to the neighbors and fauna, because of reckless hunters and others disturbing the roosting of locally protected species, according to Winters lake neighbors.

James and Karen Pair, landowners of the Northwest side of the lake, said that dove and duck hunting, as well as activities related to the waterfowl such as boating, discourage the sandhill crane from roosting in the north end of the Winters lake and endanger people around lake premises.

According to James when boats sail around looking for ducks other species get

The Ballinger Young Farmers hosted the noon and evening meal on Friday, and the Runnels County Junior Livestock Show Association hosted the noon meal on Saturday prepared by Atmos Energy.

With donors from all area and out of town participating, the show is one of the biggest fundraisers for the Runnels County youth year round. Proceeds help them earn money for their projects and scholarships for their future education.

ANIMAL CONTROL - PART VI

Article 822.041. of the Texas Health and Safety Code defines "Dangerous dog" as a dog that:

(A) makes an unprovoked attack on a person that causes bodily injury and occurs in a place other than an enclosure in which the dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own; or

(B) commits unprovoked acts in a place other than an enclosure in which the

dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own and those acts cause a person to reasonably believe that the dog will attack and cause bodily injury to that person.

If a dog owner is deemed to have a "Dangerous Dog", the code requires the owner to do the following within 30 days:

(1) register the dangerous dog with the animal

control authority for the area in which the dog is kept;

(2) restrain the dangerous dog at all times on a leash in the immediate control of a

person or in a secure enclosure;

(3) obtain liability insurance coverage or show financial responsibility in an amount of at least \$100,000 to cover damages resulting from an

attack by the dangerous dog causing bodily injury to a person and provide proof of the required liability insurance coverage or financial responsibility to the animal control authority for the area in which the dog is kept; and

If an owner of a dangerous dog does not comply with the code within the time allowed, they must turn the dog over to the animal control authority. If the owner refuses to comply, a judge will order the animal seized, impounded, and potentially destroyed, all of which the dog owner must pay for.

The Texas Health and Safety Code (Section 822.044. Attack by Dangerous Dog) also cre-

ates criminal penalties for the owners of "Dangerous Dogs" if their dog makes an unprovoked attack outside the dog's enclosure that injures another.

Section 822.045 creates an enhanced criminal penalty for owners who have been previously charged and convicted of a violation of the rules for keeping a dangerous dog. These penalties can mean up to 6 months in jail.

I want to reiterate how important it is for pet owners to take responsibility for the dogs in their control. This includes getting the appropriate vaccinations, registering the animal with the city, and insuring the animals are kept in a secure enclosure or properly restrained, so they do not roam at-large within the community.

Be aware that an owner may be issued a citation for an animal running at large if the animal is observed by an officer or if there is reliable testimony from witnesses or photographs of the dog running at large in a public place or on another citizen's private property.

The dog does not have to be impounded for the owner to receive a citation / ticket.

By preventing dogs from roaming at large, the laws are also meant to keep people and the animals themselves safe. Individuals are less likely to be bitten and/or attacked by animals that are leashed / confined and closely supervised by their caretakers.

Citizens can assist us in our efforts by taking a photograph of dogs running at large. Photographs with a date and time or a statement from the person who observed the animal greatly assist in helping police to resolve the issue. We can often find where the dog belongs, but photographs of the dog running at large help reinforce to the owner the need to keep the dog confined.

We ask for your support and assistance as we address these issues in our community.

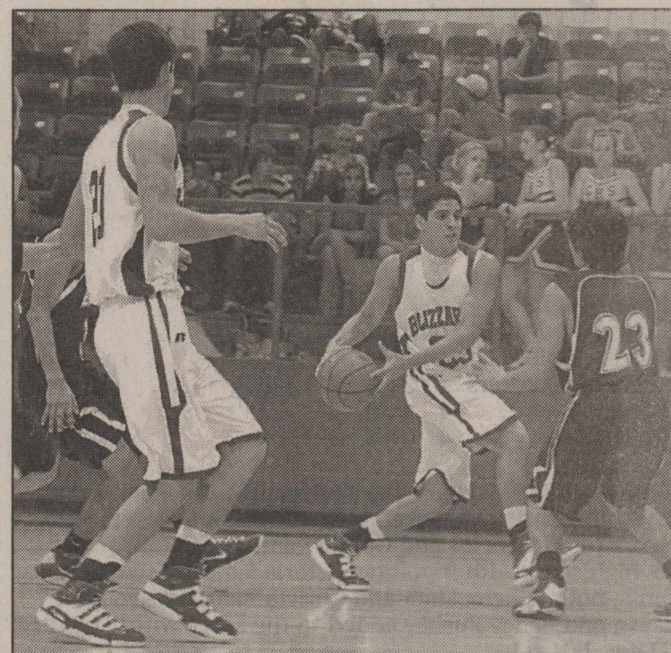

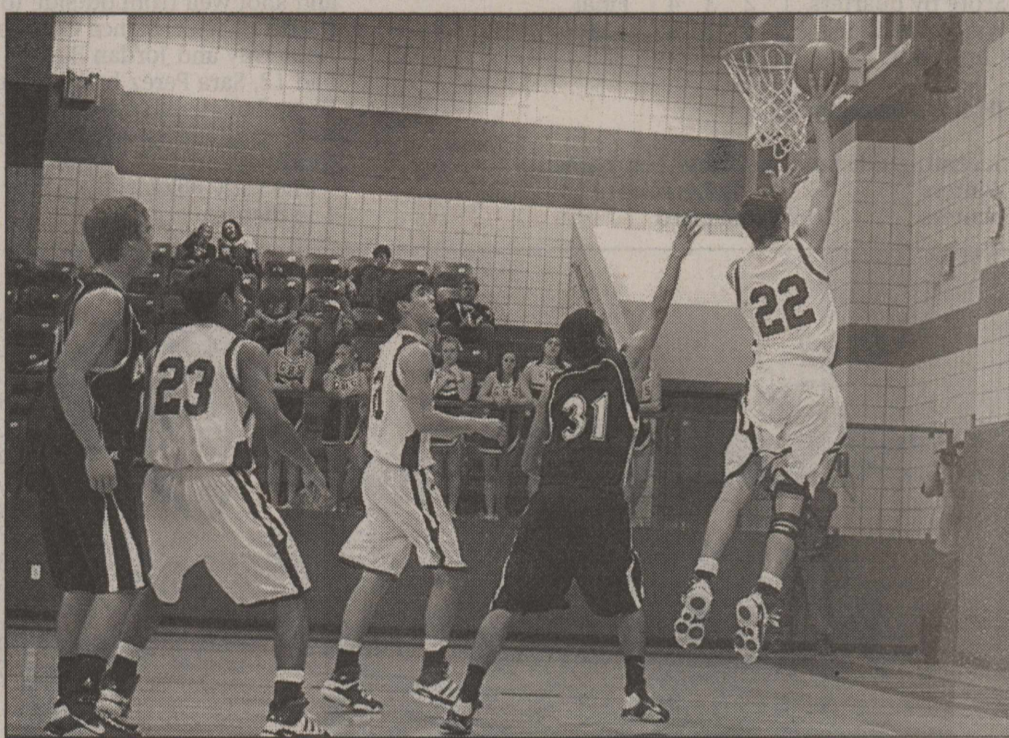

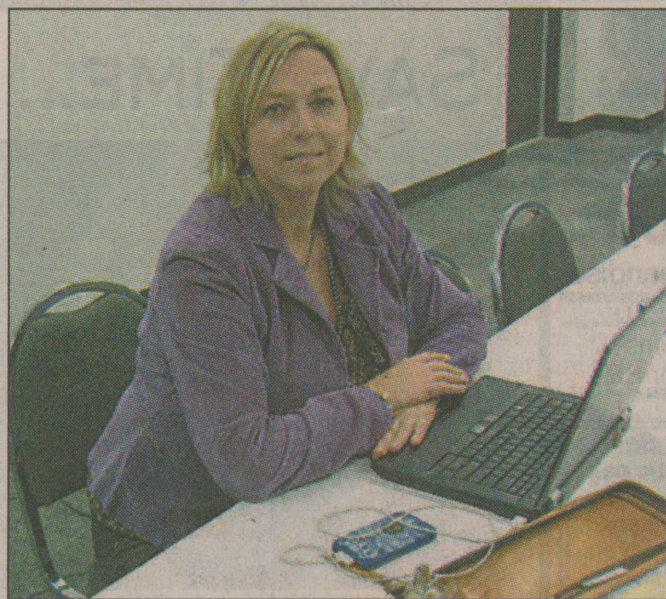

Weekly migratory bird hunting report

Weekly migratory bird hunting reports are posted from early September through early February.

High Plains Mallard Management Unit: Excellent decoying action for Canada geese has been reported throughout the week. Some outfitters have said the past week was the best decoying of the season. Best hunts have come over corn and wheat. More snow geese have been cooperative lately. Larger Canada geese have moved in to Texas with freezing temperatures to the north, and more are expected with snow in the forecast. Duck hunting has been solid in the Panhandle, but few hunters have taken advantage. Better duck hunts have come around Lubbock and Knox City. Duck season runs through Jan. 23. The West Zone goose season runs through Feb. 6. Prospects are good.

North Zone Duck: The region received needed rain over the past few weeks that helped hunting in backwater sloughs and bayous. Wood ducks continue to impress across the region. Divers, including scaup, ringed-necks, canvasbacks and a few goldeneyes, have been solid on Lake Fork, Lake O'Pines, Caddo Lake, Toledo Bend and Sam Rayburn. Mallard action has improved around Palestine, Fairfield, Marshall, Longview and Texarkana. Good hunts for woodies and mallards have been enjoyed near Franklin and Centerville. Prairie ponds near the coast have been fair at best. The season runs through Jan. 23. Prospects are fair to good.

disturbed and pay the price, looking for a better place to roost.

"This year we don't have any cranes roosting here, it could be because the water level is too low or maybe because of the hunters, but once these birds leave a roost it is very difficult to bring them back," said Pair.

After several modifications to the hunting ordinance, ranging from a total ban to waterfowl, and to ducks and doves only, some incidents have been reported. Among those incidents is the shooting of a cow with a shotgun, last summer, which made a cattleman take his cattle off the lake lease.

The Pairs considered that the City should look forward to advertise the lake as a bird watching place, a more revenue generating and nature friendly business dollar by dollar.

Teenagers reported missing in Ballinger

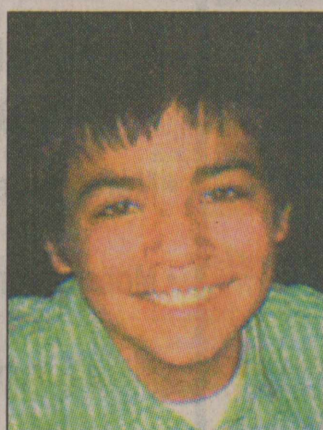

WINTERS – Two teenagers went missing last Friday night in Ballinger, in what officials believe to be a runaway case. The City Police Department and Runnels County Sheriff's Department are investigating several leads that point to the couple running away together.

Samantha Robin Cavazos and Khodie Garza are both 14-years-old, and were reported missing at 3:30 a.m. on Saturday, January 15. Law enforcement officials started the search at that time.

According to Ballinger Sergeant Mark McNulty, the missing person report doesn't have the characteristics of an abduction case.

Students and parents in social networks over the Internet compared the case with Hailey Dunn, the teen missing in Colorado City three weeks ago, but according to city officials no evidence has been found in Ballinger that can lead to authorities to an abduction case.
