BRIEF EXPLANATORY STATEMENTS OF PROPOSED

CONSTITUTIONAL AMENDMENTS **GENERAL ELECTION NOVEMBER 6, 1984**

PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 29 proposes a constitutional amendment that provides to state-chartered banks the same rights and privileges that are or may be granted to national banks of the United States domiciled in this state. For example, if national banks become authorized to maintain branch offices, this amendment would extend the same privilege to state banks.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide state banks the same rights and privileges as national banks."

PROPOSITION NO. 2

ON THE BALLOT House Joint Resolution 19 proposes a constitutional amendment that restructures the Permanent University Fund to provide: (1) for the expansion of the institutions eligible to participate in the bonding capacity of the fund to include the components of The University of Texas and Texas A&M University systems that have been added to those two systems of higher education since the Permanent University Fund was last restructured by constitutional amendment; (2) for the expansion of the purposes for which bond proceeds can be expended from new construction to include major repair and rehabilitation projects and the acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials; (3) for an increase in the bonding capacity from 20% (% for The University of Texas System and 1/3 for the Texas A&M University System) to 30% (20% for The University of Texas System and 10% for Texas A&M University System) of the value of the assets (exclusive of real estate) in the Permanent University Fund in order to provide sufficient bond proceeds to care for the addition of 10 new institutions to those authorized to participate in the Permanent University Fund bonding program and to care for the expanded purposes for which the bond proceeds can be spent; and (4) for the dedication of the dividends, interest, and other income from the Permanent University Fund remaining after payment of principal and interest due on bonds and notes issued, to the provision of support and maintenance (over and above normal legislative appropriations) for Texas A&M University in Brazos County, Prairie View A&M University, and

The University of Texas at Austin. House Joint Resolution 19 also annually appropriates \$100 million in each fiscal year, beginning September 1, 1985 (from the first money oming into the state treasury that is not otherwise appropriated by the spouses and dependent children of

education which are not included in The University of Texas or Texas A&M University Systems and, therefore, not eligible to participate in the Permanent University Fund bonding program. The amount of this appropriation could be adjusted every five years by a 3 vote of the Legislature, but could not be adjusted in such a way as to affect outstanding bonding indebtedness. Each institution of higher education that is eligible to participate (i.e., those institutions of higher education outside The University of Texas and Texas A&M University Systems) would be authorized to expend directly its share (such share to be determined pursuant to an equitable formula) of the \$100 million appropriation for the purposes of acquiring land, constructing and equipping buildings or other permanent improvements, major repair and rehabilitation of other permanent buildings or improvements, and acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials. Additionally, each institution would be authorized to issue bonds backed by a pledge of up to 50% of its share of the \$100 million annual appropriation for the purpose of land acquisition, new construction, and major repair and rehabilitation

projects. Except in the case of fire or natural disaster and in other extraordinary cases, verified by a twothirds vote of each house of the legislature, all institutions of higher education would be precluded from receiving appropriations of general revenue funds for the purposes of land acquisition, new construction, and major repair and rehabilitation projects.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to create from general revenue a special higher education assistance fund for construction and related activities, to restructure the Permanent University Fund, and to increase the number of institutions eligible to benefit from the Permanent University

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 65 proposes a constitutional amendment which authorizes the legislature to provide for the payment of assistance to the surviving dependent parents, brothers, and sisters of officers, employees and agents of the state or its political subdivisions, including members of organized volunteer fire departments and members of organized police reserve or auxiliary units authorized to make arrests, who die in the course of performing hazardous official duties. are already authorized by the Constitution. The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for payment of assistance to the surviving dependent parents, brothers, and sisters of certain public servants killed while on

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 20 proposes a constitutional amendment which abolishes the office of county treasurer in Bexar and Collin counties if a majority of the voters in each of those counties vote in favor of abolishing the office of county treasurer in a local election to be held on the issue. All the powers, duties, and functions of the office of county treasurer in each of these counties would be transferred to the county clerk.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to abolish the office of county treasurer in Bexar and Collin counties.'

PROPOSITION NO. 5 ON THE BALLOT

Senate Joint Resolution 22 proposes a constitutional amendment which provides a new method of filling a vacancy in the office of Lieutenant Governor. The amendment requires the President pro tempore of the Senate to call together the committee of the whole Senate within 30 days after a vacancy occurs in the office of Lieutenant Governor. The committee would be required to elect one of its members to perform the duties of the Lieutenant Governor until the next general election. This individual would continue his duties as Senator at the same time that he performs the Lieutenant Governor's duties. If the Senator who is elected ceases to be a Senator before the next general election, another Senator must be elected according to the above procedure to perform the Lieutenant Governor's duties. The President pro tempore would be required to perform the Lieutenant Governor's duties pending the election of one of its members by the committee of the whole Senate.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the state senate to fill a vacancy in the office of lieutenant governor."

PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that permits the use of public funds and credit for payment of premiums on non-assessable life, health, or accident insurance policies and annuity contracts issued by a mutual insurance company authorized to do business in this state. The constitutional prohibition against a grant of public money to an individual, association, or corporation or against becoming a stockholder in a corporation, association, or comgroup policies of political subdivisions to non-mutual insurance companies. The amendment would permit mutual insurance companies to bid for those policies.

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 4 pro poses a constitutional amendment to change the membership of the State Commission on Judicial Conduct to include one Judge of a Municipal Court and one Judge of a County Court at Law, who shall be selected at large and appointed by the Supreme Court with the advice and consent of the Senate.

The amendment also provides additional grounds for removal from office of judges or justices of Texas courts, and provides additional disciplinary actions that could be taken in lieu of removal or censure. The amendment would extend the Commission's disciplinary authority to masters, magistrates, and retired or former judges who hear cases by designation. The amendment creates a tribunal to review recommendations of the State Commission on Judicial Conduct for removal or retirement of a judge or justice. The review tribunal would be composed of seven (7) Justices or Judges of the Courts of Appeals selected by lot by the Chief Justice of the Supreme Court. The amendment also provides for appeal of the review tribunal's decision to the Supreme Court of Texas and grants an accused judge the right to discovery of evidence.

The proposition will appear or the ballot as follows: The constitutional amendment relating to the membership of the State Commission on Judicial Conduct and the authority and procedure to discipline active judges, certain retired and former judges and certain masters and magistrates of the courts."

PROPOSITION NO. 8 ON THE BALLOT

House Joint Resolution 22 proposes a constitutional amendment which increases the per diem of members of the Legislature. The amount of per diem allowed during a calendar year would be equal to the maximum amount set in federal income tax statutes as of January 1 of that same year as a deduction for ordinary and necessary business expenses incurred by a state legislator. Current per diem is \$30; the maximum deduction is now \$75.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide a per diem for members of the legislature equal to the maximum daily amount allowed by federal law as a deduction for ordinary and necessary business expenses incurred by a state legislator."

prepared seedbed to get good fall If a sod seeder is used, wait until growth, says Dr. Sim A. Reeves, Jr. about October 1 to plant in order to Good fall growth gives a head-start reduce competition from warm season grasses. Competition can choke out the small seedlings if temperature and moisture are favorable to the growth of warm season plants.

Small grain can be sod seeded in mid-September if a dessicant is used to retard the growth of warm season plants. Many pastures in East Texas are short enough that a dessicant will not be required unless additional rain is received and warm season grasses begin to grow again.

If a producer is putting in small grain pastures for cow-calf operations, he must use rotational or limited grazing to make it economical, Reeves says.





Time For An Armyworm Watch

By Paul D. Payne Farmers and ranchers need to keep on the lookout for Armyworms which have appeared in county pastures and meadows over the weekend. An outbreak of these forage feeders could be devastating to pastures, meadows and yards in

Individuals should inspect grass areas around trees and buildings and this is the area that the worms are likely to first appear. The grass will have a silver cast when viewed from a distance. The silver appearance is due to the feeding of the worms on the blades of the grass. When the number of worms builds up in an area, the grass is completely stripped of foliage.

The worms are easily identified. They will be a dark green to black worm with three yellowish-white stripes down the back. A conspicuous identification mark is a "Y" on the head. The moths which were very active last week depositing eggs have a wing span of about one and one half inches.

When the temperatures are hot as they were last week, the eggs can take as few as two to four days to hatch. Therefore, it appears that we could be in for a seige of this pest

There are two chemicals that will do an effective jof controlling the worms, Dylox and Sevin. Either will do the job and a good supply of both chemicals was available the first of

Individuals with highly fertilized pasture and meadows should check them daily for signs of damage.
